THE DIPLOMATIC SLATE CLEAN AS THE PRELIMINARY TO TAKING UP THE MILITARY MEANS OF GETTING THE ARGENTINIANS OFF THE FALKLAND ISLANDS....MRS THATCHER CONVEYED SOME SENSE OF HER PERSONAL ANNOYANCE AT THE SECRETARY-GENERAL'S SURPRISE MOVE WHEN SHE OPENED THE SIXTH COMMONS DEBATE ON THE FALKLAND CRISIS YESTERDAY.
