1. SUMMARY: THE UN SECURITY COUNCIL TUESDAY MAY 26 UNANI-
MOUSLY ADOPTED RESOLUTION 505 REQUESTING THE SYG TO
UNDERTAKE A RENEWED MISSION OF GOOD OFFICES AND TO SEEK
ACCEPTABLE TERMS FOR A CEASEFIRE. UK PERMREP STATED THAT
ANY CEASEFIRE MUST BE LINKED TO ARGENTINE WITHDRAWAL AND
THAT ARGENTINE AND BRITISH WITHDRAWAL COULD NO LONGER BE
LINKED. END SUMMARY.
2. FIRST SPEAKER IN DEBATE WAS FRG PERMREP.
HE SAID FRG TOOK NO POSITION ON THE SOVEREIGNTY QUESTION,
BUT ARGENTINA DEFIED APPEALS OF SC AND SYG AND CHOSE TO
SETTLE THE QUESTION BY FORCE. THIS WAS A BREACH OF THE
PEACE. THE UK WAS THUS LED TO SELF-DEFENSE UNDER
ARTICLE 51. THE FRG IMPLORED THE PARTIES TO HELP THE
SYG FIND A PEACEFUL SOLUTION.
3. PERMREP OF YUGOSLAVIA CALLED ARGENTINA'S CLAIM JUST.
HE RECALLED NON-ALIGNED DECLARATIONS ON FALKLANDS AND
SAID BOTH PARTIES MUST WITHDRAW.
4. IRISH PERMREP REFERRED TO ONE PARTY'S DEFENSE OF
PRINCIPLE AND THE OTHER'S FELT GRIEVANCES. REGARDING
THE ORIGINAL IRISH DRAFT RESOLUTION AND THE FINAL TEXT,
HE NOTED THAT THE PROPOSED CEASEFIRE IS NOW NOT REQUESTED
DIRECTLY BUT RATHER INCLUDED IN THE SYG'S MEDIATION.
HE HOPED THAT COOPERATION WITH THE SYG WOULD TAKE THE

FORM OF ENSURING THE PROPER BASIS FOR SUCH MEDIATION, IMPLYING THAT THE PARTIES SHOULD CEASE FIRE ON THEIR OWN.

5. UGANDAN PERMREP INTRODUCED THE NEW DRAFT RESOLUTION FOR THE COSPONSORS (GUYANA, IRELAND, JORDAN, TOGO, UGANDA AND ZAIRE), CALLING IT A "MODEST CONTRIBUTION TOWARD PEACE" AND ASKING THAT IT BE ADOPTED UNANIMOUSLY.

6. SPANISH PERMREP RECALLED UN DECOLONIZATION RESOLUTIONS AND REGRETTED THAT CEASEFIRE IS NOT EXPLICITLY MANDATED BY THIS RESOLUTION.

7. PANAMANIAN FOR MIN ILLUECA NOTED THE NEW RESOLUTION'S REFERENCE AND PANAMANIAN OBJECTIONS TO 502. (PANAMA VOTED NO ON 502.) HE SAID NO MENTION IS MADE OF DECOLONIZATION OR UNGA RESOLUTIONS ON DECOLONIZATION. PANAMA URGED AN IMMEDIATE CEASEFIRE WHICH IT BELIEVED SHOULD BE "ORDERED" BY THE SC. THIS RESOLUTION, HE SAID, PLACES TOO GREAT A BURDEN ON THE SYG IN THE FACE OF UK'S LACK OF POLITICAL GOODWILL. "HOSTILITIES" IN THE TEXT SHOULD BE UNDERSTOOD TO BE ON THE PART OF BOTH PARTIES. THERE SHOULD HAVE BEEN IN THE RESOLUTION A BAN ON US TRANSFER OF WAR MATERIAL TO THE BRITISH. PANAMA WOULD NOT, NEVERTHELESS, OPPOSE THE RESOLUTION. THE COUNTRY WITH FOUR-FIFTHS OF ITS FLEET IN THE FALKLANDS COULD MAKE THE SYG'S EFFORTS SUCCESSFUL. PANAMA WILL ASK FOR A NEW SESSION OF THE SC IN THE FUTURE.

8. CHINESE PERMREP SAID CHINA WOULD VOTE IN FAVOR DESPITE THE LACK OF A CALL FOR AN IMMEDIATE CEASEFIRE. CHINA HOPED THAT THE PARTIES WOULD COOPERATE FULLY WITH THE SYG.

9. THE RESOLUTION WAS ADOPTED UNANIMOUSLY (15-0-0) AS SC RES 505 (1982). THE SYG THANKED THE SC FOR ITS RENEWED CONFIDENCE, BUT STATED THAT THE TERMS OF REFERENCE DID NOT PROVIDE SUFFICIENT GUIDANCE. HE URGED THE PARTIES TO RECOGNIZE THAT CESSATION OF CONFLICT AND THEN NEGOTIATIONS ARE THE ONLY PATH TO A SOLUTION.

10. JAPANESE PERMREP SAID MAIN IDEAS OF THE JAPANESE DRAFT WERE INCORPORATED IN 505, FOR WHICH HIS DELEGATION HAD JUST VOTED.

11. SOVIET PERMREP STATED THAT 502 AND 505 IGNORE DECOLONIZATION. THE RESTORATION OF COLONIAL ADMINISTRATION BY FORCE IS INADMISSABLE. THE USSR WISHED THE SYG WELL IN HIS NEW EFFORTS. THE LONGEST NEGOTIATIONS ARE BETTER THAN THE SHORTEST WAR.

12. AMBASSADOR KIRKPATRICK MADE FOLLOWING ADDRESS:
- I SHOULD LIKE ONCE AGAIN TO EXPRESS THE ADMIRATION AND APPRECIATION OF MY GOVERNMENT FOR THE SKILL AND JUDGMENT

- THE UNITED STATES HAS ALREADY EXPLAINED HERE THAT THIS CONFLICT IS PARTICULARLY POIGNANT AND PAINFUL FOR US. WE HAVE ALREADY EXPRESSED OUR INTENSE DESIRE TO REDUCE, TO ISOLATE, AND TO END THIS TRAGIC CONFLICT. I BELIEVE WE HAVE GIVEN EVIDENCE OF THE SERIOUSNESS OF OUR DESIRE. MY GOVERNMENT IN THE PERSON OF THE SECRETARY OF STATE MADE SUSTAINED EFFORTS TO AVOID THE CONFLICT AND SUBSEQUENTLY OFFERED FULL SUPPORT TO THE EFFORTS OF PERU'S PRESIDENT BELAUNDE AND, OF COURSE, TO THE EFFORTS OF OUR DISTINGUISHED SECRETARY GENERAL, JAVIER PEREZ DE CUELLAR.

- THE UNITED STATES ARDENTLY DESIRES AN END TO THIS TRAGIC WAR. WE WELCOME THIS RESOLUTION AND PLEDGE OUR CONTINUED SUPPORT FOR THE SECRETARY-GENERAL'S EFFORTS TO FIND A JUST AND ENDURING PEACE. I SHOULD LIKE TO TAKE THIS OPPORTUNITY TO ASSURE THE DISTINGUISHED REPRESENTATIVE OF PANAMA AND ANY OTHER INTERESTED PARTIES THAT MY COUNTRY HAS DEEP RESPECT FOR ALL OF OUR NEIGHBORS IN THE HEMISPHERE, THAT WE DESIRE GREATLY TO LIVE IN PEACE WITH THEM, THAT WE ARE OURSELVES PART OF THIS HEMISPHERE, THAT WE DESIRE TO PUT AN END TO THIS CONFLICT SO THAT WE CAN GET ON WITH THE BUSINESS OF LIVING IN PEACE IN THE HEMISPHERE.

- AS I SAID EARLIER THIS WEEK, THE QUICKER WE PUT THIS TRAGIC CONFLICT BEHIND US THE QUICKER WE CAN BEGIN BUILDING OUR FUTURE -- AND THERE, AS ALWAYS, THE NATIONS OF LATIN AMERICA WILL FIND HOW DEEPLY THE UNITED STATES IS COMMITTED TO THE CAUSE OF PEACE AND PROSPERITY FOR OUR HEMISPHERE.

13. UK PERM REP SAID HIS DELEGATION VOTED FOR 505 BECAUSE IT REAFFIRMS 502 AND ITS DEMAND FOR UNCONDITIONAL WITHDRAWAL OF ARGENTINE FORCES FROM THE ISLANDS. HMG COULD NOT ACCEPT ANY CEASEFIRE UNLINKED TO THE BEGINNING OF ARGENTINE WITHDRAWAL. THE SITUATION IN THE FALKLANDS HAD CHANGED FUNDAMENTALLY. ARGENTINE WITHDRAWAL COULD NO LONGER BE LINKED TO PARALLEL BRITISH WITHDRAWAL.

14. ARGENTINE INTERNATIONAL ORGANIZATIONS CHIEF LISTRE THEN SAID A CEASEFIRE WAS NECESSARY AND WOULD HAVE BEEN IN RES 505 BUT FOR THE INTRANSIGENCE OF ONE SC MEMBER. ARGENTINA WOULD COOPERATE FULLY WITH THE SYG ON CESSATION OF HOSTILITIES AND ON NEGOTIATIONS, WITHOUT GIVING UP ANY OF ITS RIGHTS. ARGENTINA COMES TO THE NEGOTIATIONS WITHOUT PRECONDITIONS. WHEREAS THE OTHER PARTY HAD TODAY INDICATED PRECONDITIONS.

15. USSR IN RIGHT OF REPLY SAID UK STATEMENT IGNORED 502'S CALL FOR AN END TO HOSTILITIES AND 505'S REFERENCE TO BEARING IN MIND THE SYG'S STATEMENT OF MAY 5. THE UK IS AGAIN MAKING ULTIMATA WHICH CALL INTO QUESTION ITS SINCERITY IN VOTING FOR 505.

16. SC PRESIDENT (CHINA) SAID SC WILL CONTINUE CONSIDERATION OF THIS ITEM WHEN NECESSARY.
