GREAT BRITAIN WHO CONTINUES TODAY MAKING USE OF FORCE.
IT WAS GREAT BRITAIN WHO LED US TO THIS SITUATION,
IT WAS GREAT BRITAIN WHO, WHEN PACIFIC ARGENTINIAN
WORKERS WERE WORKING IN THE GEORGIA ISLANDS LEGITI-
MATELY AND WITH THE KNOWLEDGE OF GREAT BRITAIN SENT
US A NOTE SIGNED BY LORD CARRINGTON, MINISTER OF FOREIGN
AFFAIRS OF GREAT BRITAIN AT THAT TIME, A NOTE THAT WAS
WRITTEN AND CONCEIVED IN TERMS OF THE MOST ORTHODOX
COLONIALISM, OF THE MOST ORTHODOX IMPERIALISM.
"IN THAT NOTE, WE WERE TOLD THE FOLLOWING:

"BUT, IN ADDITION TO THIS, HE ANNOUNCED THAT HE WAS SENDING NUCLEAR SUBMARINES TO THE REGION, AND THAT WARSHIPS WOULD ALSO GO TO THE REGION.

"THIS IS, GENTLEMEN, A CLEAR USE OF THE THREAT OF THE FORCE, SUCH AS IS FORBIDDEN BY THE CHARTER OF THE UNITED NATIONS AND BY ALL THE PRINCIPLES THAT YEAR AFTER YEAR HAVE BEEN RATIFIED BY MEMBER COUNTRIES OF THE NON-ALIGNED MOVEMENT.

"ARGENTINA, IN THE PRESENCE OF THAT THREAT, IN THE PRESENCE OF THE THREAT OF THE ARRIVAL OF WARSHIPS AND NUCLEAR SUBMARINES, LIMITED ITSELF, THROUGH AN EXEMPLARY ACTION OF PACIFISM IN WHICH NOT ONE DROP OF BLOOD OF THE OCCUPANTS OF THE ISLANDS WAS SPILLED, TO OCCUPY ITS OWN TERRITORY.

"IS THIS USE OF FORCE? THERE IS NO DOUBT THAT GREAT BRITAIN HAS BEEN THE FIRST TO APPLY FORCE IN OCCUPYING THE ISLANDS, WHICH ARE, AS I SAY AND WITHOUT ANY DOUBT, PART OF THE NATIONAL TERRITORY.

"MRS. THATCHER SAID THAT AGGRESSION MUST NOT BE REWARDED, I WOULD ASK YOU: WHAT WOULD HAVE BEEN THE HISTORY OF GREAT BRITAIN AND PERHAPS THE HISTORY OF THE WORLD IF THIS TRUTH HAD BEEN APPLIED DURING THE 19TH AND 20TH CENTURY TO THE CONDUCT OF GREAT BRITAIN? AGGRESSION SHOULDN'T BE REWARDED. NEVERTHELESS, GREAT BRITAIN NEVER APPLIED THIS TRUTH TO ITS OWN CONDUCT. NEITHER WAS IT APPLIED BY THE UNITED STATES.
