SUBJECT: THE COUP IN LESOTHO & US SOUTHERN AFRICA POLICY

Having spent two weeks in Lesotho last June as a speaker on a USIA [AMPARTS] tour -- I was a guest at the home our ambassador there -- and having kept up contacts with Americans there, I have some thoughts on the recent coup.

In 1966 when Leabua Jonathan became the first prime minister of Lesotho [the former British colony of Basutoland], he portrayed himself as an anti-communist moderate. His election was widely known to have been rigged, and he showed his penchant for autocratic rule by visiting harsh reprisals on his political opposition: some were killed, others driven into exile in South Africa. Although he often promised new elections, none were ever held.

In 1970 Jonathan further clouded his "legitimacy" when he banished the popular King, Moshoeshoe II, thus alienating a strong royalist faction which had been willing to work with him until then. The king's loyalists never forgave Jonathan for this, even though he relented and let the king return as a mere figurehead after a year of exile in England.

South Africa looked on nervously as Jonathan engaged in ever more open collaboration with the African National Congress, the guerrilla/terrorist organization that has been under effective Soviet domination for the past 16 years. In 1983 South African special forces staged a lightning raid on an ANC safe house in Maseru, the capital. This raid infuriated Jonathan who hit upon an ingenious way to get even: he went off on a tour of Eastern bloc capitals and then invited the Soviet Union, North Korea, and the PRC to open embassies in his country.

The Soviet Embassy, a large heavily-staffed complex, was nearing completion late last June when I left. Since there are no Soviet nationals living in Lesotho (other than the 45 or so at the embassy), and since the country has no trade with the USSR, the South Africans concluded that the Soviet embassy was basically an observation and command post for their drive to bring down South Africa with the aid of their stooges in ANC and SWAPO. The fact the the Kremlin's ambassador, a short unsmiling man, was earlier kicked out of England as a high-ranking KGB operative, tended to confirm this view. Most disturbing of all, Jonathan sent several score of Lesotho's military to North Korea for training by the same notorious Korean unit that trained a killer brigade for Zimbabwe's Robert Mugabe. [This Korean trained Zimbabwean brigade has been responsible for the slaughter of thousands of Ndebele tribesmen loyal to Joshua Nkomo. They butchered about 750 civilians during just one weekend last June.]

When Lesotho's Korean-trained and indoctrinated officers returned, Jonathan attempted to have one of them put in a high command position in the General Justin Lekhanya's Paramilitary Force. This was too much for Leyhanya. He refused to go along and promptly disarmed all the Korean-trained officers. From that time the breach between Jonathan and Lekhanya has widened.

It became an unbridgeable chasm when the Koreans sent over some 600 "martial arts instructors" who proceeded to set up paramilitary and ideological training camps for Lethotho youth and young "refugees" (ANC recruits) from South Africa. These kids, from about 14 to 18 years of age and armed with AK 47s, have become a real menace, terrorizing, for example, the campus of Lesotho National University -- formerly Pope Pius XII University! Lesotho, by the way, is about 70 percent Catholic.

The church's highest ranking prelate, Archbishop Morapeli, told me that this indoctrination of the youth with communist doctrine was an outrage and that one day General Lekhanya would have to take strong action to put an end to it.

Seven months ago in a long meeting I had with him, Lesotho's highest-ranking Anglican churchman, Bishop Philip Mokuku, told me that Jonathan was guilty of squalid misrule and that his reckless South Africa baiting could only result in a bloodbath for his own people when South Africa finally decided it had taken enough.

"Jonatahan does all this rash and foolish posturing," he told me, "because he thinks it shows he opposes apartheid. But opposition to apartheid is no excuse for committing national suicide. Does Monaco pick a fight with France?

"We are <u>all</u> opposed to apartheid," Mokuku continued. "But the strongest blow we could deliver against it would be to set an example here of a black-ruled country that is truly free and fair and well-ruled and without corruption. But Jonathan does just the opposite. In fact he has made this country a visual aid for the defenders of apartheid." 2

It is worth noting that this moderate Anglican bishop's immediate predecessor was Bishop Desmond Tutu.

The immediate cause of the coup was, of course, that Jonathan, who had promised the military just a few days earlier that he would let them crack down on the ANC and the armed Korean-trained Youth Branch of Jonathan's party, reneged on this promise, announced he was in complete control, demanded the US and Britain provide him with a Berlin-Style airlift to undercut South Africa's tightening economic blockade, and finally threatened to turn to the Soviet Union and its satellites for aid if the West refused this utterly nonsensical demand. The fact that at the time Jonathan was putting on this bizarre performance he was playing host to Fidel Castro's foreign minister made it all the more the more galling to Lekhanya.

THE U.S. SHOULD IMMEDIATELY GIVE DE FACTO RECOGNITION AND SUPPORT TO THE PROVISIONAL REGIME HEADED BY GENERAL JUSTIN LEKHANYA. IT HAS THE BLESSING OF KING MOSHOESHOE, AND AND THE VIRTUALLY UNANIMOUS SUPPORT OF THE PEOPLE OF LESOTHO. IF DEALT WITH IN A FRIENDLY WAY, THE NEW GOVERNMENT WILL IN DUE COURSE REVERSE THE JONATHAN POLICY OF COZYING UP TO THE SOVIET BLOC.

I. PURPOSE

To meet with the constitutional monarch of a friendly African country which values its relationship with the United States.

II. BACKGROUND

Oxford-educated King Moshoeshoe II enjoys executive and legislative powers. He is generally respected and popular at home.

Lesotho is completely surrounded by South African territory. It is totally dependent on South Africa for its income which comes mainly from customs receipts and the remittances of Lesotho men working in South African mines. Good relations with South Africa must, therefore, be a cardinal element of Lesotho's foreign policy.

Recently, the King has expressed concerns about Lesotho's precarious geopolitical situation as an island in the sea of apartheid and has indicated interest in the U.S. acting as a "guarantor" of Lesotho's integrity. The government has also requested a U.S. Government loan to finance the purchase of aircraft. This is not possible, but Lesotho could order from a U.S. manufacturer who can request an Export-Import Bank loan.

Lesotho has just experienced its worst natural disaster. Torrential rain and snow in the mountain areas have resulted in at least 14 deaths, washed out roads and bridges, and loss of livestock. We are providing \$25,000 toward relief efforts.

I. COURTESY POINT

-- Congratulations on Lesotho's 21st anniversary of independence (October 4).

II. LESOTHO'S RELATIONS WITH THE UNITED STATES

POINTS TO MAKE:

-- The U.S. is pleased that it has been able to assist Lesotho, particularly in the areas of education and agriculture.

-- We are hopeful that improved marketing techniques and increased income will result from these programs.

ONLY IF ASKED:

-- The U.S. cannot provide aircraft to Lesotho. The government of Lesotho may order from a U.S. manufacturer, who can request an EXIM bank loan for Lesotho.

-- We plan to continue our \$50,000 military training program.

We cannot provide such a loan. However, Lesotho can order from a U.S. manufacturer who can request an Exim bank loan. The U.S. plans to continue its economic development assistance to Lesotho at current levels. We will continue the existing \$50,000 IMET program but do not plan a military assistance program.

The attached talking points provide responses should the King raise these issues with the President.

MOTLOTLEHI – HIS MAJESTY KING (CONSTANTINE BERENG SEEISO) MOSHOESHOE II OF LESOTHO

(mo-Shway-Shway)

His Majesty was born on 2nd May. 1938 at the Village of Salang in the mountain district of Mokhotlong in Lesotho. He is the second child and the eldest son of the late Paramount Chief Simeone Seeiso Griffith and Mofumahali 'Mabereng.

When Paramount Chief Seeiso died in 1940, the Young Prince was brought up by his uncles under the Regency of Mofumahali Mantsebo who was Regent from 1940 up to 1960 when the Young Prince was installed Paramount Chief. His Majesty is a direct descendant of His Majesty King Moshoeshoe I, the founder — King of the Basotho Nation, who died in 1870.

He started his primary education in Mokhotlong and continued at Roma Primary School through to Secondary School at Roma College (now Christ the King High School) from 1948 to 1954.

From 1954 to 1957, His Majesty studied at the Benedictine College of Ampleforth, Yorkshire, in the United Kingdom. He then entered Corpus Christi College, Oxford University in 1957 to read Politics. Philosophy and Economics (PPE). After nearly three years at Oxford, he returned to Lesotho at the end of 1959. Shortly afterwards he was installed as Paramound Chief of Lesotho.

In the early seventies, His Majesty resumed his studies with Corpus Christi College, Oxford to complete his Degree in Politics, Philosophy and Economics (PPE). He did another Degree of Bachelor of Arts in Law at the same College.

When he was installed Paramount Chief of the Basotho Nation on March 12 1960, he was proclaimed "Motlotlehi" by the Nation and assumed the "English title" of "King" in 1966 when Lesotho's Independence was finally restored by the British Queen. He remained a Constitutional Head of State; was exiled from Lesotho in April 1970, but returned from exile in December 1970.

With the change of Government in 1986, the King has both Executive and Legislative Powers in Lesotho in accordance with the provision of the 1986 Lesotho Order No. 1.

In August 1962, His Majesty King Moshoeshoe II married Princess Tabitha 'Masentle Lerotholi Mojela, the daughter of the late Principal Chief Lerotholi Mojela, a veteran of the First World War. Her Majesty Queen 'Mamohato Bereng Seeiso was born in the Mafeteng District.

They have three children, Crown Prince Letsie Mohato, Principal-Chief-Designate of Matsieng and heir to the throne, born on July 17 1963; Prince Simeone Seeiso born 16 April 1966; and Princess Christina 'Maseeiso born on 24 December 1969.

His Majesty has travelled widely, having visited the United Kingdom, Holland where he stayed in exile in 1970, West Germany, Botswana, Swaziland, Nigeria, Ghana, Ethiopia, Kenya, Zambia, Tanzania, Zaire, Liberia, Sweden, the United States of America, the People's Republic of China and the Bahamas.

He also attended conferences starting in 1958, when he attended the first Constitutional conference in London, which granted Self-Government to Lesotho, the second Constitutional Conference in 1964 which granted the Pre-Independence Responsible Government, and the 1966 Independence Talks which resulted in the restoration of full independence of the Kingdom of Lesotho in 1966. His Majesty has addressed the Organisation of African Unity (OAU) and the United Nations Security Council on various issues including the problems between the Kingdom of Lesotho and her neighbour, South Africa.

His Majesty's interests are wide-ranging, including tennis, squash and horse-riding. He owns and breeds race-horses.

Like most Basotho, His Majesty is keen on and enjoys mixed farming. He keeps cattle, sheep and goats.

His Majesty is interested in the welfare of the Basotho people and has great interest in education and social issues which he considers the key to the development and progress of his people. In the early 1970s, he established the Mohato Scholarship Fund financed by him to aid needy Basotho youngsters to further their education.

His Majesty established a high school named after him in 1965. Moshoeshoe II High School in the area of Matsieng was created to meet the problems of students who had to travel long distances for placement in schools, many times with little success. He maintains active links with the school and its developments.

He had been Chancellor of the University of Botswana, Lesotho and Swaziland in rotation with other Heads of State of Botswana and Swaziland, and is now Chancellor of the National University of Lesotho (NUL), with which he maintains both formal and informal contact and follows its development with keen interest.

In 1975 His Majesty established the Matsieng Development Trust, a body whose main purpose is to encourage and promote rural development on the lines of self-help and self-reliance.

His Majesty is Patron to a number of Charitable Organisations like the Red Cross of Lesotho, the Lesotho Save the Children Fund, to name only a few. Whenever possible, he participates in Charity Walks and other activities with the purpose of fund raising for special social and development projects and programmes.
