

Dear Senator Kerry:

I am replying further to your message to the President of September 28 concerning U.S. policy toward Lebanon.

The United States supports the national unity, sovereignty, and territorial integrity of Lebanon. We encourage and support efforts to end the violence and disorder there and reestablish a dialogue among the Lebanese that could open the way to constitutional reform and national reconciliation.

On the presidential election, we believe this is a critical time to work for consensus, not confrontation and partition. We urge all parties to exercise maximum restraint. The recent evolution of rivaling claims to government authority demonstrates the need for an election to be held as soon as possible in peace, freedom, and safety. The United States believes that the Lebanese must select their next president through Lebanon's constitutional process.

Throughout this critical period, the United States intends to remain in contact with as many responsible Lebanese groups and leaders as possible. We do not intend to take measures that will deepen partition rather than promote an election.

We are concerned about the plight of all innocent civilians, Christian and Muslim, who have suffered so much during the last 13 years of fighting. Reports of sectarian massacres and property destruction unfortunately have been widespread in Lebanon; no confessional community appears to have escaped unscathed.

As a reflection of our support for Lebanon's sovereignty, the United States maintains a military and economic assistance program. Also, the United States provides substantial humanitarian aid totalling over \$20 million annually to help feed and shelter the people of Lebanon. Our relief and reconstruction projects and programs also continue.

Finally, the United States continues to support efforts to end the cycle of violence in southern Lebanon, in part through its support for UNIFIL, the United Nations Interim Forces in Lebanon. We remain convinced that agreed-upon security arrangements among Syria, Lebanon, and Israel provide the best means of assuring stability and security for the people of southern Lebanon and northern Israel.

Dear Mr. President:

A number of my Lebanese-American constituents have contacted me to express their despair over recent reports that our government has altered significantly our historical policy towards Lebanon.

The stated policy of our government, dating back to the administration of President Dwight D. Eisenhowr, has been the maintenance of an independent and sovereign Lebanon, free from external interference. This position supposedly was reinforced in an August 25, 1988 letter from the Department of State to Mr. Adel Honein, the National Chairman of the American Lebanese League. In that letter, Mr. Edward Walker, Deputy Assistant Secretary for Near Eastern and South Asian Affairs, stated that:

> "The choice of a new president is for the Lebanese themselves to make. The new president must represent all the Lebanese people so that he can build on the efforts that already have been made to promote national reconciliation and to reform the Lebanese constitution."

Now, we find out that Syrian President Hafez Assad has been given veto power over who is to be the next President of Lebanon. It has been reported extensively that Assistant Secretary of State for Near Eastern and South Asian Affairs, Richard Murphy, on a recent trip to the region, informed representatives of the Lebanese Christian community that it was now United States policy to back the Syrian candidate for President. How can we expect any Lebanese nationalist to accept a President imposed on them by Damascus? I fear one result of Secretary Murphy's trip and announcement is to move Lebanon closer to partition that at anytime in the past. This episode represents a serious setback for the policy of the United States in our historical attempts to insure the territorial integrity and sovereignty of a united Lebanon.

In addition, Syria has been designated by your administration as one of six nations in the world which support international terrorism. Why are we then catering to Assad? Is this the way we reward terrorism?

Finally, Syria has been, and remains, one of the foremost obstacles to a comprehensive peace settlement in the Middle East. How does strengthening Syria's hand in Lebanon further our overall peace efforts in the region?

In light of these dire consequences for our policy in Lebanon and throughout the Middle East, I believe it is vitally important for our government to reverse this change in policy towards Lebanon. Rather than avoiding a partition of Lebanon through our acceptance of Syria's presidential candidate, we are already witnessing the beginnings of a de facto partition of that country. Certainly, we cannot expect Israel to stand by and accept Syrian hegemony over Lebanon.

In light of the stakes for U.S. policy in the region and for the people of Lebanon themselves, I believe it is essential that our government make it very clear that we will not allow Syria to dictate the outcome of the next presidential election and that our historical policy towards Lebanon is now back on track.

Thank you very much for your kind consideration of my views on this matter.

Reports of sectarian massacres and property destruction unfortunately have been widespread in Lebanon; no confessional community appears to have escaped unscathed.

As a reflection of our support for Lebanon's sovereignty, the United States maintains a military and economic assistance program. Also, the United States provides substantial humanitarian aid totalling over \$20 million annually to help feed and shelter the people of Lebanon. Our relief and reconstruction projects and programs also continue.

The Honorable Barbara Vucanovich, House of Representatives. Finally, the United States continues to support efforts to end the cycle of violence in southern Lebanon, in part through its support for UNIFIL, the United Nations Interim Forces in Lebanon. We remain convinced that agreed-upon security arrangements among Syria, Lebanon, and Israel provide the best means of assuring stability and security for the people of southern Lebanon and northern Israel.

Dear Mr. President:

It has become clear that the State Department's recent policy toward Lebanon is not in the long-term interest of the United States. Just two weeks ago, Assistant Secretary of State Richard Murphy arrived in Beirut to pressure the Lebanese Parliament to accept as their President a Syrian supported candidate. The Government of Lebanon, the Maronite Patriarch, and the Lebanese Christian community soundly rejected the overtures by Assistant Secretary Murphy and the State Department.

It is incomprehensible that representatives of the United States Government should attempt to impose on the Lebanese people a candidate supported by Syria, a state which sponsors terrorism, rejects the existence of the State of Israel, and continues to occupy large portions of Lebanon itself. Support for such a candidate would jeopardize the security of Israel and would expand Syria's access to the Mediterranean. Turning over the control of the Lebanese presidency to a Syrian supported candidate is clearly not in the interest of the United States.

Mr. President, it is difficult to understand how your Administration, which has aggressively supported people struggling for democracy around the world, would side with the terrorist regime of Syria. Our policy must be to reinforce the efforts of the existing interim military government to bring about reconciliation and free elections. The Department of State must work with the new interim Prime Minister to reach these goals if stability is ever to return to that troubled nation.



Thank you for sending us a copy of the letter on Lebanon from your constituent, Mr. Edward Kahalley, Sr., Vice President of Communications for the American Lebanese League. The President has asked me to reply.

The United States continues strongly to support the national unity, sovereignty, and territorial integrity of Lebanon. As you know, we encourage and support efforts to end the violence and disorder there and to reestablish a dialogue among the Lebanese that opens the way to constitutional reform and national reconciliation.

On the presidential election, this is a time to work for consensus, not confrontation and partition in Lebanon; and we are urging all parties to exercise maximum restraint and flexibility. The United States believes that the Lebanese must select their next president through Lebanon's constitutional process. The recent evolution of rivaling claims to government authority demonstrates the need for an election to be held as soon as possible in peace and safety.

Throughout this critical period, the United States intends to remain in contact with as many responsible Lebanese groups and leaders as possible in order to promote an election and help prevent deeper partition.

On September 21, 1988 the undersigned had the opportunity to talk personally with Ambassador Richard Murphy relative to State Department activity in conjunction with the election in Lebanon. I was extremely alarmed with the positions expressed by Ambassador Murphy and requested an immediate meeting between himself and representatives of the American Lebanese League.

On October 5, 1988 representatives from the American Lebanese League, including the undersigned, had a one and one half hour meeting with Ambassador Richard Murphy at the United Nations Plaza Hotel in New York. Unfortunately, this meeting only confirmed that our government (thru Ambassador Murphy) has been more interested in meeting Syria's demands, than it has been in protecting the life of a dying democracy.

We contend that our government has done more harm than good. To support this charge we enclose a copy of a speech made to the United States Senate on September 23, 1988 by Senator Jesse Helms. Please take a few minutes to read this speech.

We hereby call on you to express to President Reagan similar sentiments and request that our government and State Department reevaluate its position on this critical matter, recognize the duly constitutional Aoun Cabinet, declare that Syrian troops are in Lebanon illegally and work for a **free Lebanese election** in a safe area without any Syrian influence. This is the least our government can do as the leader and defender of Democracy in the world.

#### SENATOR HELMS DENOUNCES SYRIA FOR INTERFERING IN LEBANESE AFFAIRS

#### Friday September 23, 1988

In the first meaningful response to Syria's involvement in Lebanon, U.S. Senator Jesse Helms (R-NC) denounced Syria's interference in Lebanese affairs in a speech before the U.S. Senate.

Senator Helms criticized the State Department over its miserable failure in handling the Lebanese situation saying: "Mr. Murphy, instead of playing the role of honest mediator, all but handed Lebanon over to Syrian dictator Hafez Assad".

Senator Helms went on to talk about Syria's new candidate, Mikhael al-Daher, and the condemnation of the Christians of Lebanon to Murphy's mission, and demanded that the United States recognize Prime Minister Michel Aoun's new cabinet as the only legitimate authority on Lebanese soil.

Following is the full text of Senator Helms speech:

The State Department policy in Lebanon:

"Mr. President, today we stand on the verge of the collapse of Lebanon into a bloody civil war. Lebanon has been perilously weakened by the United States-or, more specifically, by the Near Eastern Affairs Bureau of the Department of State under Assistant Secretary Richard W. Murphy. The fixation of this Bureau on enhancing the power of President Hafez Assad of Syria has been contributing to the tragedy of Lebanon for more than a decade.

The election of a new Lebanese president is a matter for the Lebanese Parliament alone to decide. We should not be negotiating with Syria about the internal affairs of Lebanon. Syria should be told forcefully by the United States to stay out of Lebanese politics and to stay out of Lebanon.

Mr. President, since August Syria has been thwarting the attempts of the people of Lebanon to conduct a proper election for their president. The election was supposed to have been conducted yesterday but the Syrians demanded that the Parliament meet for the elections in Syrian-controlled West Beirut. No quorum was possible because it is not safe for Christian and Moslem deputies from East Beirut to cross over into West Beirut to vote.

The United States must recognize the legitimately constituted new government of Prime Minister General Michel Aoun which was created yesterday at 4:50 p.m. Washington time, 11:50 p.m. Beirut time. The government of General Aoun was created by the Decree of President Amine Gemayel just 10 minutes before the expiration of his term of office. Under the Lebanese constitution such a transitional cabinet may be appointed by the President; it will then govern until proper presidential elections can take place. The Prime Minister of the transitional cabinet during this period has full presidential powers. A similar transitional situation occured in 1952.

The Syrians are seeking to impose an alternate government headed by their puppet Salim al-Hoss, who has been the acting Prime Minister under President Gemayel, which would seek international recognition for itself in place of the constitutional government. Al-Hoss' cabinet resigned over a year ago on June 1, 1987.

Mr. President, the United States and all countries of good will must recognize the Aoun government in order to prevent chaos, bloodshed, and a possible partition in Lebanon.

The reason that proper elections in safe conditions did not occur yesterday is because the Syrians insisted that the elections be held in Syrian-controlled West Beirut rather than at a neutral site, the Villa Mansour, along the Green Line which separates East and West Beirut.

Deputies did meet in West Beirut but a quorum was not present. Sadly, a Shiite Moslem deputy from East Beirut, former Speaker of Parliament Kamel al-Assaad, who had gone to vote in good faith was kidnapped, assaulted, and later released by pro-Syrian Amal militia forces as he tried to return to East Beirut.

Damascus has no right to interfere in the sovereign affairs of Lebanon. Damascus has no right to occupy Lebanon with over 40,000 troops. The United States has no business promoting Syrian control of Lebanon.

Mr. President, Senators know that it has been the stated policy of the United States since 1943 to support the sovereign independence of Lebanon. Sovereign independence means no foreign interference in internal affairs.

Secretary Murphy's diplomatic failure in Damascus has unfolded over the last week. His policy has been appeasement in the face of Syrian demands. He has all but handed Lebanon over to Syrian dictator Hafez Assad. The consequences of this unprecedented betrayal may well lead to bloodshed within the coming hours and days.

The State Department mission to Damascus, rather than playing a role as an honest mediator, capitulated step-by-step to the Syrian plan to install a puppet president in Lebanon.

First, the State Department accepted rather than rejected the puppet candidates proposed by Syria. Rather than veto Syrian intervention in the electoral process, Mr. Murphy publicly indicated U.S. support of the Syrian puppet candidate Mikhael al-Daher knowing full well in advance that al-Daher was wholly unacceptable to Christian and moderate Moslem Lebanese.

Second, the State Department accepted rather than rejected the Syrian-selected West Beirut venue for the election knowing fully well in advance that this location was unacceptable to Christian and moderate Moslem deputies.

The Syrians, who militarily occupy about 60% of Lebanese territory, have tried for months to impose their own puppet as president. The Syrians proposed two candidates: Sleiman Franjieh as their first choice and al-Daher was the alternate. Both of these men are notoriously pro-Syrian control, a fact which makes their families and friends hostages to Syria. Both of these men are known to Syria and to the United States to be wholly unacceptable to the Christian and moderate Moslem communities in Lebanon.

The Syrian demand that the election take place at a location in West Beirut rather than along the Green Line at the Villa Mansour has been an attempt to put Christian and Moslem deputies living in East Beirut under Syrian intimidation in an almost hostage-like situation should they cross over to vote. As I pointed out, a kidnapping did occur. Such a venue could have no other purpose than to force deputies to boycott the election for their own safety. The Syrians then could promote an alternative government.

#### The al-Daher Candidacy:

Mr. President, as I stated earlier, the Syrians first proposed Sleiman Franjieh as their candidate for president knowing full well that he was wholly unacceptable to the Christian and moderate Moslems communities. The back-up was Mr. al-Daher, also well known to be unacceptable to these communities, as an alternate candidate.

Daher, born in the village of Kobayatt, North Lebanon in 1928, is a lawyer who once defended Fouad Awad of the Syrian Social Nationalist Party - a Syrian party with a Lebanese branch - who was charged with plotting a coup d'etat in Lebanon. The ideology of this political party holds that Lebanon and the rest of the Mesopotamian Basin - including Israel and Iraq - should be part of a so-called "Greater Syria." The Lebanese branch of this party has covert terrorist cells.

Al-Daher fully endorsed the "Tripartite Agreement" of December 28, 1985 which was the Syrian program for control of Lebanon. This plan gives Syria total control over Lebanon's defense, internal security, foreign policy, economic policy, and education policy. The plan never went into effect but has remained part of Syria's gameplan.

Reports from Lebanon indicate that on September 12 of this year, Daher, in preparation for the declaration of his candidacy, left his East Beirut residence and visited his village of Kobayatt in Syrian controlled North Lebanon. He brought two well-known Syrian sympathizers with him: ex-Ministers Michel Murr and Marwan Hamade.

It has been reported to me that al-Daher went to Damascus on September 16 to work out the details of his candidacy and platform. It has not yet been confirmed whether or not he met with the U.S. State Department delegation then in Damascus. His platform is described as consisting of most of the elements of the Tripartite Agreement and in effect the platform hands Lebanon over to Syria. Syrian Vice President Khaddam - with whom the Murphy delegation had been negotiating - declared official Syrian approval of the al-Daher platform on September 19.

Under al-Daher's platform, the Syrian military would essentially take control over the Lebanese Army and internal security forces. Christians Condemn the Murphy Actions:

Mr. President, Christian parliamentary deputies and church authorities have been meeting in emergency session in Bkerke over the last several days. The Christian deputies have taken a position that the unity of the national assembly must be preserved and that the elections must be held in secure conditions at the Villa Mansour along the Green Line.

Before Secretary Murphy left Lebanon, he was informed frankly and forcefully by the Maronite Patriarch Sfeir in person that the State Department's position in support of a Syrian diktat was rejected by the Christians community. According to informed sources, the Patriarch told Murphy that not even Lebanon's former Ottoman rulers had attempted to impose their will on the country in such a fashion as Syria's Assad.

#### September 30, 1988

Despite the clearly announced united position of the Christian community, the U.S. Embassy in Lebanon has continued to insist upon the acceptance of al-Daher or the holding of elections in Syriancontrolled West Beirut. Our Ambassador to Lebanon, John Kelley, was stricken with heart problems last week and was evacuated to Cyprus and then to West Germany for tests last Friday. Ambassador designate McCarthy has not yet left the United States to replace Ambassador Kelley. The U.S. spokesman in Lebanon, therefore, has been Daniel Simpson who has reportedly privately and publicly supported al-Daher and the West Beirut election location.

Mr. President, it is my understanding that the Vatican has been fully informed of the situation and is deeply distressed by events in Lebanon.

The French Foreign Minister has already condemned the U.S. diplomatic fiasco.

#### The Aoun Government:

President Amine Gemayel named the following to a military government in the closing minutes of his term. General Michel Aoun, a Maronite Catholic and the military chief of staff, was named the Prime Minister and given the portfolios for defense. Brigadier Issam Abu Jamra, a Greek Orthodox, was named Deputy Prime Minister and given the portfolios for transportation, housing, commerce, economics, and post office. General Edgar Maalouf, a Greek Catholic, was given the portfolios of finance, health, social affairs, oil, and industry. Col. Loutfi Jaber, a Shiite Moslem and commander of the predominantly Shiite Sixth Brigade, was given the portfolios of water, electricity, agricultrue, and justice. General Mahmoud Tay Abu Dargham, a Druze, was given the portfolios for public works, tourism, and labor. General Nabil Koraytim, a Suni Moslem, was given the portfolios for foreign affairs, interior, and education.

Owing to intense Syrian pressure, Col. Jaber, General Dargham, and General Koraytim declined to serve in the new government. An indication of the intensity of Syrian pressure was the non-acceptance of the portfolios by Col Jaber who himself had supported General Aoun for president.

The Aoun government has the united support of the Christian community in Lebanon as well as the support of moderate Moslem leaders such as Osman Danna, a Sunni Moslem deputy from Beirut. Dr. Samir Geagea, the Chairman of the Christian Resistance and Commander-in-Chief of the Lebanese Forces announced his immediate support for the Aoun government. Dany Chamoun, leader of the National Liberal Party, and George Saade, leader of the Kataeb Party, announced their support of the Aoun government. Pierre Helou, an independent Deputy and influential leader within the Christian community announced his support of the Aoun government.

Mr. President, the State Department's pro-Syrian policy has remained virtually unchanged since it was created by Henry Kissinger in the early 1970s. The inevitable consequences of this pro-Syrian policy to date has been bloody civil warfare in Lebanon, Syrian military occupation of some 60 per cent of Lebanese territory, and the spread of international terrorism.

Mr. President, it is no secret that Syria and Iran worked together to blow up the Marine Corps barracks in Lebanon which took the lives of over 250 soldiers. Of course, the State Department made every effort to cover up Syrian support of international terrorism even though Syria has been on the list of countries sponsoring terrorism. The Department of State has promoted the fiction that Syria has been helpful with respect to hostages when the fact is that Syria on its own, and working with Iran, has been behind the taking of hostages in the Middle East.

Mr. President, it is time that we drop the fatally flawed pro-Syrian policy of the Bureau of Near Eastern Affairs at the State Department. We need to construct and to implement a realistic policy for the Near East which will contribute to the peace and prosperity of the region.

Mr. President, Syria is a terrorist-sponsoring state. Syria, under the dictatorship of Hafez Assad, is a threat to peace in the Middle East. Appeasement of Syrian state terrorism and intervention in Lebanon is a road to further chaos and bloodshed. The Syrian nation deserves better than Hafez Assad, a dictator who does not nesitate to massacre tens of thousands of his own people.

Mr. President, it is clear that the policy of the Bureau of Near East Affairs, headed by Assistant Secretary Murphy, is a catastrophe for U.S. goodwill, influence, and long-range interests in the Middle East -- the ancient strategic crossroad of mankind.

The first step in a new realistic policy is to recognize immediately the government of Prime Minister Aoun in war-torn Lebanon."





We, too, want a free, democratic, and independent Lebanon and will continue our efforts to help the Lebanese achieve this goal.



I returned Mark Cowan's telephone call to you this date. Cowan was calling you to alert you to a potential domestic political problem in light of the State Department's announcement that the United States supports a specific candidate to the be the new President of Lebanon.

According to Cowan, Assistant Secretary of State Murphy cut a deal with the President of Syria to support an individual named Daher to succeed President Gemayel. This action is opposed strongly by Lebanese Christians in Lebanon and in the United States. It was the understanding of the Lebanese Christian Community that the United States would take no action in support of any individual for the Presidency. According to Cowan, there will be a strong U.S./Lebanese Christian backlash in this country directed at the President and George Bush as the result of this decision. The White House should anticipate newspaper ads and the regular onslaught of letters and telegrams in the next several days on this issue.
