I. PURPOSE

To give the President the opportunity for a discussion with Senate Republicans on topics of interest to the Senators.

II. BACKGROUND

The Senate's legislative agenda for the remainder of this session includes a number of critical and controversial items, all of which will be considered amidst an atmosphere of growing concern about the Republicans' ability to maintain a majority in the Senate after the 1986 elections.

Foremost in the Senate's mind are the issues of trade, the farm bill, and the deficit. Most of the appropriations bills have yet to be passed, some of which are coming out of committee at unacceptable funding levels. Reconciliation must be passed, the debt limit must be extended, and the prospects for tax reform remain uncertain.

As if this agenda were not prospect enough for a tumultuous fall, Republican Senators are growing more sensitive about their political prospects in 1986. Twenty-two Republicans are up for re-election next year and thus far four of them (Goldwater, Laxalt, East and Mathias) have announced they will not run. The Republican leadership may have difficulties getting support for difficult votes in light of the political pressures from constituent interest groups.

In discussing your agenda with this group, you should reassure them that one of your top priorities is maintaining a majority in the Senate. The key is teamwork - sticking together - even on tough issues like the debt limit, an issue which has been a philosophical anathema to many Republicans. As they did in 1981, the Democrats will likely force Republicans to cast the number of votes necessary to pass the debt limit. We also expect the debt limit to be a vehicle for numerous amendments and you should emphasize the need for a clean bill. Action is expected later this week.

On the tax issue, you will need to underscore the need for action this year. Thus far, there has been very little enthusiasm for action in the Senate, although Finance Chairman Packwood told you he was optimistic about getting a bill this year. Many members insist their constituents are more concerned about the deficit than tax reform, and it is likely that we will see several efforts toward deficit reduction this fall.

Today's meeting should provide a healthy "give and take" session with the Republican Senators.

POSSIBLE SUBJECTS FOR DISCUSSION DURING BREAKFAST WITH THE GOP SENATORS

Debt Ceiling - Treasury has indicated that final action on the debt ceiling must be completed by next Monday, October 7. For that reason, we must discourage all amendments to the debt ceiling and want a clean bill. We don't want the Republican Senate and a Republican Administration blamed for Social Security checks bouncing!

Farm Bill - House action will be completed this week; Senate expected to consider it mid-October. We are disappointed with the current House bill and the Senate Committee version. We want to work with Senator Helms, Senator Dole and the GOP Senate to produce a farm bill that you can sign. We are concerned about cost -- but we are even more concerned about putting into place better farm policy.

Trade - Several GOP Senators are pushing protectionist legislation (i.e., textiles, 25 percent surcharge). Recent Administration actions reflect your strong commitment to free and fair trade. You have pledged to veto any protectionist legislation and need the Senate GOPs' support to stop such short-sighted and politically motivated legislation.

Jordan Arms Sales - A substantial number of GOP Senators are adamantly opposed to the proposed arms sale to Jordan. We need to stress the importance of King Hussein's role in the Middle East and your commitment to Hussein. We must prevent Republicans from going public in their opposition to the sale.

Gramm-Rudman Debt Ceiling Amendment - Senators Gramm and Rudman have 30 cosponsors for an amendment to the debt ceiling bill. They propose to enforce a deficit reduction path that begins immediately and leads to a balanced budget by 1990. Their proposal would reduce Social Security and other COLA's and require further reductions in defense and domestic spending. We share their goal of reducing the deficit to zero -- but have concerns about their proposal -- and specifically don't want the debt ceiling legislation to be delayed or derailed by amendments. We will continue to work with Senators Gramm and Rudman on their proposal and want any suggestions the Senators have as we prepare for the 1986 - election year - budget.

Line Item Veto - Senator Mattingly and others may want to offer line item veto to the debt ceiling legislation. Senator Dole has indicated that he intends to have the Senate revisit

the line item veto issue prior to adjournment this year and would prefer that line item veto not be offered to the debt ceiling because it is sure to be rejected by the House conferees.

Balanced Budget Constitutional Amendment - You have continued to push for congressional action on the constitutional amendment and Senate Republicans have every intention of following through and passing the constitutional amendment. It would be important for a Republican-controlled Senate to pass the amendment and put pressure on the Democratically controlled House.

Tax Reform Bill - There has been substantial discussion about the prospects of both the House and Senate completing action on tax reform legislation this year. Senator Dole and Senator Packwood have told you that the Senate could complete action if the House passes the bill prior to November 1. We continue to push both the House and Senate to act as soon as possible. It is up to a Democratically controlled House to pass the bill before Senate Republicans have a chance to consider the legislation.

The following members will be seated at the President's table:

Senator James Abdnor (R-South Dakota)

Senator Abdnor is from Kennebec, South Dakota. He was elected by 58% of the vote in the 1980 election. Senator Abdnor is a member of the Senate Appropriations Committee, the Senate Environment and Public Works Committee, and the Joint Economic Committee.

Senator Abdnor faces a tough reelection effort in 1986, with the prospect of a primary challenge from the current Republican Governor William Janklow, and almost a certain challenge from Democrat Representative Tom Daschle.

Each vote cast by Senator Abdnor on the Senate floor is subject to critical political interpretation back home, and for this reason, his record of support this year for Administration positions has been sketchy. He does, however, help as much as he can.

In his capacity as Chairman of the Senate Appropriations Subcommittee on Treasury, Postal, and General Government, he presides over the budget of the Executive Branch. This bill passed on the Senate floor last Thursday, and included a 2% across-the-board cut for all programs, including the White House. A 2.65% reduction was incorporated in the House version. The Conference Committee on this bill is likely to begin Tuesday. We are seeking a compromise of the budget cuts facing the White House and Executive Office, but the Senator is sensitive to criticism he is helping the White House out with its budget problems at the expense of other agencies and departments in his bill.

Senator Jake Garn (R-Utah)

Senator Garn was born in Richfield, Utah. A former Mayor of Salt Lake City, he was elected to the Senate in 1974 and was reelected in 1980. In the Senate, Garn is Chairman of the Banking, Housing and Urban Affairs Committee. In addition, he serves on the Appropriations Committee.

He is most interested in the space program, and the NASA budget for the future. He came back from a successful space shuttle mission this year convinced of the merit of the program and its benefit to America's technological future. As Chairman of the Appropriations Subcommittee on HUD, and the Independent Agencies, including NASA, Garn is now working to get his 1986 bill to the Senate floor. It is considerably over the conference budget agreement, and the President's senior advisors have notified Garn that in its current form, they would not recommend the President sign it into law. He is hopeful that a spending reduction agreement for this bill can erase our objections, and he can then bring the bill to the floor this week.

Senator Dan Quayle (R-Indiana)

Dan Quayle was first elected to political office when he upset an eight-term Democrat in the House of Representatives in 1976. Four years later he was elected to the U.S. Senate, and he is up for re-election in 1986. Quayle is a lawyer and was practicing in Huntington, Indiana, prior to entering public service. Quayle serves on the Armed Services, Budget, and Labor and Human Resources Committees. As Chairman of the Labor Committee's Subcommittee on Employment and Productivity, Quayle was instrumental in the passage of the Job Training Partnership Act in 1982. Quayle has been a strong supporter of your policies in the Senate. He is married and has three children.

Senator Don Nickles (R-Oklahoma)

Senator Don Nickles, from Ponca City, Oklahoma, was the youngest Republican ever elected to the U.S. Senate. Now 36 and up for reelection next year, he is entering the campaign with a strong record in support of Administration initiatives and programs. He was elected by a very narrow margin in 1980 and a tough race is expected in 1986, probably against former House Budget Committee Chairman, James Jones. Senator Nickles will be strongly supported by conservative, fundamentalist Oklahomans; he is a devout Christian and avid family man with four children.

Senator Jeremiah Denton (R-Alabama)

Senator Jeremiah (Jerry) Denton was elected to the Senate in 1980, and has established a reputation as a strong conservative and supporter of Administration policies. A former Vietnam POW -- he is famous for bliking out the word "torture" in Morse code when being filmed for propaganda purposes -- he is a staunch advocate of a strong defense program, and has taken a particular interest in the issue of international terrorism. He also has strong concerns about Central America and El Salvador in particular. Denton is also very pro-family and is greatly concerned about moral and religious matters.


