MESSAGE / ANNOTATION:

AMBASSADOR HABIB HAS HAD DISCUSSIONS WITH ISRAELI, SYRIAN AND LEBANESE LEADERS AND HAS BEEN IN CLOSE CONSULTATION WITH ME THROUGHOUT THIS PERIOD. WE WERE GRATIFIED THAT A CEASE-FIRE WAS ANNOUNCED BY ISRAEL AND SYRIA ON FRIDAY. WE ARE MAKING EVERY EFFORT TO SEE THAT IT HOLDS AND THAT THE DANGER OF WIDER WAR IS AVERTED. ON MY INSTRUCTIONS, WE ARE ACTIVELY TRYING TO BROADEN THE CEASEFIRE AND TO HALT THE FIGHTING BETWEEN ISRAEL AND PLD FORCES. WE WILL NOT REST UNTIL ALL OF THE GUNS ARE SILENT.

I AGREE WHOLEHEARTEDLY WITH YOU THAT WHAT IS REQUIRED NOW IS AN "EMPHASIS OF LEBANON'S IDENTITY AND SOVEREIGNLY ON LEBANESE SOIL". THIS HAS BEEN ONE OF AMBASSADOR HABIB'S GOALS IN HIS CONSULTATION OVER THE PAST TWO DAYS WITH LEBANON'S LEADERS. WE REMAIN COMMITTED TO LEBANON'S INDEPENDENCE, UNITY, SOVEREIGNTY AND TERRITORIAL INTEGRITY. WE WANT COMPLIANCE WITH SECURITY COUNCIL RESOLUTIONS 508 AND 509 WITH ALL REASONABLE SPEED. WE SEEK A LEBANON REUNIFIED, STRONG AND FREE OF FOREIGN FORCES.

AT THE SAME TIME, WE CANNOT RETURN TO A SITUATION IN WHICH THE PLO AGAIN CAN ROCKET OR SHELL ISRAEL'S NORTHERN VILLAGES OR IN WHICH ISRAELI FORCES, ONCE WITHDRAWN, WILL FIND A REASON TU ENTER LEBANON AGAIN. THIS WILL REQUIRE AN EFFECTIVE MECHANISM TO POLICE AN ENLARGED ZONE IN SOUTHERN LEBANDN. THIS PROBLEM DEMANDS IMAGINATION AND CREATIVE THINKING FROM ALL DE US.

FINALLY, THE RECENT EVENTS IN LEBANON MUST SERVE ALSO TO REFOCUS OUR ENERGIES ON MAKING EARLY PROGRESS TOWARD SECURING -- IN THE WORDS OF THE CAMP DAVID FRAMEWORK -- THE LEGITIMATE RIGHTS OF THE PALESTINIAN PEOPLE. THE UNITED STATES WILL BE RESUMING ITS EFFORTS TOWARD THAT GUAL AS SOON AS CONDITIONS SEEM PROPITIOUS. I EARNESTLY SOLICIT YOUR THOUGHTS ON HOW THESE EFFORTS MIGHT BE MADE MORE PRODUCTIVE.

AS I TOLD YOU IN MY LAST MESSAGE, I VALUE YOUR FRIENDSHIP AND YOUR ADVICE, AND CUNGRATULATE YOU ON THE CONSTRUCTIVE POSITION YOU HAVE TAKEN DURING THIS DIFFICULT PERIOD. AS WE SEEK TO MOVE QUICKLY TOWARD OUR SHARED GUALS OF JUSTICE, SECURITY AND PEACE, I WILL GREATLY APPRECIATE YOUR CONTINUED SUPPORT AND COUNSEL.
