WE ARE MAKING DELIBERATE EFFORT WITH THE U.S. AND OTHER MEDIA HERE TO EMPHASIZE THAT THE USG, THROUGH THE HABIB MISSION, IS SUPPORTING THE GOALS OF THE GOVERNMENT OF LEBANON, BOTH AS CONCERNS THE SPECIFIC ISSUE OF WEST BEIRUT AS WELL AS THE GENERAL LEBANESE ISSUE. THIS HAS BEEN NECESSARY BECAUSE OF THE IMPRESSION IN SOME JOURNALISTIC QUARTERS THAT THE U.S. IS SUPPORTING ISRAELI GOALS, IMPRESSIONS THAT HAVE BEEN STRENGTHENED BY THE UNLIKELY COMBINATION OF ISRAELI AND PLO MEDIA.

3. YOU SHOULD TAKE APPROPRIATE OCCASIONS TO REINFORCE AND CLARIFY SITUATION RE U.S. POSTURE. YOU WILL BE RECEIVING A CABLE WHICH ELABORATES ON SITUATION AND U.S. POLICY. IN MEANTIME, YOU SHOULD DRAW ON SPOKESMAN FISHER'S JUNE 28 REMARKS ABOUT U.S. SUPPORT FOR THE GENERAL OBJECTIVES OF THE GOL. THESE REMARKS ARE ALSO DESIGNED TO HELP PUT RECENT FRENCH ACTION IN SECURITY COUNCIL, AND OUR RESPONSE IN PERSPECTIVE.

2. PERHAPS WE ASKED THE WRONG QUESTION IN RAISING THE JUNE 26 ISRAELI AIR STRIKE AGAINST A SYRIAN SA-6 BATTERY IN THE BIQA', I.E. NOT WHETHER THE ISRAELIS WERE CHANGING THE GROUND RULES ON THE CEASEFIRE BUT WHETHER THIS ACTION HARMED OUR ATTEMPTS TO CREATE THE KIND OF ATMOSPHERE IN WHICH PHIL HABIB'S EFFORTS WILL ULTIMATELY PROVE SUCCESSFUL. AS HABIB POINTED OUT SOME TIME AGO, THE ISRAELI CONCEPT OF A CEASEFIRE IS UNIQUE IN THE ANNALS OF MILITARY HISTORY--EVERYBODY STAYS IN PLACE BUT THE ISRAELI DEFENSE FORCE. THIS WAS MADE EXPLICIT BY DEFENSE MINISTER SHARON (WHO HAS A LONG, WELL-DOCUMENTED HISTORY OF CREATING THE CIRCUMSTANCES TO FIT HIS OBJECTIVES) JUNE 25 WHEN HE STATED THAT ISRAEL REACTED TO CEASEFIRE VIOLATIONS "IN PLACES WHERE WE (ISRAEL) THOUGHT IT WAS IMPORTANT FOR US TO OBTAIN OUR OBJECTIVES."
