2. PRIME MINISTER WAZZAN CALLED ME THIS EVENING, THURSDAY, JULY 1, TO EXPRESS CONCERN OVER SAUDI CALL FOR BASHIR GEMAYEL TO COME TO TAIF. HE ASKED IF HE SHOULD HOLD OFF ON CONTACTS HERE WITH PLO BECAUSE OF MEETINGS IN TAIF. I URGED HIM NOT TO DO SO, BUT TO CONTINUE TO NEGOTIATE WITH PLO AS WE HAVE AGREED.

3. HE SAID LEBANESE MUSLIMS WERE EXTREMELY UPSET OVER HAVING BASHIR IN TAIF AND NO REPRESENTATIVE OF THE MUSLIMS. HE REMINDED ME THAT HE HAD URGED SAUDIS TO SEND SOMEONE HERE IF THEY WISHED, OR AT LEAST TO SEND SEC GEN D'ARAB LEAGUE KLIBI.

4. COMMENT: I REPEAT EARLIER RECOMMENDATION THAT SAUDIS DO SOMETHING TO SATISFY LEBANESE MUSLIMS WHO ARE SUSPECTING THAT SOMETHING IS GOING ON THAT THEY DO NOT LIKE. I TOLD WAZZAN THAT ARAB LEAGUE COMMISSION HAD ASKED FOR BASHIR TO COME TO TAIF, BUT THIS DID NOT SATISFY HIM. HE AND HIS MUSLIM COLLEAGUES OBVIOUSLY NEED MORE DIRECT ASSURANCES.
