1. ~~(ENTIRE TEXT)~~

2. IT IS NOW 1300 AND IDF ARTILLERY AND TANK BOMBARDMENTS OF WEST BEIRUT AND THE SOUTHERN SUBURBS OF BEIRUT HAVE BEEN GOING ON FOR MORE THAN NINE HOURS. THERE HAS BEEN SOME RETURN ARTILLERY FIRE HITTING NEAR THE AMBASSADOR'S RESIDENCE AND THE PRESIDENTIAL PALACE, REPORTEDLY FROM THE COMMUNIST ACTION ORGANIZATION.

3. BECAUSE OF THE SHELLING, THERE IS NO PROSPECT THAT WAZZAN CAN LEAVE WEST BEIRUT TO MEET WITH ME TODAY. S'AB SALAAM BY TELEPHONE SAID HE HAD HAD A MEETING WITH PLO LEADERS LAST NIGHT, JULY 10, AS HAD WAZZAN SEPARATELY. SALAAM REPORTS "THAT SOME PROGRESS WAS BEING MADE," WHATEVER THAT MAY MEAN. SALAAM WAS ALSO SUPPOSED TO COME AND SEE ME THIS MORNING, BUT IS ALSO UNABLE TO LEAVE WEST BEIRUT.

4. UNDER PRESENT CIRCUMSTANCES, THERE IS NO WAY THAT I CAN HAVE A USEFUL CONVERSATION WITH THE PEOPLE THROUGH WHOM I HAVE BEEN NEGOTIATING. THEREFORE, THE NEGOTIATING PROCESS IS STYMIED FOR AT LEAST TODAY.

2. IT IS 1315 AND WAZZAN JUST TELEPHONED ME TO SAY HOW IMPORTANT IT WAS THAT WE TALK AGAIN AND CONTINUE THE NEGOTIATIONS. HE SAID HE WOULD HAVE MUCH TO SAY TO ME. HE HOPED THAT WE COULD GET THE CEASEFIRE REESTABLISHED IMMEDIATELY SO THAT WE COULD MEET. FOR HIS PART, HE SAID, HE WILL IMMEDIATELY URGE UPON THE PLO THAT THEY STOP FIRING AND ASKED THAT I DO THE SAME WITH THE ISRAELIS.

3. I TOLD HIM THAT OUR AMBASSADOR IN ISRAEL WAS ON THE VERGE OF MEETING WITH SHARON AND WOULD BE SEEKING TO BRING AN END TO THE FIRING.

1. (ENTIRE TEXT)
2. AT 1830 HOURS LOCAL, ISRAELI SHELLING IN THE BEIRUT AREA CONTINUES AT A HEAVY RATE WITH SHORT PAUSES. AT TIMES, RATE OF FIRE REACHES A LEVEL OF 10-15 ROUNDS PER MINUTE.
3. PRIMIN WAZZAN JUST CALLED ME TO URGE THAT WE ACHIEVE A TOTAL CEASEFIRE AS SOON AS POSSIBLE. WE AGREED THAT EACH OF US WOULD SEEK TO SET A TIME CERTAIN --2100 HOURS LOCAL -- FOR ALL SIDES TO QUIT FIRING WITHOUT EXCEPTION. HE BELIEVED HE COULD GET THE PLO TO GO ALONG AND I TOLD HIM I WOULD SEEK TO GET ISRAELI AGREEMENT.
4. THE APPROACH TAKEN BY SHARON IN REFTEL IS JUST NOT GOOD ENOUGH FOR OUR PURPOSES. I URGE THAT AMBASSADOR LEWIS GO BACK IN AND PROPOSE THE 2100 HOUR TOTAL STAND-DOWN. I MAKE THIS RECOMMENDATION FULLY AWARE THAT ISRAELI POLICY WITH REGARD TO BOMBARDMENT IS MOST LIKELY BASED ON A DESIRE TO EXERT PRESSURE ON THE PLO AND HAS LESS TO DO WITH COUNTERING PLO SNIPER FIRE AS ARRANGED.
5. SA'B SALAM, WHO WAS WITH WAZZAN, JUST CALLED TO SAY THAT THEY WOULD HOPE TO GET THE FIRING STOPPED BEFORE 2100. THE PLO IS BEING ASKED TO CEASEFIRE AT 1900 HOURS, THE END OF THE RAMADN FAST, IN THE HOPE THAT THE ISRAELIS
