Dear President Reagan:

I write to request that you not visit, much less, lay a wreath, at a German war cemetery during the course of your trip to Europe in May. I also write to request that you do visit and bestow an appropriate symbol of your visit on a United States military cemetery in Europe and at least one of the many Nazi concentration and death camps.

To visit and pay recognition to a German military cemetery, while avoiding a visit or ceremonial act at a concentration camp or cemetery for dead United States military personnel seems not only inappropriate, but intellectually inconsistent. Moreover, it leaves a tragic impression upon the minds of Americans. As one commentator has stated, paying tribute to the graves of Nazis is almost tantamount to giving legitimacy to the most barbaric regime in the modern history of mankind. It is not a matter of fear of reopening old wounds; it causes resentment and offense among former American personnel, the soldiers of our allies, and the families of all the victims of Nazi Germany's barbarism.

I make these statement as a relatively new member of Citizens for America, who agreed to the responsibility of co-chairing the organization in the Fifth Congressional District in San Francisco, and also as a member of the Galileo Post of the American Legion and B'nai B'rith International. I think it will be a terrible mistake to

acknowledge a Nazi Germany war cemetery while disregarding the death camps like Buchenwald and the graves of American soldiers. Although I respect the Presidency and your good faith efforts to lead all Americans, I will be profoundly disappointed if you actually carry out your announced intent. Please reconsider your decision and revise your itinerary to include a concentration camp and American military cemetery.

Dear President Reagan:

I am writing to express my personal disappointment and that of thousands of Massachusetts citizens who feel that your decision to visit a Nazi cemetery during your upcoming trip to Germany is tantamount to condoning the atrocities that occurred in that country so few years ago.

Last year, during your previous European visit commemorating the D-Day invasion, you refused to visit Auschwitz, the site of thousands and thousands of executions of Jewish people during the Holocaust. Recently, you stated that the new generation of German people should not feel "unnecessary" guilt for those events, and you have chosen to demonstrate to the world through your actions that all is forgiven.

You may yet decide to visit Dachau, and you may decide not to memorialize the role of the German people in advancing Western civilization. But until you personally recognize, and lead the world in recognizing the true horror of the Holocaust, no one in the United States or anywhere else in the world, no one of this generation, the previous generations, or of the generations to come, will be free of the responsibility for the state of a world in which a Holocaust can and has occurred.

It is not the role of the leader of the most powerful country in the world to excuse the events of the past. I believe it would be more appropriate for any president to help the world to acknowledge, to remember, to learn from the horrors of its irrevocable past, and to weep and pray for redemption as the world marches steadily into its otherwise immutable future.

We are proud of your direct involvement in this rescue effort. You have declared once again that freedom, human rights and the saving of human lives are resolute policies of our country. We are proud that the partnership of the democracies of the United States and Israel is a source of life and freedom for people in our world. We are proud and appreciative for what you have done to advance the cause of freedom and life.

Your consideration to visit Bittburg Cementary is a devastating blow to our sensitivities. As a moral leader in the world, you cannot allow the world to dismiss the Nazi era and the holocaust as "past memories" and thereby suggest that what occurred, but only 40 years ago, is no longer relevant.

As long as there are men and women still alive with concentration camp numbers tattooed on their arms; as long as children of survivors are still traumatized by the memories of the torture and death of their parents and families; as long as neo-Nazis (regardless of numbers) are marching in the streets of cities

anywhere in the world; as long as there are historical revisionists who deny the existence of the holocaust, we cannot dignify the graves of Germany's armies which perpetrated the horrors of genocidal acts.

We agree that forty years of strong support for our policies as an active ally deserve some recognition for the German people. However, we respectfully suggest that honoring the Nazi soldiers representing an era that the new Germany also wants to forget, is not the prudent approach.

On behalf of the Jewish Conservative congregations in this Region, I implore you to recant from your consideration to visit the grave site of the armies who fought against every value we Americans cherish.



Re: Your visit to Germany.

Dear Mr. President:

You are to be commended on your firm stand against attempts to wreck your good-will visit to Europe.

We need unity, but the ill-advised demands for your state visits to former concentration camps of the war-time Germany mean a slap in the face to an ally, ---- one of the greatest democracies of today's Europe.

At the same time, the pressure groups behind such demands have failed to succest that you also visit the history's biggest and cruelest concentration camp, the Gulag Archipelago (cemeteries) of the Soviet Union. Altough that one is still active and grinding, and although the numbers of victims of that one have been many times higher of what— ever the Germans had.

One can have no respect for the policies of the U.S. 'Zionist System' - 'Nazi Hunters', 'Holocaust' propaganda representatives, but the shenanigans of these politicians in the controlled media,-Press, TV. and pofessional protesters at the White House lawn for separation between church and state, is nothing more than cheap political ploy.

If one looks closely, one can see what I mean, because lo and behold these very same hunters and protesters , a few years ago , were so willing to scream out for brotherly warm relation with the Soviet Union. At this time their tribal brethern were Soviet Union rulers, i.e. the ruling class of USSR.

Are the U.S. politicians aware of the historical fact that the Soviet Union ruling class has killed 60 million of ITS OWN CITIZENS in the 30 year period of this century from 1917-1953.

The tyranical rulers of the Soviet Union in the Thirties and Forties make Hitler's Germany and todays Central America and Africa rulers look like a bunch of two-bit amateurs.

The scope of the USSR communistic ruling class crimes at this time is staggering. It is hard, impossible, to attribute them to only one man, i.e. STALIN, but to the Marxist Jews, who were principal office holders in the Soviet Russian Government and local leaders, especially those, that we as refugees, know personally. These projects, especially the persecution of refugee-immigrants by the Justice Department's Office of Special Investigations, in collaboration with the K.G.B. of the Soviet Union, has already caused much polarization between the Jewish and non-Jewish Americans, especially of Eastern European and German ancestry Americans. (25 million plus 52 million)

The U.S. Zionists pious disclaimer that we should consider the life of 6 million Jews more value than 12 million Nazi KZ camps and plus Gulag Archipelago repression and willful famine victims, tens of millions - lacks conviction.

Fundamental changes in our attitudes and priorities are needed and higher principles to be served of the Justice Department in this matter.

"Equality under the Law" is one of the few precepts that stands between us Eastern European, German ethnics and the special interest groups corruption of power, and ultimately tyranny in its many guises in Washington.

Forces behind this hate campaigns are playing with fire. I think enough is enough. It is time to set the record straight and Eastern European and German Americans have to go directly to the American people.

After decades of peace and harmony, one ethnic group is being set on another, insults are thrown at U.S. allies, and your scheduled traditional expression of respect to the fallen soldiers of a host country is being sneered at.

STATEMENT.

Concerning the list of RULING Class of USSR before World War II (1936 - 1939)

As it is known, each people, and especially the Jewish, cultivate its patriotism-nationalism and is proud of it. Why then does patriotism of Russian, German, French, Estonian, Latvian, etc. etc. not find approval by Zionist Jews?

Marxist-Zionists obsessed with the idea of one civilization one race and one universal sameness are campaigning in mass media, press, TV. etc. for eradiction all races and cultural differences in order to make room ultimately for a non-race (except Jewish race) of numan zombies.

Professor Solomon Lourie (Jew) in his book "Anti-Semitism in the Ancient World" scientificially explained and substantiated this invariably negative attitude of the Diaspora Jews towards patriotism and nationalism of any country and any people among whom they live, as a "nation without a language and territory".

The Jews, ardently guarding their Jewish originality and purity of race, inseparably linked with their religion, DO NOT ADMIT STRANGERS IN-TO THEIR MIDST.

But they themselves, Jews of Diaspora, strive to penetrate into all branches of the life of those foreign people among whom they live, and if there is an opportunity to occupy a leading position, they will do so, especially they are interested on banking (usury), commercial enterprise and mass media as their propaganda vehicle.

In countries and states with highly developed patriotic and national feelings and populations of homogeneous tribal composition, this is much more difficult to achieve and provokes a rebuff of the native population, which regards itself as a widened family of descendants of the same forefathers.

It is much easier for them i.e. Jews to achieve their ends in countries with a multi-tribal population, bound only by territorial unity and supreme power, e.g. United States of America, or in states in which for some reason, patriotic feelings are suppressed and brought into latency, disregard.

In countries with a multi-tribal population unlimited possibilities are open for Jews to penetrate into the RULING CLASS, without any opposotion from the native population e.g. United States.

The awakening of patriotism in a native population, naturally is regarded by the Jews as a possibility that the question will be raised about their role in the country's life, about the possibility of leading posts in the political and cultural life of country in which they live at a given time and still maintain their own idealogie and sense of justice, thus remaining ALIEN to the native population.

All Jews in all countries of their sojourn understand this circumstance very well, and this, why they regard any manifestation of national pride and patriotism as a threat to themselves and to their position in a country.

When the World War II broke out, and the Germans invaded and had to expelled from Russia. There were not many Jews in the front lines. But to make up this, medical units and supply units were overfilled with them, especially deep in the home-front, behind the Urals. They preferred 'to wage war' there.

Of course, there were exceptions, but these exceptions were not many. The officers and soldiers of the Soviet army and whole population of the country saw everything, and it is suprising that critical thoughts began to grow and strengthen about the Jewish role in the life of the country. The RULING CLASS in USSR, did not prove itself worthy of the position it occupied in the Soviet paradise on the earth.

Often this threat to their position in a country is felt even when it does not exist, as for example, in the USSR in the second part of the Thirthies, when any manifestation of Russian patriotism was qualified as "great power Chauvinism", and was brutally persecuted. And, of course there was no reverting to national traditions of Moscow and Imperial Russia whatsoever at that time in the Soviet Union.

The age old conflict between the native population of various countries and states and the Jewish ethnic groups finding themselves in the territories of these nations is well known.

Until the middle of the Nineteenth Century, this conflict was called "Judaephobia" (now "anti-Semitism"), which hindered and is still hindering a peaceful and fruitful co-existence between Jews and non-Jews

This conflict used to manifest itself with special distinction in the countries and states where a considerable Jewish population residednations in which Jews were considered "subjects".

At the beginning of the Twentieth Century, Russia (included Baltic, Polish regions, Belo-Russia) had within its borders six million Jews, whose views and values, sense of justiceand their concept were alien to native population.

The Jewish group (chosen people i.e. elite people) lived its own secluded life, most of them Zionists, - leaning toward communism, specially in Polish and Belo-Russia province.

They were unwilling to assimilate with the surrounding population in spite of any possibilities created by the Governments to achive this end.

It is this isolationist Jewish tendency , interwoven with their "spiritual aspect-political Zionism", that has given the impetus to this conflict. The entire blame for this is placed successfully upon the local nations peoples and all their nations governments and regimes, accusing them of "anti-Semitism." The political Zionists had been brought up in the midst of turbulent battles for the minds and hearts of European Jewry. Political infighting, propaganda, deceit and physical violence are nothing new to these precocious, iron-willed individuals, who are determined to REMAKE WORLD SOCIETY IN THE SOCIALIST-COMMUNIST IMAGE.

Calumni bears its fruits. It is believed without proven evidence, or even an effort to verify them, how just and valid these accusations are.

Without proof or trial, entire nations are blamed and condemned. The accused is the entire population of the USSR (Russia), together with other nationalities and tribes to that country.

Accused are descendants of the Baltic nations, as well as the "foreign Russians" and other East European nations who are here as loyal U.S. citizens.

Included here are also their numerous national patriotic and church organizations and national leaders.

Few took the trouble to listen to the accused, a practice elementary to any court of law, even in the most oppressed societies.

How does the accused respond to political Zionist trial, as we see in the United States today? Did the accused respond in any way. No! POSTSCRIPT:

Anno Domini 1985, the worlds 'elite people', do not rule anymore in the KREML as zionist Jews,- 'inside conspirators', as self confident "human rights protectors".

In the North, Finland, - which in Danilevsky's time belonged to Russia - is excluded, but is under strong Soviet influence. In the South, Greece and Constantinople with their surroundings are still missing. But against this, the power of the Soviet Union reaches into the heart of Europe.

Its fleets sail the Mediterranean and the Indian Ocean, plus Atlantic and Pacific waters. The Soviet Union is a mighty world power. Having hitherto shared world domination with the United States, it is now rapidly driving for sole domination after the collapse of the United States policy,— as a matter of fact, no policy,— in Asia, the near East and setbacks in Europe.

Present time rulers in the USSR are using the 'elite people's invented Communistic System for their own Pan-Slavism purpose and do not trust double loyal, double citizenship Zionist Jews, which as a group of the USSR was entirely on the side of those Zionists who conducted propaganda in the whole world for the creation of Israel.

The USSR Government senses the unreliability of the Zionist Jews, which is a sensation of the 'unreliability of the Jews' and corresponds to the same sensation of the whole population of the country, which in general looks at the Jews as an element 'newly arrived, strange and alien'.

There is no hope in the USSR, even considering the return of the Jewish ethnic group to its previous position as the ruling class. 

Estonia, like Finland, Sweden and Denmark, further believed that since she had very few Jews in her country that she had no Jewish problem. Estonia treated the Jews exceptionally well. A Zionist delegate visiting Tallin informed the Estonians that their remarkable tolerance towards the Jews had resulted in Estonia's name being inscribed into the Golden Book of Tel Aviv, the first 100% Jewish city in the modern world, which is in Palestine.

Two Jews showed the Estonians their mistake. One was Herman Gudkin, 25 years old, son of an Estonian senator who was educated in England and was serving as a noncommissioned officer in the Tallin artillery regiment. When the Red Army seized Estonia he obtained sick leave. The following day he presented himself at his regiment's head-quarters in the Estonian uniform with a red band around his arm. He demanded the officers haul down their flag and surrender their arms.

His demands were rejected and he returned a short time later with Soviet tanks and armored cars and forced the surrender of the regiment, arresting the officers and confining the troops to barracks. Later this order was countermanded and the officers released. They attempted to arrest Gudkin as a deserter but he was protected by the Red Army.

The next morning Gudkin, accompanied by another Jew, Victor Fagin, an ex-clothing dealer of Dorpat, climbed to the top of Pike Herman, an old stone tower which rises from the ancient castle housing the Estonian parliament and took the Estonian flag from the staff and hoisted the red soviet flag. The same afternoon a procession of Jewish residents led by Gudkin and Fagin carried this Estonian flag through Tallin's streets to the front of the Soviet legation where they tore it to pieces. I reported these facts to The Tribune which published them on 4th, July 1940, after deleting the word "Jew" from my message.



In appreciation of the benefit of a unique cultural autonomy, granted by Estonia to its national minorities (Russians, Germans, Swedes, Jews, Latvians), the Jewish National Fund in Palestine presented in 1927 to the Republic of Estonia (independent from 1918—1940) a special award, the certificate of which is reproduced above. The Hebrew and Estonian inscriptions read in English as follows:

ESTONIAN REPUBLIC. As a sign of gratitude for the first historical deed in the history of Israel through the gift of national and cultural autonomy to the Jewish minority in Estonia.

Dear Larry:

Thank you for sharing with us your views concerning the President's State Visit to the Federal Republic of Germany. We fully understand the depth of your concerns and assure you the President's feelings about the crimes against humanity perpetrated by the Nazi regime are no less deeply felt. President Reagan has attempted to make absolutely clear during his visit the revulsion all Americans feel for the horrors which were committed in the name of the German state and our determination not to forget them. As you know, his itinerary included a ceremony at Bergen-Belsen concentration camp in order to pay homage to all those who perished at the hands of the Nazis. As he said on the anniversary of the liberation of that camp April 21, there can and should be no absolution.

President Reagan is certain you agree that, as part of our efforts to learn from the experiences of this dark era, we must not reject opportunities for reconciliation. The President was asked by Chancellor Kohl to pay a visit to a German military cemetery in Bitburg, and he has honored that request.

For four decades, the Federal Republic of Germany has faced up to the guilt and responsibilities of its Nazi past and has, in countless ways, demonstrated concretely its commitment to democratic ideals and human rights, including standing shoulder to shoulder with us in the Alliance in defense of freedom. With particular regard to the younger generation in Germany, it is important to demonstrate that, while we continue to hold the nation responsible for its past, we do not consider them to bear individual responsibility for the crimes of Nazism.

Let me make clear that the President does not consider his appearance at Bitburg to represent an act of forgiveness for those crimes, but rather one of acknowledgment of the democratic society the German people have built. He considers this to be a positive gesture which in no way detracts from his full and heartfelt commitment to remember and honor the victims of the Holocaust and the American soldiers who gave their lives to defeat the Nazi regime and its crimes.

Dear Mr. President:

As an alternative to your proposed visit to the Bitburg Cemetery in West Germany, I would like to suggest two other possible sites which would demonstrate solidarity with the German people while avoiding the unnecessary controversy surrounding the Bitburg Cemetery.

In many German high schools, there are plaques or signs recognizing the sacrifice of German teenagers who were drafted and thrown into battle during the latter stages of World War II. Many young, innocent German youths needlessly lost their lives in this fashion. They can appropriately be considered victims of the Nazis. I am sure today's Germans and people of all faiths throughout the world would appreciate your recognition of this tragedy as a reminder of the sacrifice of millions of innocent victims at the hands of the Nazis.

Another possible alternative to the Bitburg Cemetery visit would be a visit to one of the many small German church cemeteries which contain the remains of other innocent German victims of Nazi policy. Germans of all ages and religious faiths could readily identify with your memorialization of these victims, while avoiding the inadvertent recognition of the SS and other perpetrators of Hitler's genocidal policies.

I respect your decision to alter your itinerary in favor of a visit to the Bergen-Belsen concentration camp. Chancellor Kohl recently visited that camp where he conducted appropriate ceremonies, including Ambassador Burns' reading of your fine statement, honoring the people who were murdered there. It would be equally beneficial to German-American relations and harmony among Americans and foreigners of all faiths if you were to pay homage to the German teenagers who were swept into the war or to visit another site as suggested above. The world would respect and appreciate such statesmanlike action.

The Bitburg Blunder

When presidential aide Michael Deaver visited the German military cemetery at Bitburg in February, the White House now says, snow covered the ground and obscured the grave markings of the World War II veterans buried there. That unfortunately prevented Deaver, who was in West Germany doing advance planning for President Reagan's visit next month, from noting that among the dead at Bitburg are some members of the Schutzstaffel, the infamous SS that ran Hitler's concentration camps and provided the most criminally ruthless soldiers of his army. An example of such ruthlessness occurred just a short distance from Bitburg, across the Belgian border, where in 1944 more than 200 American prisoners of war were murdered by the SS.

Deaver's German hosts, again according to the White House, said nothing about the SS graves. Indeed, Deaver apparently came away mistakenly believing that both American and German soldiers share the cemetery. What better place, then, for a presidential appearance that would emphasize reconciliation 40 years after the end of World War II? What better place for the President to lay a wreath and make some suitable remarks about past enemies who are now friends?

The Bitburg blunder has produced a major political embarrassment for Reagan and, far worse, left him with a morally insupportable burden.

Certainly the insult inherent in paying homage to SS men was not intended, and Reagan's deep sympathy for all who suffered so incalculably during the Hitler era is not being questioned. But even the most eloquent expression of remembrance for those victims won't erase the implications of a presidential appearance at an SS burial site. The White House is now hastily arranging a visit by Reagan to a former concentration camp. But Reagan stubbornly, even obtusely, clings to his plan to visit Bitburg rather than give in to "unfavorable attention." He has yet to grasp that what is at issue here is not unfavorable attention, but propriety and respect for the millions of victims of Nazism.

Bitburg was chosen because it is in West German Chancellor Helmut Kohl's home territory, and it would help Kohl's political fortunes for Reagan to be there. It was chosen because it is close to a U.S. air base, which makes travel and security arrangements easier. These considerations shrink to utter insignificance, however, when placed alongside the potential spectacle of an American President even inadvertently honoring the members of an organization that committed the most unspeakable of crimes. Let the President celebrate reconciliation with Germany in some other, more suitable, place. To go to the Bitburg cemetery would be an act of appalling moral insensitivity.
