



SCHUMER MEETS WITH SILDENT ACTIVISTS DISTURBED BY PRESIDENT'S FLANS TO VISIT NAZI CEMETERY

Stodents believe Tresident's "Beacisian Shows Lack of Sonsitivity to Millions of Victims of Holocaust"

Congression Charles Schuzer will deliver a letter and petitions addressed to President Regan requesting that he reconsider his descision to visit a Ceruan War Cenetery. 2500 signatures were gathered by five students: Melanie Faher, Meyer Elnadov, Beit Ridary, Larry Siegel, and Michael Tessler, representing Brooklyn College; The Albert Einstein College of Medicine; New York University; Yeshiva College and Stern College of Yeshiva University. The petitions and letter were presented to Congressman Schumer at his district office on Kings Highway in Brooklyn, on Friday, April 19th. The students met with the Congressman to share their concerns and express thanks for his support.

Congressman Schumer is an outspoken critic of the President's plans to visit a German Military Cemetery. He and 15 other Congressmembers wrote to the President urging him to amend his schedule to include a stop at a Concentration Camp. To date, The President has refused to cancel his visit to the Bithurg Cemetery. This burial ground includes the tombstones of SS Nazi soldiers who were responsible for carrying out the systematic mass murders of Jews during World War II.
