Dear Mr. Knight:

I have been asked to reply to your letter of April 11 to President Reagan regarding his trip to the Federal Republic of Germany.

The President made absolutely clear during his visit the revulsion all Americans feel for the horrors which were committed in the name of the German state and our determination not to forget them. As you know, his itinerary included a ceremony at the site of the Bergen-Belsen concentration camp, in order to pay homage to all those who perished at the hands of the Nazis. As he said on the anniversary on April 21 of the liberation of that camp, and again during his own visit, there can and should be no absolution.

The President strongly believes that, as part of our efforts to learn from the experiences of this dark era, we must not reject opportunities for reconciliation. It was in this spirit that he was asked by Chancellor Kohl, and accepted the invitation, to visit a German military cemetery in Bitburg.

For four decades, the Federal Republic of Germany has faced up to the guilt and responsibilities of its Nazi past and has, in countless ways, demonstrated concretely its commitment to democratic ideals and human rights, including by standing shoulder to shoulder with us in the Alliance in defense of freedom. (The trip to Bitburg included a visit to the large Bitburg Air Base, which houses members of both the U.S. and German Air Forces.) With particular regard to the younger generation in Germany, it is important to demonstrate that, while we continue to hold the nation responsible for its past, we do not consider them to bear individual responsibility for the crimes of Nazism.

The Honorable John Knight, States Attorney, Bond County Court House, Greenville, Illinois. Dear President Reagan:

I cannot even conceive of what noble purpose will be served when you when you visit that graveyard and place that wreath as head of state for the United States of America.

As I realize that this is just one letter and that it will be read by some low level member of your staff, I harbor no hope that you will be sensitive to my ideas. As I make this realization, my anger has matured into sorrow for the many Jews and the families of the many Americans who fought and died at the hands of the Germans in World War II and for the message that they will be receiving from your actions. I certainly hope that your sentiments are not a reflection of the majority of Americans. You have lost my respect.



It is with a deep sense of indignation that I write to you today. As National Commander of the Jewish War Veterans of the U.S.A., I am appalled at your decision to visit a German military cemetery, and pay homage to German soldiers. I protested your earlier decision not to visit a concentration camp and, in that communique, reminded you that the Germany we defeated -the fascist, totalitarian regime of Hitler -- is not the Germany of today. 
