INFORMATION FOR DELEGATES STAYING AT THE SHERATON HOTEL

The Coordinator of the International Meeting on Coope. On and Development wishes to extend a cordial welcome to the Delegates attending the Preparatory Meeting of Ministers of Foreign Affairs and provide them with the following useful information for their stay at the Sheraton Rotel.

In addition to normal services during the Preparatory Meeting, the Hotel will provide 24-hour room service; laundry and dry cleaning services every day, including Saturday and Sunday; and additional specialized personnel for the Hotel's various service areas.

The Coordinator has set up certain special services during the Meeting, as follows:

1. REGISTRATION OF DELEGATES

Upon arrival, each Delegate will receive the key to the room that has been pre-assigned to him. He should sign the Hotel registration form and hand it over to the Delegate Registration counter in the lobby of the Hotel in exchange for his identification badge.

2. DRESS

Dress will be totally informal during all sessions and events during the Meeting days, including the dinners on July 31st.

3. COMMUNICATIONS

A list of Delegates and their room numbers will be distributed in order to facilitate communications during the Meeting. In order to communicate from one room to another, Delegates should dial 9 on the brown telephone and request the room number desired. Delegates preferring not to receive calls in their rooms should so inform the operator.

To make local calls within the city of Cancun, Delegates should dial 0, followed by the five digit number desired. For domestic and international long distance calls a Communications Center has been set up in the Salon Contoy on the ground floor of the Hotel. This Center will operate 24 hours a day during the Meeting.

Each Minister of Foreign Affairs will be provided with a red telephone in the sitting room of his suite for making long distance calls at any hour.

The Communications Center also has telex cabins for Delegation use. Charges for telephone and telex calls must be paid by each user.

4. GROUND TRANSPORTATION

Transportation will be provided by the Government of Mexico between the airport and the Sheraton Hotel on arrival and departure days for each Minister of Foreign Affairs and his immediate party.

During the days of the Meeting, each Minister of Foreign Affairs will be assigned an automobile with chauffeur and a Security escort car provided round-the-clock service. Sufficient vehicles of various kinds will also be available in pool to transport Delegates desiring to leave the Hotel.

For transportation between the Sheraton and the Hyatt, Aristos, Viva and Presidente Hotels, a bus route will be established to provide service every 10 or 15 minutes. This service will operate between 7:00 a.m. and 1:00 a.m. every day and will be available to Delegates having badge identification.

The Covernment of Mexico has assigned civilian aides to each of the Ministers of Foreign Affairs. These aides—all officials of the Mexican Ministry of Foreign Affairs—will meet the Ministers upon their arrival at Cancon airport, accompany them to the Sheraton and be lodged on the same floor as the Ministers. Their duties are to provide assistance and resolve any problems or neccesities that may arise and to act as liaison between the Delegation and the Coordinator of the Meeting.

6. DOCUMENTS

The Documents Center is located in the Coordinator's offices. Services for photocopying, typing, translation (to a limited extent) and production of documents related to the Meeting will be provided. All requests in this regard should be addressed to the person responsible for the Center in Coordinator's Office.

Pigeon holes have been installed at the Delegate Registration counter for each Delegation to receive documents, messages, etc.

7. SECURITY

Since the Sheraton will be a restricted area during the Meeting and only properly identified personnel will have access to it, identification badges must be worn at all times.

In the main conference room it will only be possible to seat five Delegates per country, in addition to the Minister of Foreign Affairs. The cooperation of Delegates is requested in this regard.

Those Delegations which made arrangements to bring their own vehicles to Cancon may pick up their identification cards at the Coordinator's Office.

8. MEETING ROOMS

In addition to the main conference room located in front of the elevators, two smaller rooms have been provided for meetings of Delegates. Requests for the use of these rooms should be addressed to the person in charge of Conference Services, Miss Sylvia Klee. Rooms will be assigned in the order in which requests are received. These rooms are not equipped for sound or for simultaneous interpretation.

9. SOCIAL EVENTS

The Minister of Foreign Affairs of Mexico will host a dinner for the other Ministers of Foreign Affairs in the "La Gaviota" Restaurant at 8:30 p.m. on 31 July. Ministers may bring their own interpreters to the dinner if they so desire.

The Government of Mexico will host a buffet dinner at the same time on the same evening in the "La Duna" Restaurant. Invitations will be delivered in Cancun. Dress will be informal for both events.

Mrs. Susan Iruegas, the Officer in charge of Delegates of Delegate Services, will provide information on other activities optionally available to Delegates during their stay in Cancún.

10. PLANE RESERVATIONS AND TRAVEL AGENCIES

Four of the main airlines with service to Cancon will provide reconfirmation and reservation services at desks located in the Hotel Lobby near the elevators. Other airlines have offices in the "El Parian" Shopping Center next to the Press Center.

11. OTHER SERVICES

The Hotel will exchange foreign currency for local currency. Safe deposit boxes will also be available and it is suggested that Delegates do not leave valuables in their rooms.


A variety of shops selling clothing, jewelry, handcrafts and other articles, in addition to a travel agency, are to be found in the area between the Hotel Lobby and the swimming pool. Articles purchased in these shops may not be charged to rooms.

A permanent medical unit will be provided for Delegates in room 125/127.

12. COORDINATOR'S OFFICE

The Coordinator's Office will operate 24 hours a day during the Meeting. Any particular problem or need can be taken up with the duty staff in the Office. Coordinating personnel will also be on duty at Hyatt, Aristos, and America Hotels to handle special requests.

A map of the hotel area of Cancun and a directory of main officers of the Coordinator's Office, their office telephones and their hotel room numbers, are attached.





OUTLINE OF PROCEDURAL DECISIONS FOR THE INTERNATIONAL MEETING FOR COOPERATION AND DEVELOPMENT

At the Preparatory Meeting, the Foreign Ministers decided as follows:

Conduct of the Meeting

There should be no general debate; however, should participants wish to make a statement of a general nature, it would be understood that such a statement would be as concise and brief as possible (not exceeding 10 minutes).

It would be up to the Co-Chairmen to direct the discussion so as to focus on major areas of concern.

All participants may, if they wish to do so, submit papers beforehand on any relevant subject; these papers would be distributed to all participants in the language(s) in which they are received.

Allocation of time

According to the wishes of participants, arrangements can be made either for 2 three-hour sessions or 3 two-hour sessions a day.

The President of Mexico will offer an informal dinner for his colleagues Wednesday evening, 21 October 1981 at 8:30 p.m. No other formal social events are anticipated.

Seating arrangements

At a round table, there will be two places for each delegation and two additional places behind them.

Languages

Simultaneous interpretation will be provided from and into Arabic, Chinese, English, French, and Spanish. Participants wishing to speak in other languages may arrange for simultaneous interpretation on their own initiative.

Documents produced during the Meeting will be distributed in English and French.

Press

The Press arrangements as proposed by the host country were accepted. In particular, it was agreed that no individual statements on the progress of the Meeting would be issued until after the final briefing by the Co-Chairmen. Each participant, however, may make comments to the media on his or her own statements or positions.

La legisladora unica oradora en la sesión, dijo que el viejo edificio de Allende y Doncel s ha sido testigo de "incontables raformas a la Constitución, para satisfacer las necesidades de dinamismo y operatividad que exigen las graunstancias actuales"

Recordó que en la actual Cámara de Diputados, rindieron su protesta como presidente de la República, distinguidos políticos mexicanos que dieron su esfeerzo por engrandecer el país

Los legis adores, después de la breve intervención oratoria, por 22 votos aprobaron la celebración del periodo extraordinario.

En la sesión se conoció, tàmbién, de la so citud de permiso que pre-sentó el diputado ederal Francisco José Midero, quien dejará el cargo temporalmente para ocupar el pues-to de abbernador interino del estado de Coanuila.

La responsabilidad de la Cumbre recae entonces sobre el secretario Jorge Castañeda, responsabilidad que rebasa la cuestión circunstancial política y llega hasta la historia, y que además no sólo involucra a Castañeda sino al propio Presidente López Portillo, quien junto con el premier Bruno Kreisky, de Austria, es patrocinador del evento.

Quizás por esto es que el secretario Castañeda debería de formular un serio análisis sobre el equipo que integró con sus colaboradores para la organización de la Cumbre de otoño. De lo que funcionarios y periodistas que estuvieron en Cancún a principios de este mes han comentado, se podría concluir lo siguiente:

El hombre-conflicto en la preliminar de Cancún fue Andrés Rozental, a quien el secretario Castañeda designó como coordinador oficial del evento.

Rozental, quien es hijastro de Castañeda y ocupa en la cancillería el cargo de director de Asuntos de América del Norte, se supo ganar a pulso la animadversión de las autoridades municipales de Cancún, de los representantesdel gobierno estatal de Quintana Roo, de los coordinadores del Estado Mayor Presidencial y de los periodistas de todos los medios que cubrieron el acontecimiento. Los quejosos están dispuestos a dejar debidamente asentada su responsabilidad ante la indiferencia con que la cancillería recibió las

quejas. Los problemas que desató el embajador Rozental fueron mucho más allá y causaron el disgusto de no pocos de los miembros de las delegaciones invitadas que tuvieron que retirarse masticando su disgusto y profiriendo improperios en contra de México y los organizadores. Y es que Rozental, en un intento de superar la ineptitud que en su persona disfraza con prepotencia, se rodeó de un equipo de jóvenes tan frívolos como soberbios que se limitaron a convertir a Cancún en un carnaval de vanidades —como lo describió un delegado de Francia--- para dejar la solución de los problemas al Esta-

do Mayor Presidencial. Pero el engrudo "se le hizo bolas" a los organizadores también en otra área de importancia vital: la prensa, en donde el vocero de la cancillería, Miguel López Azuara cometió serios errores en un afán desmedido por otorgar trato preferencial a un grupo de periodistas de su amistad personal que le llevó a discriminar al grueso de los informadores, lo mismo reporteros que columnistas y corresponsales, quienes aún guardan rencor hacia la oficina de prensa de la cancillería.

La conferencia preliminar de Cancún permitió sacar a flote los errores de organización, también sirvió

para probar la eficiencia de la Presidencia de la República.

Los innumerables errores de los "diplomáticos" encabezados por Rozental fueron cubiertos con eficiencia y discreción por el equipo comandado por el general Carlos Humberto Bermúdez en forma tal que casi pasaron inadvertidos.

Para salvar las fallas de la oficina de prensa de la cancillería hubo de hacerse presente en Cancún el coordinador de comunicación social de la Presidencia de la República, Luis Javier Solana Morales, quien finalmente salvó el evento.

Lo importante para el secretario Castañeda ahora es dejar de lado los afectos personales e ir pensando en otra persona para la coordinación de la conferencia de otoño, porque en ello va no sólo su propio prestigio y responsabilidad, sino que también compromete al Presidente López Portillo.

Current universal figures such as Ronald Reagan, Margaret Thatcher, Francois Mitterand, King Faisal and the heads of State of the twenty-two nations with major participation in the North-South dialogue will make Mexico the center of world attention for at least a month before and after the work sessions which will take place in Cancun next October 22 and 23rd.

Last August 2 and 3, a preliminary conference was celebreted there with the attendance of the chancellors of the 22 nations which will meet in October. This meeting served to establish the basis for the Summit Conference, but for Mexico it served — or should have served— as the final rehearsal of the mechanism which will be used to receive the heads of State, to assure their security, and basically, to diffuse throughout the world the Cancun agreements, since the success of the North-South dialogue will depend in large part — as Secretary Jorge Castañeda observed during the press conference which he offered together with the Austrian Chancellor, Willibald Pahrr, at the end of the meeting— on the awareness of world public opinion in this regard.

Responsibility for the Summit Meeting therefore lies with Secretary Jorge Castañeda. Furthermore, it not only involves Castañeda but also President López Portillo himself who, together with Premier Bruno Kriesky, of Austria, sponsors this event.

Perhaps for this reason Secretary Castañeda should carry out a serious analysis of the team which he put together for the organization of the Autumn Summit Meeting. From commentaries made by officials and newsmen who were in Cancun the beginning of this month, the following conclusions may be reached:

The man who caused the conflicts during the preliminaries at Cancun was Andrés Rozental, whom Secretary Castañeda named official coordinator of the event.

Rozental, who is Castañeda's stepson and who occupies the position of Director of North American Affairs at the Chancery, earned the enmity of the municipal authorities of Cancun, of the state government representatives of Quintana Roo, of the coordinators of the President's military staff (Estado Mayor) and of the media newsmen who covered the event. Those who complained are disposed to put on record their outrage in the face of the indifference with which the Coordinating office received their complaints.

The problems caused by Ambassador Rozental caused the disgust of many of the invited delegation members, who had to leave chewing on their annoyance and voicing insults against Mexico and its organizers. And all because Rozental, in an effort to overcome his ineptitude, which he tries to disguise through a show of power, surrounded himself with a team of young people as frivoulous as they were haughty, allowing themselves to convert Cancun into a "carnival of vanities" —as was described by a French delegate —and leaving the solution of all problems to the Presidential military staff.

But in another vitally important area, the "paste" the organizers used got "all balled up": in the press section where Miguel López Azuara, spokesman for the Coordinating Office, committed serious errors in his excessive efforts to grant preferential treatment to a group of newsmen, personal friends of his, which caused him to discriminate against the greater part of the reporters; not only reporters but also columnists and correspondents, all of whom still bear grudges against that press office.

The preliminary conference at Cancun also served to prove the efficiency of the Office of the President of the Republic (Estado Mayor). The innumerable errors committed by the "diplomats" headed by Rozental were covered with efficiency and discretion by the team headed by General Carlos Humberto Bermudez.

In order to overcome the deficiencies of the Chancery's press office, Luis Javier Solana Morales, the coordinator for social communications of the Office of the President of the Republic, had to present himself personally in Cancun to finally save the event.

The important thing now is for Secretary Castañeda to lay aside his personal attachments and begin considering some other person to coordinate the conference next Autumn since not only his own prestige and responsibility are at stake, but also that the prestige and responsibility of President López Portillo.
