SUBJECT: BRITISH AND U.S. REPRESENTATION AT DAIMOND JUBILEE

1. ~~CONFIDENTIAL~~ ENTIRE TEXT.

2. BRITISH HIGH COMMISSION HAS INFORMED EMBASSY THAT QUEEN ELIZABETH II'S WRITTEN RESPONSE TO KING SOBUZA II'S LETTER INVITING HER TO ATTEND HIS DIAMOND JUBILEE IN SEPTEMBER IS EXPECTED IN MAY 27 POUCH FROM LONDON. AS SOON AS IT ARRIVES, LETTER WILL BE DELIVERED TO KING PERSONALLY AND WITHIN 48 HOURS PUBLIC ANNOUNCEMENT MADE. BHC, WHICH UNDOUBTEDLY HAS SUBSTANCE OF QUEEN'S REPLY, REMAINS VERY UP BEAT ABOUT BRITISH PARTICIPATION IN JUBILEE AND EXPECTS TO WORK "FLAT OUT ON NOTHING ELSE" FOR MONTH PRECEDING THE BIG EVENT.

3. ACTION REQUEST: WILL PRESIDENT REAGAN'S REPLY BE SIMILARLY PERSONAL? DOES DEPT ANTICIPATE THAT WE WILL BE ABLE TO SAY SOMETHING MORE THAN "SENIOR LEVEL EXECUTIVE PRESIDENTIAL DELEGATION BEFORE AMBASSADOR'S SCHEDULED DEPARTURE JUNE 5 ON HL AND CONSULTATION? FYI: SO FAR, WE HAVE NOT BEEN PRESSED FURTHER THAN ASSISTANT SECRETARY CROCKER'S COMMITMENT TO PRINCE GABHENI ON MAY 5. END FYI.

SUBJECT: DRAFT PROGRAM FOR DIAMOND JUBILEE CELEBRATIONS

1. ~~CONFIDENTIAL~~ - ENTIRE TEXT.

2. BRITISH HIGH COMMISSION FURNISHED US JUNE 29 ON CONFIDENTIAL BASIS COPY OF DRAFT PROGRAM FOR KING SOBUZA'S DIAMOND JUBILEE CELEBRATIONS. SEPTEMBER 1 AND 2 ARE DEVOTED TO ARRIVALS OF HEADS-OF-STATE AND MINOR ACTIVITIES. MAJOR ACTIVITIES BEGIN SEPTEMBER 3 AT 1200 WITH ADDRESSES AT PARLIAMENT BY PRESIDENT OF SENATE, KING MOSHOESHOE OF LESOTHO AND PRINCESS MARGARET. AT 1500 HEADS-OF-STATE ARE RECEIVED BY KING SOBUZA AT LOZITHA ROYAL RESIDENCE, "LOYAL ADDRESS" IS GIVEN BY PRIME MINISTER. A STATE BALL IS PLANNED FOR 2000 HRS AT UNIVERSITY COLLEGE OF SWAZILAND, KWALUSENI CAMPUS.

3. SEPTEMBER 4 IS MAIN DAY OF CELEBRATION. HEADS-OF-STATE ARE SCHEDULED TO ARRIVE AT SOMHLOLO NATIONAL STADIUM AT 1030 WITH KING SOBUZA ARRIVING AT 1200 TO BEGIN DAY'S EVENTS. A STATE BANQUET IS SCHEDULED FOR 1930. LOCAL TOURS ARE SCHEDULED FOR SEPTEMBER 5 AND THANKSGIVING SERVICE FOR SEPTEMBER 6.

4. COMMENT: DRAFT PROGRAM WAS PRODUCED PARTLY AT BRITISH INSISTANCE THAT THEY MUST HAVE PROGRAM TO BEGIN PLANNING FOR PRINCESS MARGARET'S VISIT. MAIN POINTS OF PROGRAM ARE PROBABLY FIRM, HOWEVER NUMEROUS MINOR CHANGES ARE EXPECTED. FOR INSTANCE, BHC HAS SUGGESTED TO GOS THAT STATE BALL BE MOVED TO LOZITHA PALACE. BHC SOURCE SAID A BALL AT UNIVERSITY CAMPUS WOULD RESEMBLE A "HIGH SCHOOL DANCE." BHC ALSO INSISTS THAT PRINCESS MARGARET CANNOT BE EXPECTED TO ARRIVE AT STADIUM AND WAIT ONE AND HALF HOURS FOR EVENT TO START. PROGRAM GIVES NO TIME FRAME FOR CEREMONIES ON AFTERNOON OF SEPTEMBER 4, HOWEVER BASED ON NUMBER OF EVENTS LISTED AND PAST EXPERIENCE, EMBASSY ESTIMATES IT WILL TAKE TWO AND HALF TO THREE HOURS. EMBASSY'S JUDGMENT IS THAT AT MINIMUM USG DELEGATION SHOULD ARRIVE MORNING OF SEPT. 3 AND COULD LEAVE MORNING OF SEPT. 5.

5. EMBASSY FORWARDING JULY 5 TO AF/S VIA CLASSIFIED POUCH REGISTRY NO. 4816406 COPY OF DRAFT PROGRAM, ADDRESSED TO DAN SIMPSON DUE TO ABSENCE OF DESK OFFICER.

X 6. GIVEN THAT FACILITIES (HOTEL ROOMS, RENTAL CARS, COMMUNICATIONS, ETC.) IN SWAZILAND AND RESOURCES OF EMBASSY ARE VERY LIMITED, MISSION WOULD APPRECIATE ANY ADDITIONAL INDICATION THAT DEPT. CAN PROVIDE OF SIZE AND LEVEL OF USG DELEGATION. AS MUCH ADVANCE NOTICE AS IS POSSIBLE WOULD BE VERY HELPFUL.

SUBJECT: Swaziland Diamond Jubilee

As you know, King Sobhuza has invited the United States to Swaziland's Diamond Jubilee in September. The State Banquet is set for September 3 as far as we know. If the President decides to send a delegation and if that delegation does not include either the President or the Vice President, then Protocol will be making arrangements for the delegation. It is our responsibility to obtain first class air transportation from the place of their residence to the host country and return. Additionally, we make arrangements for all ground transportation en route, housing accommodations in the host country and in transiting other countries, with the assistance of the American Embassy in the host country. We also provide for passports, visas, inoculations, and the schedule of events in the host country. We notify the delegation of the appropriate clothing requirements, and give any other assistance that is necessary.

It would be extremely helpful if you could notify us at your earliest convenience who the members of the delegation will be so that we can begin our portion of the trip.

Ambassador Richard C. Matheron, US Ambassador to Swaziland, and Mrs. Matheron.

By participating in the Diamond Jubilee celebrations, the United States wishes to demonstrate our respect for the wisdom with which King Sobhuza has guided his people during his 60 years on the Swazi throne and to underscore the close and friendly relations we enjoy with this southern African country.
