Update on Allied Burdensharing

WILLIAM A. COCKELL

OSD's thinking on the proper United States Government organizational structure to deal with allied burdensharing issues has evolved.

- During his return trip from Switzerland, Frank will be briefed on his staff's recommendations for the Special Task Force.
  - To be chaired by Will Taft to tie together ISP (Europe), ISA (Japan and Far East), and ASD/ Procurement and Logistics -- those elements of Frank's staff that have policy oversight over most of the potential intitiatives.
  - State (Ridgway) to be invited this week to provide participation at both task force and working levels. NSC will participate in observer status.
  - First priority task is refinement of lists of ---potential initiatives already solicited from Embassies, CINCs, and staffs.
- A letter was hand carried to Andy Goodpaster this week to solicit advice, ideas, and possible participation -- individually or with the Atlantic Council.
- Joint testimony by Ridgway (State) and Bader (OSD/ISP) before HASC Defense Burdensharing panel (Schroeder) on Tuesday resolved nothing. Schroeder CODEL to visit European capitals over Easter break.

After Frank makes final decisions on the Special Task Force and it is determined what issues have potential, there may still be the need for an interagency organization for burdensharing issues, to include such plavers as Commerce, Treasury, USTR, and OMB. We should have a better feel for that after we see the specific initiatives the Special Task Force thinks worth serious exploration. If it appears that broadening the group would be useful, we can create an ad hoc SIG under Will Taft's chairmanship, or use an existing interagency structure. We have discussed both options with DASD John Woodworth. Defense understands we are prepared to assist when they are ready (in draft) (in draft)




