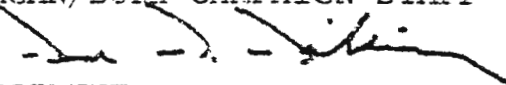

When we spoke yesterday morning, I promised I would write you a note confirming the substance of our telephone conversation regarding the Sam Popkin "Balloon Popping" memo.

That memo was provided to me by Prof. Samuel Popkin following an interview I conducted with him for my book, Political Campaign Debates: Images, Strategies and Tactics (Longman, April 1983). A few pertinent facts to clarify this matter:

1. The interview was conducted on July 8, 1981.
2. The interview was tape recorded with his consent and transcribed.
3. During the interview Popkin refers to the memo by name and tells me that he will be sending it to me.

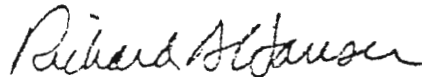
