



On behalf of UJA Federation, I would like to extend our sincere appreciation to you for being our guest speaker at the special outreach program held in Potomac last week.







The National Council of Jewish Women, organized in 1893 by Hannah G. Solomon, at the Chicago World's Fair, is the oldest Jewish women's organization in the United States, with 100,000 members in 200 sections, with other sections abroad.

Our 1984 image of "Lady Bountiful" has long given way to that of advocate for those unable to plead their own causes. Priority areas are: women's issues, Jewish life, aging, children and youth, Israel and constitutional rights.

Council has always ferreted out community needs and met the challenge. Remember Port and Dock work (in the late 19th century), Golden Age clubs, Child Day Care, Sesame Street, Head Start, Juvenile Justice programs, Senior Service Corps, Civil Rights, Domestic Violence programs? N. C. J. W. was an instigator of, or actively involved in, all of these - and many more - projects.

For 92 years, the D. C. Section (of 575 members) has served the community to improve the quality of life for people of all ages, races, religions and socio-economic backgrounds. In addition to our local study groups, there is an active community service program: ^(Women in Community Service) W.I.C.S., mental health, three senior adult programs, Soviet Jewry and Ship-A-Box (to Israel and other countries).

"Look Out For Your Children" is the newest local project, in conjunction with the D. C. Department of Recreation. Slated to begin almost momentarily at the Chevy Chase Community Center, it will, hopefully, spread throughout the entire Community Center network.

This and our other projects are funded through dues, through our "Better Buys" thrift shop at Wisconsin and Albemarle, by theater benefits, 2 "occasion" funds and by our new "CALL POLICE" banners.
