SUBJECT: Request for Farewell Calls by De Laboulaye on the President and Vice President

State's recommendation that both the President and the Vice President receive outgoing French Ambassador de Laboulaye for farewell calls poses a bit of a problem: if the President sees de Laboulaye, he will be under pressure to schedule farewell calls for other departing European Ambassadors. Given the multiple constraints on his time, I do not feel that it is a good idea to proceed down a path that should be reserved for exceptionally special circumstances (e.g., meeting with Israeli Ambassador Evron).

Accordingly, I favor going with the Vice Presidential call only, and have done up a memo from you to the Vice President to that effect (Tab I).

Subject: Request for Farewell Calls on the President and Vice President by French Ambassador de Laboulaye

Ambassador de Laboulaye has asked to pay farewell calls on the President and Vice President. He is departing Washington on January 31, but would prefer that a meeting be set prior to January 27.

Ambassador de Laboulaye, one of the most influential ambassadors in Washington during the past four years, is well known and highly respected within the Administration, on Capitol Hill, and in the private sector. He considers himself a personal friend of the Vice President. Following his return to France and retirement, Ambassador de Laboulaye is likely to remain an active member of France's influential elite, especially with regard to promoting closer Franco-American relations. Meetings with de Laboulaye would be a sign of respect for this highly respected diplomat, and recognition of the importance we attach to France as a key ally.

The State Department recommends that the President and Vice President agree to receive Ambassador de Laboulaye.

Subject: French contributions toward the rehabilitation of the Statue of Liberty

The French representative of the French-American Committee for the Restoration of the Statue of Liberty, a non-governmental foundation chartered in the State of New York, will be in the United States from March 1, through March 9, and has requested an opportunity to meet with the President.

M. Philippe Vallery-Radot would be available on the 1st, 8th, or 9th; while Secretary Watt, who would accompany M. Vallery-Radot if his own schedule would permit, is available only on the 1st. Mr. Russell Dickenson, Director of the National Park Service, would accompany the group and could be available to stand in for Secretary Watt on the 8th and 9th.

The Statue of Liberty was dedicated to the American people while still in France on July 4, 1884, and with the centennial approaching the French group, having recently been involved in the restoration of a sister statue in France, felt that the restoration of the American statue was appropriate.

M. Vallery-Radot has recently secured the support of the new French President, M. Mitterand, and desires the opportunity to present the plan to the President and seek his support. The Department of the Interior, through the National Park Service, has signed a Memorandum of Agreement with this group and looks forward to the raising of some 15 million dollars from private sources for this effort.

Due to the short notice, it would be understandable if a meeting were not possible at this time. However, this is a project which we would hope would receive the future support of the President, and perhaps a brief meeting could be arranged at a later date.

SUBJECT: Mitterrand Visit to U.S. Preceding Economic Summit

French President Mitterrand is pushing to meet with the President preceding the June Economic Summit in Paris, and State recommends that we agree (Tab I-B), perhaps in the context of a Mitterrand visit to Japan April 15-20 (he could stop here either en route to or return from Tokyo).

This proposal intersects a number of related (and somewhat complicated) issues which it will be the purpose of this memo to address in a comprehensive way. I summarize these as follows (Please bear with us as we try to keep our eye on the bouncing ball!):

1. Answering Mitterrand's Mail. The French are pushing for acceptance of the June 5-6 dates for the Economic Summit. We have not formally responded to a Mitterrand message on this subject, now nearly a month old, and we should do so without further delay. Presumably the memo which you moved to Mike Deaver earlier this week will take care of that item, and may even be out of the way by the time you read this. In any case, it would be well to have State prepare a brief Presidential letter to Mitterrand which acknowledges the latter's request and confirms (or reconfirms) U.S. acceptance.

2. Level of French Participation in NATO Summit. Closely related to the question of dates for the Economic Summit is the subject of a NATO Summit a few days later, and the level of French participation in that Summit. An earlier memo from State (Tab II), and Van Galbraith's luncheon exchange with Mitterrand & Co. last Monday, indicate the unlikelihood of Mitterrand's personal attendance. I do not believe that we should automatically consider Mitterrand a no-show. There is effective Presidential leverage that can be applied, and I strongly recommend that we apply it in the context of the request for a pre-Economic Summit meeting which Mitterrand is now making to us.

Mitterrand Visit. I support the idea of a Mitterrand 3. bilateral with the President preceding the Economic Summit, but to the extent possible we should make this contingent upon the French meeting some of our own priority concerns. We have deferred to them on the question of not scheduling any Presidential travel to Europe in front of the Paris Summit, and if we now agree to an unconditional meeting with him here prior to that event (during which his main purpose will be to precook U.S. support for French agenda positions), we gain nothing, and indeed, put ourselves in a posture where the French are calling Why not use the Mitterrand request to extract all the shots. a commitment from him to attend a NATO Summit? We are fully aware of the delicacies vis-à-vis France's relationship with the Alliance, but Poland does, after all, highlight the extraordinary circumstances of a Summit meeting - which involve political not military consultations - and which put a special premium on the forging of Western unity at the highest possible level.

In close collaboration with Chuck Tyson, Henry Nau, and Dennis Blair, therefore, I recommend the following:

Mike Deaver, accelerate a positive response to the French on their proposed dates for the Economic Summit (and ensure that a confirmatory Presidential letter to Mitterrand foreshadows some related discussions about pur interest in the NATO Summit). 

SUGGESTED TALKING POINTS FOR THE PRESIDENT'S USE DURING A PHONE CALL TO FRENCH PRESIDENT FRANÇOIS MITTERRAND

- <u>Purpose</u>: To discuss Mitterrand's interest in meeting with the President prior to the June 4-6 Economic Summit in Paris and to explore the possibility of making such a meeting contingent upon Mitterrand's agreement to participate personally in a NATO Summit to be held a few days after the Economic Summit.
- -- I look forward to visiting Paris for the Economic Summit in June and am pleased that we are able to agree to the dates that you proposed;
- -- I appreciate the personal interest which you have brought to the complex preparations for that event and am confident that the meeting will be crowned by success;
- -- Ambassador Galbraith has informed me of your interest in a bilateral meeting here in Washington preceding the Economic Summit, perhaps in late April on the way to or on return from the trip I understand you will be making to Japan;
- -- The idea of such a meeting appeals to me, and I will be pleased to see what we can work out that might be mutually convenient;
- -- At the same time, however, I will be grateful for your support in a matter I consider exceptionally important: the necessity of ensuring a successful outcome to the NATO Summit meeting now being planned shortly following the Economic Summit;
- -- I fully recognize France's special position so far as participation in Alliance affairs is concerned; nevertheless, the Polish crisis is an extraordinarily serious juncture in East-West matters and imposes on all the allies the need for the greatest possible public perception of unity in the face of this latest Soviet trampling of human liberty;
- -- I appeal for your personal participation in the NATO Summit, which would help underscore Western unity at this critical moment and leave the Soviets with no misapprehension concerning Allied resolve.

- PARTICIPANTS: A small number of officials on each side (to be provided).
- OUTLINE OF EVENT: Restricted session in the Oval Office; larger session during working lunch (total time approximately 75 minutes).
- REMARKS REQUIRED: NSC will provide background and briefing points.
- MEDIA COVERAGE: Meeting will be announced; full-blown photo opportunity; informal remarks on South Lawn upon conclusion of substantive talks.
- RECOMMENDED BY: State Department (see attached memo); NSC (provided, however, that prior effort is made to make U.S. agreement to meeting contingent upon Mitterrand participation in NATO Summit).
- OPPOSED BY:

Subject: Informal Request for President Mitterrand to Meet the President

During a private meeting in Paris with Ambassador Galbraith, key Mitterrand advisor Jacques Attali said that President Mitterrand would like to meet with the President sometime before the June economic summit in Paris. We believe that additional contacts between the President and Mitterrand would further cooperation and understanding with France, especially on East-West issues such as Poland. However unjustified, Mitterrand could interpret a refusal to see him as a rebuff. He will be visiting Japan April 15-20, and it might be possible to arrange a Washington stopover on his way to or from Tokyo. The Department recommends trying to arrange such a stopover, provided it fits in with the President's schedule.


Given French sensitivity, it would be desirable to respond to Attali's invitation soon, particularly if the answer is likely to be negative.

Subject: French Response on Atlantic Summit Meeting and Request for Confirmation of Paris Economic Summit Dates

French Foreign Minister Cheysson has written Secretary Haig urging acceptance of the June 5-6 dates for the Seven Nation Economic Summit. In his letter, Cheysson notes that, while the French have no objection to a subsequent Alliance Summit, it is "unlikely" that Mitterrand himself would attend.

The French President has never attended an Alliance Summit, and in view of the special French position in NATO, such attendance would constitute an extraordinary political act in the French context. In the past, the French have instead sent their Prime Minister, and Cheysson's letter implies that this level of attendance is the most we can expect from France on this occasion.

While it would obviously be more dramatic if Mitterrand himself were to attend, the French position is well known, and a NATO Summit including the French Prime Minister can be fully successful.

We will be forwarding separately a draft letter for the President to send to Mitterrand accepting the dates for the Seven Nation Summit and enlisting French cooperation in pinning down dates for a subsequent Alliance Summit.



Ladies and Gentlemen:

President Mitterrand and I have had a very productive day. In the Oval Office and during our working lunch we covered a very broad range of subjects, which naturally included our preparations for two major Summit meetings in June. President Mitterrand will host this year's Economic Summit in Versailles; and we are, along with the other participants, committed to a conference which will help the industrial democracies deal more effectively with today's economic challenges. With that in mind, I look forward with special pleasure to my visit to France, America's oldest ally.

We also touched on the NATO Summit and the need to demonstrate Allied unity and resolve in response to Soviet expansionist pressures. I will attend the NATO Summit with the greatest of interest and commitment.

As I indicated a moment ago, our talks were comprehensive. Since President Mitterrand has just returned from Israel, I was particularly interested in his assessment of the peace process in the Middle East.

Regarding Central America, I believe that President Mitterrand now has a better understanding of U.S. policy objectives in that troubled region. Our discussion on this subject was particularly candid and thorough. President Mitterrand shares my concern that the failure to promote the evolution of democratic government in

this region would have the most serious consequences. The principles and goals we share suggest we will be able to work together on this problem in the months ahead.

Our exchange of views on the economic concerns of our two countries was equally frank and productive. President Mitterrand made a forceful and thorough presentation of his Government's views on outstanding trade and financial issues. While it would be impossible to resolve our economic differences in one day, I think we have made tangible progress towards better communication on these important issues.

Let me repeat today my personal thanks to President Mitterrand for coming to Washington. As always, I found him to be a wise and persuasive partner. His insight, candor, and graciousness have deepened my respect for his leadership of the great people of France.



The French Embassy called to convey the request of General Rhenter to meet with you anytime during the period March 25-27.

Rhenter is the four-star head of the Secretariat-General de la Défense Nationale, a body which reports to the Prime Minister and which combines some functions of both our own NSC and the JCS planning staff.

The Embassy told me you were aware of the General's visit through the new Ambassador. Rhenter would want to discuss the general strategic situation in the world and the ways by which our two countries might possibly improve their strategic cooperation.

I know Rhenter and believe you would enjoy chatting briefly with him. However, I do not consider this an essential meeting, and it would be easy to deflect it -- legitimately -- on the grounds of the Pertini visit which will be happening during the same period. We could offer the General some senior NSC staff time in place of a West Wing call.

RECOMMENDATION

That you decide whether to meet with General Rhenter during the period March 25-27.
