## Dr. Koop's Decent AIDS Dissent

Even after 26,566 reported cases and 14,977 deaths, Americans tend to whisper when they talk about AIDS. Welcome, therefore, the loud voice of Surgeon General C. Everett Koop. His is a message Americans need to hear, and it rings with added credibility from someone of such rigorous stature in this Administration. No one needs to hear it more than this Administration's Justice Department.

In many communities the response to AIDS is ignorant, superstitious, inhumane. Dr. Koop's is informed and compassionate. "Many people, especially our youth, are not receiving information that is vital to their future health and well-being because of our reticence in dealing with the subjects of sex, sexual practices and homosexuality," Dr. Koop writes in a report requested by the White House. "This silence must end. We can no longer afford to sidestep frank, open discussions. ... Education about AIDS should start at an early age so that children can grow up knowing the behaviors to avoid to protect themselves from the AIDS virus."

The report, a 36-page booklet, is specific about how AIDS is and isn't spread — which makes it just the kind of frank discussion for which Dr. Koop pleads. "AIDS," he says, "is not spread by casual, nonsexual contact. It is spread by high-risk sexual

and drug-related behaviors — behaviors that we can choose to avoid."

To that end, Dr. Koop would like to see strong sex education at home and in the schools "at the lowest grade possible"; an increased use of condoms, and the use of clean needles and syringes by drug addicts. He opposes compulsory blood testing to identify those who may have been infected with the virus, or any efforts to quarantine them.

A copy of his report ought to be delivered to the Office of Legal Counsel at Justice. Last summer, that office ruled that employers who receive Federal funds may dismiss victims and carriers of AIDS because they need not be considered handicapped and entitled to protection against arbitrary dismissal. To have AIDS is to be handicapped, according to this ruling, but being able to spread it is not. If, despite all medical evidence, an employer believes that AIDS can be spread through casual contact, he can send the sufferer packing.

Compare that callous response to the AIDS crisis with Dr. Koop's view: "It is time to put self-defeating attitudes aside and recognize that we are fighting a disease — not people." May that recognition come soon, across the country, and across the Administration.

### Flying the Koop

U.S. Surgeon General C. Everett Koop, who got his present job at the urging of prolife forces in and around the fledgling Reagan administration and who has scarcely been heard from on that issue since, had one doozy of a bomb for his old supporters last week. Taking aim at AIDS, he recommended sex education starting in third grade, with detailed information about homosexuality starting in junior high school. A more complete case of mental takeover by the Washington establishment is probably not on record.

By way of introducing his new study on the subject, Dr. Koop observed that many people, especially young people, "are not receiving information that is vital to their future health and well-being because of our reticence in dealing with the subjects of sex, sexual practices, and homosexuality." Hmm. From what we have heard about what goes on in those sex-ed seminars in the public schools, "reticence" is not exactly the word that first comes to mind.

To be sure, Dr. Koop's course would not be the usual "value-free" how-to. "Couples who engage in freewheeling casual sex these days are playing a dangerous game," he warns. Perhaps he expects parents to rally behind a sex-ed program designed to frighten kids into chastity. If so, he misses the point.

Chastity prevents AIDS — agreed. But fear does not produce chastity. Even as Dr. Koop was speaking, a conference sponsored by the Department of Health and Human Services was taking stock of "what works" in preventing teen-age pregnancy (not the same issue as AIDS, obviously, but relevant). There was general agreement that what works is teaching kids self-esteem and resistance to peer pressure — not merely providing information.

A compelling case can be made, on the other hand, that some children are harmed psychologically when given sexual information at too tender an age. As a result of its transfer of parental roles to institutions — which would be a dubious project even if it attained its advertised objectives — the present generation may be raising its children as emotionally handicapped misfits.

UW AIDS REPORT URGENT

FOR RELEASE AT 1 P.M. EDT

WASHINGTON -- THE GOVERNMENT, RELEASING AN UPDATE OF ITS PLAN FOR CONTROLLING THE SPREAD OF AIDS, PREDICTED TODAY THAT MORE THAN 270,000 PEOPLE WILL HAVE BEEN DIAGNOSED WITH THE DEADLY DISEASE BY 1991 AND MORE THAN 179,000 WILL HAVE DIED.

DEATHS FROM AIDS IN 1991 ALONE ARE PREDICTED AT MORE THAN 54,000, ACCORDING TO PROJECTIONS BEING RELEASED BY THE PUBLIC HEALTH SERVICE. BY COMPARISON, 46,200 PEOPLE DIED IN AUTO ACCIDENTS IN 1984, ACCORDING TO THE NATIONAL SAFETY COUNCIL.

THE HEALTH AGENCY SAID THE FIGURES ARE BASED ON PROJECTIONS BY THE CENTERS FOR DISEASE CONTROL. IT SAID THE DEATH ESTIMATE COULD BE AS MUCH AS 20 PERCENT LOW BECAUSE OF UNDER-REPORTING OF AIDS CASES.

THE REPORT SAID MORE THAN 70 PERCENT OF AIDS CASES WILL BE DIAGNOSED ANONG HONOSEXUAL OR BISEXUAL MEN; CONSIDERED THE HIGHEST RISK GROUP. ABOUT 25 PERCENT OF THE CASES WILL BE AMONG DRUG ADDICTS WHO USE INFECTED NEEDLES. THOSE TWO FIGURES OVERLAP; THE AGENCY NOTED.

ABOUT 9 PERCENT OF THE CASES WILL OCCUR AMONG HETEROSEXUAL MEN AND WOMEN; A FIGURE ESTIMATED AT NEARLY 7,000 CASES; THE AGENCY SAID.

AND NORE THAN 3,000 CASES WILL BE DIAGNOSED IN INFANTS AND CHILDREN, THE HEALTH SERVICE SAID, BUE TO THE INCREASED INFECTION AMONG WOMEN OF CRILD-BERRING AGE.

AIDS ALSO WILL SPREAD DRAWATICALLY OUTSIDE THE NEW YORK AND SAN FRANCISCO AREAS WHERE IT NOW IS CONCENTRATED, THE AGENCY SAID. THOSE TWO CITIES NOW ACCOUNT FOR MORE THAN 40 PERCENT OF ALL AIDS CASES. BUT BY 1991, MORE THAN 80 PERCENT OF THE CASES WILL COME FROM OTHER STATES AND LOCALITIES.

THE PROJECTIONS ARE INCLUDED IN THE HEALTH AGENCY'S UPDATE OF ITS MASTER PLAN TO CONTROL THE SPREAD OF AIDS, OR ACQUIRED INNUNE DEFICIENCY SYNDROME.

DESPITE THE NUMBERS IN THE PROJECTION, THE AGENCY SAID IT STOOD BY THE GOALS IT SET LAST YEAR: TO REDUCE THE SPREAD OF INFECTION BY 1987; TO SLOW THE INCREASE IN AIDS CASES BY 1990; AND TO ELIMINATE THE SPREAD OF THE DISEASE BY THE YEAR 2000.
