You may recall during out conversation with Louise Firouz and David Laylin, she mentioned that a road was under construction toward the Soviet border from Gonbad-e-Kanus across the Turkoman steppes. There has long been a secondary gravel road in that area which went toward the Soviet border but did not cross.

I checked with Bob Ames' office (LCol Bob Mattingly). He said the road has been checked in January and in July before that, with no indication of any upgrading. The road runs up to a river (which is the boundary with the USSR at that point). There was no bridge as of January. There is a border post on the opposite side, but nothing more. There is a major Soviet highway not far away which connects with a railroad some distance off. Obviously, it would be an excellent route into Iran IF there was a bridge and a good road on the Iranian side.

He is tasking another look when the asset is next in position.

It is important that the technical "state of national emergency" on Iran be maintained at least until the courts have settled the question of voiding of claims against Iran and transferred those claims to the Hague. The SFRC apparently has recognized this and has chosen to leave the order in place without challenge for the time being.

There is nothing further that needs to be done here with this package. However, since the State Legal Advisor follows this question and will be interested in what the SFRC has done, I recommend that a copy of the Percy/Pell letter and the Friedersdorf reply be forwarded to State, Attn: Jim Michel, for information.

Dear Mr. President:

On November 14, 1979, President Carter declared a national emergency to deal with the situation in Iran. Although the Americans held as hostages in Iran have been released, financial and diplomatic aspects of that crisis are still being resolved. As a result, the Administration has taken no action to terminate the emergency.

As you are aware, in cases when a national emergency continues for this length of time, Congress is mandated by law to consider whether or not that emergency should be terminated. Section 202(b) of the National Emergencies Act states that, "not later than the end of each six-month period [after] such emergency continues, each House of Congress shall meet to consider a vote on a concurrent resolution to determine whether that emergency shall be terminated." No Senator has introduced such a resolution.

The Committee on Foreign Relations, acting in satisfaction of the duty imposed by Section 202(b) of this Act, has considered whether or not the introduction of a concurrent resolution is warranted at this time. After due consideration of the question, the Committee has determined that, because certain aspects of the emergency with respect to the situation in Iran continue to this day, no reason now exists for the introduction and the Senate debate of a resolution to terminate the emergency.

SUBJECT: Iran Study

I was contacted today by David Laylin whom you met with his sister several weeks ago. I think you know that Laylin is organizing a small collection of analytical talent to do studies which focus particularly on Iran. He has a contract with the Georgetown Center to do a study of the situation in Baluchistan. He has also submitted a proposal for a study on the role of the bazaar in Iranian politics and its possible effect on future political development.

The latter proposal has been reviewed by Joe Jordan who is interested. However, Jordan thinks the study should be expanded to a broader study of domestic politics in Iran. Laylin and co. are prepared to expand the scope of their proposal, and they are starting to work on that.

Joe Jordan says that he does not presently have enough money to fund such a study, but he hopes to get DOD interested. I think that a systematic study of Iranian internal dynamics could be a useful policy contribution, if only to keep the subject alive and in front of key decision-makers. If well done, it could provide a useful input if and when things once again get hot.

If you agree that a Georgetown study on Iran would be a useful undertaking, you might wish to consider dropping a word in the ear of Fred Ikle or one of your other contacts at the Pentagon. The NSC, of course, has no budget for external research, but an indication of interest from this side can help State and Defense decide where they might best invest their own efforts.

I have been encouraging Laylin in his efforts to develop some analytical talent on Iran. He has been after me to join his group, but I have resisted since I have more to do now than I can handle. I spent several hours helping him to put together the bazaar proposal, and I might give him some help on the study if it materializes. However, my main interest is to persuade him to tap some of the Iranian talent in the exile community and put it to work on constructive projects rather than endless coffeehouse discussions. You can use your own judgment about the value of encouraging such an effort and whether or not you wish to prod it along.

June 23, 1981

I am deeply honored to join with the citizens of Valdosta as you gather to dedicate this park in tribute to the memory of Major Lyn McIntosh.

The American people will long remember the courage and sacrifice of Lyn and his seven fellow soldiers who died in their attempt to liberate their captive countrymen in Iran.

It is most fitting that you have chosen to honor Lyn on Independence Day, the day on which Americans celebrate the freedom that he gave his life to defend.

Although I cannot be with you, my heart and my prayers go out to Major McIntosh's family and to the city of Valdosta.

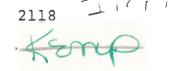

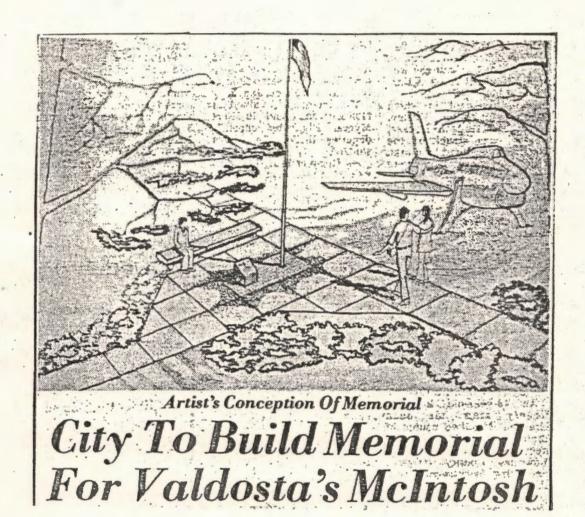

Dear Mr. President:

On behalf of millions of Iranians and thousands in exile, I wish to extend my highest esteem to you.

I am certain that you are aware of the current situation in Iran. I beg your permission to add a further note in reference to the covert forces which are penetrating into the key areas of Iranian infrastructures. While Iran continues to teeter on the edge of anarchy, Marxist groups, especially the Communist party (known in Iran as the Tudeh Party), are strengthening their organizations in the country. They have infiltrated government agencies, the armed forces and the oil field regions of southern Iran.

The geostrategic balance of the Persian Gulf is being dramatically altered by this infiltration and the deterioration of civil government in Iran. If this is not challenged and changed we face the Balkanization of the entire Persian Gulf region. We see the Soviet tactics gaining momentum. We are also certain that the strategic vortex of the crisis in Iran lies in the Persian Gulf and other regions with vast reserves of oil

Iranian nationalists are aware of their country's crisis in all of its depth and severity. We are determined to safeguard our homeland and restore our relations with the Western world, particularly with the United states which has unfortunately been marred by the actions of a few, fanatic clergymen.

We know that the United States has always shown magnanimity and clear vision to invest its power in assisting countries wishing to remain free. Our homeland is being threatened by the activities of ignormant, tyrannical clergymen who lack a foreign policy and strategic perception. And they are being duped by the covert actions of Communist elements whose only aim is the imprisonment of our country in the Soviet net.



Mr. President, since the situation in Iran is deteriorating day by day, we find it necessary to move. We plead and make this appeal to you to assist us so that we can shore up our independence, return peace and stability to Iran and renew our historical relations.

I wish to assure you, Mr. President, that millions of Iranian patriots greatly appreciated your nation's benevolent and gallant decision in favor of Iran when its territorial integrity was being threatened by external Communist forces in 1946. The Iranians shall never forget the United States' assistance which saved Iran from enslavement.

Once again we focus our hope on the United States which we are certain can help us to save our homeland again. We are pleading for your assistance at this decisive period of Iranian history and the history of the Western world. We pray for your help and your magnanimity.

These documents were given to me last night by a former Admiral in the Iranian Navy. Honestly, I've forgotten his last name, but at one point he was the Naval Attache here in Washington and his last job was Governor of Kurdistan, and before that was Commander of the Baucher (ph) Naval District. He's pro-American and typical Aryana type supporter. I met him in the office of Burt Talcott (a former Congressman from California who evidently is a friend of Dick's). The Admiral was making the usual pitch: time is short, only General Aryana and possibly Medini have the credibility to begin a new regime in Iran, that they want to act before Khomeini dies, etc. etc. I have a feeling it is the same old story, but you might want to take a glance at these pieces of paper and see if they add anything at all to what we know. I'll try and find out the guy's name when I get back. I was in such a rush last night I forgot to pick up his card.

## THE IRANIAN SITUATION: AN ASSESSMENT

November 12, 1980

### General Background

Conflict between Iran and Iraq has now been underway for the past two months. US diplomatic hostages are, after more than one year, still in the hands of Iranian radical and government hands. A major internal power struggle is evolving between radical clergy and so-called moderates. Additional power blocs inside and outside the country could, and almost certainly will, enter this power struggle. Food, fuel oil, heating oil and medical supplies are now in seriously short supply, impacting on the domestic and . conflict situation. All elements involved (people, shortages and situation) have reduced the flexibility of the current leadership to the point where very few viable options are available either for the continuation of the war or the pursuit of peace. Inflation rate of 180% and an unemployment rate of 5-million (of 36-mill, pop.) further exacerbates the situation. Failure to achieve success in economic, military or political arenas has led to widespread public unrest to the point where the demand for some form of strong leadership is growing significantly.

Prior to the war with Iraq, some 500,000 small arms pieces were in the hands of the general public; that figure now has reached appr. 1-million. Marxist groups (Fedayeen, Chirikya, etc.) and pro-Soviet Tudeh Party members, plus left Mujahedin are now heavily armed. These groups have varying -- but all strong -- overt and/or covert connections with the USSR.

There are appr. 3,000 identified Marxists among the Iranian clergy, and close to an estimated 5,000 active KGB agents/officers in the country. There has been no intelligence community to monitor Soviet covert agitpropolitical action and intelligence operations in Iran.

Ayatollah Khomeini and the clergy are meither able to continue the war or make peace with Iraq. The longer they remain in power, the more the country is weakened and prepared for structural disintegration and chaos, the result

of which could be a leftist takeover or the seizure of power by a "Qadhafi" figure from the younger military.

The USSR, because of extensive overcommitment in Afghanistan and concern over the European situation (Poland), and because of internal political changes, is not expected to interfere militarily in a direct fashion, but it does not need to do so. If the present trend continues without additional catalysts, the Marxist or pro-Marxist groups will be able to achieve control of the country in the wake of the clergy without overt Soviet assistance.

# Internal Dynamics

There is growing and widespread discontent with the clergy rule in Iran, with the final discontent brought about by the apparently insoluble conflict with Iraq. The evident lack of leadership from the clergy has led to a leadership vacuum which the left hopes to fill. However, the situation is such that at present the left is reluctant to seize power because the national deterioration and disintegration has not yet reached the level where it would be publicly acceptable. It is, however, moving in that direction. Additionally, the left is insufficiently cohesive to mount such a move. As well, an extreme right move -- whether religious or military -- is also not acceptable to the general population. The Center, such as the National Front, is similarly unacceptable because of its clear inability to control the situation in the recent past. The major external alternatives until recently were viewed as Dr Shahpour Bakhtiar (for two weeks the Shah's last prime minister) and former Imperial Ground Forces' commander Gen. Golam Ali Oveisi. They, too, are unacceptable in the current situation because of their close identification with Iraq in the months prior to the conflict.

## 3. Major Forces: Internal

The three major internal forces are: (i) Clergy: (ii) Leftists: (iii) Military.

The clergy has lost its ability to control events, either toward resolving the conflict or toward resolving economic problems, food and other supply shortages. This, and the fact that it is by its very nature a restricted group in terms of numbers and because its nominated leader (Khomeini) is in failing health, spells the end of clergy rule in the near future.

The left is fragmented and unless a total vacuum docums

because of premature clerical collapse, or unless the clergy and left are galvanized by extreme-right military action (such as extensive pressure from a force led by Oveisi), it is unable to move in the very near future to seize power. The conflict with Iraq has unified the military to the extent where it could currently thwart a leftist take-over of the reins of power. The left's major hope is for more time to consolidate and to assume control over some areas of power, an for the gradual replacement of the old military by a new military force (such as the Revolutionary Guards) which was being implemented before the conflict with Iraq returned some of the armed forces' power.

The Military, whilst regaining some of its viability in order to meet the military threat from Iraq, remains restricted to a large degree in its ability to overthrow the clerical Government in the immediate term. This, however, is changing more rapidly than the power position of the other two major internal power groups. The military will once again fragment, however, if the older, traditional leadership still inside the country fails to make headway either in the Iraq conflict or in the assumption of power internally. The emergence of a young officer clique to seize power as it did in Libya is now more feasible than ever, and, indeed, fits with Libya's strong and overt current support to the Iranian military.

# 3(a) Major Forces: External

The major external Iranian forces impacting on the current situation are: (i) the monarchy; (ii) external Iranian technocrat/middle class expatriates; (iii) external military personnel; (iv) Dr Bakhtiar's organization; (v) Gen. Oveisi's organization; (vi) some National Front elements; (vii) Gen. Bahram Aryana's organization; (viii) Soviet-controlled "student" groups.

Alliances, tacit or formal, between some of these groupings can and has occurred, and several may seek a unity of action in order the bring about the desired result of overthrowing the present situation inside Iran. However, the potentially most strong group is the external military, led by a core of officers who have, in the past two months, achieved a considerable degree of organization and commitment. They are largely in the United States and Western Europe. This group is now increasingly supportive of Gen. Bahram Aryana, the former commander of the Imperial Iranian Armed Forces.

Gen. Aryana, resident in Paris and now 73 years old but extremely active

was discharged by the Shah because of his growing power. Has historically been identified as

strongly Persian in outlook and was in no way identified with Iraq. Condemned Iraqi aggression over BBC and some other international radio, a factor not without significance because of the dependence of many Iranians on the BBC for news and opinion. Has developed a strong command structure and has stated a readiness to return immediately to Iran to "liberate" it. As former supreme commander of the Iranian forces and the most senior Iranian officer outside the country he has organized a Supreme Command of the Liberated Armed Forces. Receiving widespread support from officers outside the country and has contacts inside Iran. Aryana believes in moving the takeover in three stages: subversion of the current rule, military takeover and creation of stability; return of control to civilians.

The monarchy has improved its potential to impact on the situation by the statement by the (then) Crown Prince (now Shah) to the effect that he was ready to return to Iran and fight for the country. Whilst his popularity has improved, the consensus is that the monarchy, and the King himself, should maintain a low-key approach to the situation.

Former Prime Minister Shahpour Bakhtiar and Gen. Oveisi have been reduced in significance since the conflict with Iraq. Both had strong Iraqi connections and alliances. Bakhtiar's major core of supporters within the armed forces was destroyed in an abortive and premature coup attempt prior to the Iraq conflict, reducing hi≊ apparent attractiveness even before his association with Iraq unercut his position. Gen. Oveisi, despite major expenditures to buy the allegiance of expatriate officers, has been unable to build a loyal external force and is regarded internally as being too closely aligned with both the former Shah and excesses of force. His top-level connections (with Pres. Sadat, for example) have kept him in the limelight, although there is little substance to support him.

Expatriate Iranian middle class refugees, many of them skilled in technical areas, largely believe that the only solution is a military one. They remain mostly uncommitted, but potentially a significant economic and psychological force. Some 2.5-million Iranians are abroad.

Expatriate Soviet-backed groups continue to function although their major task was completed with the overthrow of the Shah. They retain some viability as an agitprop (agitation propaganda) force, but their impact has been lessened by their reduced numbers and by the tide of events.

### 4. International Impact

The changing political situations in the United States and the Soviet bloc hold the key to major external pressures on Iran, with the exception of the immediate impact of the Iraqi invasion. Both superpowers recognize the geopolitical and resource importance of Iran, but their ability to achieve their goals with Iran is now changing. The United States, because of the election of Ronald Reagan to the Presidency, and the coming to power in the US of a more strategically aware and sensitive group of policymakers, will result in a reassertion of US power which will affect the psychological and physical situation in the region. Internal Iranian groups, confused and fragmented by Carter's policies, can now regroup around the expectation of revived US support for a moderate, pro-Western Iran.

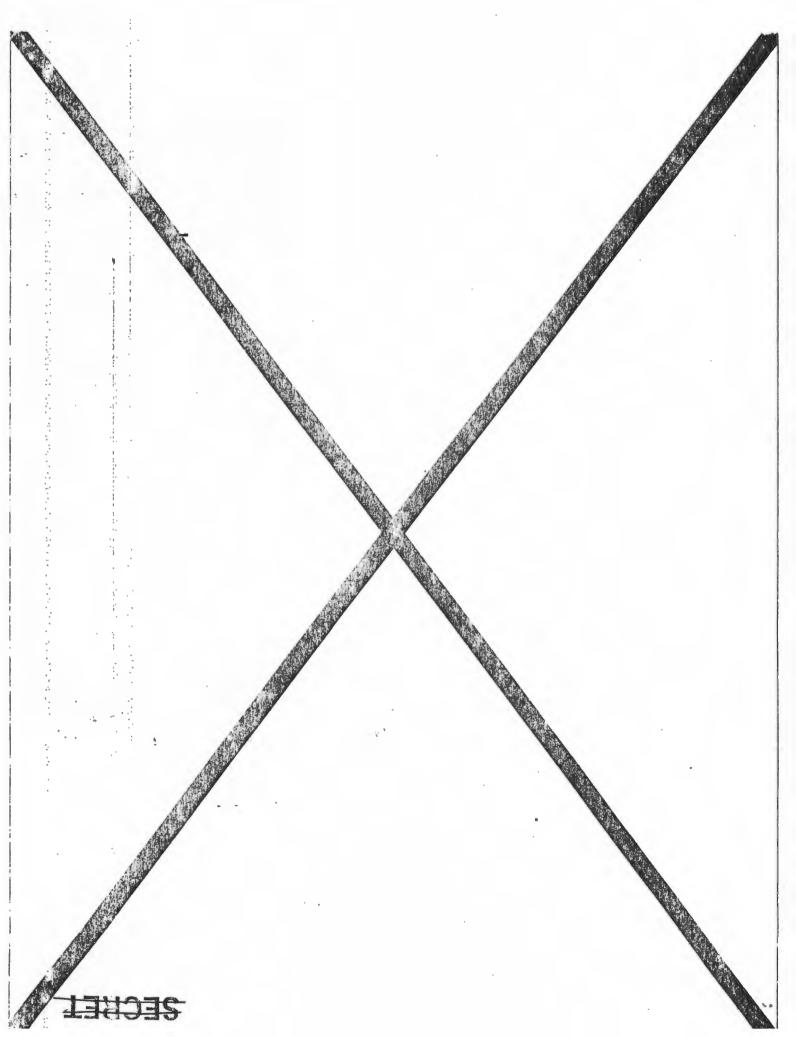
The USSR, on the other hand, has peaked in its major efforts against its Iranian target because of a variety of factors: the commitment to the Afghan conflict and the resultant world outcry; the concern over the stability of its Warsaw Treaty allies highlighted by the Polish situation; the failing health of the Soviet leadership gerintocracy; and the internal Soviet economic problems. This could change with a change of Soviet leadership, but any such changes will not be completed within the next few months even should Brezhnev die immediately. However, the USSRis apparatus operating against Iran KGB - and (mainlu International Section) continues to have an impact, and the Soviet supply of arms, and oil to the current leadership could impact strongly -- and even decisively -on the outcome of the present crisis if no other forces project themselves onto the situation.

## 5. Outlook

Failure of external factors to act, or a failure of the traditional military to acquire power (with or without external help), will lead to continued disintegration of Iran. This in turn will result in the almost centain acquisition of power by either the pro-Soviet left or a Qadhafi-type figure. Such an eventuality would severely de-stabilize regional states. Balkanizing the region in preparation for conflict of a level likely to lead to superpower confrontation.

The prospect for change in a moderate, pro-Western fashion appears to be coalescing around Gen. Bahram Aryana, who seems to be acceptable as an "umbrella" for a broadly divergent group of nationalist moderate forces, ranging from the monarchy's supporters to those in favor of a moderate

democracy. Aryana believes, probably correctly, that unless he moves inside Iran in the very near future the emergence of a "Qadhafi-type figure" is more likely. He is reported preparing to move. Aryana is the only leadership figure currently visible who would not antagonize large sections of the Iranian population, and who would be acceptable not only to the United States and Western Europe, but also to a degree to the USSR with which he would resume normal relations.

An Open Letter To His Excellency, Imam Khomeini:

Often, in the past, I have said such things as I thought needed saying, and have brought them to your excellency's attention. It is again time to speak out. The revolution, which at first amazed the world, bearing the promise of victory and prosperity for the deprived—and you were its architect, creating a new world of pride for the nation of Iran—this revolution has been debased and subverted to an extent that I could not have thought possible.

Nor have strangers brought this about, but, worse still, our own people. As a result, the nation of Iran has fallen into wretchedness, and is disgraced in the eyes of all nations.

During my recent months of self-exile, I have from time to time joined in discussion with various people of the world. I have, all my life, tried not to display sadness, however great my grief is. Now, however, because of the things I have heard, I cannot conceal my grief.

Alas, for our revolution once shone brightly. You and your leadership lit the lamp, but you are now the one who is putting it out. You raised an edifice by your own effort, and you are letting it crumble.

I wonder what they tell Your Excellency about the state of our country, about the suffering of the people and the ruin of the nation, about the disorder and disunion which rule over our people. I wonder what they tell you about the theft of our national treasury, the barbarous plundering of our limitless cultural and national wealth, which can never be restored. Sadly, the plunder continues, and the soon the nation will be reduced to beggary.

I wonder whether they tell you that this so-called "Islamic" revolution, this ignorant and incompetent, "Islamic" government, this "Islamic" judiciary- and all the other non-Islamic elements which they call Islamic- have brought such torment upon the nation and the revolution. I wonder whether they tell you that those who surround you have committed such evils that the oppressed people of Iran have forgotten earlier hardships and speak only of those brought on by these usurpers of the revolution and betrayers of the faith. I wonder whether they tell you that they have driven the nation to such extremities that the people are sick of it- not only of such a "revolution", but, indeed, of such an "Islam". Or have the shouted slogans and the clamour of approval that surround Your Excellency's residence brought you satisfaction and tranquility? Are these things enough to make you contented?

The truly pious clergy, together with the moderate, competent, and responsible people who truly sympathize with the revolution and the Faith, with the people and the nation, and who are humane in their thoughts and actions— these are driven away from your side, and many have gone into seclusion or exile. The few who remain have sealed their lips and concealed their grief. In place of these creative and constructive elements the field is held by the incompetent, the usurpers and the faithless, whose forerunners surrendered Ali and Hossein to martydom.

Therefore I urge you, if you would serve Islam, if you would please God and his Prophet, at least to remove the epithet "Islamic" from what are called the "Islamic" Republic, "Islamic" Parliament, "Islamic" Revolution, "Islamic" Republican Party, "Islamic" Judiciary, and so on . These names disgrace Islam and the nation of Iran . They shame the Prophet, they bring disorder upon the nation and leave the revolution defenseless . And for the nation, each day is worse than the day before .

These people claim to follow a school of "Law", but they do not even know the meaning of "Law", its limits, its truth, its contents. They only parrot its words and imitate them in order to set their traps. They cause nothing but destruction, they act only in order to plunder the capital of the nation, they have nothing to offer a defenseless people but violence and slaughter.

The law is not merely destruction, wrath, vengence, slaughter, exile, and suffering . A school of the law is the creation of a human being, from whom it derives its life, and the human who combines oppsites within himself is the more sublime- one like Muhammad, like Ali . And this is why the school of law of Muhammad is comprehensive,

this is why the Alawite School is most favored: because it both repels and attracts, it gives both death and life, it both tears down and builds up, it uproots and it plants, it contains both suffering and joy. In short, the law both brings pain and provides the cure, but each in its place, each with its own principles and rules, and thus it advances.

You should follow this example, and spread and cherish the true Muhammadan and Alawite School of Law. Allow the nation of Iran to be free of the folly and reaction with which it is afficted, to advance and progress, to end its shame and disgrace in the eyes of the nations and peoples of the world.

Do not allow the usurpers of the revolution and their accomplices in political infamy to seize the field as they have, interfering in all matters. They are either merely ignorant or they are traitors, and they have brought the revolution to the brink of failure. Their bloodlust and greed have no limits.

If "religion" means firm blief, humanity, and a pure piety within and without, and if a "religious" person overflows with creative strivings forgiveness, and love, then such a person seeks only to serve society and to contribute to the welfare and prosperity of mankind. He fearless moves in a constructive direction, and refrains from encroachment upon the rights of others. He is truthful, kind, and charitable. And if a religious person is supposed to love his land and his people, and to fulfill those other duties which our Prophet enumerated, then I must conclude that those who surround you are neither pious nor patriotic. Thus, I urge you to turn away from these people, for they do not find favor in Islam. Nor are they the best of our nation.

Those who assume responsibility for our revolution and our nation need certain qualities, among which are sympathy for the nation and for humanity. They must be competent, decisive, and pious. Only such people can ensure our progress and welfare. If you had had with you such a group from the beginning, this ruin and disorder would not have happened. So many great things could have been accomplished in the last two years, but were not.

However, the nation did not suffer imprisonment, torture and slaughter for nothing. They did not cast off one set of exploiters and oppressors, only to accept a worse one. They did not make a revolution only, as our proverb says, to climb out of a pit and fall into a well. What was their sin, that they should suffer so?

Yet the opportunity is not dead, if you will rise to it. No longer allow those elements, in your name and under your flag, to negate the rights of our people, to rob, oppress, and exterminate the nation. The leadership of the nation is in your hand. Whether or not

you have been aware of these excesses, the responsibilities is yours, and you are answerable, before God and the nation, for what happens. Grant our people those things for which they have struggled; grant them the political and judicial security, the right to productive work and life, and the legal, humane government which they have suffered and died to achieve. Only then will the creative and constructive forces of our nation be free to act.

And put an end to this infernal war, not only because it sheds
the blood of our people and threatens to annihilate what remains of
our nation in its flames, but because it also threatens the Iraqi
people with the same fate. And remember that a peace that does not
recognize the just rights of the Iranian people, or which allows the
slightest alteration in our borders, will surely fail to win the
acceptance of those who truly believe in our nation and our revolution.
