On Tuesday, June 1, 1982, the President will be conducting an interview in the Library with 4 foreign correspondents to be fed live to Europe... please be advised that we are taping a session with the President on Monday, May 31 so the Library should be kept empty as we are going to piggy-back the set-up of the interview.

<u>USHERS OFFICE AND CONTROL CENTER</u> - E.J. STEWART the remote truck will arrive at the EAST gate at 4:00 PM on MONDAY May 31 and should be directed to park outside the Library. They will feed their cables through the bathroom window. All concerned will be at the White House on MONDAY for set-up and will return on TUESDAY for the actual interview. They will return on Tuesday at 9:00 AM.

#### The clearance list is for Monday and Tuesday.

Please have an electrician available on Monday at 4:00 PM and Tuesday for power hook-up for the truck as well as the room. The telephone lines should be hooked up in the Library already.

The remote truck will remain outside the Library until we complete the interview at 4:00 PM Tuesday.

WHCA should provide audio recording equipment and mics. If you don't have 5 microphones, we can mic the 4 correspondents and you can mic the President.

USHERS OFFICE: We will need four arm chairs (5 if you have them) exactly alike in the Library at 4:00 PM Monday.

Dear Jan,

Enclosed are the accreditation details for the E. J. Stewart staff, U.S.I.C.A. personnel and B.B.C. personnel who will need to enter the White House for our June 1st interview with President Reagan. I have indicated where possible if the people have White House passes. Stewart's tell me that all their staff are in the Green Book. If the other foreign correspondents have not let you have their details as requested, please let me know and I will chase them immediately.

With regard to RAI, the last time I spoke to Sergio Telmon on Thursday, he confirmed that he would come to Washington in time for the planning meeting at 1000 am on Tuesday (which will take place at ZDF at 1077 31st St., N.W. Tel: 333-3909) and that he would be at the walk-through at 2 pm at the White House. I hope he doesn't change his mind again!

We will call in on Tuesday as soon as we have a firm idea of the question areas each correspondent will approach.

I would also like to confirm that the E. J. Stewart trucks will arrive at 4 pm on Monday at the East Gate of the White House. I shall be there too, with Dave Cohen and Frank Garcia of U.S.I.C.A., and we should like to meet with the White House electrician at that time.

For information, the four cameramen will be Edward Walsh, Samuel Hirnheisen, Philip Taplin and Charles Whitfield.

On presentation in Europe, ZDF are transmitting the interview live, and the BBC will be transmitting it in full during the second half of an hourlong news bulletin, between 2130 and 2200 BST. Both ZDF and BBC are hoping that the interview runs closer to 30 than 40 minutes. I will check what RAI and TF1 intend to do and let you know today. The BBC expects an audience of between 12 and 16 million viewers. The BBC are offering the interview to the EBU on Friday, with permission to air it live. The same permission is being given to broadcasters in the U.S.A.
