Chad3. CHAD/LIBYA: SPIRALING EFFECTS OF FACTIONAL FIGHTING

The Libyan cause in Chad has received a blow. After six years of Libyan sponsorship, the rebel Government of National Unity (GUNT) has fallen apart, exposing Libya's military occupation of northern Chad. President Habre has new opportunities to pressure Libya and extend control over the rebels.

\* \* \*

In response to Libya's support of attacks on Goukouni Weddeye's GUNT forces by rival factions in northern Chad, GUNT representatives signed a secret peace accord with the Ndjama government on October 26. Goukouni, who sanctioned the break with Libya, was shot and severely wounded on November 1. There is little hope the GUNT can be reconstructed.

Break in August. Acheik Ibn Omar, leader of the Chadian Democratic Revolutionary Council (CDR) faction, resigned from the GUNT in August after a bitter dispute with Goukouni in Tripoli. Three days later, fighting broke out in northern Chad between Acheik's and Goukouni's forces. Initially, Libya urged negotiation, but when fighting escalated in October, Libya supported the CDR in the field.

Libya's next move. Qadhafi has made no official statement regarding the GUNT or Acheik but has been active in behind-the-scenes lectures to GUNT faction leaders. Libya continues to concentrate on the immediate threat posed by Goukouni's troops. Over the next six weeks, Libya can be expected to resupply its field units, augment its artillery, and secure its overland supply routes. France will monitor closely any Libyan buildup.

Ndjama's reaction. President Habre will use the rallying of rebel forces to expose Libya's occupation of Chad. He accuses Libya of genocide and vehemently demands that France assist him in striking the Libyans. He will sound these themes at the Franco-African summit in Togo later this week.
