SUBJECT: Governor Thompson's Phone Call

Governor Thompson called you on two personnel matters:

1. The position on Donatelli's staff if Gwen King leaves. His recommendation is Cail Cousins, who used to be the head of Governor Thompson's State of Illinois/Washington office. She was also the President of the State's Washington representatives. The Governor says she would be outstanding.

Below is a short biography on Deputy Kalon Lodi Gyari:

Mr. Gyari is a cabinet member of the Dalai Lama's Government-in-Exile. Although his title is that of Minister of Education and Religious Affairs, the majority of his time is spent working as a liaison between foreign governments, including the People's Republic of China, and the Office of the Dalai Lama, which is based in Dharamsala, India.

He is perhaps one of the most informed individuals about the current situation in Tibet and would play a strong leadership role in any discussions with the PRC government. He is also one of the very few people that can speak on behalf of the Dalai Lama. Considering recent events in Tibet and growing international concern about the Chinese human rights abuses in Tibet, I think the Office of the President would be interested in hearing an authoritative Tibetan voice on the subject.

Mr. Gyari is, at my best guess, in his early forties. He is fluent in several languages, English included. Mr. Gyari and I would appreciate it if any quiet meeting could be arranged with a high ranking member of President Reagan's staff, preferably our friend Mr. Howard Baker and anyone else Mr. Baker may think should hear from Mr. Gyari. Mr. Gyari will be in Washington from April 25th thru April 27th, 1988.

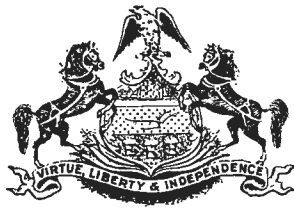

Dear Dan,

It was good to talk to you at the Kennedy Center Honors last Sunday. I thought that gave me the right to drop you a note about something you said on-the-air today during the departure ceremony for Gorbachev. You will recall that audio was lost for 52 seconds. Your comment was to the effect that the problem originated with the "White House Sound System". Not so.

The White House feed was never lost. That's why the PA System continued to function normally. For whatever reason, the networks insist that they operate their own "mult" in the Washington area. And, for whatever reason, the networks use mults that require AC power. (We use battery-operated mults.) Unfortunately, one of the press pool tripped over your power cord and that effectively disconnected all the network feeds.

We did play a role in this drama, however. Specialist First Class Joe Plaza of the White House Communications Agency quickly and calmly found the problem, plugged in the cord, and restored the network feeds. We're happy we could help.

Given the complexities of this week's electronic media coverage, I think we all did a terrific job.
