I hope that you enjoyed your China trip. It must have been a fabulous experience which makes any other request seem mundane.

However, the 3rd International Warranty and Housing Conference is scheduled for October 7 in Sydney, Australia. Home Owners Warranty (HOW), the founder of insured warranties/insurance for new single family housing in the States, will present an update of our program to England, Canada, Australia, Ireland, Finland and Japan.

The HOW 16mm film will document the first decade of this builder/consumer protection through interviews with key builders, bankers, realtors and home owners.

We would like to have President Reagan tape a greeting to the Conference participants expressing his pleasure in this world-wide effort to provide quality housing through the free enterprise system. A point should be made of the fact that HOW has proved that the private sector can regulate itself better than government can.

HOW was founded by the National Association of Home Builders and is now a builder-owned company which the Association endorses. It has been acclaimed by James Miller, Elizabeth Dole, Sen. Charles Percy and the President's Commission on Housing. HOW also works closely with the federal housing agencies.

The HOW informal dispute resolution procedure is considered the most advanced of any used by industry. The Office of Consumer Affairs has been instrumental in increasing awareness of its effectiveness.



SUBJECT: Presidential Video-tape for 40th Anniversary of Polish American Congress, May 5, 1984, Chicago

The Polish American Congress (PAC) has invited the President to address the PAC at its banquet commemorating Polish Constitution Day and the 40th anniversary of the PAC at the Conrad Hilton in Chicago on May 5. This commemoration will be the largest and most important Polish-American event of the year. 2,000 people will be in attendance at the banquet and tens of thousands will be attending other programs in Chicago at that time.

The PAC is the recognized umbrella organization of this key ethnic community. The PAC has played a very important role in U.S.-Polish relations, and has supported the President's sanctions policy very strongly.

Unfortunately, neither the President nor the Vice-President will be able to attend the banquet. Their absence breaks a tradition by which almost every recent President has attended a PAC banquet during his term.

Kenneth Dam has agreed to represent the Administration at the banquet, but it is also vitally important that the President have visibility at this event. Thus, we feel that it is very important that a video-taped message be prepared for this event. The message, which would be played not only at the banquet, but also on Polish television and radio programs throughout the U.S., would send an important message not only to the 8 million Polish-Americans, but to the people of Poland itself.

However, we have been advised that no video-taping sessions are scheduled between now and May 5. Because of the importance of this event, we strongly recommend, that a special video-tape session be scheduled upon the President's return from Asia, on May 3 or 4.

Polish heritage. They live mainly
in the industrial Northeast (Illino-

dominantly registered Democrats,
they overwhelmingly supported the
President in 1980. The PAC's
president, Al Mazewski, has sup-
ported most of the President's
domestic and foreign policies,
especially those affecting U.S.-
Polish relations. The banquet will
be covered by local and Polish-
American press.

Thus, we feel that it is very important that a video-taped message be prepared for this event. The message, which would be played not only at the banquet, but also on Polish television and radio programs throughout the U.S., would send an important message not only to the 8 million Polish-Americans, but to the people of Poland itself.

PRESIDENTIAL TAPING: 50th ANNIVERSARY DINNER OF THE FEDERAL
COMMUNICATIONS ACT
THURSDAY, MAY 31, 1984

Representatives of the Congress, the Courts, the Commerce Department, the Federal Communications Commission, and distinguished ladies and gentlemen: Good evening. It's a pleasure to be with you, via modern electronic communication, to congratulate the Federal Communications Commission on its 50th Anniversary.

The Commission's founding in 1934 brought together under one roof the duties of the Federal Radio Commission and the telecommunications responsibilities of the Interstate Commerce Commission. This unusual marriage of interests has served our country well through the 50 -- often rough, sometimes tumble -- years of the F.C.C.

Radio communication is nearly as old as this century. With the advent of ship-to-shore transmissions, it became clear that radio frequencies had to be protected from interference. The Navy first took on the job, and then the Department of Commerce licensed channels, trying to ensure that each operator stayed on his own frequency. As the commercial potential of this new medium became clear, broadcasters swamped the airwaves of our big cities. It was evident to all concerned that the time had come to get the situation organized.

By 1934 -- I was a sportscaster by then -- radio licensing was part of the Federal scheme. The new Federal Communications Commission reported 623 broadcast stations on the air that year.

Today there are over 9,400 radio stations and 1,400 T.V. stations in service throughout America.

The Commission has also grown. On that first day of the F.C.C., July 11, 1934, 233 employees reported for work. Today, over 1,900 professionals work for the F.C.C. The industries regulated by the Commission -- not only broadcasting and telecommunications, but mobile radio, satellites, and so many others -- are inseparably linked to our national vitality and the American way of life.

Change, of course, has been the one aspect of electronic communications that has remained constant. The business has been perpetually evolving, leaping forward with electronic discoveries, setting new ground rules for itself with every advancement. Today, for example, competition is seeping into every nook and cranny of the telephone business. Telephones in automobiles are becoming standard equipment. Paging devices and other wireless forms of communication permit us to keep in touch anywhere in the world. Fifty years ago, in the first summer of the F.C.C., this was the stuff of comic strip and science fiction writers, not regulators.

This jubilee year of the F.C.C. helps us recognize the importance of maintaining our freedom -- every American's most precious possession -- in light of the technological progress. If our liberty is to have meaning, it must keep pace with technology. The slow, sure attainment of First Amendment rights for broadcasters has been a significant step in the right direction. In 1982, I had the opportunity to express my support

for full First Amendment rights for radio and television broadcasters. As I said then, there is simply no basis under our First Amendment to distinguish between a journalist who uses a microphone and a camera, and a journalist who uses newsprint and ink. Protection for both should be equally vigorous.

The electronic press informs, educates, enlightens, and entertains. Sometimes it even gets under our skin, but that's its job, too. In 1984, we will likely see the number of television stations surpassing the number of daily newspapers in this country. Television and radio must be afforded the same Constitutional protection as other members of the press. Our current F.C.C. Director, Mark Fowler, has provided leadership and common sense in this effort.

I believe the F.C.C. has been a good regulatory institution. It's an institution of integrity, often asked to do the seemingly impossible task of regulating rapidly expanding, and sometimes unruly technologies.

And it's performed well. We've seen the F.C.C. become everything you wanted from your Government . . . and less. We've learned that sometimes, the best we can do in Washington is to get out of the way of the innovators and entrepreneurs. Mark S. Fowler and his colleagues can be proud of the job they are doing. The F.C.C. is there when it's needed -- as a cop on-the-beat, keeping the airwaves free and clear. But it's not standing as a roadblock to those who would enter the highways of service to the American people.

So, congratulations to all of you who work with and for the Federal Communications Commission, especially to the pioneers present tonight. When the F.C.C. opened its doors for business some 50 years ago, few dreamt that it would usher our country into the communications revolution of the last half century. I salute a great agency and its leadership for making good on a 50-year-old promise of service to the American people. Here's to your next 50.





decor. Items up for auction range from first-class European holidays and Caribbean cruises to stud services by the son of Secretariat.

Set in the rolling hills of B.F. Phillips' ranch north of Dallas, re-creations of historic Texas scenes will provide backdrops for the *au courant* cowboys. A 24-foot replica of Spindletop has center stage, surrounded by such Lone Star era-markers as

the Alamo and, of course, the best little Chicken Ranch in Texas. Set for the sidelines are strolling country singers, an Arabian horse show, a trick-roping demonstration and a fast-draw contest. Those who aren't amused by all this can swill their way to Margaritaville or gnaw their way to hearthurn on chicken-fried steak, tacos, fried catfish and barbecued ribs.

That all this western mad-

ness was dreamed up by Jacquelyn (Mrs. Toddie Lee) Wynne should come as no surprise to the upper social circles. Never one to do things in a small way, Jacque is known for her outlandish costume parties — the white-wreathed funeral motif for her 29th birthday; the Casablanca party for which she re-created Rick's Cafe, the seventh anniversary where she appeared in a white wig as Marilyn Monroe.

Jacque says she created the gala because she was disappointed with previous benefits for the American Cancer Society.

"It was before country-and-western was in, and frankly, I wasn't sure if it would go over. I was afraid that it might be too hokey."

Hokey or not, the affair went

over. Close to 500 people showed up for the first Cattle Baron's Ball, held at the the Wynnes' Star Brand Ranch in Kaufman.

"We were scared to spend a lot of money on it, so we got everyone to donate their time," she says. "For the first four or five balls, a group of 10 of us worked ourselves to death to do everything — we mowed the lawns, put up the decorations, swept the stage and cleaned up afterwards."

But she admits it all paid off. "The first year, we were nominated for the best function put on for the Cancer Society, but we didn't win because they felt it was too much of a regional theme, that it wouldn't work anywhere else. Two years later, we had the largest single-night fund-raiser in the country, and the Cancer Society sent down people from New York to see what we were doing. Now they're having Cattle Baron's Balls in Palm Beach and New York and all over. I didn't have any idea that first year quite what it would grow into."

When the first Cattle Baron's Ball made the social scene a decade ago, it set a new style on the charity-ball circuit. It was the first to forsake the fusty formality of hotel ballrooms for the dusty terrain of Texas ranch land. It shunned the standard seven-course cuisine for barbecued brisket and longneck Lone Stars. It compelled the elite to closet their constraining black-tie attire and cut loose in more ca-

sual cowboy garb.

Which is not to say there is anything casual about the Cattle Baron's Ball. It is the myth of Texas excess made reality, the Crystal Charity on the range. It is part Dodge City abandon and part Ewing extravagance. It is everything Hollywood ever hallucinated about the Wanton West.

And as it grew in favor with the *creme de la* cowboy, the Cattle Baron's Ball became a people-watchers' paradise, the costumes more elaborate with each passing year. Socialites took their Indian-princess fantasies to New York designers and returned in form-fitting

sequins, feathered headdresses sweeping to the ground. Others donned exotic-skin boots, intricately beaded jackets and enough sterling silver to prompt another panic.

And those who didn't get more elaborate got more daring. Gold lame and appliqued haltertops plunged lower, fringed skirts rose higher, leathered flanks were bound tighter. And they're still talking about the woman who arrived in see-through black lace with nothing but prime cuts underneath.

As the players became more outlandish, so did the playground. Professional party designers transformed pastures into stylized

western movie sets. Entertainers were imported from the cover of Rolling Stone: Willie Nelson, Tom T. Hall, Tammy Wynette, Johnny Cash. A fleet of orange helicopters deposited the stars of TV's "Dallas" at the center of the soiree scene. National Geographic shutters came West to catch the natives at a "typical" tribal function.

The auction items got more esoteric and the bull got deeper. "She usually gets what she wants," said oilman Bill Hamilton after his wife bid \$9,000 for a Texas-shaped dia-

mond. "I drill a well and she gets the money when it comes out. What she doesn't get, the government does." An equally free-spending but less flamboyant baron placed the high bid for a lunch with Larry Hagman. "I don't mind paying \$3,500 for lunch," he said, "but I would pay \$10,000 to keep my name out of the paper." (Send to Unique, c/o Herald Square.)

Each ball seems an attempt to top the last, and pulling it off demands an instinct for the theatrical and an accountant's acumen. And if Saturday night's 10th annual Cattle Baron's Ball does no less than equal last summer's gala, it will be a contender for Texas-class showmanship.

With an appropriate theme of "Big Bucks, Texas," Cattle Baron's 1982 was, as one observer put it, "a celebration of everything it means to be Texas rich."

By 7:30, chauffeur-driven limosines were bumper to bumper on the farm road leading to rancher Cloyce K. Box's spread near Frisco — the original Southfork of "Dallas." Barons paid \$1,000 a couple just to get past the gate, and some had already laid out twice that just to dress the part. From there, the big spending began.

Gamblers lined up to trade cash for chips at the craps tables. Others signed multi-thousand-dollar checks for auction items including a registered longhorn bull named Bon-Bon and a cruise aboard the Love Boat. At a general store across the drive, baronesses bought New Mexico turquoise and Navajo rugs. Cattle Baron's T-shirts at \$15 appeared to be a bargain by comparison.

The center of action was a stadium-sized barn transformed by party designer Wendy Moss into the Big Bucks Saloon. Chandeliers were installed in the rafters and turn-of-the-century mahogany bars were trucked in from Red's Antiques. Deer and boar heads covered the walls, wooden Indians guarded the cantinas, and models dressed as dance-hall hostesses waved from swings overhead.

The guests were no less luminous than the surroundings. There were bank presidents and corporate executives, oilmen and the ubiquitous "investors," real-life cattle barons, would-be barons and the merely rich. There were even some true cowboys, or at least ex-Cowboys, in the form of Roger Staubach and Charlie Waters, whose wife Rosie co-chaired the gala with Jackie Stewart and Ashley Smith. There was hotel baroness Caroline Hunt Schoellkopf in a bad-man black hat and the polo and Burger King Brinkmans, Norman and Nancy, who had her Barboglio white dress westernized by designer Milo with sequined stars and feathers.

And there were the Hollywood heavies — just about the whole cast of "Dallas." The crowd-shy Victoria Principal kept to the sidelines and denied her identity as the put-upon Pamela Ewing to anyone approaching her. Larry Hagman wore a white hat and bandana, his eyes red from allergies. Linda Gray sat at Cloyce Box's table, while Patrick Duffy and Steve Kanaly cruised through the crowds.

Outside, surreys and stage-coaches carried socialites on sightseeing tours of the ranch while the less squeamish tossed cow chips to vie for a helicopter flight to beauteous Beaver, Okla., for the national meadow-muffin fling-off.

Far past his allotted two hours, headliner Willie Nelson twanged through his greatest hits, perhaps none more appropriate than "If you've got the money, honey, I've got the time."

1983 Cattle Baron's co-chairmen Peggy Sewell and Janie McGarr seem to have put together all the ingredients to match last year's success. The 1,500 tickets for Saturday night's ball were sold out weeks in advance. The usual array of stars have been imported: Barbara Mandrell as the headline performer, Larry Hagman as a guest auctioneer, a handful of others from the Ewing clan for

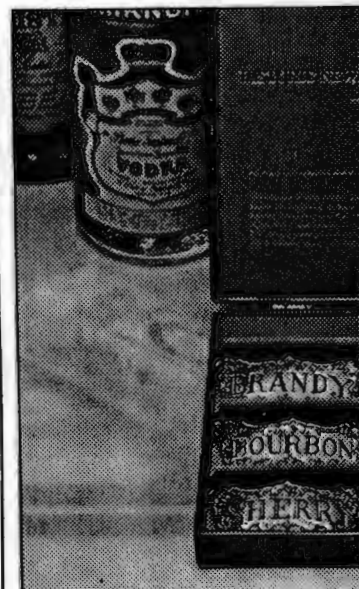

TEXAS TREAT

The food of the Southwest can be as hot as its blistering climate.

TEXANS, IT SEEMS, have their fingers in many pies. Take quiche. Wendy Moss, a Dallas-based planner of extravagant parties, dissented from the thesis of Bruce Feirstein's book, "Real Men Don't Eat Quiche," stirred up a Texas variety and produced a tasty pie as hot and spicy and macho as the Southwest itself.

When not spicing up quiches with jalapeño peppers, Miss Moss operates An Affair to Remember Inc., a company that dreams up and

executes fanciful parties. There was, for example, the "Murder in Marrekesh" soiree, which she staged in Las Vegas for the Young Presidents' Organization, complete with live camels and a sultan's tent. Or the debutante party, entitled "Get Your Kicks on Route 66," that managed to relocate the highway so that it passed through Fort Worth. Not to mention the entire Western town that she built for the Cattle Baron's Ball in Dallas.

Says Miss Moss, the 35-year-old daughter of Jane Withers, the actress, and William Moss, the oilman and film producer, her flair for the dramatic is "in my genes."

Wendy Moss's Texas quiche

- 1 pie crust, either frozen or made from scratch
- 1 7-ounce can of mild jalapeño peppers, drained
- 1 small tomato, seeded and diced
- ½ pound sharp Cheddar cheese, grated
- 4 eggs, beaten.

1. Preheat oven to 350 degrees.

2. Place the pie crust in a nine-inch pie plate. If a purchased frozen crust is used, it should not be thawed before cooking.

3. Put the peppers — seeded and cut into long, thin strips — on top of the crust. Sprinkle the diced tomato over the peppers. (There should be about twice as much pepper as tomato. For a milder version, use about a half a can of the peppers, cut into smaller pieces.)

4. Sprinkle the grated cheese over the peppers and tomato.

5. Pour the beaten eggs over the cheese.

6. Bake in the preheated oven for 30 to 40 minutes or until the eggs are set.

7. Slice into small pieces to be served as hors d'oeuvres or into larger pieces for a luncheon dish. ■
