Field Marshal Mohamed Abdel Abou Ghazala, Deputy Prime Minister and Minister of Defense and War Production of Egypt, will be visiting Washington at my invitation on 22-23 November. Considering Abou Ghazala's position and the strategic importance of Egypt in the Middle East, I recommend that you meet with him for discussions the morning of 23 November.


