EGYPT: MINING OF GULF OF SUEZ

Q. What can you tell us about press reports of a series of mining incidents in the Gulf of Suez?

A. -- We are aware of reports of explosions in the Gulf of Suez that may have been mines and are seeking details on what exactly happened.

Q. What are we doing to deal with these mine explosions? Are we taking any action to defend U.S. military and merchant shipping against this possible threat?

A. -- We are seeking details on exactly what has happened. A Notice to Mariners is being issued which states:

Mariners should exercise caution when transitting the Gulf of Suez. There have been unconfirmed reports of explosions which were possibly mines near ships in this area.

Q. Do we know who may have planted the mines?

A. -- We are seeking details on exactly what has happened.

Q. Is this an expansion of the Iran-Iraq War? Is this related to the recent events in the Gulf of Sidra?

A. -- We are seeking details on what has happened in the Gulf of Suez. It would be premature to speculate on what exactly has happened or why.

Q. Have you consulted with our allies and Congress?

A. -- We are gathering the facts and will be consulting with interested countries and with the Congress as appropriate.
