2. AS YOU ARE AWARE (REFTEL), WE ARE SERIOUSLY CONCERNED BY RECENT INTELLIGENCE WHICH MAKES IT FAIRLY CERTAIN THAT INDIA IS BEGINNING TO PREPARE A NUCLEAR TEST HOLE IN RAJASTHAN. WE BELIEVE IT IMPORTANT THAT WE URGENTLY APPROACH THE GOI TO SHARE THESE CONCERNS WITH THEM AND TO SEEK AN EXPLANATION OF THEIR ACTIVITY. THE NEED FOR A PROMPT APPROACH IS HEIGHTENED BY OUR EXPECTATION OF AN EARLY LEAK OF THIS INFORMATION. WE BELIEVE IT WOULD

BE HIGHLY PREFERABLE TO APPROACH THE INDIANS ON THIS ISSUE BEFORE IT BECOMES PUBLIC.

3. ACCORDINGLY, YOU SHOULD AT THE EARLIEST OPPORTUNITY CALL ON FOREIGN MINISTER RAO OR, IF THAT IS NOT FEASIBLE, FOREIGN SECRETARY SATHE OR SECRETARY GONSALVES. STATING THAT YOU ARE ACTING UNDER INSTRUCTIONS, YOU SHOULD MAKE

THE FOLLOWING POINTS, LEAVING THEM WITH HIM AS A "NON-PAPER". (FYI. WE RECOGNIZE THAT THE MINISTRY OF EXTERNAL AFFAIRS MAY NOT BE AWARE OF THE RAJASTHAN ACTIVITY. WE HAVE CONCLUDED NONETHELESS THAT AN APPROACH TO THE MINISTRY WOULD BE MOST APPROPRIATE. END FYI.)

4. TALKING POINTS:

-- WE WANT TO SHARE WITH YOU OUR CONCERN OVER A DEVELOPMENT WHICH COULD SERIOUSLY COMPLICATE OUR BI-LATERAL RELATIONS AND HAVE POTENTIALLY SERIOUS CONSEQUENCES IN THE REGION AND ELSEWHERE.

-- WE HAVE INDICATIONS THAT YOU ARE PREPARING ANOTHER UNDERGROUND NUCLEAR TEST SITE NEAR THE LOCATION OF YOUR 1974 EXPLOSION.

-- WE BELIEVE IT IMPORTANT THAT WE DISCUSS THIS ACTIVITY AND OUR INFORMATION ABOUT IT CANDIDLY WITH YOU. WE DID NOT WISH TO DRAW ANY CONCLUSIONS UNTIL WE HAD THE OPPORTUNITY TO DISCUSS IT WITH YOU. YOU SHOULD KNOW, HOWEVER, THAT WE BELIEVE A DECISION ON THE PART OF THE GOI TO DETONATE A NUCLEAR EXPLOSION WOULD HAVE PROFOUND CONSEQUENCES FOR REGIONAL STABILITY AND INTERNATIONAL NON-PROLIFERATION EFFORTS, AS WELL AS FOR INDO-U.S. RELATIONS.

-- WE WOULD APPRECIATE ANY LIGHT YOU CAN SHED ON THIS MATTER.
