PRESIDENT'S MESSAGE, HE SAID ALGERIA WAS WILLING TO CONTINUE ITS EFFORTS. IN ORDER TO PREVENT FURTHER DEATHS, IT WAS ESSENTIAL ISRAEL BEGIN TO RELEASE THE SHIITE PRISONERS AS IT HAD ANNOUNCED IT WOULD DO. GOA DID NOT KNOW WHY HIJACKERS RENEGED ON EARLIER AGREEMENT. ONE THEORY WAS THAT HIJACKERS HAD HEARD RADIO REPORTS OF U.S. DELTA-TYPE TEAM IN MEDITERANEAN AREA AND HAD DECIDED ALGERIA WAS NO LONGER SAFE.

3. ON RECEIPT OF REFTEL AT AIRPORT 0100 LOCAL JUNE 16, I REQUESTED IMMEDIATE MEETING WITH BENDJEDID. AROUND 0330 I WAS TOLD PRESIDENT WOULD SEE ME AROUND 0900 SAME DAY. (WE BELIEVE PRESIDENT MAY HAVE BEEN AT HIS HOUSE IN ORAN.) WHEN REPORTS WERE RECEIVED EARLY MORNING JUNE 16 THAT AIRCRAFT WAS BEING REFUELED, I CONVEYED ESSENTIAL POINTS TO PRESIDENCY CHIEF OF STAFF BELKHEIR, URGED HE PREVENT PLANE FROM LEAVING AND ASKED HE INFORM PRESIDENT BENDJEDID.

4. PRESIDENT BENDJEDID AND BELKHEIR RECEIVED ME SHORTLY AFTER NOON JUNE 16. I MADE ORAL TRANSLATION OF MESSAGE. BENDJEDID SAID ALGERIA WOULD CONTINUE TO DO ITS UTMOST. IN HIS VIEW, THE ESSENTIAL THING WAS FOR ISRAEL TO BEGIN RELEASING THE SHIA PRISONERS AS IT EARLIER HAD INTENDED TO DO. IF NOT, THERE WOULD BE FURTHER BLOODSHED AND POSSIBLE TOTAL DISASTER.

5. I INFORMED PRESIDENT OF OUR CONTACTS WITH ICRC AND ISRAEL AND HE EXPRESSED SATISFACTION. CONCERNING OUR REPEATED DEMAND GOA DETAIN PLANE IN ALGIERS AT ALL COSTS, BENDJEDID

2. DCM HOWELL SPOKE MORNING JUNE 16 WITH JEAN HOEFLIGER, CHIEF OF ICRC TEAM IN ALGIERS. HOWELL BRIEFED HOEFLIGER, WHO HE HAD KNOWN FROM BEIRUT IN 1975-1976, ON PASSENGERS BELIEVED REMOVED FROM AIRCRAFT IN BEIRUT NIGHT JUNE 14/15 AND PROVIDED LIST CONTAINED REFTEL. HE INFORMED HOEFLIGER THAT USG EXPECTED THESE HOSTAGES BE INCLUDED IN NEGOTIATIONS. HOEFLIGER TOOK LIST BUT INDICATED HE DID NOT KNOW PERSONALLY WHETHER ICRC GENEVA WOULD DISPATCH TEAM TO BEIRUT UNDER EXISTING CIRCUMSTANCES.

3. TAKING QUICK LOOK AT LIST, HOEFLIGER SAID HE WAS NEARLY CERTAIN [REDACTED] IS ON AIRCRAFT. HE RECALLED A HOSTAGE WITH WHOM HE SPOKE ON PLANE EARLY MORNING JUNE 16 TELLING HIM THAT [REDACTED] IS AMONG REMAINING HOSTAGES [REDACTED] AS HOEFLIGER RECALLS.) IN RESPONSE TO QUESTION, HOEFLIGER SAID ICRC INSISTED ON MAKING HOSTAGE COUNT. HE SAID THERE ARE 29 HOSTAGES AND 3 CREW ON BOARD AS OF JUNE 16 FOR A TOTAL OF 32 RPT 32.

4. ICRC TEAM HERE CONTACTED GENEVA BY PHONE AT ABOUT 1030 LOCAL AND WERE INSTRUCTED TO DEPART IN TEAM AIRCRAFT FOR GENEVA. ENROUTE OR IN GENEVA, TEAM WOULD RECEIVE FURTHER INSTRUCTIONS, INCLUDING POSSIBLE DEPLOYMENT TO TEL AVIV, ALTHOUGH HOEFLIGER POINTED OUT ICRC HAS ALL THE ASSITS NEEDED FOR RESUMED NEGOTIATIONS WITH GOI ON THE GROUND IN ISRAEL.
