2. WE ARE SENDING OUR PAO, ONE OF OUR POLOFFS, OUR CONTRACT-HIRE EMBASSY NURSE AND A TRSUTED LARNACA PHYSICIAN TO MEET MR. PEEL WHEN HE ARRIVES AT LARNACA AIRPORT VIA MEA 261 AT 1415 LOCAL THIS AFTERNOON. PAO WILL HANDLE THE MANY MEDIA REPS WHO WE UNDERSTAND ARE CLUSTERED AT THE AIRPORT IN ANTICIPATION OF PEEL'S ARRIVAL. GIVEN FACT THAT THERE ARE NO DIRECT OR CONNECTING FLIGHTS FROM LARNACA TO PARIS THIS AFTERNOON, WE PROPOSE TO BRING PEEL STRAIGHT FROM THE AIRPORT TARMAC TO NICOSIA, WHERE HE WILL RON IN THE AMBASSADOR'S RESIDENCE, BE ISSUED A NEW PASSPORT, AND BE DEBRIEFED BY APPROPRIATE EMBOFFS. FURTHER MEDICAL ASSISTANCE WILL ALSO BE PROVIDED, AS REQUIRED, AND WE ASSUME MR. PEEL WILL WANT TO TELEPHONE HIS WIFE AND DAUGHTER-IN-LAW AT THE HOTEL CONCORDE LAFAYETTE IN PARIS. 1. ~~(SECRET)~~ - ENTIRE TEXT)

2. THE TWA PLANE REMAINS ON THE GROUND AT BEIRUT INTERNATIONAL AIRPORT. THERE WAS RELATIVELY LITTLE ACTIVITY IN AND AROUND THE HIJACKED AIRCRAFT, AND THE HOSTAGES PROBABLY HAVE BEEN REMOVED FROM THE PLANE (SEE BELOW). THROUGHOUT THE NIGHT THE HIJACKERS REACTED TO A SERIES OF FALSE ALARMS REGARDING UNIDENTIFIED AND SUSPECTED ISRAELI FORCES APPROACHING THE COAST AND IN THE AIR OVER SOUTHERN LEBANON.

3. NATIONAL SECURITY ADVISER MCFARLANE TELEPHONED LEBANESE MINISTER OF INTERIOR NABIH BARRI URGING HIS MEDIATION IN THE CRISIS, PARTICULARLY EFFORTS TO DELINK HOSTAGE RELEASE FROM THE HIJACKERS DEMANDS. BARRI CONFIRMED HAVING RULED OUT A PROPOSED ADDITIONAL DEMAND BY HIJACKERS FOR RELEASE OF AL-DAWA PRISONERS HELD IN KUWAIT. BARRI ALSO INDICATED FOUR OF HIS OWN MEN HAD BEEN PUT ON BOARD THE PLANE, ACCOUNTING, HE BELIEVED, FOR THE LAST RELEASE OF SOME HOSTAGES IN ALGIERS.

4. BARRI SAID HE MIGHT BE ABLE TO CONVINCE HIJACKERS TO REMOVE THE REMAINING HOSTAGES FROM THE AIRCRAFT TO A "SAFE PLACE" IN BEIRUT, THUS ENDING THE SHUTTLE BETWEEN

5. ALGERIAN AMBASSADOR TO BEIRUT, ABDELKRIM GHERAIEB, IS ENROUTE FROM LARNACA, CYPRUS, TO BEIRUT; GHERAIEB IS WELL RESPECTED AND HAS WORKED CONSTRUCTIVELY AS AN INTERMEDIARY IN SIMILAR SITUATIONS.
