(S/NF) THE FOLLOWING INFORMATION WAS OBTAINED DURING 17 JUNE AM DEBRIEF OF THOSE RELEASED PASSENGERS STILL REMAINING IN PARIS; THE GROUP WITH WHOM DEBRIEFERS MET CONSISTED OF APPROXIMATELY 25-30 PEOPLE; AND FOR THE MOST PART, WERE ELDERLY INDIVIDUALS, BOTH MEN AND WOMEN. (S/NF) HIJACKER REST PATTERNS, SCHEDULES, PLACES OF REST: NO REST PATTERN WAS DISCERNIBLE ALTHOUGH IT WAS REMARKED THAT THE ORIGINAL TWO HIJACKERS WENT FOR APPROXIMATELY 20-24 HOURS WITHOUT ANY REST. UPON ARRIVAL OF THE SECOND GROUP, ONE OF THE ORIGINAL TWO APPEARED TO BE COMPLETELY FATIGUED AND STRETCHED OUT OVER 3 SEATS. AN AREA CONSISTING OF 2 TO 3 ROWS LOCATED BY THE FIRST EMERGENCY EXIT AT APPROXIMATELY ROW 12 WAS TAKEN OVER BY THE HIJACKERS AS A REST AREA IN ADDITION TO THE COMPLETE FIRST CLASS AREA WHICH WAS BEING USED AS THEIR HQ.

B. (S/NF) LOCATION OF TERRORISTS: AT ANY GIVEN TIME, THERE WERE AT LEAST FOUR HIJACKERS IN THE HOSTAGE AREA WANDERING UP AND DOWN THE AISLES. AT ALL TIMES THERE WAS ONE HIJACKER IN THE COCKPIT AREA. THE REMAINING HIJACKERS WERE IN THE "HQ AREA" MENTIONED IN A ABOVE.

- E. (S/NF) AIRCRAFT DOORS BLOCKED/SECURED: UNDETERMINED.
- F. (S/NF) TERRORIST WEAPONS: THE NEW GROUP, WHICH ARRIVED AFTER THE ORIGINAL TWO HIJACKERS, CARRIED A FULL COMPLEMENT OF MILITARY-TYPE WEAPONS: AUTOMATICS, PISTOLS, BANDOLIERS OF AMMUNITION. AND GRENADES. THE GROUP WAS HEAVILY ARMED. BUT EXACT NUMBERS WERE UNKNOWN. ONE FORMER INFANTRYMAN IDENTIFIED THE WEAPONS AS BEING OF SOVIET, AMERICAN AND ISRAELI ORIGIN AND LISTED THE FOLLOWING: A SOVIET AK-47. AN UZI SUBMACHINE GUN, A CHROME-PLATED BERETTA WITH PEARL HANDLE, A COLT-38, AND A BRITISH STEN.
- G. (S/NF) ALL PASSENGERS INDICATED THE ORIGINAL NUMBER OF TERRORISTS INVOLVED TO BE TWO: ONE PASSENGER THOUGHT THAT THERE MAY HAVE BEEN A THIRD "SLEEPER" IN THE GROUP. THE SPOKESMAN AND POSSIBLE LEADER OF THE HIJACKERS WHO BOARDED THE PLANE IN BEIRUT WAS LAST SEEN WEARING A COWBOY HAT GIVEN TO HIM BY ONE OF THE PASSENGERS. HE SPOKE ENGLISH, AND IS SAID TO HAVE TOLD SEVERAL PASSENGERS THAT HE WAS A TEACHER BY BACKGROUND. THE OTHER TERRORISTS WERE DRESSED IN QUASI-MILITARY TYPE CLOTHING.



1. SECRET ENTIRE TEXT.

- 2. THE TWA PLANE REMAINS ON THE GROUND AT BEIRUT INTERNATIONAL AIRPORT. ALL PASSENGERS ARE BELIEVED TO HAVE BEEN REMOVED FROM THE AIRPLANE AND, ACCORDING TO PRESS REPORTS, ARE HELD IN SEVERAL LOCATIONS IN WEST BEIRUT. THE STATUS OF THE CREW REMAINS UNCLEAR. REG BARTHOLOMEW IN BEIRUT REMAINS IN CLOSE CONTACT WITH AMAL LEADER NABI BARRI, MAKING CLEAR WE CONSIDER A PROMPT RESOLUTION OF THE HIJACKING TO BE HIS RESPONSIBILITY.
- 3. THE HIJACKERS CONTINUE TO DEMAND THE RELEASE OF THE PRISONERS TRANSFERRED EARLIER THIS YEAR FROM ANSAR IN SOUTHERN LEBANON TO ISRAEL. ISRAEL! OFFICIALS HAVE MADE IT CLEAR THAT IT REMAINS GOI POLICY TO RELEASE THE 700-800 FORMER ANSAR DETAINEES (MOSTLY SHIA) FOLLOWING ISRAELI WITHDRAWAL FROM LEBANON - NOW COMPLETED -DEPENDENT ON THE SECURITY SITUATION.
