1. SECRET ENTIRE TEXT.

- THE SITUATION IN BEIRUT REMAINED ESSENTIALLY UNCHANGED OVERNIGHT, ALTHOUGH THE TWA PLANE WAS MOVED TO THE WESTERN SIDE OF THE AIRPORT DURING THE NIGHT SO THAT EMBASSY OBSERVERS CAN NOW ONLY VIEW THE TAIL SECTION OF THE AIRCRAFT. THE AIRCRAFT WAS REFUELED WITH 24,000 POUNDS OF FUEL (APPROXIMATELY 2/3 FULL). REPORTS TH REPORTS THAT THE AIRCRAFT HAD UNDERGONE REPAIRS JUNE 17 WERE SUBSEQUENTLY DENIED BY MEA AND AIRPORT OFFICIALS IN CONTACT WITH EMBASSY BEIRUT. AMBASSADOR BARTHOLOMEW HAS CONTINUED HIS CONTACTS WITH NABIH BARRI AS INSTRUCTED. FURTHER REPORTS THAT THE AIRCRAFT TOOK ON EXPLOSIVES WHILE IN BEIRUT, MONITORED ORIGINALLY ON VOICE OF LEBANON, WERE ALSO DENIED BY BOTH MIDDLE EAST AIRLINES AND AIRPORT OFFICIALS. THE WHEREABOUTS OF THE PASSENGERS REMAINS UNCLEAR.
- IN PUBLIC REMARKS LAST NIGHT ISRAELI DEFENSE MINISTER RABIN SAID THAT THE RESPONSIBILITY FOR NEGOTIATIONS WITH THE HIJACKERS AND THE WELL-BEING OF THE HOSTAGES REST SOLELY WITH THE AMERICANS. RABIN REPEATED THE ISRAELI FORMULA THAT, SHOULD THE UNITED STATES APPEAL TO ISRAEL, THE CABINET WOULD DISCUSS WHETHER TO COMPLY WITH THE APPEAL. SHULTZ BT

- 2. PER REQUEST REFCONS, FOLLOWING IS SUGGESTED LANGUAGE FOR PRESIDENT'S STATEMENT.
- 3. WE CANNOT AND WILL NOT MAKE CONCESSIONS TO TERRORISTS. WE CANNOT AND WILL NOT ASK OR PRESSURE OTHER GOVERNMENTS TO DO SO. IF WE START DOWN THE PATH OF CONCESSIONS TO TERRORISTS, THERE WILL BE NO END TO IT, AND NO END TO THE SUFFERING OF INNOCENT PEOPLE, AMERICAN AND OTHERS. - 1. ADDRESSEES WILL HAVE SEEN NUMEROUS FBIS ITEMS REPORTING AMAL LEADER NABIH BARRI'S JUNE 16 PRESS STATEMENT CONCERNING THE TWA HIJACKING. THERE FOLLOWS, FYI, OUR INFORMAL TRANSLATION OF THE FULL TEXT OF THAT STATEMENT, STATEMENTS BY OTHER LEBANESE LEADERS FOLLOW SEPTEL.
- 2. BEGIN STATEMENT. "THE WESTERN MEDIA, MAINLY THE AMERICAN, TRIES TO PRESENT WHAT HAS OCCURRED, ESPECIALLY SINCE AMAL MOVEMENT HAS BECOME INVOLVED, AS A SHIITE TERRORIST ACTION. AMAL MOVEMENT THUS MAKES THE FOLLOWING CLARIFICATION:
- A. IT IS KNOWN THAT WE DID NOT INTERFERE UNTIL AFTER WE WERE ASSURED THAT THERE WOULD BE GUARANTEES FOR THE SAFETY OF THE PASSENGERS THROUGHOUT THE PERIOD OF NEGOTIATIONS, AND AS A CONSEQUENCE WE BECAME INVOLVED ABOVE ALL ELSE IN THE INTERESTS OF HUMANITY
- B. THE HIJACKERS MADE THREE DEMANDS: FIRST: THE RELEASE OF THE DETAINEES IN KUWAIT; SECOND: THE RELEASE OF THE DETAINEES IN SPAIN; THIRD: THE RELEASE OF THE PRISONERS HELD BY ISRAEL IN ATLIT. 2. (S/NOFORN) ACCOPDING TO NONE OF THE LORDANIAN SKYMARSHALS ASOLAND THE ALIA FLIGHT WERE MEMBERS OF HIS UNIT. HIS MEN HAD RECENTLY BEEN WITHDRAWN FROM SKYMARSHAL DUTY SECAUSE OF A DISPUTE HE HAD WITH THE JORDANIAN MINISTER OF TRANSPORT ABOUT THE QUALITY AND DEMEANOR OF HIS SF SOLDIERS AND APPARENTLY COMPLAINTS BY AIRLINE PASSENGERS ABOUT THEIR BEHAVOIR. SAID HE EXPECTED HIS MEN TO ACT LIKE SOLDIERS AND NOT LIKE TOUR GUIDES, THAT THE SKYMARSHALS ON THE ALIA FLIGHT WERE FROM THE PUBLIC SECURITY FORCE AND OTHER BRANCHES OF THE ARMED FORCES.

- DISCUSSED A POSSIBLE COURSE OF ACTION WHICH INVOLVED THE DEPLOYMENT OF THE 101ST SPECIAL FORCES BATTALION INTO BEIRUT AND RUSHING OF THE AIRCRAFT BY HIS REACTION TEAM. THE PLAN MAY OR MAY NOT HAVE BEEN APPROVED BY THE GOJ, BUT STATED THAT HIS ANTI-HI-JACK REACTION TEAMS HAD COMPLETED WITHIN THE PAST THREE WEEKS, EXTENSIVE DRILLS ON A 727 AIRCRAFT IN A VARITY OF SIMULATED SITUATIONS, INCLUDING A DENIED POLITICAL ENVIRONMENT.
- 4. (S/NOFORN) THE SAID FOR A SHORT TIME THE EVENING OF 16 JUNE, HE HAD PUT HIS FORCES ON ALERT AGAINST THE EVENTUALITY THAT TWA FLIGHT 847 MIGHT DIVERT TO AMMAN ON ITS TRIP BACK FROM ALGIERS. IF THE TWA FLIGHT HAD COME TO AMMAN, WOULD HAVE WELCOMED A U. S. TEAM TO "COME AND WORK WITH HIS GUYS" OR HE WOULD BE GLAD "TO TAKE OUT THE AIRCRAFT HIMSELF." HE STRESSED HOWEVER, IF THE TWA FLIGHT LANDED IN JORDAN, IT WOULD NOT TAKE OFF AGAIN.
- 5. (S/NOFORN) REGARDING THE CURRENT SITUATION IN BEIRUT, DOES NOT BELIEVE A U.S. FORCE SHOULD TRY TO "GO IN", HE SAID THE AMAL HAS MOVED IN NUMEROUS TANKS AND APC'S TO STRATEGIC PLACES AROUND THE AIRPORT.
