1. Banks Agree to Reschedule Polish Debt. The international bank task force meeting in Vienna has reached agreement on rescheduling Polish debts falling due in 1981. Terms are essentially those demanded by the banks with but one compromise: the banks agreed to defer Polish repayment of 5% of the principal falling due -- about \$150 million -- until 1982. The agreement requires the Poles to pay about \$700 million, a sum they do not have, on signing the agreement -- probably in December. We do not know how Poland will satisfy this obligation, but a senior banker reports the COMECON International Investment Bank is seeking to borrow \$100 million on the Euromarket for Poland. While the agreement may lessen uncertainties over Poland's financial crisis, banks are unlikely to extend significant new loans to Poland at this time. (C)

2. Congressional Meeting on Northern Ireland. In an afternoon meeting with Walter Stoessel, Rep. Charles Dougherty and three other Congressional members of the Friends of Ireland emphasized extreme emotions generated in their constituencies by the Northern Ireland hunger strike. They attacked the Thatcher government's position as "unacceptable" and warned that, if HMG does not show some "flexibility", moderate Congressmen would take action. Dougherty threatened to "attack" the Anglo-American relationship on every possible level including defense cooperation, aiming to force the Administration to overtly support Irish unification. Dougherty said the Friends of Ireland would continue to insist on meeting with you to register their concerns. (C)

3. Under Secretary Stoessel's Meeting with Philippine Prime Minister. Ambassador Walt Stoessel told Philippine Prime Minister Virata that we are today implementing our policy of favoring loans to the Philippines by international development banks, reversing the previous Administration's policy of abstaining on human rights grounds. Walt expressed happiness with the post-martial law political normalization process underway in the Philippines but also reiterated to Virata our continuing interest in human freedoms including the problem of military abuses in areas affected by insurgency. Virata said his government was taking steps to curtail abuses and eliminate causes of insurgency.

Virata said this was a difficult time for the Philippine economy, especially because of high world interest rates. Virata told us the Philippines continue to believe in the importance of private enterprise in promoting development, although assistance from the World Bank and similar institutions is important to infrastructure projects. 1. Meeting with Saudi Foreign Minister Saud. In a morning meeting today Saud and I had a thorough review of AWACS. Saud received a frank assessment of our chances under current circumstances as I tried to set the stage for some further movement by the Saudis which could help us in the Senate. Saud resisted the idea but did not entirely close the door. In the course of the discussions we covered the breadth and depth of our strategic relationship which extended far beyond the specific AWACS issue. In this respect I briefed Saud on my meeting yesterday with Egyptian Vice President Mubarak on the current threats to the Sudan from Libya and the dangers stemming from the recently concluded treaty among Libya, Ethiopia, and South Yemen. Saud agreed wholeheartedly with our assessments of the U.S.-Saudi relationship and of the threat posed by Libya and its new treaty partners. We agreed to keep in close touch on this issue. (S)

2. Demarche to Soviets on Biological Weapons Compliance. On October 1, the Acting Director of ACDA delivered a demarche to Soviet Charge Bessmertnykh on compliance with the Biological Weapons Convention (BWC). Acting Director Grey noted that we had strong reason to believe the Soviets are not in compliance with the BWC. Grey repeated a call for a meeting of US and Soviet technical experts to resolve these compliance concerns and also called on the Soviets to take action to prevent recurrence of incidents related to toxin use. The Soviets were warned that chances of resolving the matter bilaterally were almost exhausted and that the US was prepared to take its concerns to other fora. (S)

3. Meeting with the Foreign Ministers of Zaire and Senegal. I met in New York this morning with the Foreign Ministers of Zaire and Senegal. Both expressed heightened concern about Communist and Libyan adventurism in Africa and applauded our determination to oppose Qadhafi's destabilization efforts. The Zairian told me that the slowdown in the world economy had adversely affected Zaire's export earnings and that it was therefore unlikely that Zaire would be able to meet the end-of-year targets set by the IMF as a prerequisite for drawing down additional funds. 1. Results of the Mubarak Visit. Egyptian Vice President Mubarak's visit focused on regional security, specifically Sudan's vulnerability to Libyan subversion and/or attack. We have agreed without any commitment with the Egyptians to discuss further measures in three broad areas: (1) Early actions to deter Qadhafi--e.g., joint military exercises and political actions in international fora; (2) expedited deliveries of military equipment to Sudan, e.g., air defense equipment; (3) possible US actions in the event of hostilities between Libya and Egypt. We are examining these issues urgently, and will dispatch a State/Defense team to Cairo and Khartoum in mid-October to discuss the issue further with the Egyptians and Sudanese. Mubarak made clear that Egypt would not devote its major military effort to the Sudan if Libya attacked Sudan, but would instead attack Libya directly and keep up the military pressure until the Qadhafi regime fell. However, no imminent initiatives are being contemplated by Egypt, since the Egyptians recognize that they cannot currently launch and sustain such a major action. I emphasized our view that such action would be very imprudent at this time. (SECRET/SENSITIVE)

2. Meeting with Willy Brandt. My discussion with Willy Brandt today concentrated on two subjects--Cancun and the so-called "peace movement" in West Germany. Brandt said that he had spoken in New York with Waldheim and with several Third World Ambassadors. Their main concern seemed to be how the principles which the US has set forth could be merged with the continued desire of Third World countries to find some sort of unifying framework for North-South discussions. Brandt argued that this framework need not necessarily be described as "Global Negotiations." He added that he believed we could control any ultimate "global" process by pointing the agenda in the direction of those issues most important to the Third World such as food and energy. On the peace movement, Brandt stressed his strong belief that young people in Germany were not turning neutralist or pacifist. They were concerned about the modern world and wanted to find new solutions. Brandt noted that the health of his party (SPD) depended on its success in integrating these groups. (Confidential)

1. Havana Site for UN Conference on Trade and Development (UNCTAD) Defeated. As a result of the firm U.S. position opposing Havana as the site of the UNCTAD VI meeting in 1983, Cuba has agreed to withdraw in favor of an African site. This solution, negotiated with U.S. support by Kuwaiti Ambassador Dabbagh, Chairman of the UNCTAD Trade and Development Board meeting currently in Geneva, will be announced formally to the Board by Dabbagh by October 9. The spokesman for the African Group has informed Dabbagh that Africa will accept the responsibility to host the conference, but a site has not yet been agreed upon. Under the arrangement, the site of the 1988 UNCTAD VII meeting will rotate back to Latin America; Dabbagh will note "the desire" of Cuba to host that meeting. This does not, however, amount to an endorsement of Havana as the site can be determined only after UNCTAD VI is held. (C)

2. Moroccan Foreign Minister. I gave Moroccan Foreign Minister Boucetta a strong message of encouragement this evening to calm any nervousness which King Hassan may have in the wake of Sadat's assassination. He believes that in the wake of Sadat's death moderate Muslim countries such as Morocco, Jordan and Saudi Arabia need to stand closely together and Boucetta promised that Morocco will work for stability and moderation in the region.

Boucetta passed on a request from King Hassan to postpone his visit to Washington until after the Arab Summit which Hassan will host in November. The King believes that the burden of preparations for the Summit would be great and that the visit would be more profitable after his conclave with Arab leaders. I told Boucetta that we would work out a mutually convenient date for the King's visit. Boucetta also expressed appreciation for our support of Morocco on the Western Saharan issue. He said Morocco was now ready for a referendum of the Saharan population and was sure that it would win. He asked that we continue to support Morocco diplomatically in its efforts to solve the Saharan question; he was assured of our support. (C)

1. Walesa Visit. Lech Walesa plans to accept an invitation of the AFL/CIO to visit the U.S. and states that he wishes to meet with Al Haig and you to discuss U.S. food and financial assistance to Poland. While dates and modalities remain to be worked out, we assume Walesa will attend the AFL/CIO convention in New York November 15-19. Information on Walesa's visit will become available with the arrival next week in Washington of Andrzej Celinski, the advance man for the visit. (LOU)

2. Meetings with Foreign Ministers of Morocco and Tunisia. Al Haig met with the Foreign Minister of Morocco last night and the Foreign Minister of Tunisia early this morning. Both expressed profound regret at the loss of Sadat, and deep concern about the stability of the Middle East in the aftermath of the tragedy. Both offered to work closely with us. ✓

The Tunisians urgently appealed for improved military assistance on the basis that while threats to Tunisia are now greater, it cannot abandon domestic economic and social progress to improve its military capability. They also pleaded that we seek prompt Israeli withdrawal from the Sinai, perhaps ahead of schedule. This would constitute an early, positive success for Mubarak and help him stabilize fragile Egyptian domestic and external political positions. (S)

3. South Korean Foreign Minister Lho's Meeting with Walt Stoessel. Continuing a round of appointments, South Korean Foreign Minister Lho met with Walt Stoessel following a trip to Capitol Hill. Lho asked for U.S. assistance in normalizing Korean relations with Egypt and Pakistan. He also sought our understanding of the Korea-Japan dispute over foreign aid. Walt reaffirmed our commitment to Korean security and expressed hope for a quick resolution of Japanese and Korean differences. He congratulated Lho on the ROK's human rights performance and noted that continued improvement would help in our dealings with the Congress. Lho replied that he had received a similar message from Congressional leaders. (C)

1. Under Secretary Stoessel's Meeting with Indonesian Intelligence Chief Murdani; Kampuchea and Refugees. Walt Stoessel met today with Lt. General Murdani, Chief of Indonesian Military Intelligence, one of President Suharto's closest advisors, and the highest ranking Indonesian official to visit Washington this year. Murdani was skeptical about ASEAN efforts to create a non-communist Kampuchean resistance ("Third") force. Although a firm advocate of ASEAN unity, Murdani made clear that Indonesia does not see ASEAN's current policy of pressuring Vietnam (which we support) as an effective way of weaning Vietnam away from the Soviet Union. Instead he proposes an early "political" settlement on terms closer to Vietnam's position, to be followed by a long term ASEAN effort to reduce Vietnamese dependence on the Soviets. Murdani's assessment diverges sharply from that of the Malaysians, Thais and Singaporeans, as expressed to us by their Foreign Ministers in recent weeks. However, Indonesia is not presently disposed to break ASEAN unity on this issue. On Indochinese refugees, Murdani stressed the importance of the American leadership role in resettlement. He expressed concern that our off-take not fall below the present annual rate of about 100,000. Walt assured Murdani of our intention to continue an appropriate level of Indochinese refugee resettlement from the ASEAN countries. (S)

2. Canada: Discussions on Investment and Energy Policies. Don Regan led an inter-agency group to Ottawa today to discuss Canadian energy and investment policies. Both sides agreed to the establishment of a small, high-level committee to review the Canadian National Energy Program and the activities of the Foreign Investment Review Agency. The consultations evolved from a meeting I chaired last week involving Regan, Mac Baldrige, and Bill Brock at which we agreed to request urgent talks with Canada to demonstrate our concerns. While there is no certainty of significant changes in the Canadian position, I believe that further consultations will be useful. (C)

1. Message from King Hassan of Morocco. Moroccan Ambassador Bengelloun passed on urgent message to you from King Hassan concerning the destruction of two Moroccan aircraft flying at high altitudes over the Sahara. He sent similar messages to the UN and the OAU. The King believes that the Libyans have introduced sophisticated surface to air missiles (SAM-6 or SAM-8) into the Polisario inventory. More importantly, Hassan believes that no African personnel are able to manage these weapons, suggesting that Cuban, East German or even Soviet personnel might now be involved. Under the circumstances the Moroccans have requested a public statement from us reaffirming our support and continuing close consultations as the situation on the ground worsens. I took the occasion of my public remarks at Joe Reed's swearing in to make some appropriate comments, as did the Department's press spokesman today also in answer to questions. (S)

2. Meeting with Spanish Foreign Minister. During my meeting with Spanish Foreign Minister Perez Llorca, he informed me of the progress which has been made toward Spanish Parliamentary approval of accession to NATO. He was confident that the Parliament would approve NATO entry without pre-conditions, although there would be several guidelines for Spanish Government action within NATO once Spain is a member. Perez Llorca expressed concern that hesitations over Spanish membership on the part of some allies could be seen in Spain as a rebuff, and have a negative effect. He also referred to the Spanish application for entry into the European Community (EC), explaining that NATO and EC membership would complete the construction of a stable democracy in Spain. He is particularly worried over French opposition to EC entry, and I said we would try to be helpful. You will want to raise this with Mitterrand this weekend. Perez Llorca urged that we approve a generous security assistance program for Spain, which would demonstrate to the Spanish public the benefits of NATO membership and alliance with us. He said Spain would be a worthwhile ally and this money would be well invested. (S)

3. Meeting with Australian Ambassador on the Sinai Force. In a meeting with Ambassador Parkinson today (as a follow-up to Prime Minister Fraser's letter to you), Parkinson made the familiar arguments concerning domestic opposition to Australian participation in the Sinai Multilateral Force and Observers. I listened sympathetically but urged that the Australians retain flexibility in their position given the problems we see with British and/or Canadian participation. We plan to approach the French and the Italians again in the near future. (S)

1. Meeting with Ambassador Dobrynin. Ambassador Dobrynin called on me today with a message from Brezhnev which I have forwarded to you under separate cover. Dobrynin told me that in his debriefings of our New York meetings, Gromyko had characterized them as constructive and positive. Dobrynin said that we should now identify specific areas where we could make progress. He raised Afghanistan and I discussed the southern African situation. Dobrynin did not reject our two-track approach on Namibia. Predictably, Dobrynin also pushed on SALT, suggesting that we might be able to move quickly with a more narrow focus. We agreed to begin discussions later in the fall on the agenda for my next meeting with Gromyko. (SECRET/SENSITIVE)

2. Meeting with Senate Minority Leader, Robert Byrd. I met today with Bob Byrd to follow-up your conversation with him on AWACS. We reviewed together the cables exchanged with Riyadh. I emphasized that we had struck a good bargain, and pointed out the differences between the understandings we could talk about publicly and those which had to remain private. Byrd also quickly reviewed a draft of your proposed letter to the Senate, and promised to study it at length. Byrd said that he disagreed with the partisanship on this issue. He had asked all Democrats at their caucus yesterday to "vote their consciences" rather than follow a party line on this issue. I believe that Byrd is very important to our effort. He is probably leaning our way on the merits, but will require one last follow-up from you after we have dealt with his reaction to the draft letter. (SECRET/SENSITIVE)

3. Algerian Views on Western Sahara Fighting. On Thursday, Assistant Secretary Veliotes raised with Algerian Ambassador Malek our serious concern about the escalation of fighting between Morocco and the Polisario in the Western Sahara--especially the destabilizing effect of the introduction of advanced SAM missiles. Malek said he could deny categorically the Moroccan assertion of participation by "non-Africans," i.e., Soviets, Cubans or East Germans. Malek attributed the latest fighting to a desire on the part of the Polisario to make a "statement" on the eve of the expected UN debate on the Sahara. (S)

4. Polish Request for Agricultural Commodities. Today, the Polish Ambassador presented Under Secretary Stoessel with an official Polish request for \$740 million worth of US agricultural commodities in FY 82. He asked for special consideration in view of Poland's difficult economic circumstances, but did not specify Warsaw's terms. He also indicated that Poland would ask for further purchases of \$840 million in each of FY 83 and FY 84. Stoessel noted that the US would consider Poland's request sympathetically but stressed the need for meaningful economic reform measures in Poland. (S)

1. Resumption of SR-71 flights along North Korean Coast.
In accordance with your instruction of September 29 the Air Force will, weather permitting, resume high altitude intelligence flights Wednesday, October 21 (10:00 p.m. October 20 EDT), along tracks close to the North Korean coast. The track previously flown has been slightly modified to ensure our aircraft remains outside of the North Korean three mile limit. Ambassador Walker has informed the South Korean Government of this and of US plans to knock out the North Korean missile site before sunset in the event the North Koreans again fire at and hit our aircraft. We have also told the Koreans that in the event our aircraft is fired upon and not hit, we will reassess our options. (TOP SECRET)

2. Dutch Government Crisis. The Dutch Queen has "taken under consideration" the resignation of the five week old Van Agt Government. The three party coalition (Christian Democrats, D'66 and Socialists) came apart over the issue of Government-sponsored job creation versus reducing the ballooning national deficit. Defense policy, particularly TNF modernization, was not an issue. The Government is effectively in caretaker status until the Queen and her advisers decide whether to accept the Government's resignation, ask the coalition to reform itself, or reopen the Government formation process. (C)

3. State Authorization Bill. House Minority Leader, Bob Michel, hosted a meeting between key Republican House leaders and Deputy Secretary Clark, Under Secretary Kennedy and David Stockman. In a generally cordial meeting, it was concluded that new '82 and '83 budget numbers could probably be sold to the House Foreign Affairs Committee leadership and eventually to the full House. Minority Whip Trent Lott said the House Republicans would accept these numbers. House Foreign Affairs Committee Chairman, Clement Zablocki, is holding up all of our foreign affairs legislation until this bill is passed. Our hosts were cautiously optimistic that this could be the first step to breaking the impasse. (U)

1. SR-71 Flights in Korea. The planned resumption of SR-71 reconnaissance flights near the Korean DMZ on October 21 has been postponed until Monday, October 26, due to adverse weather (Typhoon GALE). The Rules of Engagement remain that if the aircraft is fired upon and hit, a retaliatory strike will be conducted before sunset. In the event of a miss, we will provide you with a new set of options. (TS)

2. Japanese Briefing on Arafat Visit. Japanese Ambassador Okawara called on Under Secretary Stoessel on instruction this morning to brief us on the outcome of the Arafat visit to Japan. While he said the Japanese and PLO positions voiced during the visit reflected no changes, he noted Arafat wanted Japan to persuade the US to take a more forthcoming attitude toward the PLO. Suzuki and Sonoda have been anxious to pursue discussion of the Arafat visit at Cancun with us, and we detect signs that they see some new give in the PLO position. We have attempted in Tokyo and at this meeting to disabuse the Japanese of any inclination to play a broker role, noting that we see nothing new in Arafat's remarks, and initiatives toward the PLO at this time could complicate next steps in the peace process. We have also pointed out that it will not be possible to schedule bilaterals with the Japanese at Cancun. (S)

3. Former Israeli Foreign Minister Abba Eban. Eban told me today that earlier this year he had spent two hours with Mubarak and had come away convinced that Mubarak's dedication to Camp David is real; he has not simply been following Sadat's lead. Eban said that Mubarak's creed is "Egypt above all" and that he should prove relatively immune to Arab pressure.

Eban agrees that real progress must be made in the autonomy negotiations if we are to avoid pressure for some alternative such as the Saudi "Eight Points". He was unusually upbeat about the Begin Government's flexibility, saying that it is more pragmatic than the media has portrayed. At the same time, Eban's Labor Party opposition will "spur" the Begin Government to be flexible. Eban stressed that Egypt must compromise as well -- by stopping efforts to define autonomy as statehood for the Palestinians, and "by realizing that no Israeli government will ever go back to the pre-1967 borders." (C)

1. UNGA Adopts ASEAN Resolution on Kampuchea. The General Assembly in Plenary session approved a resolution proposed by ASEAN countries on "the Situation in Kampuchea" by a vote of 100 to 25 with 19 abstentions. The vote on a similar resolution last year was 97 to 23 with 22 abstentions. The resolution calls for withdrawal of all foreign troops from Kampuchea and selection of a new government by the people of Kampuchea. The vote was a major victory for ASEAN and the West, and a firm repudiation of Vietnam's aggression in Kampuchea. (C)

2. Foreign Assistance Authorization Bill. The Senate today adopted by 51 to 45 Senator Glenn's Amendment to the Foreign Assistance Authorization Bill which will require a cutoff of all assistance to India or Pakistan should either detonate a nuclear device. Following this, the Senate adopted Senator Helms' Amendment requiring a cutoff of aid to any non-nuclear country which detonates a nuclear device.

1. Operation Bright Star '82. Final preparations are underway for the four country exercise scheduled to begin in Egypt in early November and to extend to Sudan, Somalia and Oman, ending mid-December. A DOD team is obtaining host government confirmation of specific details, including the degree to which each host government will participate with us. As currently envisaged, we plan to deploy in Egypt two reinforced Army battalions (one parachuted in), 12 A-10 ground support aircraft, RDJTF headquarters command in Cairo, and engage in a live bombing exercise with B-52s flying in from and returning to the U.S. non-stop. AWACS aircraft may assist. An unconventional warfare company will be dropped into Sudan, possibly joined by Egyptian forces, and a logistics and engineer group will be landed by roll-on, roll-off ship in Somalia. A 2000 man Marine Amphibious Unit will practice an assault on a deserted beach in Oman (perhaps Masirah Island), supported by an F-4 squadron. We are coordinating public relations guidance, keeping it very general until the host governments agree (probably on or about October 28). (S)

2. CIA Charges Against Ambassador Harry Barnes. In response to recent Indian leftist press accusations that Ambassador Harry Barnes is a CIA agent, Embassy New Delhi expressed our concern to the GOI and asked help to dispel such false allegations. GOI replied that nothing could be done at this time. GOI will likely follow the matter closely -- we do not rule out some action by it. We have also protested both in Moscow and to the Soviet Embassy here concerning repetition of the Indian press stories in Izvestiya. (C)

1. Pakistan. The second ranking official in Pakistan's Ministry of Foreign Affairs, S. Shahnawaz, visited Washington October 22 and 23 where he met with me and Jim Buckley and several key Congressmen concerned with foreign policy and our Pakistan program in particular. Shahnawaz was optimistic that this year's UN resolution on Afghanistan should get at least as many votes as last year's 111. He was pessimistic over prospects for Soviet withdrawal from Afghanistan, and saw no hope for improved U.S.-Iran relations as long as Khomeini remained in power. Shahnawaz thought that his meetings on the Hill had gone well and that he had contributed to Administration efforts to win Congressional approval of our Pakistan package. We agree. (CONFIDENTIAL)

2. Chad: Goukouni Appeals for Aid. President Goukouni of Chad has apparently refused a Libyan demand for immediate merger of the two countries and wants to break with Libya. Citing his fear of being replaced by Libyan-backed Foreign Minister Acyl Ahmat, Goukouni has launched a diplomatic offensive to several countries, making an urgent appeal for aid and an OAU peacekeeping force. The French take this very seriously. Mitterrand made an appeal at Cancun for immediate establishment of the OAU force. The French Ambassador conveyed Goukouni's request to me this morning and asked for cooperation with France on the peacekeeping force and public support for the Chadian Government. President Mobutu of Zaire has also conveyed Goukouni's appeal, and we expect other messages over the weekend. We regard the situation as urgent and are analyzing options. (SECRET)

3. Pakistan. Pakistani authorities have accused an American DEA agent stationed in Islamabad of illegally importing weapons for resale. He has been declared persona non grata and will leave Pakistan October 23. An Embassy search of his house uncovered 19 weapons; a second DEA agent may also be involved. Pakistani officials are being kept informed of the Embassy investigation and have expressed appreciation for our cooperation. While damage to our overall relations will probably be limited, future cooperation in the narcotics area could be adversely affected. It is hoped to keep the incident out of the media. (SECRET/EXDIS)

4. El Salvador. Sol Meza, accused of the murders of two American AIFLD personnel in El Salvador, was released October 22 by a Salvadoran court for lack of evidence. At the Embassy's request, Defense Minister Garcia has issued a warrant prohibiting Sol Meza from leaving El Salvador, but he may have left already. Hans Krist, also accused of the crime, remains free on bail in Miami, while a court considers a request for extradition. The AFL/CIO leadership was upset over news of Sol Meza's release, but has been somewhat reassured by Garcia's action. (CONFIDENTIAL)

1. Pakistan F-16's. Jim Buckley discussed the Pakistan F-16 sale and related matters with Clem Zablocki today. Zablocki indicated that he was prepared (a) to see Pakistan buy 40 F-16A and not press for a mix of F-X and F-16's and (b) would try to get a Presidential waiver added to the Helms Amendment, which would cut off aid to any country exploding its first nuclear device. (S)
2. Moroccan Request for Assistance. Morocco has now lost five or six aircraft attempting to put down a resurgence of Polisario activity in the Western Sahara. At least one of these aircraft was lost to a Soviet-made SAM-6 missile--the first time such a missile has been used in the conflict. We have agreed to provide Morocco with additional equipment and advice to deal with this new element and we are exploring with DOD the possibility of providing other equipment for the suppression of the SAMS. King Hassan has sent his senior Counselor to see me on Friday and has asked for General Walters to meet with him in Rabat tomorrow. (S)
3. Jamaica. Prime Minister Seaga has told our Ambassador that he plans to sever diplomatic relations with Cuba on Thursday, October 29. This move, the first break by an English-speaking Caribbean state, will be a severe blow; Jamaica was one of the first to recognize Castro's Government in 1961. Seaga's decision is based on evidence of Cuban involvement with radical elements of the opposition People's National Party. Undoubtedly, Castro will try to characterize Seaga's actions as those of a U.S. puppet. We expect the Cubans to retaliate against Seaga, probably through covert means. (S)
4. Envoy to Zaire. Dick Walters is headed for Zaire to talk with President Mobutu about growing economic and political threats to his regime. Dick will offer Mobutu an additional \$5 million in Foreign Military Sales assistance to be targeted at security in Zaire's mineral-rich Shaba heartland, an area still menaced by rebels supported by the Soviets and Cubans. Though a small sum, this money will reaffirm our interest in helping Zaire; it will enable Walters to say some hard things to Mobutu about improving Zairian economic management; and it will help us to persuade the Belgians and French to increase their efforts to rebuild the Zairian armed forces. After Dick returns, we will take a closer look at what we can do to help Zaire tow the line in economic reconstruction. (S)
5. Upgrading our Representation at the Autonomy Talks. Despite earlier indications to the contrary, the latest word from Israel and Egypt is that we need not upgrade the level of our delegation to the November 3-4 round of the autonomy talks. Walt Stoessel will therefore not be going to Cairo and our ambassadors will continue to head the U.S. team. (S)
