## MEMORANDUM FOR THE PRESIDENT

FROM: RICHARD V. ALLEN *Allen*

SUBJECT: Security Situation in Egypt

Embassy Cairo reports two, and possibly three, bombs contained in suitcases exploded at Cairo airport today as the luggage of an Air Malta flight from Tripoli (via Valletta) was being unloaded.

- o One baggage handler was killed and several wounded.
- o The bombs were reportedly powerful enough to have damaged the aircraft.
- o The airport was closed temporarily and has now reopened.
- o TWA reports that aircraft at the airport have been "dispersed."

The government has now released a statement on the incidents in Asyut. According to the statement:

- o The attacks had been organized by about 50 extremists from the "Islamic Group."
- o The attackers reportedly lost nine, with ten wounded and 37 captured.
- o The government lost 44, with 99 wounded.

The embassy is receiving conflicting reports about the situation today in Asyut.

- o The government says the situation is under control.
- o An embassy contact reports the city remains under a 24-hour curfew, both water and power have been cut off, and train, plane, and bus service to and from the city has been cancelled.
- o According to UPI, police under "shoot on sight" orders today arrested 5 Moslem extremists following a dawn shootout.

The situation in Cairo appears to be returning to normal, though security remains extremely tight. Penalties for carrying unlicensed firearms, unauthorized wearing of police or military uniforms, and for helping fugitives or withholding information from the security authorities have been increased. (U)
