1. THE EMBASSY IS REQUESTED TO DELIVER THE FOLLOWING MESSAGE TO THE EGYPT-U.S. BUSINESS COUNCIL ON THE OCCASION OF ITS MEETING IN CAIRO, MAY 11-12.

2. BEGIN TEXT.

TO THE OFFICERS AND MEMBERS OF THE EGYPT-U.S. BUSINESS COUNCIL. YOUR SEVENTH ANNUAL MEETING TAKES PLACE JUST AFTER A MAJOR, HISTORIC SUCCESS IN THE LONG AND DIFFICULT SEARCH FOR PEACE IN THE MIDDLE EAST: EGYPT'S RECOVERY OF THE SINAI, AND THE FULL IMPLEMENTATION OF THE PEACE TREATY WITH ISRAEL. THE UNITED STATES REMAINS FULLY COMMITTED TO CONTINUING ITS EFFORTS TO ASSIST ALL THE PEOPLES OF THE MIDDLE EAST TO LIVE AND PROSPER IN PEACE AND SECURITY. WITHIN THIS OVERALL CONTEXT, IT IS MORE IMPORTANT THAN EVER THAT THE EGYPT-U.S. BUSINESS COUNCIL CONTINUE ITS OWN COMMENDABLE EFFORTS TO FURTHER THE STRONG, GROWING AND MUTUALLY BENEFICIAL ECONOMIC AND

MESSAGE (CONTINUED):

COMMERCIAL TIES BETWEEN OUR TWO COUNTRIES.

MY ADMINISTRATION WELCOMES THE REITERATION OF EGYPT'S COMMITMENT TO THE OPEN DOOR POLICY, AND A ROLE FOR PRIVATE CAPITAL IN ASSISTING IN THE ACHIEVEMENT OF THE ECONOMIC GOALS OF THE EGYPTIAN PEOPLE. IN THE UNITED STATES, THE CONTRIBUTION A DYNAMIC PRIVATE SECTOR CAN MAKE TO THE GROWTH OF A FREE, HEALTHY AND STABLE ECONOMY ARE EQUALLY WELL UNDERSTOOD.
