YOUR SEVENTH ANNUAL MEETING TAKES PLACE JUST AFTER A MAJOR, HISTORIC SUCCESS IN THE LONG AND DIFFICULT SEARCH FOR PEACE IN THE MIDDLE EAST: EGYPT'S RECOVERY OF THE SINAL, AND THE FULL IMPLEMENTATION OF THE PEACE TREATY WITH ISRAEL. THE UNITED STATES REMAINS FULLY COMMITTED TO CONTINUING ITS EFFORTS TO ASSIST ALL THE PEOPLES OF THE MIDDLE EAST TO LIVE AND PROSPER IN PEACE AND SECURITY. WITHIN THIS OVERALL CONT"XT, IT IS MORE IMPORTANT THAN EVER THAT THE EGYPT-U.S. SINESS COUNCIL CONTINUE ITS OWN COMMENDABLE EFFORTS TO FURTHER THE STRONG, GROWING AND MUTUALLY BENEFICIAL ECONOMIC AND
