TALKING POINTS FOR THE PRESIDENT'S MEETING WITH RELATIVES OF HOSTAGES REUNION ARENA, DALLAS, TEXAS Friday, June 21, 1985 -- 11:30-11:40 a.m.

- -- Each of your loved ones has become a victim.
- -- But you and your families have not been singled out. Rather it is all of us together, the civilized, peace-loving people of America and the West, who are under attack.
- -- We all witnessed the bravery of Allyn Conwell and Vincente
 Garza during yesterday's press conference. I know that
 Robert Trautmann is just as strong.
- -- Please tell me of your concerns.
- -- I want to assure you that the safety of all hostages and their prompt release is a paramount concern.
- -- But I also ask you to understand that America's policy not to negotiate with terrorists cannot be compromised, or we will all face an ever-increasing terrorist threat. Our society cannot afford to let terrorism work.
- -- I would like Robert McFarlane, my National Security Adviser, to provide you with an update on the most recent developments.
- -- Be assured that we will bring your loved ones home as soon as we can.

MEETING WITH RELATIVES OF HOSTAGES

- -- EACH OF YOUR LOVED ONES HAS BECOME A VICTIM.
- -- BUT YOU AND YOUR FAMILIES HAVE NOT BEEN SINGLED OUT. RATHER, IT IS ALL OF US TOGETHER, THE CIVILIZED, PEACE-LOVING PEOPLE OF AMERICA AND THE WEST, WHO ARE UNDER ATTACK.
- -- WE ALL WITNESSED THE BRAVERY OF ALLYN
 CONWELL AND VINCENTE GARZA DURING YESTERDAY'S
 PRESS CONFERENCE. I KNOW THAT ROBERT
 TRAUTMANN IS JUST AS STRONG.
- -- PLEASE TELL ME OF YOUR CONCERNS.

- -- ASSURE YOU SAFETY OF ALL HOSTAGES AND 2 THEIR PROMPT RELEASE IS A PARAMOUNT CONCERN.
- -- ASK YOU TO UNDERSTAND AMERICA'S POLICY NOT TO NEGOTIATE CANNOT BE COMPROMISED, OR WE WILL ALL FACE AN EVER-INCREASING TERRORIST THREAT. OUR SOCIETY CANNOT AFFORD TO LET TERRORISM WORK.
- -- I WOULD LIKE ROBERT MCFARLANE, NSC ADVISER, TO PROVIDE YOU WITH AN UPDATE ON THE MOST RECENT DEVELOPMENTS.
- -- BE ASSURED THAT WE WILL BRING YOUR LOVED ONES HOME AS SOON AS WE CAN.

WHITE HOUSE SITUATION ROOM

Allyn Conwell

- -- He was elected spokesman of the hostage group and made a statement during press conference at the Beirut International Airport on June 20, 1985.
- -- Reading from prepared remarks, Conwell beseeched President Reagan and fellow Americans to refrain from military action. He said all hostages condemn hijacking and terrorism of any sort. He also called on Israelis to carry out release of the Shiite prisoners held in Israel.
- -- His wife Olga, a Greek citizen, is in Corfu with her parents. They were to have traveled together but she could not get a seat on the plane.
- -- He works for Enterra Oil Company headquartered in Muscat, Oman.
- -- His mother, brother Michael and sister Carma Little live in Texas.
- -- His mother appeared on national television the evening of June 20, 1985 giving her reactions to his appearance at the Beirut press conference.

Vincente Garza

- -- He participated in the news conference in Beirut.
- -- His wife, daughter and married daughter and her family were all aboard TWA-847 when hijacked.
- -- His wife Irma and daughter Adriana were released separately: Irma in Beirut on June 14 and daughter Adriana in Algiers on June 15.
- -- Her daughter Irma Garza Trautmann and her daughters Susan and Katherine were among the hostages released in Beirut on June 14. Son-in-law Robert Trautmann is still a hostage but did not appear at the news conference in Beirut on June 20, 1985. His wife and daughters and granddaughters returned to the United States on June 17.
- -- He reported in the press conference on June 20 that he had received necessary medication for treating colitis and was "very satisfied"
- -- He is a retail store developer in Texas.

Robert Trautmann

- -- He did not participate in the press conference in Beirut on June 10, 1985.
- -- His wife Irma Garza Trautmann and daughters Susan and Katherine were also hostages and were among the first 19 hostages released in Beirut on June 14 shortly after the hijacking took place.
- -- His father-in-law Vincente Garza is a hostage and was involved in the press conference in Beirut.
- -- He is a land developer in Texas.
