United States v. Deaver

Independent Counsel Whitney North Seymour, Jr. referred to my office twenty documents marked as government exhibits and requested that the National Security Council (NSC) certify the documents as true and accurate copies of official records.

Five of the exhibits are copies of records located in files maintained by the NSC Secretariat. The Director of the NSC Secretariat has certified that these five trial exhibits are true and accurate copies of official records. (Tab I.) You should be aware that some of the official records in the NSC Secretariat record files are themselves xerox copies of documents. As the NSC does not have an official seal, I am certifying as the NSC Legal Adviser that the Director of the NSC Secretariat has legal custody of the relevant records.

Six of the trial exhibits are copies of documents located in the These exhibits White House Office of Records Management (ORM). generally match records maintained in the ORM with minor differences. For instance, some trial exhibits are missing pages (such as routing slips) found with the corresponding ORM records. Furthermore, two trial exhibits are missing John Poindexter's initials which appear on the ORM records. Copies of documents without the initials were found in your office's files one trial exhibit includes a handwritten note from Dick Darman ("John Please see minor suggested edits attached. Thanks. Dick D. (2:00 p.m., Nov 19)") which does not appear on ORM's record copy. We were unable to find a copy of a White House or NSC document that includes the handwritten Darman note--although the memorandum on which the note is written is in ORM's files and otherwise matches the trial exhibit.

I recommend that you inform the Independent Counsel of this last discrepancy in particular and the other minor discrepancies in general. The few differences between the trial exhibits and ORM records do not appear to be substantive. I understand that you discussed this with Jock Scharfen of my office, and are of the view that Clarence Henley can properly certify that the exhibits are true and accurate copies of records in his custody. At Tab II is a memorandum in which Mr. Henley has so certified; the memorandum, which contemplates (as in the case of NSC) a parallel certification that Mr. Henley has legal custody of the relevant records, has been prepared for your signature.

The remaining trial exhibits (Tab III) that the Independent Counsel referred to this office are not copies of documents maintained in NSC record files. These documents include records of schedule for Robert C. McFarlane and a PROFS note sent to William F. Martin. A thorough search of NSC records revealed no NSC or presidential records matching these exhibits. Mr. McFarlane's former secretary indicated that the exhibits may be copies of documents in the possession of Mr. McFarlane.
