Attached at Tab A is a letter that was hand-delivered to Ty at the NSC by Mr. Jim Hickman, a consultant working with the Rockefeller Foundation. He is coordinating a meeting between former American astronauts and Soviet cosmonauts at Pocantico Hills in May. The letter to you is from former astronaut Rusty Schweickart, who has been active in promoting this sort of activities.

- -- By way of background, there is some enthusiasm among our former astronauts for this enterprise, but also a certain degree of hesitancy based on concern over White House evaluation of the project and potential political fallout. At Tab C are examples of correspondence sent to Gil Rye indicating that the astronaut community is far from unanimous on this issue.
- -- One group, led by Rusty Schweickart, is pressing for expanded cooperation, to include work toward the "First Planetary Congress" referenced in his letter. Schweickart also has his own agenda, including controversial disarmament and space schemes, that concerns many of the astronauts.
- -- Another group of more "conservative" astronauts, principally Collins, Schmitt and Cunningham, support the project, but do not wish to proceed unless they are assured that the White House is either in favor or has no objection. They fear that, given the downturn in relations, we might wish to discourage these contacts. These astronauts have serious reservations about Schweickart's motives and fear that an astronaut/cosmonaut meeting could degenerate into an election year political football.

Hickman has been in touch with State (SOV/EE) and Ambassador Hartman in Moscow, who feel that there may be some value in these meetings as a small step forward in Soviet-American relations. At the same time, they have explicitly reminded the organizers of the potential for political propaganda it represents and of the possibility of Soviet attempts to use the gatherings to promote their national security policies (such as the demilitarization of space).

In short, while we should do nothing to obstruct the meeting (this would receive maximum press play), we should also do nothing to encourage it. We feel that Jack Matlock should respond to Schweickart on your behalf, indicating that we are aware of the project and have no objections as long as the ground rules laid out in his letter are observed.

Ron Lehman and Gil Rye concur.



Dear Frank.

You are probably aware of the efforts initiated by our associates, Rusty Schweickart, Ed Mitchell and Mike Collins to establish an organization of Astronauts and Cosmonauts. The driving force is Rusty. The unifying basis for the association appears to be the unique (?) perspective on the world's problems which each of us gained in passing through that barrier to space fifty miles above the earth. The raison d'etre appears to be sharing this wisdom with the less fortunate through the process of American and Russian spacemen reasoning together, developing position papers and, if/when endorsed by a majority of those in attendance, duly publicizing them. Our relatively high media interest would guarantee broad coverage in Western news media.

The frequently stated rationale for all this is that world peace is so important that any effort to establish communications with "the other side" is worth the cost.

Then, too, there is the lure of an occasional free trip to Europe with funding sometimes provided by questionable organizations.

You are certainly capable of forming your own conclusion about the merits and inherrant dangers of accomplishing this when representatives of a monolithic bureaucracy are expected to work within an American institution — the private citizen, free-speech forum. The positive reaction among our group seems to be related inversely to the degree of activism and substance level of the proposed organization. The highest positive reaction is for a social or fraternal arrangement (the world can better solve its own problems). The lowest, for an attempt to forge collective, U.S. and Soviet space explorer positions on issues which can save humanity.

The organizers disavow any political intentions in a situation which, by its very nature is political. Unfortunately, given the particular concerns and politics of Rusty and Jim Hickman, (psychologist, fund raiser and associate of Rusty's involved from the beginning) the proposed organization is being driven towards the activist end of the spectrum. For the past twelve months I have communicated with Rusty and Ed at great lengths, hoping to avoid any scenario where an individual could be trapped in a collective political statement of any persuasion.

My concern is that our group could be naively drawn into an association which could be politically manipulated to suit the needs of an organized minority. I am beginning to believe that one of the primary motivations for establishment of the proposed organization is the platform it could provide to pursue a political agenda encompassing the peace movement, nuclear disarmament and de-militarization of space. Because of the notoriety of the participants and the left leaning causes which are likely to obtain endorsement, spokesmen for the organization could become the "darlings" of the news media. Plans are already underway to publicize the organization's affairs.

I am writing you because I believe most of us would like to see our past career association remain apolitical in nature.

This is my perception. What could or should be done?

This is one of those cases where the best defense is probably not an offense. That would only serve to generate more publicity. However, I do believe we should be prepared to counter with a public statement if such a group, claiming to represent cosmonauts and astronauts, (as opposed to the individuals involved) makes public statements with political overtones.

I have no desire to make a political statement on your behalf or of our group, collectively. My political statements are in my name only. I am equally committed to other individuals not making political statements claiming to be representative of a group to which we both belong and for which I have the greatest respect. Are you interested in being included in or endorsing a public disavowal of such statements or organizations should it become necessary in the future?

Dear Rusty:

First, let me say thank you for the invitation to attend the pre-planning meeting in New York this past weekend. I accepted because it was my first exposure to your plans regarding the Space Congress, and I wanted to be informed about the proposed meetings. Let me go on to say that, after the discussion and some personal reflection after returning home, I cannot support your group and wish to be dropped from any further discussions. I have an intuition that what you are doing can only be an embarrassment to all of us and to the United States Government. The following issues are, to me, at least, areas of deep concern and potential harm to the integrity of our group (Astronauts) and the President.

1. Press Releases and Public Statements by the "Congress":

The measures you have outlined to control the content of any public statements and press releases fairly cry of Russian dominance. They will act as a common unit with Soviet direction while our group will act as individuals without government acceptance. They will obviously have the majority vote if even one of the astronauts agrees with them. The potential divisive effect on this country is incalculable.

#### 2. Media Attraction:

If the "Congress" would act beyond the realm of media attention, there might be a glimmer of hope. Sadly, most of the astronaut group seemed to encourage media attention, leading me to suspect even the motives of our own people. The meeting in May will be a huge media event unless my suspicions are not correct. And this, in an election year with a great potential for embarrassing President Reagan.

#### 3. Timing:

Again, this is the wrong year to even contemplate such an activity with national elections ongoing. Unless President Reagan were in full accord and publicly endorsed the initiative, it would only do him great harm. I recognize that we live in a free society and that "they" can't tell us what to do, but my loyalties are with NASA and our President, and I would do nothing to tarnish my personal relationship with those entities and my own sense of patriotism.

#### 4. Political Acceptance:

I am mostly disturbed by the fact that the Russians will participate as a unified entity with the direction and concurrence of their government. It is clear that you have no meaningful dialogue with our own government, and that this group will act out of individual and personal political conviction. The results can only be perceived as a total and unrestrained willingness to espouse policies deterimental to our country.

#### 5. Affiliations:

I must admit that my initial thoughts on this subject were to go for private sponsorship. However, that did not imply a naive approach to the direction an astronaut group would take, or to a flaunting of our government, i.e., it's a free country and we can do what we want. Since I now perceive that by private sponsorship you also mean unrestrained direction, I think you play directly to the Russian hand. Also, a direct affiliation, such as the N.A.S. or the JAF, would defuse the publicity surrounding a "Congress".

#### 6. Statement of Purpose:

I am of the opinion that your statement of purpose directly impacts U.S. policy and current direction. I see no way to work with the Russians for mutual benefit because they will act in concert in making public announcements. Will the group, for instance, declare that space should not be used for nuclear testing or operations? That just might be a total disregard for U.S. policy. I don't know, but that statement of purpose certainly leaves the door wide open for public disagreement with our own government. I can't accept that. I tried to introduce a statement of purpose that focused on events so far removed from present political considerations that it just might be acceptable. I didn't even get the courtesy of a discussion on the issue. I am, therefore, honor-bound to ask the <u>real</u> purpose of this endeavor.

In summary, Rusty, maybe I am much too patriotic to engage in an activity I see as clearly dangerous to our country. In the right circumstances, with the proper support from our own government, and with the right controls to insure that the "Congress" does not become a vehicle of Soviet propaganda, it could have had some chance of succeeding. Dialogue with the Russians is important, but I cannot be party to something that will ultimately degrade my own country, or in the least promote a few individuals.

Dear Rusty:

Thank you for your letter of January 30, 1984, bringing me up-to-date on your efforts to form a 'Planetary Congress of Space Explorers.'

Rusty, I see no way that you and I are going to agree on the advisability of an effort along the lines that you describe. I do not think I am alone among our colleagues in this regard. Therefore, at the least, you must keep at a minimum any appearance that this group, if formed, has an "Astronaut" sanction.

However, my concern goes much deeper than the possibility that our apolitical stature as astronauts will be compromised by this organization. In your letter, you say,"...our intent is not political." However, I see no way that that intent can be realized in the context of your proposal. In fact, in your proposed statement of purpose enclosed with your letter, you say in the last paragraph, "It is then the intention of this organization...to meet, confer, to speak and act from this unique experience." I see no way that a group of cosmonauts and astronauts "speaking" and "acting" will not be interpreted and used as political statements in less than the "largest and highest sense of that word."

An initiative of this kind just does not seem appropriate in view of the continuing international arrogance of the Soviet Union and the largely military context in which their space program is conducted.

Now, having said all of that, I would strongly recommend that you touch base with George Mueller in order to be brought up-to-date on the

intentions of the IAF to form an astronaut-cosmonaut special section. At this time, it would seem that this could be a first step in a clearly nonpolitical context. With time, who knows what might grow from it. It is my impression that we could have almost unanimous support for the IAF initiative, whereas controversy will stalk what you are trying to do, however well motivated it may be.

Finally, Rusty, our discussions in Houston in April did not leave a very warm feeling in the minds of several who were there that your intentions were purely apolitical in attempting to form this group. I hope that we are wrong. One way to convince us is to work through the IAF, and not unilaterally with the Soviet cosmonauts, who clearly must act with the concurrence and guidance of their government.

#### Dear Dante:

I would like to take this opportunity to provide a detailed response to your July 25 and September 6 letters to President Reagan. In those letters you recommended that the issue of Andrei Sakharov be raised formally at the Stockholm CDE meeting in September and at the September meeting in Vienna on space weapons.

As you know, although film recently funneled to the Western press by the Soviets indicates that Sakharov was probably alive six weeks ago, we have no reliable independent information on his current health or whereabouts. During the last several weeks, reports have been circulating which state that Sakharov was force-fed and possibly treated with psychotropic drugs. There are also reports, as yet unconfirmed, that his wife, Yelena Bonner, has been tried and sentenced to five years of internal exile. These reports give us great cause for concern and I want to assure you that the Administration is doing everything possible to help the Sakharovs, through private as well as public diplomacy.

The President has expressed his concerns about this issue on several public occasions. Privately we have raised the Sakharovs' situation with the Soviets many times and we will continue to do so. We are also in close touch with friends and allies on this subject. The U.S. delegation raised the Sakharov case with our NATO allies at the CDE meeting last June and Ambassador Goodby circulated copies of House and Senate resolutions calling on all Helsinki signatories to protest Soviet treatment of the Sakharovs. He also raised the Sakharov issue with his Soviet counterpart. The strong Soviet reaction to these steps in Stockholm indicates that they had an impact on Moscow.

The Sakharov issue has also been a subject of extensive bilateral discussions. Last month Walter Stoessel travelled to France, Germany, Switzerland, and Denmark on a Presidential mission to discuss Soviet human rights abuses with European leaders and the situation of the Sakharovs figured prominently in these discussions. We will monitor closely the results of

these discussions. We will continue to consider carefully your recommendation that the Sakharov issue be formally raised at the CDE, particularly if we conclude as a result of our ongoing review, that such an initiative would be helpful in eliciting information about their condition or in helping to secure permission for Mrs. Bonner to travel abroad for medical treatment. Prospects for a meeting in Vienna do not appear promising at this time; however, if that situation changes, we will take careful account of your recommendation. We are also currently exploring how we can effectively mobilize international support for the Sakharovs during the forthcoming session of the United Nations General Assembly.

As Chairman of the Commission on Security and Cooperation in Europe, you may be assured that we welcome your continued interest in the Sakharov issue. I can assure you that we will continue to work with our allies and through both public and private channels to press the Soviets to allow Ers. Bonner to go abroad for medical treatment and to allow Dr. Sakharov to travel and work where he wishes, including outside the Soviet Union.

#### SUGGESTED RESPONSE

Dear Senator Hawkins:

I am replying further to your September 28 letter on behalf of Rabbi Ralph Kingsley in which he recommends President Reagan raise the plight of Soviet Jews during his discussions with Soviet Foreign Minister Gromyko.

President Reagan shares your deep concern about Soviet treatment of Jews wishing to emigrate from the Soviet Union. The issue of religious freedom in the Soviet Union, as well as the rights and welfare of those imprisoned for their religious activities, remain matters of fundamental concern to the U.S. Government. We have stressed repeatedly that these abuses constitute a major negative factor in U.S.-Soviet relations.

The President raised our human rights concerns with Foreign Minister Gromyko. The Soviets can have no misunderstanding of the importance we attach to these matters.

Dear President Reagan:

On the occasion of your imminent meeting with Foreign Minister Andre Gromyko, I would make this urgent request of you, namely that you put the issue of Soviet Jewry on the table, and specifically that you ask Mr. Gromyko to intervene on behalf of a young Russian Jew whose name is Yacov Levin, who awaits trial in Odessa following his arrest.

Several days ago I returned from Russia where I spent four days in Leningrad and four days in Moscow visiting with Refusenik families and learning first hand of their plight. While nothing that I heard was new to me, since I have been involved with the Soviet Jewry Movement for twenty years, the experience of meeting in person Refuseniks whose names and pictures had long been familiar to me was an experience that almost defies description.

During one of my evening visits I met the father of the girl to whom Yacov Levin was to have been wed - Mark Nepomnischy. Mr. Nepomnischy had come to Moscow to tell me first hand the story of his son. I enclose that story, word for word, with this letter. I ask you please to use your office and your influence to secure the release of Yacov Levin as well as the other Soviet Jews who have recently been arrested on charges that have been manufactured by the Soviet authorities. In particular I add the names of Alexander Kholmiansky and Yuli Edelshtein, both of whom are in serious difficulty. I am hopeful that you will be able to help, and would, needless to say, be extremely grateful to you if you could.

APPEAL FROM MARK NEPOMNISCHY, ODESSA, AS RECORDED ON SEPTEMBER 6, 1984 AND BROUGHT BACK TO SOUTH FLORIDA BY RABBI RALPH P. KINGSLEY, TEMPLE SINAI OF NORTH DADE, AND RABBI JEFFREY BALLON, TEMPLE EMANU-EL, FT. LAUDERDALE, FLORIDA

This is Mark Nepomnischy from Odessa appealing on behalf of Yakov Levin. I appeal to the government of Israel to help him because Yakov Levin considers himself to be a citizen of Israel and he is entitled to get help from the government of Israel. Help all Jews in Russia who want to get out of here. The ones who want to stay should be able to study their culture and their language.

I appeal to all Jews of the world to institute a day in defense of Soviet Jewry. Every Jew in the world will do something for Soviet Jews. Some will pray, some will demonstrate, but all will do whatever they can to help us. If I am arrested because I signed the same letter as did Yakov Levin, I also think I am entitled to the same help from the government of Israel.

I want the Russians to reconsider all of the old cases and there are a lot of them. You should understand here in the Soviet Union we cannot protest anything about our situation in newspapers, radio, or in demonstrations. It should be demanded from the Soviet government to get the answers to our letters about repatriation. We wrote this letter, but it is dangerous to us because we can be arrested at any time. This is why we are appealing to the Jews of the world to help us.

About Yacov Levin, he was under constant surveillance for three and a half years. Now they are incriminating him for anti-Soviet activity. This is absurd. His only activity is to be a Jew. I appeal to former prisoners of Zion who are fortunate enough to be in Israel and relatives of present prisoners of Zion to tell the world the real situation that people are serving prison terms just for their desire to be Jews. All of these trials have to be stopped.

My family has been refused for five years, during which we suffered a lot. There were three searches in my apartment. We were called to KGB several times and told to stop studying Hebrew, celebrating Jewish holidays and shabbat. Colonel Krasnov, the head of the Jewish Affairs Department of the KGB, threatened me to be introduced to Anatoly Shcharansky who is a known prisoner of Zion imprisoned for many years. He means he was going to send me to the same place, and many similar threats.

Yet what Yacov Levin was told was beyond what we were told before. When they learned that Yacov Levin wants to marry my daughter, he was told he would not marry her but he would be put in a cell with homosexuals and criminals and she would be raped in front of his eyes. It is a big risk for me, but nothing could be worse. My daughter is not allowed to emigrate, not allowed to get married. I could have kept quiet, but what will I achieve? Only the death of my family.

I beg you to help my daughter to leave, get married, and live a normal life.
