DOC formulating strategy consisting in part of resubmission of earlier Administration bills; push for hearings; and publicity campaign. Need RR to emphasize antitrust reform as key to enhanced productivity without additional capital investment.

Antitrust Division (DOJ) requests that superconductivity bill be cleared and sent up.

Intellectual Property and superconductivity proposals likely to pass (need sponsors for superconductivity). DOJ reports some possibility of passage of proposal to ease §8 Clayton Act restriction on interlocking directorship and proposal on claims reductions when plaintiff settles with one defendant. (Metzenbaum opposes claims reduction bill.)

DOJ reports de-trebeling proposal and merger proposal not likely. In interim, brief Congressmen on principles and wait for appropriate opportunity to further action.
