OPPOSE HATCH ACT REFORM

Develop method of communicating with Federal employees to explain the disadvantage of becoming subject to political pressure to join campaigns, etc.

OPM and OMB are working with leaders, Chamber, and good government groups. Governmental Affairs is working with Republican state and local political leaders. Volker Foundation may come out against (OPM indicates HHB or WW call to Volker would help).

OPM requests RR radio address to say we oppose the Hatch Act reform because of the need to maintain a non-partisan, professional civil servant corps. OPM working with local editorial writers.

OPD reports that the primary groups lobbying in favor of the bill are the right-to-life organizations and the United States Catholic Conference. Arrayed against them are Planned Parenthood, National Organization for Women, and the American Civil Liberties Union. OPD recommends we should make a major effort to mobilize evangelicals behind the bill. National Association of Evangelicals. CBN people. Jim Dobson.

OPD recommends a major speech by RR on abortion to a black evangelical church, perhaps the Reverend E.V. Hill's church in California to highlight changes in medical evidence that substantiate our moral arguments.

Again, energizing the evangelical community is essential because it is the most broadbased grassroots group, other than right-to-life. Recommendations from Range, Donatelli.
