Attendance is expected to be approximately 10,000 people including Cabinet members, White House staff, Reagan-Bush '84 staff members, and the Administration's political appointees.

TALKING POINTS -- ELECTION NIGHT REMARKS BY THE PRESIDENT

• We have won a great victory -- not for ourselves, but for America -- and we owe it to the American people to be worthy of their trust in our leadership.

• More people have voted today than ever before in our nation's history. Just a few years ago, we heard some of the gloom-and-doomers saying that our votes didn't really count -- that ordinary Americans couldn't make a difference.

Well, today there was nothing "ordinary" about the American people. They have made a difference -- they have turned this country around. We are the instruments of their will.

• Already we're hearing that there is no mandate for our leadership over the next four years, that this was a "popularity contest" or some other thing, not an American election.

Well, don't you believe it. We have only begun to rebuild America; our business is far from finished. Tonight, I am asking you -- each and every one of you -- to dedicate yourself to making these the best four years of our lifetimes -the best four years that America has yet seen.

• We do have a mandate -- for less government interference in our people's lives; for lower taxes; for helping needy Americans get back on their feet; for continuing our program of upgrading America's defenses; for strength abroad; for America as a force for peace throughout the world; for excellence in the workplace, in the classroom and in America's homes.

Our mandate comes from the people. It is not an endorsement of the status quo -- because, let's face it, we aren't as good as we can be. We chose the theme of "rebuilding America" for our campaign because it is our objective. We have had much success, but we aren't finished yet.

Government is still inefficient. High taxes and high spending still choke opportunity and hurt our economy. Crime is going down, but we must work for a safer society. We are stronger than four years ago, but not strong enough. We have spoken with the Soviets, but we must seek real arms reductions through honest negotiations.

We're on the right track, and the people have confirmed this today. But there is so much to look forward to -- and so much we have yet to accomplish. Indeed, we ain't seen nothin' yet.

America is back -- now is the time to move forward into the light of a new day of opportunity and maturity as a nation.

INTERVIEW WITH TIME, NEWSWEEK AND WASHINGTON POST

FOREIGN POLICY

We recommend that you focus on two generic foreign policy themes: <u>continuity</u> and change.

In discussing change we recommend that you tic off specific areas where U.S. influence can be brought to bear in resolving problems. However, we do not think you should go into much detail on specifics.

For example, you will be asked if you plan to name an arms control "czar" and concentrate management of the U.S. Government's arms control process in the White House. There is no need to provide your thoughts on this idea, or other possible approaches to specific problems. If asked, you could begin now to signal -- by stressing change as well as continuity -- that you have some new initiatives under consideration.

CONTINUITY

- The <u>peace and prosperity</u> we enjoy today are born of the solid policies of the past four years. <u>Peace relies on</u> strength:
 - -- <u>Militarily</u>, so that we deter aggression. We will continue to maintain our strength.
 - -- Economically, so that we have the resources to help those less fortunate, and so that the U.S. economy serves as the engine for recovery overseas.
 - -- <u>Diplomatically</u>, by preserving strong alliances which lower the costs of deterrence for all.
- o Peace also relies on a <u>willingness to negotiate differences</u> with adversaries. We will redouble our efforts to solve problems with the Soviet Union.
- o Prosperity will also require continuity:
 - -- Efforts toward freer trade -- we will seek to open a new round of multi-lateral trade negotiations and to set a firm date next year.
 - -- Efforts to solve lingering problem of <u>massive debts</u> in developing countries.
 - -- Efforts to <u>influence other countries</u> -- notably in Europe -- to adopt the policies which have served us so well here in the U.S.

CHANGE

- o We seek to bring U.S. influence to bear in resolving several of the key problems whose time has come:
 - -- Arms reductions with the Soviet Union.
 - -- Establishing a truly effective <u>non-proliferation</u> regime.
 - -- Efforts to expand our ability to help <u>developing</u> <u>countries</u>, especially through a larger and more effective foreign <u>assistance</u> program.
 - -- Efforts to forge a greater community of nations in Asia.
 - -- Efforts to influence the <u>economic renewal of Europe</u> -- they are simply not creating new jobs and they must.
 - -- Efforts to advance the peace process in the <u>Middle</u> East when the time is right.
 - -- Holding our own in <u>Central America</u> and turning the tide -- the free people of El Salvador and elsewhere are winning.
