SUBJECT: U.S.-USSR Grain Trade

Attached (Tab I) is a draft statement by the President and proposed Q's and A's on U.S.-USSR grain trade for the SIG-IEP at 4:00 p.m.

I am exploring an idea with Bob Sims to divide the President's announcement on grain into two parts. First, the President would use his Wednesday press conference to announce that although he has not made a final determination on the framework for U.S. grain sales to the USSR, he has decided not to negotiate a new long-term grain agreement. This position would be tied to Poland and highlight the consistency of his position related to the sanctions for a worldwide audience. Second, the President would use the occasion of his appearance before the Corn Growers Association on Monday, August 2, to drop the other shoe and announce the one-year extension with or without a change in the minimum. This is the appropriate domestic audience who should appreciate this concession under the circumstances. By this time, the foreign audience would have been largely disarmed and the domestic press calloused to the inevitability of an extension.

U.S.-USSR Grain Trade

Presidential Statement

I have reviewed the issue of U.S. grain trade with the Soviet Union and have decided that the U.S. will propose to the USSR a one year extension of the present grain agreement through September 30, 1983. This decision maintains our sanctions imposed on December 29, 1981, of postponing negotiation of a new long-term grain agreement while Soviet-supported repression continues in Poland.

I lifted the grain embargo, imposed by the previous Administration, in spring of 1981 because it was not having the desired effect of seriously penalizing the USSR for its brutal invasion and occupation of Afghanistan. Instead, alternative suppliers of this freely available commodity stepped in to make up for the grain which would have been normally supplied by U.S. farmers. These developments substantially undercut the tremendous sacrifices of our farmers and I vowed at that time not to impose a grain embargo unilaterally unless it was part of a general cut-off of trade between the U.S. and the Soviet Union.

Although our farmers will have a fair opportunity to export grain to the USSR on a cash or cash-equivalent basis, I continue to be unwilling to negotiate a longer-term commitment for the purchase of U.S. grain until the Soviet Union, in turn, permits the restoration of the pluralistic process and human liberties that were underway in Poland before December 1981.

U.S.-USSR GRAIN TRADE

Q: Was the President's decision to extend the U.S.-USSR Grain Agreement for one year a response to General Jaruzelski's speech on July 21 concerning the potential easing of martial law?

A: No. As you know, the present agreement expires on September 30 and the issue of how to proceed on U.S. grain sales has been before the Administration for the past several weeks. The timing of this decision should not be viewed in relation to General Jaruzelski's speech or recent developments in Poland.

Q: But isn't our policy on grain sales to the Soviet Union already linked to events in Poland?

A: Yes. The President committed not to negotiate a new long-term agreement with the Soviet Union while Soviet-supported repression continues in Poland. This decision is consistent with that position. I was stating that the timing of this decision should not be interpreted as a U.S. response to the recent announcements in Poland.

Q: Does the extension call for any change in the minimum purchase requirements?

A: No. We will propose that the agreement be extended without any changes except for the period covered. The minimum Soviet purchase requirement will remain at 6 million tons annually, with the possibility that the Soviets may purchase an additional 2 million tons without consultations with the U.S.

(If extension calls for raised minimum purchase requirement, use following bracketed answer)

[Yes. There will be a modest increase in the minimum required purchases from 6 million tons to ____ million tons with the possibility that the Soviets may purchase an additional ____ million tons without consultations with the U.S. These new limits merely update the agreement and more closely conform to the reality of the situation today with actual Soviet purchases of U.S. grain likely to be significantly higher than this new minimum. A new agreement would go much further than simply changing the limits as many new provisions would have to be negotiated while this proposed adjustment requires no negotiation with the Soviet Union.]

Q: Doesn't the President's decision to even extend the grain agreement for one year further exacerbate U.S.-EC tensions and the Europeans' claim that U.S. grain sales are inconsistent with the sanctions covering their equipment sales for the Siberian pipeline?

A: First, it should be remembered that the sanctions imposed by the President in December to respond to repression in Poland have also suspended substantial oil and gas equipment sales by U.S. companies. The U.S. grain embargo connected with the invasion of Afghanistan proved that there are sufficient suppliers worldwide of this fungible commodity (grain) to seriously weaken the impact of unilateral U.S. restraint in this area. This is not true of the sanctions on oil and gas equipment where U.S. companies hold a

technological advantage in key components making substitution extremely difficult. The second major difference between grain and the sanctions covering oil and gas equipment is that food imports absorbed about \$11-12 billion in Soviet hard currency in 1981 while the Siberian pipeline project will generate for the Soviet Union up to \$10 billion annually in hard currency when completed.

Q: Have you consulted with the allies on this announcement or will it come as another unwelcome surprise?

A: We have consulted with the allies who are aware of the President's rationale behind this decision.

Q: What is the reaction of this proposal in Europe?

A: There are probably differing views. We hope that the consistency of our position on grain sales to the Soviet Union is understood.

Q: What are the most recent projections of the Soviet harvest? Are they facing a fourth consecutive poor harvest?

A: It is difficult to predict what the harvest will ultimately look like, but there are indications that another poor Soviet harvest is in the offing, requiring the USSR to continue to import substantial amounts of grain. Estimates of Soviet grain imports range from 40-50 million metric tons in the coming year.

Q: Will the Soviets need to import U.S. grain or can they fulfill their needs from other supplier countries?

A: If our estimates are correct, the USSR will enter the U.S. market for a portion of its import quotas and/or purchase U.S. grain through third parties. We believe that extending the grain agreement makes these purchases more orderly and provides our farmers with a fair share of the grain market. Nevertheless, the Soviets are not being afforded the security and stability of a new long-term grain agreement during this period of repression in Poland.

IMPACTS OF LARGER LTA RELATIVE TO CURRENT LTA

Grain

...A larger LTA could result in an additional 4-5 million metric tons of grain exports in each of the next three crop years.

...The additional 14 million metric tons over the 3 year period would have the following average annual impacts

(1) Farm prices would be higher

Wheat +15 to +25 cents/bushel

Corn + 7 to + 9 cents/bushel

(2) Value of agricultural exports would increase by around \$1 1/2 billion per year due to increased volume and higher prices. Additional economic activity generated through other sectors of the economy would result in 25,000 more jobs per year and an additional \$1 1/2 billion in economic activity per year.

(3) Budgetary savings over the three year period could average \$1 billion per year or in excess of \$3 billion for the entire period.

In summary, over the 3 year period an agreement with larger sales levels would mean:

- (1) \$4.5 billion increase in sales
- (2) 75,000 man years of jobs
- (3) Budgetary savings of \$3 billion
