DEAR MR. PRESIDENT:

I MUCH APPRECIATE YOUR LETTER OF MARCH 15, 1984, OFFERING YOUR CONGRATULATIONS ON THE OCCASION OF THE SIGNATURE OF THE NKOMATI ACCORD.

WE TOO SEE THIS ACCORD, WHICH IS THE PRODUCT OF A SOBER AND REALISTIC VIEW OF WHAT IS BEST FOR THE COUNTRIES OF SOUTHERN AFRICA, AS A MAJOR CONTRIBUTION TO THE ESTABLISH-MENT OF PEACE AND HARMONY IN THIS REGION. WE SINCERELY HOPE THAT A TURNING POINT IN THE HISTORY OF SOUTHERN AFRICA HAS INDEED BEEN REACHED AND THAT WE SHALL HENCE-FORWARD BE ABLE TO POOL OUR RESOURCES AND ENERGIES FOR THE GOOD OF ALL WHO LIVE HERE.
