(U) ACCORDING TO THE URUGUAYAN PRESS OF AUGUST 7, PRESIDENT JULIO MARIA SANGUINETTI, DURING AN INTERVIEW WITH BOLIVIAN FOREIGN MINISTER GUILLERMO BEDREGAL, EXPRESSED URUGUAY'S "WARM AND DECIDED SUPPORT" FOR THE ANTI-NARCOTICS EFFORTS UNDERWAY IN BOLIVIA. BOTH MEN ARE CURRENTLY IN BOGOTA FOR THE INAUGURATION OF COLOMBIAN PRESIDENT BARCO, AND BEDREGAL WAS SAID TO HAVE REQUESTED AN INTERVIEW TO DELIVER SANGUINETTI A MESSAGE FROM BOLIVIAN PRESIDENT PAZ ESTENSSORO. AFTER THE MEETING, WHICH WAS ALSO ATTENDED BY FOREIGN MINISTER ENRIQUE IGLESIAS, REPORTERS WERE INFORMED THAT SANGUINETTI HAD EXPRESSED HIS TOTAL SUPPORT FOR BOLIVIA'S CURRENT EFFORT AGAINST NARCOTICS, WHICH WERE CHARACTERIZED AS AN EVIL "WHICH REQUIRES ALL OUR EFFORTS TO COMBAT IT."

2. (U) SANGUINETTI TOLD REPORTERS THAT EACH COUNTRY IS INTERNALLY SOVEREIGN AND HAS THE RIGHT TO DECIDE WHAT MEASURES ARE BEST FOR IT TO TAKE AGAINST DRUGS.

INTERNATIONALLY, HE SAID, COOPERATION BETWEEN STATES IS VITALLY NECESSARY, AND HE EXPRESSED HIS SUPPORT FOR THE MEASURES BOLIVIA HAS TAKEN AND HIS DESIRE TO COOPERATE TO THE EXTENT POSSIBLE IN HELPING THE BOLIVIANS. FINALLY, HE EXPRESSED HIS CONCERN OVER THE INCREASING NUMBER OF INCIDENTS OF DETECTION OF TRAFFICKERS USING URUGUAY AS A TRANSIT POINT.

3. (C) COMMENT: DURING A CONVERSATION WITH IGLESIAS AUGUST 1, THE AMBASSADOR MADE A STRONG PITCH FOR URUGUAYAN SUPPORT FOR "OPERATION BLAST FURNACE" (REFTEL). ALTHOUGH IGLESIAS LISTENED INTENTLY AND PROMISED TO TAKE SOME KIND OF ACTION (UNSPECIFIED) IN SUPPORT OF THE BOLIVIANS, YET MADE NO PUBLIC STATEMENT AT THE TIME, YESTERDAY'S COMMENTS BY SANGUINETTI SUGGEST THAT THE MESSAGE STRUCK HOME.

1. (LOU) SUMMARY: THE HIGHLIGHT OF THE AUGUST 6 INAUGURAL SESSION OF THE BOLIVIAN CONGRESS FOR THE 1986-1987 LEGISLATIVE CYCLE WAS PRESIDENT PAZ ESTENSSORO'S SPEECH TO THE CONGRESS IN WHICH HE REVIEWED THE FIRST YEAR OF HIS PRESIDENCY. PAZ STRONGLY DEFENDED HIS ECONOMIC PROGRAM AND CALLED ON THE BOLIVIAN PEOPLE TO MAKE FURTHER SACRIFICES. HE ALSO REAFFIRMED HIS COMMITMENT TO STRENGTHENING DEMOCRACY AND RIGOROUSLY DEFENDED HIS DECISION TO

CONFIDENTIAL

CALL ON U.S. HELP IN THE "LIFE AND DEATH" STRUGGLE AGAINST DRUG TRAFFICKING. VICE PRESIDENT JULIO GARRETT'S EFFORT, ON THE OTHER HAND, LACKED FOCUS AND, WITH ITS "NEW WORLD ECONOMIC ORDER" BIAS, SEEMED MORE APPROPRIATE FOR A MEETING OF THIRD WORLD NATIONS.

LEFTIST MINI-PARTIES REFUSED TO STAND UP FOR OR APPLAUD PAZ ESTENSSORO AND WILL STEP UP THEIR AMTICS WITH CALLS FOR THE PRESIDENT'S IMPEACHMENT OR RESIGNATION FOR ALLOWING U.S. TROOPS ON BOLIVIAN SOIL. NEVERTHELESS, PAZ'S TOUGH AND COURAGEOUS PUBLIC STAND HAS REAFFIRMED HIS DETERMINATION TO PREVAIL IN WHAT HE BELIEVES TO BE THE RIGHT COURSE FOR BOLIVIA. HIS AGENDA AS OUTLINED IN HIS SPEECH CLOSELY COINCIDES WITH THE REALIZATION OF KEY U.S. GOALS HERE: ECONOMIC DEVELOPMENT, STRENGTHENING DEMOCRACY, AND FIGHTING DRUGS. END SUMMARY.

- 2. (U) THE BOLIVIAN NATIONAL CONGRESS HELD ITS FIRST CEREMONIAL SESSION AUGUST 6 TO INAUGURATE THE 1986-1987 LEGISLATIVE CYCLE. THE REGULAR SESSION BEGINS AUGUST 11. AS IS CUSTOMARY, THE FIRST ORDER OF BUSINESS WAS THE PRESIDENT'S REVIEW OF THE PAST 12 MONTHS -- THE EQUIVALENT OF A "STATE OF THE UNION" SPEECH. VICE PRESIDENT GARRETT, IN HIS CAPACITY AS PRESIDENT OF THE CONGRESS, ALSO ADDRESSED THE JOINT SESSION. GARRETT'S MEANDERING ATTACK ON THE INDUSTRIALIZED NATIONS AND HIS CALL FOR A REVITALIZED NEW WORLD ECONOMIC ORDER SEEMED OUT OF PLACE AND MORE THAN A BIT POLITICALLY OPPORTUNISTIC. IN ANY EVENT, THE STAGE BELONGED TO THE PRESIDENT WHO, DESPITE A LACKLUSTER PRESENTATION, MADE THE MOST OF IT SUBSTANTIVELY.
- 3. (U) PAZ'S LESS THAN ELECTRIFYING SPEECH TOOK OVER ONE HOUR TO DELIVER AND AT TIMES SEEMED TO GET LOST IN A MORASS OF ECONOMIC DETAIL. MANY COMMENTATORS HAVE REACTED TO HIS "BORING STYLE" RATHER THAN THE SUBSTANCE OF WHAT HE HAD TO SAY. NEVERTHELESS, PAZ MADE DECISIVE AND POSITIVE COMMENTS ON SUCH KEY U.S.-BOLIVIAN BILATERAL ISSUES AS ECONOMIC DEVELOPMENT, STRENGTHENING DEMOCRACY, AND COMBATING NARCO-TRAFFICKING.

ECONOMIC PROGRAM DEFENDED

- 4. (U) IN HIS SPEECH PAZ:
- . -- SINGLED HIS ECONOMIC RECOVERY PROGRAM OUT AS AN IMPORTANT ACHIEVEMENT OF HIS FIRST YEAR OF RULE;
 - -- ARGUED THAT THE ECONOMIC PROGRAM IN LESS THAN

A YEAR HAD REDUCED INFLATION FROM 11,750 PERCENT TO 92 PERCENT AND HAD PROVIDED STABILITY TO THE PESO:

- -- STRESSED THE NECESSITY FOR RATIONALIZING BOLIVIA'S ECONOMY, WHICH HIS GOVERNMENT SOUGHT BY PASSING A BUDGET AND TAX LAW REFORMS:
- -- NOTED THAT WHILE SIGNIFICANT GAINS HAD BEEN MADE, THERE WAS STILL A LONG WAY TO GO AND THAT MORE SACRIFICES WOULD BE NECESSARY.

FOREIGN POLICY TO SERVE ECONOMIC PROGRAM

- 5. (U) IN HIS REMARKS ON FOREIGN POLICY, PAZ REAFFIRMED:
- -- BOLIVIA'S COMMITMENT TO A NON-ALIGNED FOREIGN POLICY THAT OPPOSED COLONIALISM, RACISM AND SUPPORTED DIALOGUE, EQUALITY, AND SELF-DETERMINATION;
- -- THE IMPORTANCE OF TALKS WITH CHILE ABOUT BOLIVIAN ACCESS TO THE SEA;
- -- HOWEVER, PAZ QUICKLY MOVED FROM THESE ISSUES TO A DISCUSSION OF THE CENTRAL GOAL OF BOLIVIA'S FOREIGN POLICY -- INCREASED ECONOMIC COOPERATION THROUGH THE UNITED NATIONS EMERGENCY ASSISTANCE FUND AND THROUGH INCREASED BILATERAL ARRANGEMENTS. PAZ PAINTED A PICTURE OF BOLIVIAN OFFICIALS COMBING THE WORLD IN THE SEARCH FOR MONEY OR WHAT HE MORE OBLIQUELY CALLED: "STRENGTHENING ECONOMIC AND COOPERATION RELATIONS IN ORDER TO INCREASE AND INTENSIFY THE CURRENTS OF INVESTMENTS AND SUPPORTING DEVELOPMENT AND COOPERATION FOR THE IMPLEMENTATION OF A NEW ECONOMIC POLICY."

STRENGTHENING DEMOCRACY

6. (U) PAZ NOTED THAT HIS DEMOCRATICALLY ELECTED GOVERNMENT IS AN EXPRESSION OF THE BOLIVIAN PEOPLE'S

DESIRE TO LIVE IN A DEMOCRACY AND THAT AS SUCH HIS RESPONSIBILITY IS TO PRESERVE AND NOURISH THAT ASPIRATION.

- . -- HE STRESSED THAT DESPITE THE COUNTRY'S "SEDITIOUS HISTORY," BOLIVIANS NEED TO "LIVE IN KEEPING WITH DEMOCRATIC RULES."
- -- PAZ ALSO STRESSED THE IMPORTANCE OF THE "PACT FOR DEMOCRACY" THAT HIS PARTY HAD SIGNED WITH THE OPPOSITION NATIONALIST DEMOCRATIC ACTION (ADN) PARTY. HE PRAISED THE PACT AS BEING ABLE TO "PROVIDE DEMOCRACY WITH A FIRM FOUNDATION" AND "TO ACHIEVE A REASONABLE STABILITY IN THE RESTLESS WORLD OF POLITICS FOR THE GOOD OF ALL BOLIVIANS."

JOINT ANTI-DRUG TRAFFICKING EFFORTS DEFENDED

7. (U) PAZ SPENT A SIGNIFICANT PART OF HIS SPEECH JUSTIFYING DECISIONS TO GO AFTER DRUG TRAFFICKERS AND TO CALL ON U.S. HELP IN THIS CAMPAIGN. HE TRACED A NUMBER OF BILATERAL AND MULTILATERAL PRECEDENTS, A TOUGH ANTI-NARCOTICS STANCE AND INVOKED POPE JOHN PAUL II'S DESCRIPTION OF DRUG USE AS A "NEW SLAVERY" AND CALLED FOR A "FRONTAL WAR" AGAINST THIS "SCOURGE." HE SAID THAT BOLIVIA'S LOSS OF RESERVES OF 50 MILLION DOLLARS SINCE THE START OF THE NARCOTICS OPERATION ON JULY 15 INDICATED AN URGENT NEED FOR A

ONE HUNDRED MILLION DOLLAR LINE OF "BACKUP" CREDIT TO FORESTALL A PANIC RUN ON BANKS. HE ALSO SUGGESTED THAT THE PRICE OF COCA LEAVES HAD DROPPED TO THE POINT WHERE GROWERS WOULD BE READY TO ACCEPT RESETTLEMENT TO GROW ALTERNATIVE CROPS (E.G. SOY BEANS IN SANTA CRUZ).

SACHS SAID THE GOVERNMENT WOULD REQUIRE AN ESTIMATED 200 TO 400 MILLION DOLLARS FOR RESETTLEMENT COSTS INCLUDING AGRICULTURAL CREDIT FOR SETTLERS AND INFRASTRUCTURE DEVELOPMENT. END SUMMARY

(S) ON AUGUST 7 HARVARD PROFESSOR AND BOLIVIAN GOVERNMENT ECONOMIC ADVISOR JEFFREY SACHS, ACCOMPANIED BY MINISTRY OF FINANCE SUB SECRETARY RAMIRO ORTEGA, DISCUSSED WITH EMBASSY AND USAID OFFICERS THE UPCOMING TRIP TO WASHINGTON ON AUGUST 12 OF MINISTER OF PLANNING GONZALO SANCHEZ DE LOZADA AND MINISTER OF FINANCE JUAN CARIAGA. THE MINISTERS CURRENTLY HAVE SCHEDULED APPOINTMENTS WITH SECSTATE SHULTZ, TREASURY SECRETARY BAKER AND WHITE HOUSE CHIEF OF STAFF REGAN, PRESUMABLY MADE BY THE BOLIVIAN EMBASSY IN WASHINGTON. SACHS SAID THAT THE BOLIVIAN GOVERNMENT AT THIS MOMENT FEELS THAT IT MUST ACT DECISIVELY TO SHORE UP DOMESTIC CONFIDENCE IN ITS FINANCIAL STABILITY AND TO CARRY OUT THE ANTI-DRUG OPERATION TO ITS ULTIMATE CON-CLUSION, INCLUDING RESETTLEMENT OF 250,000 TO 300,000 PEASANTS NOW GROWING COCA IN THE CHAPARE. THE GOVERNMENT BELIEVES THAT CHAPARE PEASANTS MAY SOON BE READY TO DIG UP THEIR COCA PLANTS AND

SEEK OTHER OPPORTUNITIES IF THEY EXIST. (FYI-BOLIVIA'S MAJOR AGRICULTURAL PLANTING SEASON IS IN OCTOBER-NOVEMBER. IN THIS CONTEXT, CHAPARE FARMERS ON THE VERGE OF GIVING UP COCA WILL HAVE TO OPT QUICKLY FOR ALTERNATIVE ECONOMIC ACTIVITIES. END FYI) USAID DIRECTOR COHEN OBSERVED THAT STUDIES INDICATED THAT MOST CHAPARE COCA GROWERS ARE TRANSIENTS WHO HAVE LEFT THEIR FAMILIES AND PREVIOUS ECONOMIC BASE BEHIND AND WHO WOULD NOT NECESSARILY HAVE TO BE RELOCATED IF THEY WERE DEPRIVED OF A PROFITABLE

DEVELOPING A SANTA CRUZ RELOCATION EFFORT, SACHS REFERRED TO THE CASE OF PARAGUAY, WHERE THE ENGINE OF GROWTH FOR A DECADE HAS BEEN SOY BEANS, STATING THAT SOYA ALSO COULD BE ONE OF BOLIVIA'S BEST HOPES FOR FUTURE EXPORTS. HE EMPHASIZED THAT THIS IS A CRUCIAL MOMENT TO ACT BECAUSE NEW PLANTINGS WILL BE UNDERTAKEN WITHIN A COUPLE OF MONTHS. (EMBASSY COMMENT: SACHS' REFLECTION OF THE PLANNING AND FINANCE MINISTERS ON THE CURRENT SUSCEPTIBILITY OF CHAPARE COCA GROWERS' WILLINGNESS TO VACATE THE CHAPARE IS PROBABLY PREMATURE. IT DOES REFLECT, HOWEVER, THE LOGIC OF THE GOVERNMENT'S "BLAST FURNACE" INTERDICTION STRATEGY THAT IF THE PRICE OF COCA BELOW PRODUCTION COSTS CAN BE SUSTAINED FOR A LONG ENOUGH PERIOD, TRANSFER OUT OF COCA INTO ALTERNATIVE CROPS WILL BE EASIER TO EFFECT. THE IMPORTANT ASPECT OF SACHS' OBSERVATION IS THAT THE GOVERNMENT HAS BEGUN THINKING ABOUT THE POLITICAL POSSIBILITIES OF EXTENSIVE ERADICATION. CHAPARE'S PREDOMINANTLY TRANSIENT POPULATION CAN BE PERSUADED, THROUGH A COMBINATION OF LOW COCA PRICES AND ALTERNATIVES, TO VACATE THE CHAPARE, IT WOULD APPEAR THE GOVERNMENT IS PREPARED TO ERADICATE THE REMAINING COCA. END COMMENT)

4. (S) WITH REGARD TO THE REQUEST FOR THE HUNDRED MILLION DOLLAR LINE OF CREDIT, SACHS REMAINS CONVINCED THAT THE KEY TO CONTINUED ECONOMIC STABILITY IS TO MAINTAIN EXCHANGE RATE STABILITY. ALTHOUGH HE

SECRET

CONCEDED THAT THE PESO IS OVERVALUED AND THAT DEVALUATION WOULD BE SENSIBLE FROM A PURELY ECONOMIC STANDPOINT, IN A POLITICAL/ECONOMIC SENSE IT WOULD BE DISASTROUS FOR THE GOVERNMENT. NOT ONLY WOULD IT DESTROY THE PAINSTAKING EFFORT TO REBUILD CONFIDENCE, BUT ALSO IT WOULD BE SEEN AS A DIRECT RESULT OF THE ANTI-NARCOTICS OPERATION. BASED ON THE SUCCESS OF THE ANTI-INFLATION PROGRAM TO DATE, SACHS BELIEVES THAT INFLATION CAN BE BROUGHT DOWN TO ZERO AND THAT THE PESO CAN STABILIZE AT THE PRESENT RATE (PRIMARILY THROUGH CONTROL OF MONETARY EMISSIONS AND THE GOB FISCAL DEFICIT).

5. (S) SACHS SAID THAT BOLIVIA HAS LOST 50 MILLION DOLLARS IN RESERVES SINCE THE START OF THE NARCOTICS

OPERATION. HE BELIEVED THAT WHILE NOT PROBABLE A PANIC RUN ON THE BANKS COULD HAPPEN AT ANY MOMENT AND THAT SUCH A PANIC WOULD BE THE ONE SINGLE EVENT THAT WOULD BE DISASTROUS TO THE ONGOING ECONOMIC STABILIZATION PLAN. SACHS SAID THAT NO ONE KNOWS IF THE CENTRAL BANK WILL CONTINUE TO LOSE THREE MILLION DOLLARS IN RESERVES A DAY (DURING THE LAST TWO WEEKS CENTRAL BANK DAILY AUCTIONS HAVE AVERAGED 2.2 MILLION DOLLARS PER DAY).

- 6. (S) FYI: THIS MEETING WITH SACHS WAS REQUESTED BY GOB TREASURER FERNANDO KEMPH. KEMPH INDICATED THAT PART OF SANCHEZ DE LOZADA'S AND CARIAGA'S WASHINGTON AGENDA WOULD BE TO REQUEST THE SCHEDULING OF A MEETING BETWEEN PRESIDENT PAZ AND REAGAN. THIS SUBJECT WAS NOT REPEAT NOT RAISED BY SACHS. END FYI.
- 7. (S) EMBASSY COMMENT: IN A SIGNIFICANT WAY, SACHS' COMMENTS INDICATE THAT THE BOLIVIAN GOVERNMENT ECONOMIC TEAM MAY BE MOVING FROM A POSITION OF RESENTMENT TO ACCELERATION OF NARCOTICS CONTROL ACTIVITIES TO COMBAT THE THREAT TO THE SUCCESS OF THE RECOVERY PROGRAM AND TO UNDERTAKE A MORE CONSTRUCTIVE EFFORT TO CONSOLIDATE AND COORDINATE EFFORTS TO ACHIEVE BOTH NARCOTICS AND ECONOMICS OBJECTIVES. IF THIS IS SO, THE EMBASSY CONSIDERS THIS TO BE A VERY POSITIVE DEVELOPMENT. END COMMENT.

IN THIS CONTEXT, WE URGED THAT THEIR PRESENTATION AND REQUESTS BE MADE AS SUBSTANTIVE AND REALISTIC AS POSSIBLE. HOPEFULLY, HE UNDERSTOOD AND TRANSMITTED THE ADVICE ACCURATELY AND WITH EFFECT. END COMMENT.
- 9. (S) AT A CENTRAL BANK BREAKFAST FOR CHIEFS OF MISSION HOSTED BY THE FINANCE MINISTER, A SIMILAR BUT LESS SPECIFIC CASE WAS MADE FOR THE NEED FOR INCREASED BILATERAL AND MULTILATERAL ASSISTANCE. MINISTER JUAN CARIAGA PRESENTED THE HISTORY OF BOLIVIA'S ECONOMIC REFORM PACKAGE OVER THE PAST YEAR OF THE PAZ ESTENSSORO GOVERNMENT AS A PROLOGUE TO THE ECONOMIC IMPLICATIONS OF OPERATION BLAST FURNACE.

THE DRAW DOWN ON CENTRAL BANK DOLLAR RESERVES, THE ULTIMATE NECESSITY OF RESETTLING COCA FARMERS IN PRODUCTIVE AREAS FOR CROPS SUCH AS SOYA, BOLIVIA'S NEED TO "REINVENT" A NEW EXPORT SECTOR, ALL IMPOSED THE GREATEST NEED FOR IMMEDIATE ASSISTANCE SINCE THE GOVERNMENT HAD "GONE IT ALONE" ON ECONOMIC REFORM IN AUGUST 1985. TO EMPHASIZE THE NARCOTRAFFICKING THREAT, AND IN A SPIRIT OF CANDOR NOT LOST ON THE WEST EUROPEAN COMS, CARIAGA STATED THAT THE GOB'S ESTIMATE WAS THAT SOME 50 PERCENT OF THE CENTRAL BANK'S CURRENT RESERVES REPRESENTED NARCO DOLLARS. (EMBASSY COMMENT: WHILE THE EMBASSY'S ESTIMATE WOULD BE CLOSER TO 30-40 PERCENT, THIS IS THE FIRST TIME A MAJOR GOB PLAYER HAS UTTERED A PUBLIC COMMENT. END COMMENT). CARIAGA INDICATED THAT THE PAZ ESTENSSORO GOVERNMENT REGARDED THE DOMESTIC THREAT OF NARCOTICS AND NARCOTRAFFICKING AS SUFFICIENTLY DIRE THAT THEY HAD PLUNGED INTO THE CURRENT INTERDICTION EFFORT KNOWING FULL WELL THE POLITICAL AND ECONOMIC RISKS THEY WERE RUNNING, BUT HOPED THE NATIONS REPRESENTED AT THE BREAKFAST WERE EQUALLY DETERMINED TO CONFRONT NARCOTRAFFICKING TO ASSIST BOLIVIA IN ITS "HOUR OF NEED".

(EMBASSY COMMENT: SACHS' REFLECTION OF THE PLANNING AND FINANCE MINISTERS ON THE CURRENT SUSCEPTIBILITY OF CHAPARE COCA GROWERS' WILLINGNESS TO VACATE THE CHAPARE IS PROBABLY PREMATURE. DOES REFLECT, HOWEVER, THE LOGIC OF THE GOVERNMENT'S "BLAST FURNACE" INTERDICTION STRATEGY THAT IF THE PRICE OF COCA BELOW PRODUCTION COSTS CAN BE SUSTAINED FOR A LONG ENOUGH PERIOD, TRANSFER OUT OF COCA INTO ALTERNATIVE CROPS WILL BE EASIER TO EFFECT. 4. (S) WITH REGARD TO THE REQUEST FOR THE HUNDRED MILLION DOLLAR LINE OF CREDIT, SACHS REMAINS CONVINCED THAT THE KEY TO CONTINUED ECONOMIC STABILITY IS TO MAINTAIN EXCHANGE RATE STABILITY. ALTHOUGH HE

SERET

CONCEDED THAT THE PESO IS OVERVALUED AND THAT DEVALUATION WOULD BE SENSIBLE FROM A PURELY ECONOMIC STANDPOINT, IN A POLITICAL/ECONOMIC SENSE IT WOULD BE DISASTROUS FOR THE GOVERNMENT. NOT ONLY WOULD IT DESTROY THE PAINSTAKING EFFORT TO REBUILD CONFIDENCE, BUT ALSO IT WOULD BE SEEN AS A DIRECT RESULT OF THE ANTI-NARCOTICS OPERATION. BASED ON THE SUCCESS OF THE ANTI-INFLATION PROGRAM TO DATE, SACHS BELIEVES THAT INFLATION CAN BE BROUGHT DOWN TO ZERO AND THAT THE PESO CAN STABILIZE AT THE PRESENT RATE (PRIMARILY THROUGH CONTROL OF MONETARY EMISSIONS AND THE GOB FISCAL DEFICIT).

5. (S) SACHS SAID THAT BOLIVIA HAS LOST 50 MILLION DOLLARS IN RESERVES SINCE THE START OF THE NARCOTICS

OPERATION. HE BELIEVED THAT WHILE NOT PROBABLE A PANIC RUN ON THE BANKS COULD HAPPEN AT ANY MOMENT AND THAT SUCH A PANIC WOULD BE THE ONE SINGLE EVENT THAT WOULD BE DISASTROUS TO THE ONGOING ECONOMIC STABILIZATION PLAN. - 8. (S) EMBASSY COMMENT: THIS MISSION TOOK GREAT EFFORT TO EXPLAIN TO SACHS THE U.S. BUDGET-RELATED DIFFICULTIES THAT SANCHEZ DE LOZADA AND CARIAGA ARE LIKELY TO ENCOUNTER IN WASHINGTON. IN THIS CONTEXT, WE URGED THAT THEIR PRESENTATION AND REQUESTS BE MADE AS SUBSTANTIVE AND REALISTIC AS POSSIBLE. HOPEFULLY, HE UNDERSTOOD AND TRANSMITTED THE ADVICE ACCURATELY AND WITH EFFECT. END COMMENT.
- 9. (S) AT A CENTRAL BANK BREAKFAST FOR CHIEFS OF MISSION HOSTED BY THE FINANCE MINISTER, A SIMILAR BUT LESS SPECIFIC CASE WAS MADE FOR THE NEED FOR INCREASED BILATERAL AND MULTILATERAL ASSISTANCE. MINISTER JUAN CARIAGA PRESENTED THE HISTORY OF BOLIVIA'S ECONOMIC REFORM PACKAGE OVER THE PAST YEAR OF THE PAZ ESTENSSORO GOVERNMENT AS A PROLOGUE TO THE ECONOMIC IMPLICATIONS OF OPERATION BLAST FURNACE.

THE DRAW DOWN ON CENTRAL BANK DOLLAR RESERVES, THE ULTIMATE NECESSITY OF RESETTLING COCA FARMERS IN PRODUCTIVE AREAS FOR CROPS SUCH AS SOYA, BOLIVIA'S NEED TO "REINVENT" A NEW EXPORT SECTOR, ALL IMPOSED THE GREATEST NEED FOR IMMEDIATE ASSISTANCE SINCE THE GOVERNMENT HAD "GONE IT ALONE" ON ECONOMIC REFORM IN AUGUST 1985. TO EMPHASIZE THE NARCOTRAFFICKING THREAT, AND IN A SPIRIT OF CANDOR NOT LOST ON THE WEST EUROPEAN COMS, CARIAGA STATED THAT THE GOB'S ESTIMATE WAS THAT SOME 50 PERCENT OF THE CENTRAL BANK'S CURRENT RESERVES REPRESENTED NARCO DOLLARS. (EMBASSY COMMENT: WHILE THE EMBASSY'S ESTIMATE WOULD BE CLOSER TO 30-40 PERCENT, THIS IS THE FIRST TIME A MAJOR GOB PLAYER HAS UTTERED A PUBLIC COMMENT. END COMMENT). CARIAGA INDICATED THAT THE PAZ ESTENSSORO GOVERNMENT REGARDED THE DOMESTIC THREAT OF NARCOTICS AND NARCOTRAFFICKING AS SUFFICIENTLY DIRE THAT THEY HAD PLUNGED INTO THE CURRENT INTERDICTION EFFORT KNOWING FULL WELL THE POLITICAL AND ECONOMIC RISKS THEY WERE RUNNING, BUT HOPED THE NATIONS REPRESENTED AT THE BREAKFAST WERE EQUALLY DETERMINED TO CONFRONT NARCOTRAFFICKING TO ASSIST BOLIVIA IN ITS "HOUR OF NEED".

SUMMARY -----

- 1. (C) IN A HISTORICAL CONTEXT THE STATE OF SIEGE INVOKED BY THE PAZ ESTENSSORO GOVERNMENT ON AUGUST 28 HAS BEEN RELATIVELY BENIGN. THUS FAR IT HAS PROVOKED LESS OVERT DEFIANCE FROM LABOR, STUDENTS AND THE RADICAL LEFT THAN MIGHT HAVE BEEN EXPECTED. CALLED IN RESPONSE TO A POTENTIALLY SEROUS CHALLENGE BY THE ULTRA-LEFT LED BOLIVIAN LABOR CENTRAL (COB), THE CIRCUMSTANCES THAT PROVOKED THIS STATE OF SIEGE NEVERTHLESS DIFFER MARKEDLY FROM THOSE THAT TRIGGERED A SIMILAR MEASURE A YEAR AGO.
- 2. (C) IN 1985 LABOR AND THE RADICAL LEFT CHALLENGED THE NEW PAZ ESTENSSORO GOVERNMENT AND ITS AUSTERE, FREE-MARKET ORIENTED ECONOMIC POLICY FROM A POSITION OF RELATIVE UNITY AND ECONOMIC STRENGTH IN A BOLD ATTEMPT TO PRESERVE THE PRIVILEGED POLITICAL AND ECONOMIC POSITION THEY HAD ENJOYED OFF AND ON SINCE 1952 AND PARTICULARLY UNDER THE SILES ZUAZO ADMINIS-TRATION (1982-85), THIS CHALLENGE PROVIDED PAZ WITH A TAILOR-MADE OPPORTUNITY TO CONSOLIDATE HIS POWER --

AND DEMONSTRATE THAT HIS GOVERNMENT REPRESENTED A REAL CONTRAST TO THE IMMEDIATE PAST.

- 3. (C) THE MOOD IN 1986, HOWEVER, IS ONE OF DESPERATION, PARTICULARLY AMONG THE EMPLOYEES OF THE STATE MINING CORPORATION (COMIBOL) WHO ARE FIGHTING FOR SURVIVAL. THEIR EFFORTS TO FORCE THE GOVERNMENT TO RESPOND TO THEIR DEMANDS -- INCLUDING THE RECENT MARCH ON LA PAZ -- GAVE EXTREMIST ELEMENTS IN THE COB LEADERSHIP AN IDEAL OPENING TO PURSUE THEIR POLITICAL AGENDA. THIS IN TURN ENHANCED THE STANDING OF THOSE ELEMENTS IN A FACTIONED AND WEAKENED COB.
- 4. (C) CONGRESS IS CURRENTLY DELIBERATING WHETHER TO RATIFY THE STATE OF SIEGE. SIMULTANEOUSLY REPRESENT-ATIVES OF THE MINERS AND THE GOVERNMENT ARE MEETING UNDER CHURCH AUSPICES TO TRY TO RESOLVE WHAT APPEAR TO BE IRRECONCILABLE DIFFERENCES. THE OUTCOME OF BOTH DELIBERATIONS IS UNCERTAIN AND THE POTENTIAL FOR SERIOUS LEFT-LED CHALLENGE TO THE GOVERNMENT REMAINS HIGH. WE ARE WORKING WITH USAID ASSETS ON SEVERAL PROGRAMS THE BOLIVIAN GOVERNMENT IS READYING TO ALLEVIATE THE MINERS' SITUATION WITHOUT UNDERMINING THE BASIC PRINCIPLES OF THE ECONOMIC RECOVERY PROGRAM. END SUMMARY.

THE CRUX OF THE PROBLEM

- 5. (C) PRODUCTION AT MOST COMIBOL MINES IS PARALYZED BECAUSE OF LOW MINERALS PRICES. SOME MINES ARE CLOSED AND MANY OTHERS ARE SLATED TO SHUT DOWN UNDER THE RECENTLY ANNOUNCED REORGANIZATIOM PLAN FOR COMIBOL (REF B). THE PLAN, WHICH PROVIDES FEW ALTERNATIVES FOR IDLE, SOON-TO-BE-UNEMPLOYED MINERS BEYOND A VAGUE "CO-OPERATIVIZATION" OF THE LEAST PRODUCTIVE MINES, INCREASED ANTI-GOVERNMENT ATTITUDES DURING THE RECENT MINERS MARCH.
- 6. (LOU) LABOR'S POSITION IS AMBIVALENT AND IGNORES ECONOMIC REALITY. MANY MINERS BELIEVE THAT THE GOVERNMENT SHOULD CONTINUE TO SUBSIDIZE THE BANKRUPT COMIBOL TO PROTECT THEIR JOBS AND THEIR STANDARD OF LIVING. ALTERNATIVELY, SOME ARE DEMANDING THAT ALL OF THE CORPORATION'S PROPERTIES AND ASSETS BE TURNED

OVER TO THE WORKERS, NOT JUST THE MARGINAL MINES AS ENVISAGED IN THE REORGANIZATION PLAN. THIS, OF COURSE, WOULD DEPRIVE THE GOVERNMENT OF ONE OF ITS MOST IMPORTANT SOURCES OF FOREIGN EXCHANGE. UNDER PRESENT CIRCUMSTANCES THIS IS UNTHINKABLE, AND EVEN UNDER OPTIMUM ECONOMIC CONDITIONS WOULD LIKELY REPEAT THE FAILURES OF THE PAST.

NO ALTERNATIVES

7. (C) LABOR'S DEMANDS FOR ADEQUATE SALARIES AND GREATER SECURITY, WHILE NOT UNREASONABLE IN A MORE NORMAL CONTEXT, FAR EXCEED THE GOVERNMENT'S ABILITY TO DELIVER. THE GOVERNMENT SIMPLY DOES NOT HAVE THE RESOURCES TO CONTINUE THE COSTLY SUBSIDIZATION OF COMIBOL. EVEN IF IT DID, TO DO SO WOULD BLATANTLY CONTRADICT PAZ ESTENSSORO'S FREE-MARKET, PRIVATE SECTOR-ORIENTED ECONOMIC POLICY. WHILE THE GOVERNMENT CANNOT BE BLAMED FOR REFUSING TO SPEND MONIES THAT IT DOES NOT HAVE TO KEEP COMIBOL AFLOAT FOR A FEW MORE MONTHS. IT HAS NOT MOUNTED A CREDIBLE PLAN OR EFFORT TO PROVIDE UNEMPLOYED MINERS WITH A VIABLE ALTERNATIVE TO WORKING IN COMIBOL. THE SITUATION OF MOST OF THE 15,000 STATE-EMPLOYED MINERS SLATED FOR DISMISSAL AND THEIR FAMILIES IS INCREASINGLY DESPERATE. FOR TECHNICAL AND SOCIO-CULTURAL REASONS IT IS DIFFICULT FOR THEM TO MIGRATE TO THE TROPICAL EASTERN LOWLANDS AND START AFRESH IN AGRICULTURE. MANY DO NOT HAVE ANCESTRAL LANDS TO RETURN TO, OR IF THEY DO THESE LANDS ARE TOO POOR TO PROVIDE THE STANDARD OF LIVING TO WHICH THE URBANIZED MINE LABOR FORCE HAS BECOME ACCUSTOMED.

WHATEVER MIGRATION THAT HAS OCCURRED HAS BEEN SPONTANEOUS TO ARGENTINE AND CHILEAN LABOR CENTERS. WITH NO GOVERNMENT SUPPORT (REF C).

LEFTIST OPPORTUNISM

- 8. (C) LEFTIST POLITICANS WERE QUICK TO INSTIGATE AND TAKE ADVANTAGE OF THE INCREASINGLY DESPERATE RESPONSES OF THE MINERS, WHICH SNOWBALLED UNTIL THE GOVERNMENT INVOKED THE STATE OF SIEGE ON AUGUST 28. UNLIKE 1985, THE COB, ALTHOUGH WEAKENED AND DIVIDED, IS NOW IN THE HANDS OF EXTREMISTS LIKE WALTER DELGADILLO, WHO LEADS THE RADICAL, VIOLENCE-PRONE "EJE" FACTION. THEIR AGENDA IS OF COURSE MORE THAN SIMPLY ECONOMIC. THEIR FUNDAMENTAL OBJECTIVE IS TO OVERTHROW THE PAZ ESTENSSORO GOVERNMENT AND CREATE THE CONDITIONS FOR THE WORKER/PROLETARIAN MILLENIUM, EVEN THOUGH THE CONCEPT IS AS FUZZY TO THEM AS IT IS TO THE REST OF US.
- 9. (C) MEANWHILE VETERAN COB LEADER JUAN LECHIN -- WHO OFTEN HAS USED HIS LONG RELATIONSHIP WITH PRESIDENT PAZ ESTENSSORO TO MODERATE LABOR CONFLICTS -- IS OUT OF THE COUNTRY. LECHIN WOULD NOT/NOT NECESSARILY BE A HELP THIS TIME AROUND, HOWEVER, BECAUSE HE HAS BEEN IN BED WITH THE "EJE" FOR SEVERAL MONTHS AS PART OF THIS STRUGGLE WITH THE COMMUNISTS FOR CONTROL OF THE COB.

PROSPECTS WORRISOME

10. (C) BOTH LABOR AND THE GOVERNMENT HAVE MOMENTARILY

STEPPED BACK FROM THE BRINK. UNDER CHURCH AUSPICES THEY ARE DISCUSSING THEIR DIFFERENCES. A GOVERNMENT SPOKES-MAN INDICATED ON SEPTEMBER 3 THAT THE COMIBOL REORGAN-IZATION PLAN IS NOT YET CASE IN CONCRETE, LEAVING OPEN THE POSSIBILITY OF MINOR CONCESSIONS TO THE WORKERS. CHURCH SPOKESMEN, AS EXPECTED, ARE OPTIMISTIC. SUCH MODIFICATIONS AND THE BEST OF GOODWILL ON BOTH SIDES. HOWEVER, WILL NOT BRIDGE THE GAP BETWEEN THE TWO EXTREME POSITIONS, AND PROSPECTS FOR THE OUTCOME ARE DISCOURAGING.

11. (C) AT THE SAME TIME, CONGRESS IS CURRENTLY DEBATING WHETHER TO RATIFY THE STATE OF SIEGE. THE GOVERNMENT/ ADN (NATIONALIST DEMOCRATIC ACTION) MAJORITY COULD EASILY OVERRIDE LEFTIST OBJECTION TO THE STATE OF SIEGE AND WILL PROBABLY DO SO IN LIGHT OF RISKS OF ULTRA-LEFT INSPIRED FUTURE UNREST. UNLIKE THE 1985 STATE OF SIEGE, WHICH EXPIRED UNEVENTFULLY, THE CURRENT SITUATION DEMANDS THAT THE GOVERNMENT COME UP WITH SERIOUS PROPOSALS AND PROSPECTIVE SOLUTIONS TO THE MINERS' PLIGHT BY THE END OF 90 DAYS (THE DURATION OF A STATE OF SIEGE). CONGRESS MAY BE WILLING TO GIVE PAZ THREE MONTHS BREATHING SPACE, BUT COULD BE RELUCTANT TO GIVE HIM MORE. THIS OBVIOUSLY PLACES AN ENORMOUS BURDEN ON AN UNDER-FUNDED, UNDER-STAFFED GOVERNMENT FACED BY MANY OTHER SERIOUS PROBLEMS, INCLUDING NARCOTICS TRAFFICKING.

12. (C) IF THE GOVERNMENT FAILS TO PROVIDE SOLUTIONS, LABOR AND THE FAR LEFT WILL HAVE FEW OPTIONS. ONE EXTREME STEP WOULD BE TO SEIZE AND "CO-OPERATIVIZE" STILL-VIABLE COMIBOL OPERATIONS IN DEFIANCE OF THE NEW REORGANIZATION PLAN. ANOTHER COULD BE THE GRADUAL INFILTRATION OF LARGE NUMBERS OF MINERS AND THEIR DEPENDENTS INTO LA PAZ, FOLLOWED BY MASSIVE, PROBABLY VIOLENT ANTI-GOVERNMENT DEMONSTRATIONS. THE ODDS ARE JUST AS GOOD, HOWEVER, THAT THE MINERS WILL FOLLOW THE EXAMPLE OF MANY OTHER HARD-PRESSED BOLIVIANS, EMIGRATING TO ARGENTINA AND OTHER NEIGHBORING COUNTRIES IN SEARCH OF WORK OR MIGRATING TO SANTA CRUZ AND THE EASTERN LOWLANDS.

13. (C) DESPITE THE RELATIVE CALM NOW, TENSIONS ARE LIKELY TO CONTINUE AT A HIGHER LEVEL THAN WAS THE CASE IN 1985. THE GOVERNMENT IS CRANKING UP PUBLIC WORKS AND CONSTRUCTION (INCLUDING LOW-INCOME HOUSING) EFFORTS WITH THE MEAGER AVAILABLE RESOURCES TO TRY TO RELIEVE PRESSURE IN THE HARDEST HIT MINING COMMUNITIES.

DEFENDING U.S. INTERESTS

14. (C) WE (USAID) ARE WORKING WITH THE GOVERNMENT IN THIS EFFORT, AND ARE MAKING AVAILABLE ESF LOCAL CURRENCY COUNTERPART FUNDS AND PL 480 RESOURCES TO RELIEVE THE PRESSURE OF MINING SECTOR LAYOFFS. A NEW WAVE OF MIGRATION TO POTENTIAL COCA-GROWING AREAS OR A SERIOUS ULTRA-LEFT CHALLENGE TO THE PAZ ESTENSSORO GOVERNMENT -- BOTH REAL POSSIBILITIES IF THE MINERS GET NO HELP -- WOULD SIGNIFICANTLY DAMAGE U.S. INTERESTS AND OBJECTIVES.

Military Support for Drug Operation in Bolivia ______ (Operation BLAST FURNACE)

Operation BLAST FURNACE was developed at the request of the Bolivian government. Operations began on July 18th. The Department of Defense has provided transportation, communications, and intelligence support to the Bolivian national police. US efforts are coordinated by the Drug Enforcement Administration and the US Embassy in La Paz.

There are approximately 180 Army and Air Force personnel, six Blackhawk helicopters, and one C-130 transport aircraft in Bolivia. To date, Bolivian National Police have inspected 32 suspected drug processing/transshipment areas. Seven active processing labs and two transshipment storage sites have been destroyed. In addition, according to USSOUTHCOM, BLAST FURNACE has provided excellent training for US troops operating from austere staging bases located far from normal supply depots.

Operation BLAST FURNACE has produced more immediately positive anti-narcotics results for the US in Bolivia than any initiative undertaken before. Major and intermediate narcotrafficking elements have either fled Bolivia or gone into hiding. For example, during the first week of BLAST FURNACE, a surge of 250 Bolivians entered Panama and some 600 Bolivians fled to Paraguay. While the nature of the operation made it unavoidable that many traffickers themselves would flee the country and shut down processing operations, the seizure of seven hydrocloride laboratories and associated equipment (vehicles, airplanes, generators, power tools, etc.) has stopped the weekly production of over six tons of drugs from these laboratories alone. The cocaine production process in Bolivia has effectively ground to a halt.

BLAST FURNACE has served as a catalyst within Bolivian society forcing many heretofore sideline players, such as the armed forces, to face seriously the narcotics issue. On the public scale, it has given rise to numerous editorials, newspaper articles, and radio and television programs, not all positive about the operation, but virtually all discussing the problems of trafficking and addiction in serious terms. While no formal Bolivian public opinion polls are available, general public reaction appears supportive of the government's decision.

The US Ambassador has asked that BLAST FURNACE be extended until November, 1986, when the rainy season begins. We expect a request from Bolivia for additional resources to sustain a long-term Bolivian campaign against drug processing and trafficking.

SUMMARY

2. FROM THE AMEMBASSY LA PAZ VIEWPOINT, OPERATION "BLAST FURNACE," IN CONJUNCTION WITH INM-SUPPORTED EFFORTS IN THE CHAPARE, HAS BEEN A VIRTUALLY UNQUALIFIED SUCCESS TO DATE IN BOLIVIA IF JUDGED AGAINST THE INITIAL EXPECTATIONS, AS OPPOSED TO THE FREQUENTLY VAUNTED MEDIA EXPECTATIONS. IT HAS GROUND COCA-PROCESSING IN THE COUNTRY TO A HALT AND DISRUPTED THE ENTIRE DEVELOPMENT CHAIN FROM THE PRICE OF COCA LEAVES (CURRENTLY AT AN ALL-TIME LOW AND BELOW THE COST OF PRODUCTION TO THE CULTIVATOR) THROUGH PASTE AND HYDROCLORIDE PROCESSING AND FINAL EXPORT OF HCL OUT OF BOLIVIA. IF SUSTAINED INDEFINITELY. THE OPERATION HOLDS FORTH THE FURTHER PROSPECT OF EVENTUAL ERADICATION OF COCA ITSELF AS THE CULTIVATOR CAMPESINOS ARE ULTIMATELY FORCED BY ECONOMIC PRESSURES TO SEEK ALTERNATIVE AND LEGAL

3. FACED WITH WHAT IT REGARDED AS AN UNACCEPTABLE POLITICAL LIABILITY OF CONFRONTING COCA-GROWING CAMPESINOS WITH THE PROSPECT OF FORCED ERADICATION, THE BOLIVIAN GOVERNMENT APPROACHED THE EMBASSY AND USG-WASHINGTON IN 1985 ABOUT AN ALTERNATIVE STRATEGY TO ACCOMPLISH THEIR OWN AND U.S. ANTI-NARCOTICS POLICY GOALS. THE STRATEGY AIMED AT A SUSTAINED DISRUPTION OF COCA PROCESSING IN BOLIVIA WITH THE OBJECTIVE OF A SIGNIFICANT REDUCTION IN THE EXODUS OF COCAINE INTO U.S. MARKETS AND THE MAINTENANCE OF A BELOW-COST-OF-PRODUCTION PRICE FOR COCA LEAVES THAT WOULD EVENTUALLY LEAD CAMPESINOS OUT OF COCA AND INTO LESS ATTRACTIVE BUT LEGAL AND SUSTAINABLE CROP ALTERNATIVES. THE STRATEGY WAS, HOWEVER, IMPOSSIBLE UNLESS THE BOLIVIAN GOVERNMENT GAINED ACCESS TO THE REQUIRED AERIAL MOBILITY IN THE VAST LABORATORY AREA OF THE BEN! DEPARTMENT WHERE THE BOLIVIAN NATIONAL POLICE HAD NEVER BEEN ABLE TO MOUNT A SUSTAINED INTERDICTION OPERATION. BOLIVIAN INTERIOR MINISTER BARTHELEMY FIRST RAISED THE MATTER WITH THE U.S. IN THE FALL OF 1985 WHEN HE REQUESTED HELICOPTER SUPPORT.

4. THE U.S. POLICY DECISION ON A ROLE FOR THE U.S. ARMED FORCES IN DRUG INTERDICTION WAS A PREREQUISITE TO ACCEPTANCE OF THE BOLIVIAN GOVERNMENT'S INVITATION TO PARTICIPATE IN "BLAST FURNACE." THE DURATION OF

THE U.S. MILITARY SUPPORT OPERATION WAS FORESEEN AS LIMITED AND FINITE; THE ONLY ROLE WAS TO PROVIDE TRANSPORTATION SUPPORT; AND IT WAS NOT PLANNED AS A REHEARSAL FOR FUTURE OPERATIONS (REF A).

THE BOLIVIAN GOVERNMENT COMMITMENT

5. PRESIDENT PAZ ESTENSSORO AND HIS GOVERNMENT ARE NOW TOTALLY COMMITTED TO A "WAR TO THE FINISH" AGAINST DRUG TRAFFICKING AND DRUG-DESTINED COCA CULTIVATION. THEY EMBARKED ON THIS DECISION WHEN BT

THEY AGREED TO OPERATION "BLAST FURMACE." THE ECONOMIC AND POLITICAL FALLOUT FROM "BLAST FURNACE" COMPOUNDS OTHER PROBLEMS WHICH, ON THEIR OWN, HAVE BEEN DRIVING THE GOVERNMENT TO ENTERTAIN THE POSSIBILITY OF A STATE OF SEIGE. THE BOLIVIAN GOVERNMENT TO ENTERTAIN THE UNITED STATES AS A PARTNER IN ITS ANTI-DRUG EFFORT AND HAS SENT THE CURRENT DELEGATION OF ITS FOREIGN AND PLANNING MINISTERS TO THE UNITED STATES TO DISCUSS THE COLLATERAL ISSUES TO "BLAST FURNACE" (REF B):

- . -- HELP TO GET THROUGH THE THREAT TO THE ECONOMIC RECOVERY PROGRAM THAT THE ANTI-DRUG CAMPAIGN HAS PRODUCED IN THE FOREIGN EXCHANGE MARKET (REF C);
- . -- RESOURCES NECESSARY TO SUSTAIN FOR A LONG PERIOD THE ANTI-NARCOTICS CAMPAIGM AND THE COCA ERADICATION EFFORT;
- . -- AND MECHANISMS TO ACCELERATE FOREIGN
 DEVELOPMENT ASSISTANCE TO ALLEVIATE ANTICIPATED
 PROBLEMS IN ECONOMICALLY RESETTLING FORMER COCA
 GROWERS.
- 6. THE SUSTAINMENT,
 "BLAST FURNACE" AND THE USG'S ADDRESSING THE
 COLLATERAL CONCERNS ARE ESSENTIAL IF WE WANT TO AVOID

SENDING SUCH WRONG SIGNALS AS: NON-COMMITMENT BY THE U.S., EAVING THE GOB AT RISK AFTER ITS ALREADY HAVING PAID A SIGNIFICANT POLITICAL COST FOR INVITING U.S. SUPPORT, AND PUTTING THE NARCO-TRAFFICKERS IN A MUCH MORE DOMINANT POSITION THAN THEY OCCUPIED FEFORE THE INCEPTION OF "BLAST FURNACE" (REF D). ANY PREMATURE WITHDRAWAL OF U.S. SUPPORT-ASSISTANCE WOULD RESULT IN AN ALMOST CERTAIN DISCONTINUITY IN THE OVERALL CONTROL EFFORT IN BOLIVIA AND RETURN TO "BUSINESS AS USUAL" FOR THE TRAFFICKERS, THUS UNDERMINING THE BOLIVIAN GOVERNMENT'S OWN CONTROL-RELATED CREDIBILITY AND THEREFORE ITS FUTURE ABILITY TO ACT, AND IS A MAJOR CONSIDERATION. AMEMBASSY LA PAZ'S STRATEGY CONSIDERATIONS FOR A CONTINUATION OF "BLAST FURNACE" HAVE BEEN SENT TO ADDRESSEES SEPTEL (REF E).

RESULTS OF "BLAST FURNACE" TO DATE

- 7. THE CURRENT ONGOING OPERATION "BLAST FURNACE"

H S AND WEST FUROPEAN MARKETS.

-- OPERATION "BLAST FURNACE," TARGETED AGAINST COCAINE HYDROCHLORIDE PROCESSING LABS IN BOLIVIA'S BENI DEPARTMENT, HAS BEEN COMPLEMENTED BY COORDINATED ACTIONS OF BOLIVIA'S NARCOTICS STRIKE FORCE POLICE IN THE CHAPARE AND YUNGAS COCA GROWING REGIONS. THE RESULT HAS BEEN A GIGANTIC MONKEY WRENCH IN THE ACTIVITIES OF BOLIVIAN NARCOTICS PRODUCERS AND TRAFFICKERS NATIONWIDE. CLOSING DOWN THE HYDRO-CHLORIDE LABS HAS SHARPLY REDUCED THE DEMAND FOR COCA PASTE THAT IS THEIR-RAY MATERIAL. IN THE MONTH OF JULY ALONE 941 KILOS (APPROXIMATELY 2, 000 POUNDS OR ONE TON OF PASTE) WERE SEIZED. THIS, IN TURN, HAS UNDERCUT THE MARKET FOR COCA LEAVES AND CAUSED THE PRICE OFFERED FOR CHAPARE AND YUNGAS COCA LEAF TO PLUMMET BELOW PRODUCTION COST (CURRENT LEAF PRICE FOR A "CARGA" OR 100 POUNDS HAS BEEN AVERAGING AROUND 20 TO 25 DOLLARS AS CONTRASTED WITH THE ESTIMATED PRODUCTION COST OF 35 TO 40 DOLLARS). THIS DRUG LEAF PRICE CONTRASTS SHARPLY WITH THE PRE-BLAST FURNACE OPERATION PRICE OF 100 TO 120 DOLLARS PER HUNDRED WEIGHT. IN THE PAST FEW YEARS THIS PRICE HAS BEEN AS HIGH AS 700 DOLLARS. THE FARMERS WHO GROW COCA ARE CONFUSED AND APPREHENSIVE. ACCUSTOMED TO ANNUAL PROFITS AVERAGING AS MUCH AS 10,000 DOLLARS PER HECTARE, THEY ARE NOW UNABLE TO COVER EVEN LABOR COSTS FOR HAND-HARVESTING OF THEIR COCA. MANY HAVE BEGUN TO CALL AT USAID-SUPPORTED BOLIVIAN AGRICULTURAL

EXTENSION OFFICES IN THE CHAPARE TO ACQUIRE SEEDS AND PLANTS FOR ALTERNATIVE CROPS. COCA PASTE PROCESSORS IN THE CHAPARE, EXPECTING TO RIDE OUT THE STORM BY PRODUCING AND STORING COCA PASTE UNTIL THE HEAT IS OFF, HAVE BEEN HIT HARD BY NARCOTICS STRIKE FORCE (UMOPAR) POLICE UTILIZING A SMALL BOLIVIAN GOVERNMENT HELICOPTER TO LOCATE AND DESTROY LABS. NEW UMOPAR POSTS WERE ESTABLISHED AT THREE LOCATIONS IN THE YUNGAS IN EARLY JULY, WHICH HAVE HELPED TO REDUCE ILLEGAL ACTIVITY IN THIS SECOND MOST IMPORTANT BOLIVIAN COCA PRODUCING REGION. NATIONWIDE SEIZURE TOTALS OF BOLIVIAN NARCOTICS POLICE ARE CURRENTLY AT AN ALL-TIME HIGH, LEADING TO NET REDUCTION IN THE AMOUNT OF COCAINE HYDROCHLORIDE AVAILABLE FOR EXPORT FROM BOLIVIA.

-- OPERATION "BLAST FURNACE" HAS SERVED AS A CATALYST WITHIN BOLIVIAN SOCIETY FORCING MANY HERETOFORE SIDELINE PLAYERS SUCH AS THE ARMED FORCES TO SERIOUSLY FACE THE NARCOTICS ISSUE. DN A BROADER PUBLIC SCALE, IT HAS GIVEN RISE TO A PLETHORA OF EDITORIALS, COLUMNS, ARTICLES, AND RADIO AND TELEVISION PROGRAMS, NOT ALL POSITIVE ABOUT THE OPERATION, BUT VIRTUALLY ALL DISCUSSING THE PROBLEMS OF TRAFFICKING AND ADDICTION IN SERIOUS TERMS. USIS PLACEMENT ON NARCOTICS HAS INCREASED SUBSTANTIALLY IN THE BOLIVIAN MEDIA. EVEN MORE ENCOURAGING HAS BEEN THE APPEARANCE OF SELF-GENERATED COLUMNS AND T.V. PROGRAMS ADDRESSING THE ISSUES. ONE T.V. CHANNEL HAS REGUN A SERIES OF REPORTS ON ADDICTION AND TRAFFICKING IN THE MAJOR CITIES OF THE COUNTRY. ANOTHER IS CO-SPONSORING, WITH OTHER MEDIA ORGANIZATIONS, A FOUR-DAY DEBATE ON THE COCAINE PROBLEM. WHEN EXTREMIST NATIONALISTIC AND LEFTIST GROUPS TAKE TO

THEIR SOAPBOXES TO DENOUNCE THE "ILLEGAL AMERICAN INTERVENTION, " EVEN THEY FEEL COMPELLED TO PREFACE THEIR REMARKS WITH THE DECLARATION THAT THEY, TOO, ARE AGAINST NARCOTRAFFICKING AND DRUG ADDICTION. CONSCIOUSLY OR UNCONSCIOUSLY, THE FACT THAT BOLIVIA, AS A PRODUCING COUNTRY, HAS A SERIOUS PROBLEM WHICH MUST BE ADDRESSED IS BEING ACKNOWLEDGED. A QUANTUM LEAP FROM JUST A YEAR AGO, WHEN FEW BOLIVIANS, OM WHATEVER END OF THE POLITICAL SPECTRUM, WOULD ADMIT

THE PAZ ESTENSSORO GOVERNMENT'S STERN RESOLVE HAS MEANT THAT THE ISSUE IS NOW JOINED AND PART OF THE PUBLIC AGENDA ON TERMS FUNDAMENTALLY DIFFERENT FROM THE PREVIOUSLY SIMPLISTIC ARGUMENTS OF "NO DEMAND, NO SUPPLY. " WHILE NO FORMAL PUBLIC OPINION SOUNDINGS ARE AVAILABLE, GENERAL PUBLIC REACTION APPEARS SUPPORTIVE -- AND SOMEWHAT ADMIRING -- OF THE GOVERNMENT'S DECISION.

DEVELOPMENT/ECONOMIC IMPLICATIONS OF BLAST FURNACE

8. "BLAST FURNACE" AND THE COLLATERAL INM CONTROL ACTIVITIES IN THE CHAPARE ESSENTIALLY HAVE ESTABLISHED THE PRECONDITIONS WHICH CAN ENABLE THE SUCCESSFUL IMPLEMENTATION OF THE CHAPARE REGIONAL DEVELOPMENT PROJECT. THE CHAPARE PROJECT RATIONALE HAS BEEN THAT, ABSENT AN EFFECTIVE NARCOTICS CONTROL EFFORT WHICH WOULD LOWER THE PRICE OF COCA LEAVES AND/OR INCREASE THE PHYSICAL AND ECONOMIC RISKS TO GROWING COCA, NO CROP OR COMBINATION OF CROPS COULD PROVIDE SUFFICIENT ECONOMIC INCENTIVE TO CONVINCE FARMERS TO ERADICATE AND PLANT SUBSTITUTE CROPS FOR COCA. THE INTERDICTION ACTIVITIES OF THE PAST MONTH HAVE REDUCED THE PRICE OF COCA LEAVES TO A LEVEL THAT HAS REMAINED WELL BELOW THE COST OF PRODUCTION. IN ADDITION, CHAPARE FARMERS MISTAKENLY BELIEVE THAT A U.S. - SPONSORED FORCEABLE ERADICATION PROGRAM IS IMMINENT. THIS CONTEXT, A

NUMBER OF POSITIVE EVENTS HAVE OCCURRED:

-- GOB (USAID-SUPPORTED) AGRICULTURAL EXTENSION WORKERS IN THE PAST TEN DAYS HAVE RECEIVED REQUESTS TO ESTABLISH (NON-COCA) PLANT NURSERIES FOR USE BY FARMERS IN FIVE CHAPARE COMMUNITIES, TWO OF THESE COMMUNITIES ARE LOCATED IN PARTICULARLY INTENSIVE COCA PRODUCTION AREAS. PRIOR TO "BLAST FURNACE," ONLY ONE CHAPARE COMMUNITY HAD EVER REQUESTED A NURSERY FACILITY. (FYI: SUCH NURSERIES OFFER SUCH PLANT SEEDLINGS AS CITRUS, CACAO, COCONUT AND CARDAMOM.)

-- APPROXIMATELY FOUR TIMES THE PRE-BLAST FURNACE NUMBER OF REQUESTS HAVE BEEN RECEIVED AT USAID-FUNDED AGRICULTURAL RESEARCH STATIONS FOR SEEDLINGS OF PLANTS WHICH CAN BE ASSUMED TO BE CONSIDERED AS TEMPORARY OR PERMANENT REPLACEMENTS FOR COCA. THE PLANT ATTRACTING MOST INTEREST HAS BEEN CACAO, FOLLOWED BY COFFEE AND COCONUT. REQUESTS HAVE ALSO BEEN HIGH FOR RICE AND BEANS, WHICH, FOR THE MOST PART, CAN BE CONSIDERED AS SUBSISTENCE, RATHER THAN ECONOMIC, CROPS.

PER REFTEL C, THE APPARENT GOB CONSOLIDATION AND INTEGRATION OF NARCOTICS INTO ITS OVERALL (AND, THUS FAR, VERY SUCCESSFUL) ECONOMIC RECOVERY PROGRAM CAN ALSO BE CONSIDERED A SUCCESS OF BLAST FURNACE. IN EFFECT, THIS OPERATION HAS SENSITIZED THE GOB TO RECOGNIZE HOW CLOSELY RELATED NARCOTICS CONTROL IS TO THE ECONOMIC (AND POLITICAL) FUTURE OF THE COUNTRY. PREVIOUS EMBASSY/USAID DIALOGUE ON THIS MATTER WAS NOT NEARLY AS EFFECTIVE IN ESTABLISHING SUCH A CRITICAL LEVEL OF AWARENESS.

CONCLUSION

9. IN SUMMARY, AN INTERIM ASSESSMENT OF OPERATION "BLAST FURNACE" WOULD INCLUDE THE FOLLOWING FACTORS -FORCING THE CONCLUSION THAT IT HAS BEEN A MAJOR SUCCESS:

-- MAJOR TRAFFICKERS HAVE CEASED OPERATIONS AND PREFER TO WAIT FOR MORE OPPORTUNE TIMES OR A CESSATION

BOLIVIA ASKS CONTINGENCY HELP IN CASE OF NARCO-TRAFFICKER RUN ON THE EXCHANGE MARKET

- 1. (C) THE BOLIVIAN FOREIGN MINISTER'S CONFIDENTIAL AIDE HANDED THE AMBASSADOR THE NOTE INFORMALLY TRANSLATED IN PARA 6 ON FRIDAY NIGHT, JULY 18. THE MAIN POINT IS A REQUEST FOR U.S. BACKING FOR BOLIVIA'S CENTRAL BANK IF THE CURRENT HIGHLY PUBLICIZED NARCOTICS INTERDICTION EFFORT PRODUCES A RUN ON THE PESO.
- 2. (C) THE BOLIVIANS BELIEVE THAT THE NARCOTICS TRAFFIC HAS BEEN BRINGING DOLLARS INTO THE ECONOMY AT A RATE OF ABOUT DOLS 600 MILLION PER YEAR. THEY STATE THAT THE TOTAL VALUE OF LEGAL EXPORTS IN 1985 WAS ABOUT DOLS 500 MILLION. THERE IS A GENERAL ASSUMPTION IN LA PAZ THAT ONE REASON FOR THE STEADY EXCHANGE RATE (1.9 MILLION PESOS PER DOLLAR) SINCE LAST JANUARY HAS BEEN THE LARGE VOLUME OF DOLLARS AVALLABLE AN THE INFORMAL STREET- EXCHANGE MARKET. THE PRICE AT THE OFFICIAL EXCHANGE AUCTIONS CONSISTENTLY TRACKS CLOSELY WITH THE STREET PRICE. IN ADDITION, THE BOLIVIANS REFER TO THE 1984 ARMY INCUR-SION INTO THE CHAPARE -- THE FIRST EFFORT TO ASSERT GOVERNMENT AUTHORITY IN A WILD-WEST COCA GROWING REGION. ON THAT OCCASION THE PESO DEVALUED BY ALMOST 30 PERCENT WITHIN A FEW DAYS.
- 3. (C) EXCHANGE MARKET CONDITIONS DIFFER VASTLY TODAY FROM THOSE IN 1984. THE PAZ ESTENSSORO GOVERNMENT'S RADICAL ECONOMIC STABILIZATION HAS WRUNG MOST OF THE EXCESS PESOS OUT OF THE ECONOMY. THE DEMAND FOR DOLLARS THEREFORE HAS BEEN MUCH MORE LIMITED THAN IN 1984. SECOND, A CONCERTED TRAFFICKER EFFORT TO DRIVE DOWN THE VALUE OF THE PESO WOULD REQUIRE A GREATER DEGREE OF COORDINATION BETWEEN TRAFFICKERS THAN THEY HAVE APPSARED

TO HAVE THUS FAR. IT ALSO WOULD REQUIRE THAT THEY ACCUMULATE ENOUGH PESOS TO BE ABLE TO RUSH INTO THE PARALLEL MARKET TO DEMAND DOLLARS. ALTHOUGH SOME TRAFFICKERS HAVE SUBSTANTIAL PESO RESOURCES IN THE FORM OF OPERATIONAL BANK ACCOUNTS OR ACCUMULATED STOCKS USED FOR MONEY LAUNDERING, WE SUSPECT THAT THEY KEEP THE BULK OF THEIR RESOURCES IN HARD CURRENCY OUTSIDE OF BOLIVIA.

4. (C) THE AMBASSADOR EXPRESSED TO THE MINISTER'S ALDE THESE BASES FOR DOUBTING THE SEVERITY OF THE THREAT. NONETHE-LESS, IN VIEW OF THE MINISTER'S STRONG INSISTENCE, THE AMBASSADOR SAID HE WOULD FORWARD THE REQUEST TO WASHING-TON. WE ALSO HAD TO ACKNOWLEDGE THAT IN VIEW OF BOLIVIA'S 1984 EXPERIENCE, IT WOULD BE RECKLESSLY IMPROVIDENT TO FAIL TO CONSIDER HOW TO DEAL WITH A TRAFFICKER-INDUCED RUN ON THE PESO.

(C) ACTION:

- A. REQUEST URGENT GUIDANCE FOR A REPLY TO THE FOREIGN MINISTER.
- B. IF OPERATION BLAST FURNACE HAS HAD A SUFFICIENTLY FAVORABLE IMPACT IN THE U.S. CONGRESS, MAYBE WE COULD GET AGREEMENT TO RELEASE THE SECOND HALF OF FY-86 ESF AND MILITARY ASSISTANCE FUNDS. THE SECOND HALF ESF WOULD BE THE BEST POLITICAL AND PSYCHOLOGICAL DEMONSTRA-TIONS OF U.S. SUPPORT AND COMMITMENT WE COULD MAKE. THE SECOND HALF OF MAP COULD HELP US BEGIN RPT BEGIN TO BUILD A MILITARY CAPABILITY FOR NARCOTICS INTERDICTION AND WOULD HELP THE GOVERNMENT TO DVERCOME SOME OF THE MILITARY FRUSTRATION DUE TO TOTALLY INADAQUATE NATIONAL SOURCES AND, CURRENTLY, NON PARTICIPATION WITH THE U.S. IN BLAST FURNACE.

BOLIVIA ASKS CONTINGENCY HELP IN CASE OF SUBJECT:

IN ACCORDANCE WITH THE DOCUMENTS THAT OUR GOVERNMENTS EXCHANGED ON THE 9TH OF JULY THIS YEAR AND WHICH REFER TO THE ESSENTIAL THEME OF BUILDING A COMMON EFFORT TO ERADI-CATE THE CRIME OF NARCO-TRAFFICKING, I WISH TO EXPRESS TO YOU IN THE NAME OF THE BOLIVIAN GOVERNMENT A FEW COMMENTS WHICH CORRESPOND TO THE REALITY OF THE INTERDICTION OPERATIONS BEGUN A FEW DAYS AGO AND THEIR POSSIBLE CONSEQUENCES.

- 1. IN ACCORDANCE WITH WHAT I SAID YESTERDAY, JULY 17, AT THE MEETING IN THE MINISTRY OF THE INTERIOR, WE BELIEVE THAT THE LACK OF PRESS COORDINATION AND THE LEAKS THAT TOOK PLACE IN WASHINGTON HAVE UNDERHINED THE EFFICIENCY OF THIS OPERATION WHICH WAS BASED FUNDAMENTALLY ON THE FACTOR OF SURPRISE. I TRUST THAT THE LACK OF PRESS COORDINATION WHICH HAS OCCURRED CAN BE RECTIFIED AND SHAPED IN THE FUTURE TO THE POLICE OBJECTIVES TO BE -CARRIED OUL ---
- 2. IT IS IMPORTANT THAT PRESS COVERAGE DURING THE TIME THAT THIS CONTROL AND REPRESSION OPERATION -- UNDER THE CHARGE OF THE BOLIVIAN POLICE AND WITH THE LOGISTICAL AND TECHNICAL SUPPORT OF SPECIFIED ORGANIZATIONS OF YOUR GOVERNMENT -- BE SPECIFICALLY FORMED ACCORDING TO THE FACTS OF THE OPERATION, SEEKING TO INSURE THAT CONJECTURE OR COMMENTARY THAT THE PRESS MAY MAKE WILL IN NO CASE BE BASED ON OFFICIAL INFORMATION WHICH ITSELF HUST BE SOBER AND OBJECTIVE.
- 3. IT IS POSSIBLE THAT THE OPERATION UNDER WAY TO ATTAIN THE RESULTS THAT WE SEEK, THAT IS, THE ERADICATION OF THIS EVIL THROUGH THE DESTRUCTION OF THE CRIMINAL PERPETRATORS THEMSELVES (NARCO-TRAFFICKERS IN GENERAL, PERSONS DEDICATED TO THE PRODUCTION OF DRUGS, LABORATORY OPERATORS AND MERCHANTS OF THE PRECURSORS FOR THE CHEMICAL

PRODUCTION PROCESS, ETC.) COULD SIGNIFY FROM THE POINT OF VIEW OF THE GOVERNMENT'S ECONOMIC POLICY AND PARTICULARLY OF THE EXCHANGE MARKET A LESSENING IN THE OFFER OF DOLLARS THAT WOULD GRAVELY PRESSURE THE LEVEL OF OUR RESERVES. IN ORDER TO BE ABLE TO COUNT ON COVERAGE THAT WOULD BLOCK ANY EXCESS DEMAND THAT WOULD DAMAGE MONETARY STABILITY, IT IS IMPORTANT THAT BALANCE OF PAYMENTS SUPPORT PROGRAMS (FRESH DOLLARS) BE WORKED OUT WHICH COULD GIVE US AN ADEQUATE MARGIN OF SAFETY UNDER THE PRESENT CIRCUMSTANCES UNTIL ECONOMIC NORMALITY CAN BE REESTAB-LISHED IN THE COUNTRY VIA THE REACTIVATION POLICY WHICH WILL COUNT ON SUPPORT FROM THE WORLD BANK CONSULTATIVE GROUP AND OTHER, BILATERAL SOURCES OF FINANCING.

IN CONSIDERATION OF THIS SUBJECT (3), BY MEANS OF THIS OFFICIAL COMMUNICATION I ASK IMMEDIATE CONTINGENT COOPERATION FROM THE GOVERNMENT OF THE UNITED STATES IN ORDER TO STRENGTHEN THE RESERVE LEVEL OF THE CENTRAL BANK IN BOLIVIA. THERE EXISTS EVIDENCE THAT THE DOLLAR MARKET OF THE INFORMAL ECONOMY, SURELY PROMPTED BY THE NARCO-TRAFFICKERS, MAY BEGIN A PANIC ACTION AND EXAGGERATED DEMAND FOR U.S. CURRENCY WHICH COULD BRING DOWN THE GOVERNMENT'S ENTIRE ECONOMIC PROGRAM.

I REGARD THIS REQUEST AS HAVING THE HIGHEST PRIORITY. AND GREATER ELABORATION REGARDING IT IS UNNECESSARY DUE TO THE FACT THAT THE EMBASSY UNDER YOUR CHARGE IS FULLY AWARE OF THE TRUE OVERALL SITUATION OF THE COUNTRY REGARDING SUCH A DELICATE SUBJECT AS OUR, WEAK EXTERNAL ECONOMY WHICH HAS BEEN SO BADLY DAMAGED IN RECENT TIMES BY THE FALL IN INTERNATIONAL PRICES OF OUR MOST IMPORTANT EXPORTS.

FOR THESE REASONS I PRESENT MY COMPLIMENTS TO YOUR EXCELLENCY AND REITERATE THE ASSURANCES OF MY HIGHEST

AND MOST DISTINGUISHED CONSIDERATION. GUILLERMO BEDREGAL GUTTERREZ, MINISTER OF FOREIGN RELATIONS AND WORSHIP.

massive disruption of the entire cocaine industry.
