SUBJECT:

IMPLEMENTING NARCOTICS CONTROL IN BOLIWIA

1. CONFIDENTIAL ENTIRE TEXT.

2. THIS CABLE CONVEYS THE DEPARTMENT'S DECISION ON NARCOTICS RELATED ASSISTANCE SOUGHT BY THE GOVERNMENT OF BOLIVIA TO IMPLEMENT ITS NARCOTICS CONTROL PLAN. THE CABLE ESTABLISHES THE FRAME OF REFERENCE FOR NEGOTIATION OF A NEW INM PROGRAM AGREEMENT WITH THE GOVERNMENT OF BOLIVIA ON A US-ASSISTED NARCOTICS CONTROL PROGRAM FOR FY 1987 AND FUTURE YEARS. YOU AND INM/AS WROBLESKI SHOULD DRAW UPON THESE DECISIONS IN YOUR TALKS JANUARY 9 AND JANUARY 12 TO DETERMINE WHETHER THERE IS A BASIS FOR MORE SPECIFIC NEGOTIATIONS.

>BEGIN SUMMARY>

- 3. SUMMARY OF DECISION. THE US ENDORSES THE FRAMEWORK OF THE PLAN DELIBERATED BY U.S. AND BOLIVIAN REPRESENTATIVES LAST OCTOBER. OUR GOVERNMENT SHOULD MOVE FORWARD AS EXPEDITIOUSLY AS POSSIBLE WITH A US ASSISTED NARCOTICS CONTROL PROGRAM AND ASSISTANCE TO FARMERS WHO ERADICATE COCA. THE KEY ELEMENTS APPROVED INCLUDE:

 --IMPROVED INTERDICTION OPERATIONS ARE ESSENTIAL;
 ERADICATION EFFORTS WILL FAIL UNLESS INTERDICTION KEEPS PRICES DOWN.
- A NEW LAW MUST BE IN PLACE ALONG WITH A VIGOROUS ENFORCEMENT PROCESS. ERADICATION WON'T WORK UNLESS THERE IS PUBLIC ACCEPTANCE GENERATED. THROUGH A VIABLE PUBLIC AWARENESS PROGRAM AND A LEGAL FRAMEWORK FOR IMPLEMENTING THE PROGRAM.
- -- EVERY EFFORT MUST BE MADE TO ENSURE THAT THE PROPOSED COMMODITIES-BASED PROGRAM IS ESTABLISHED QUICKLY AND OPERATES EXPEDITIOUSLY TO MEET THE NEEDS OF FARMERS. A STRONG AID PRESENCE IS ESSENTIAL TO ENSURE PROGRAM INTEGRITY.
- FARMERS ERADICATING COCA WOULD RECEIVE A DIRECT TO FARMER COMBINATION OF PAYMENTS FOR LABOR COSTS OF ERADICATION (350 DOLLARS PER HECTARE SHOULD BE REVIEWED AS IT MAY BE EXCESSIVE), AND IN-KIND PAYMENT IN THE FORM OF COMMODITIES FOR HECTARES ERADICATED. THIS WOULD CONSIST OF MATERIALS OR SERVICES, NOT LIMITED TO FOOD, TOOLS AND CONSTRUCTION MATERIAL.
- -- THE USG IS WILLING TO CONSIDER CASH REIMBURSEMENT IN GOB-OWNED LOCAL CURRENCY TO FARMERS VOLUNTARILY ERADICATING COCA TO COVER SOME RESETTLEMENT COSTS BUT ON A FAMILY AND NOT A PER HECTARE BASIS.
- 4. YOU SHOULD SEEK A MEETING WITH APPROPRIATE SENIOR GOB OFFICIALS AS SOON AS POSSIBLE TO INFORM THEM THAT:
- -- THE US AGREES TO THE FRAMEWORK DEVELOPED IN NOVEMBER

BY US AND GOB OFFICIALS FOR NARCOTICS INTERDICTION, COCA ERADICATION AND DEVELOPMENT.

-- INTERDICTION. IT IS ESSENTIAL THAT INTERDICTION
OPERATIONS BE IMPROVED; THE RECENT SHARP INCREASES IN
COCA PRICES IS CAUSE FOR DEEP CONCERN. THE USG SHARES
THE BELIEF THAT THE ERADICATION PROGRAM WILL NOT SUCCEED

UNLESS THE INTERDICTION EFFORT KEEPS PRICES DOWN. THE USG IS PROVIDING THE AIRCRAFT AND OTHER RESOURCES REQUIRED FOR INTERDICTION. THE USG HAS BEGUN TO PROVIDE THE RESOURCES REQUIRED FOR INTERDICTION AND HAS BUDGETED THE REQUIRED FUNDING TO CONTINUE THAT SUPPORT DURING THIS FISCAL YEAR.

-- THE USG RECOGNIZES THE IMPORTANCE OF LAUNCHING THE ERADICATION PROGRAM AT ONCE AND HAS GONE TO EXTRAORDINARY LENGTHS TO MAKE FUNDS AVAILABLE FROM PREVIOUSLY AUTHORIZED FY 1987 GLOBAL ASSISTANCE PROGRAMS. ACCORDINGLY, WE HAVE ALLOCATED 20 MILLION DOLLARS (5 MILLION INM FUNDING AND 15 MILLION DOLLARS SF) TO BOLIVIA TO SUPPLEMENT THE 5 MILLION DOLLARS OF ITS OWN FUNDS WE UNDERSTAND BOLIVIA HAS AVAILABLE TO BEGIN THE VOLUNTARY ERADICATION PROGRAM.

-- TYPE OF ASSISTANCE. THE US ACCEPTS THE NEED TO PROVIDE THE MEANS FOR AFFECTED GROWERS TO SUSTAIN THEMSELVES UNDER A FAMILY REHABILITATION PROGRAM, WHILE DEVELOPING OTHER MEANS OF LIVELIHOOD. HOWEVER, WE HAVE NOT SUPPORTED CASH PAYMENTS ELSEWHERE AND THERE IS LEGISLATIVE PROVISION AGAINST REIMBURSING FARMERS WHOSE CROPS HAVE BEEN ERADICATED. THE US OFFERS TO SUPPORT A DIRECT-TO-FARMERS COMBINATION OF PAYMENT FOR LABOR COSTS OF ERADICATION TIED TO HECTARES ERADICATED, AND VOUCHERS FOR IN-KIND COMMODITIES, MATERIALS OR SERVICES, INCLUDING TRAINING AND CREDITS, NOT LIMITED TO FOOD, TOOLS AND CONSTRUCTION MATERIALS, WITH A VERSATILITY THAT PERMITS DIRECTING COCA FARMERS TOWARD OTHER LEGAL OCCUPATIONS. THE PROGRAM OFFERED IS CONSISTENT WITH US POLICY AND LAW. THE US EMPHASIZES THAT THIS OFFER PROVIDES A PACKAGE EQUAL IN VALUE TO THE CASH PAYMENTS SOUGHT BY THE GOB (THIS ASSUMES THAT OUR FY 88 LEVELS WILL BE AT LEAST EQUAL TO FY 87 LEVELS); ASSURES THAT FARMERS RECEIVE MATERIALS SPECIFICALLY DESIGNED TO ASSIST THEM AND THEIR FAMILIES IN ADOPTING A NEW LIFE; AND CAN BE IMPLEMENTED WITHIN 40-60 DAYS.

-- LIMITS ON ASSISTANCE. FARMERS WHO AGREE TO ERADICATE CAN RECEIVE UP TO THE EQUIVALENT OF 2,000 DOLLARS IN ASSISTANCE PER FAMILY. (FYI: CASH PAYMENTS FOR THE LABOR INVOLVED IN ERADICATION WHICH WOULD BE IN LOCAL CURRENCY ARE PERMITTED BY THE US CONGRESS UNDER SEC. 483; WE CONSIDER THE 350 DOLLAR FLOURE TO BE HIGH AND SHOULD BE REVIEWED IN COMPARISION TO OTHER EXPERIENCED COSTS FOR LABOR IN BOLIVIA. END FYI) WE ARE AWARE THAT MANY OF THE CURRENT COCA FARMERS HAVE MOVED INTO THE CHAPARE SOLELY TO GROW COCA AND THAT THE CHAPARE CANNOT SUPPORT THE LARGE NUMBER OF THESE FARMERS AGRICULTURALLY, THE US IS ALSO WILLING TO CONSIDER CASH REIMBURSEMENT (GOB-OWNED LOCAL CURRENCY)

FOR MOVING AND POSSIBLY SOME RESETTLEMENT EXPENSES. IF THE LATTER ARE OFFERED, IT SHOULD BE ON A FAMILY, NOT A PER HECTARE BASIS, AND ONLY FOR THOSE WHO MOVE OFF THEIR CURRENT FARMS.

-- VERIFICATION. THERE SHOULD BE AGREEMENT ON A METHOD

OF VERIFYING VOLUNTARY ERADICATION, AND NO PAYMENTS OF ANY KIND SHOULD BE MADE UNTIL CROP DESTRUCTION IS VERIFIED.

-- FUNDING. US ASSISTANCE TO BOLIVIA IN 1987 WILL BE THE HIGHEST FOR ALL OF SOUTH AMERICA, IN A PERIOD OF SERIOUS BUDGET CONSTRAINTS. WE ARE PROPOSING TO ALLOCATE 67.8 MILLION DOLLARS IN ECONOMIC, MILITARY AND FOOD ASSISTANCE, WHICH INCLUDES 15 MILLION DOLLARS IN NEW ESFFUNDS (THE LOCAL CURRENCY EQUIVALENT OF) WHICH WILL BE ALLOCATED TO THE NARCOTICS-RELATED ASSISTANCE PROGRAM, AS WELL AS 12 MILLION DOLLARS IN NARCOTICS ASSISTANCE. THERE ARE 22 MILLION DOLLARS IN DEVELOPMENT ASSISTANCE PIPELINE FOR THE CHAPARE THAT CAN BE USED TO IMPLEMENT A COMPANION ECONOMIC REDEVELOPMENT PROGRAM.

-- THE USG WILL CONTINUE TO MAKE A SIGNIFICANT EFFORT TO

SUPPORT THE ERADICATION AND ECONOMIC REACTIVATION PROGRAMS AS THEY PROGRESS OVER THE NEXT 3 YEARS BY GENERATING FUNDS FROM NEW BILATERAL ASSISTANCE, REPROGRAMMING AVAILABLE RESOURCES AND SEEKING THE SUPPORT OF OTHER INTERESTED NATIONS BILATERALLY AND MULTILATERALLY. (YOU SHOULD DISCUSS FRANKLY OUR SERIOUS BUDGET CONSTRAINTS AND OUR INTENTION TO DO ALL ME CAN TO. COME UP WITH THE NECESSARY FUNDING. EMPHASIZE THAT MUCH WILL DEPEND ON SUCCESS OF THE INITIAL STAGES OF THE PROGRAM).

-- A NEW LAW MUST BE IN PLACE THAT INCLUDES ALL OF THE LEGAL PROVISIONS CONTAINED IN THE OCTOBER PLAN RECOMMENDED BY US/BOLIVIAN OFFICIALS.

-- THERE MUST BE A VIGOROUS ENFORCEMENT PROCESS. THE US CONCURS IN A ONE-YEAR VOLUNTARY PROGRAM, WITH A GOB COMMITMENT TO ENFORCED, INVOLUNTARY ERADICATION FOR THE FOLLOWING TWO YEARS, WITH NO SPECIAL BENEFITS TO FARMERS WHO FAIL TO COOPERATE. THE US ENCOURAGES A STRONG PUBLIC AWARENESS CAMPAIGN TO BOLSTER PUBLIC ACCEPTANCE OF THIS PROGRAM.

-- COCA CONTROL AGREEMENT. TO ENCOURAGE FARMER PARTICIPATION, AND TO ENSURE WIDE UNDERSTANDING OF GOB INTENT, THE US RECOMMENDS A PARALLEL FIRST-YEAR ERADICATION EFFORT. AS REQUIRED BY LAW, A COCA CONTROL AGREEMENT MUST SET A NUMERICAL OBJECTIVE FOR ERADICATION. A MINIMUM OBJECTIVE MUST BE SET FOR THE FIRST YEAR, DURING WHICH THE PROGRAM WILL RELY IN PART ON VOLUNTARY ERADICATION. BOLIVIA SHOULD AGREE TO ADOPT LAWS AND DEVELOP A PROGRAM WHICH: (1) LIMITS LICIT CULTIVATION TO THE DEPARTMENT OF THE YUNGAS; (2) COMMITS BOLIVIA TO ERADICATE IN 1987 AND FUTURE YEARS ALL NEW COCA CULTIVATION; (3) COMMITS BOLIVIA TO ERADICATE IN 1987 ALL COCA BEING GROWN ON LANDS UNDER FEDERAL CONTROL; AND (4) COMMITS BOLIVIA TO ERADICATE ALL GOCA OUTSIDE THE YUNGAS IN 1988 AND THEREAFTER.

-- DEADLINES. THE GOB MUST UNDERSTAND THAT THE US HAS ADOPTED A NEW CERTIFICATION PROCESS (SEC. 481 FAA), UNDER WHICH THE PRESIDENT MUST CERTIFY ON OR BEFORE MARCH 1 THE ADEQUACY OF NARCOTICS COOPERATION BY ALL MAJOR SOURCE COUNTRIES. MOST KINDS OF US ASSISTANCE WILL BE SUSPENDED FOR ANY COUNTRY NOT CERTIFIED; THERE WILL ALSO BE A LOSS OF TRADE BENEFITS AND SUPPORT IN MDBS. (NOTE THAT INM NARCOTICS ASSISTANCE IS EXEMPTED.) BOLIVIA HOWEVER MUST MEET OTHER CONDITIONS, SPECIFICALLY THE REQUIREMENTS OF SEC. 611 AS AMENDED BY PL 99-578, WHICH SPECIFY THAT THE

US AND BOLIVIA CONCLUDE AND MAKE SUBSTANTIAL PROGRESS TOWARDS IMPLEMENTATION OF A NEW NARCOTICS CONTROL AGREEMENT WHICH, INTER ALIA, SETS NEW NUMERICAL GOALS FOR ERADICATION, IN PURSUIT OF A BOLIVIA PLAN FOR COCA CONTROL. AGREEMENT SHOULD BE CONCLUDED IN ADVANCE OF MARCH 1, TO FACILITATE SECTION 481 CERTIFICATION. ONLY IF THAT CERTIFICATION SURVIVES CONGRESSIONAL REVIEW, AND IF WE ARE ABLE TO MAKE SECTION 611 CERTIFICATION, CAN WE OBLIGATE SECOND 50 PERCENT OF ASSISTANCE TO BOLIVIA. - CONGRESSIONAL CONSULTATION. WE WILL ADVISE APPROPRIATE US CONGRESSIONAL COMMITTEES OF DECISIONS ON THE OVERALL PROGRAM FRAMEWORK AND HOW OUR ECONOMIC AND NARCOTICS ASSISTANCE IS RELATED TO IT. THE SECTION 611 CERTIFICATION PROCESS WILL PROVIDE THE BASIS FOR ADVISING CONGRESS OF BOLIVIAN PROGRESS TO DATE, PRIOR TO THE MARCH 1 CERTIFICATION UNDER SEC. 481. 5. ACTION REQUESTED: DEPT REQUESTS THAT POST REPORT SUBSTANCE OF DISCUSSIONS WITH GOB BY IMMEDIATE CABLE.

1. (C) AT A JANUARY 9 LUNCHEON HELD AT THE AMBASSADOR'S RESIDENCE IN HER HONOR, ASSISTANT SECRETARY WROBLESKI HAD A FRANK AND OPEN CONVERSATION WITH BOLIVIA'S MINIS-TERS OF FOREIGN RELATIONS (BEDREGAL) AND PLANNING (SANCHEZ DE LOZADA). MRS. WROBLESKI EMPHASIZED THE IMPORTANCE GIVEN BY THE USG AND THE REST OF THE INTER-MATIONAL COMMUNITY TO GOB PASSAGE OF A TOUGH, CREDIBLE ANTI-NARCOTICS LAW. SHE ALSO UNDERSCORED THE CRITICAL PEQUIREMENT FOR A NEW BILATERAL AGREEMENT TO REPLACE THE 1983 ACCORD IN ORDER TO ENABLE THE MARCH 1 CERTIFI-CATION UPON WHICH THE CONTINUATION OF ASSISTANCE DEPENDS. THE AMBASSADOR AND THE ASSISTANT SECRETARY ALSO COMMUNICATED THE SUBSTANCE OF REFTEL, I.E., THAT THE U.S. ENDORSES THE OBJECTIVES FRAMEWORK OF THE GOB ANTI-NARCOTICS PLAN DESCRIBED IN THE OCTOBER AD REFERENDUM MEMORANDUM AND AT THE DECEMBER CONSULTATIVE GROUP MEETING, BUT THAT OUR PARTICIPATION IN ASSISTANCE TO FARMERS WHO ERADICATE COCA WILL BASICALLY BE IN THE FORM OF COMMODITIES PLUS SOME LABOR COSTS. U.S. LAW AND POLICIES PREVENT US FROM FINANCING A PROGRAM OF DIRECT CASH PAYMENTS TO FARMERS WHO ERADICATE THEIR COCA. BOTH MINISTERS EXPRESSED THEIR DISAPPOINTMENT WITH THIS DECISION AND VOICED DOUBTS AS TO WHETHER ANY OTHER APPROACH COULD WORK. MORE DETAILED DISCUSSIONS ON THIS MATTER WILL TAKE PLACE IN THE FOLLOWING WEEK. FOREIGN MINISTER BEDREGAL STATED A CONCERN THAT THE FEBRUARY 7 MEETING IN VIENNA ON BOLIVIAN NARCOTICS PROGRAM NEEDS WOULD BE POSTPONED. MRS. WROBLESKI INDICATED THAT SHE WOULD BE HAVING A MEETING WITH UNFDAG DIRECTOR DI GENNARO IN LA PAZ ON JANUARY 12, DURING WHICH SHE WOULD STRONGLY ENCOURAGE THAT THE VIENNA MEETING BE HELD. END SUMMARY. > FND SUMMARY>

2. (C) A FOLLOW-UP CALL ON BEDREGAL AT THE FOREIGN MINISTRY WAS MAINLY PROTOCOLARY. AT A LATER ONE-HOUR SESSION WITH INTERIOR MINISTER BARTHELEMY, BARTHELEMY SAID HE WANTS TO STEP UP INTERDICTION, AND HE IS READY TO PUSH FOR IMMEDIATE ERADICATION OF NEW COCA NURSERIES. HOWEVER, HE SAID HE COULD NOT COMMENT ON THE WORKABILITY OF COMMODITY ASSISTANCE TO EX-COCA FARMERS BECAUSE THE ISSUE TRANSCENDS MINISTERIAL LINES.

3. (C) THE NIGHT OF JANUARY 9 SANCHEZ DE LOZADA ASKEO FOR A PRIVATE JANUARY 13 LUNCH WITH THE AMBASSADOR TO EXPLORE THE COCA ERADICATION STRATEGY WITH ABSOLUTELY OPEN MINDS TO SEE IF THE U.S. COMMODITY ASSISTANCE PROPOSAL CAN BE MADE TO WORK; (B) ASSURE U.S. THAT NO MATTER WHAT THE OUTCOME, BOLIVIA WILL PUSH INTERDICTION; (C) DEPENDING ON THE RESULTS OF THE JANUARY 13 LUNCH, THE BOLIVIAN GOVERNMENT WILL JUDGE HOW AND HOW FAR IT CAN GO ON ERADICATION.

BACKGROUND

4. (U) ON FRIDAY, JANUARY 9, AMBASSADOR ROWELL HELD A SMALL, INFORMAL LUNCHEON IN HONOR OF THE VISIT OF INM ASSISTANT SECRETARY WROBLESKI. ALSO PRESENT WERE THE MINISTER OF FOREIGN RELATIONS, GUILLERMO BEDREGAL; THE MINISTER OF PLANNING, GONZALO SANCHEZ DE LOZADA; DCM JEFFREY BIGGS; USAID DIRECTOR DAVID COHEN; NAU CHIEF DONALD YELLMAN AND INM'S LATIN AMERICAN DIRECTOR, SUE PATTERSON.

GOB STRATEGY

5. (U) SANCHEZ DE LOZADA DESCRIBED THE GOB "CARROT STICK" STRATEGY FOR DEALING WITH THE COUNTRY'S NARCOTICS PROBLEM. ONCE COCA PRODUCERS KNOW THAT THE GOVERMENT IS SERIOUS ABOUT ELIMINATING TRAFFICKING AND ILLICIT PRODUCTION, THEY SHOULD COOPERATE PEACEFULLY WITH A VOLUNTARY ERADICATION PROGRAM. THERE ARE THREE CRITICAL ELEMENTS TO THE PROGRAM: (1) ESTABLISHMENT OF AN EFFECTIVE, SUSTAINED INTERDICTION PROGRAM THAT WILL HOLD CONFIDENTIAL SECTION 02 OF 04 LA PAZ 00335 E.O. 12356: DECL: OADR TAGS: BL, SNAR, EAID SUBJECT: INM ASSISTANT SECRETARY WROBLESKI LUNCHEON

THE PRICE OF COCA BELOW THE COST OF PRODUCTION; (2) PASSAGE OF A STRONG, CREDIBLE GOB ANTI-NARCOTICS LAW; AND (3) CASH PAYMENTS TO FARMERS WHO ERADICATE THEIR COCA SO AS TO FACILITATE THEIR TRANSITION TO LEGAL ECONOMIC ACTIVITIES.

USG POLICY AGAINST CASH PAYMENTS *******

6. (C) AMBASSADOR ROWELL DESCRIBED THE DECISION AGAINST CASH PAYMENTS PROVIDED IN REFTEL, SANCHEZ DE LOZADA INDICATED HIS DISAPPOINTMENT WITH THIS, BUT DID NOT WANT TO REJECT THE PROPOSED COMMODITY-BASED ALTERNATIVE OUT OF HAND WITHOUT GIVING IT FURTHER CONSIDERATION. HE EXPRESSED HIS BELIEF THAT ANY MEANS OF COMPENSATION OTHER THAN CASH -- IN U.S. DOLLARS -- WILL NOT/NOT GET CAMPESINOS TO PULL THEIR COCA OUT OF THE GROUND. WITHOUT SUCH AN INCENTIVE, HE SAID, FARMERS WILL MOVE ON TO SOME OTHER ACTIVITY, BUT LEAVE THEIR COCA PLANTS WHERE THEY ARE IN CASE INTERDICTION FAILS TO HOLD DOWN PRICES AND

COCA AGAIN BECOMES PROFITABLE. NEVERTHELESS, SANCHEZ DE LOZADA SAID HE WOULD HAVE TO THINK ABOUT OTHER OPTIONS. AS A MATTER OF INTELLECTUAL HONESTY HE ACKNOWLEDGED THAT CASH PAYMENTS (I.E., SEVERENCES) TO MINERS WHO HAD BEEN DISMISSED BY COMIBOL HAD NOT PROVIDED AN ADEQUATE SOLUTION FOR THAT PROBLEM, AS AFTER THE MINERS HAD SPENT THEIR CASH THEY WERE STILL WITHOUT JOBS AND WERE PRESSING THE GOB FOR EMPLOYMENT. FOREIGN MINISTER BEDREGAL WAS NOTABLY MORE NEGATIVE THAN SANCHEZ DE LOZADA, STATING THAT THE U.S. HAD BETRAYED BOLIVIA IN REJECTING WHAT IT HAD "AGREED TO" DURING THE OCTOBER BILATERAL NEGOTIATIONS. TO THIS, SANCHEZ DE LOZADA REMINDED HIS COLLEAGUE THAT THE OCTOBER AGREEMENT WAS AD REFERENDUM, THUS "BETRAYAL" WAS PERHAPS NOT QUITE AN ACCURATE DESCRIPTION OF WHAT HAD OCCURRED. THE ASSISTANT SECRETARY INDICATED THAT THE

DECISION WAS NOT ARRIVED AT EASILY, AND THAT THE ALTERNATIVE CONSTITUTED AN HONEST ATTEMPT TO MEET THE NEEDS OF THE FARMERS.

FEBRUARY 7 VIENNA MEETING

7. (C) THE FORMIN MADE A STRONGLY NEGATIVE INFERENCE THAT THE USG HAS BEEN TRYING TO POSTPONE THE BOLIVIA ANTI-NARCOTICS PROGRAM NEEDS CONSULTATIVE GROUP SUB-COMMITTEE MEETING SCHEDULED TO TAKE PLACE IN VIENNA ON FEBRUARY 7. MRS. WROBLESKI EXPLAINED THAT IF SUCH A POSTPONEMENT WAS BEING SOUGHT, IT WAS NOT AT THE INITIATIVE OF THE USG, BUT RATHER UNFDAC, WHICH RECENTLY HAD BEEN MANIFESTING INCREASED DISCOMFORT WITH THE POSSIBILITY OF SETTING AN UNSUSTAINABLE PRECEDENT BY HAVING A COUNTRY MAKE A DIRECT PLEA FOR AID TO THE UNFDAC MEMBERSHIP. IT WAS POINTED OUT THAT (A) THE MEETING WAS NOT BEING HOSTED BY UNFDAC, BUT RATHER UNFDAC, AT ITS OWN SUGGESTION, WAS PROVIDING LOGISTIC SUPPORT FOR THE MEETING; AND (B) THE MEETING WAS CONSIDERED THAT OF A SUB-COMMITTEE OF THE BOLIVIA CONSULTATIVE GROUP AND THEREFORE WOULD NOT SET ANY PRECEDENTS FOR UNFDAC. THE ASSISTANT SECRETARY INDICATED THAT SHE WOULD BE HAVING A MEETING ON JANUARY 12 IN --- LA PAZ WITH UNFDAC DIRECTOR GUISEPPI DI GENNARO AND WOULD STRONGLY ENCOURAGE HIS SUPPORT FOR THE FEBRUARY 7 MEETING.

THE BOLIVIAN NARCOTICS LAW

8. (LOU) MRS. WROBLESKI AND AMBASSADOR ROWELL EMPHASIZED SEVERAL TIMES HOW CRITICAL IT IS FOR BOLIVIA TO PASS QUICKLY A STRONG ANTI-NARCOTICS LAW. BOTH MINISTERS ACKNOWLEDGED THIS, BUT INDICATED THAT PASSAGE OF THE LAW WOULD REQUIRE AT LEAST SOME INDICATION THAT THE OVERALL COCA ERADICATION PROGRAM WILL RECEIVE ADEQUATE INTERNATIONAL FINANCIAL SUPPORT. THIS, ACCORDING TO SANCHEZ DE LOZADA, WAS HOW THE GOB HAD FINALLY SECURED POSITIVE CONGRESSIONAL ACTION ON ITS MAY 1986 TAX REFORM C D N F I D E N T I A L SECTION Ø3 OF Ø4 LA PAZ ØØ335

LEGISLATION. IT WAS AGREED THAT IT IS A SINE QUA NON

COMPLETED DRAFT OF THE LEGISLATION AT THE VIENNA
MEETING. SANCHEZ DE LOZADA SAID THAT, BECAUSE OF

NATIONAL ELECTIONS OF 1989, THE TIME WINDOW FOR

(LOU) COMMENT: THE DAY BEFORE (JANMUARY 8) IN A MEETING WITH THE DCM AND USAID DIRECTOR, SANCHEZ DE LOZADA HAD CALLED BOLIVIA'S AMBASSADOR TO THE UNITED STATES, FERNANDO ILLANES, AND ASKED HIM TO COME TO LA PAZ THE NEXT WEEK (JANUARY 12016) TO HEAD A LAW-DRAFTING TASK FORCE. (THE LAW NOW BEFORE THE BOLIVIAN CONGRESS DOES NOT CONFIRM WITH THE GOB PROGRAM OUTLINED IN EITHER THE AD REFERENDUM MEMORANDUM OR THE DRUG POLICY PAPER PRESENTED TO THE CONSULTATIVE GROUP IN PARIS.) END COMMENT.

USG CONDITIONALITY

10. (U) THE ASSISTANT SECRETARY EMPHASIZED SEVERAL TIMES THE IMPORTANCE OF THE GOB HAVING AN ACCEPTABLE NARCOTICS LAW IN PLACE AND A NEW BILATERAL AGREEMENT WITH THE USG PRIOR TO THE MARCH 1 DATE FOR CERTIFICATION TO THE U.S. CONGRESS. IF THIS DEADLINE FOR CERTIFICATION IS NOT MET, BOLIVIA, WHICH IS SLATED TO RECEIVE THE LARGEST AMOUNT OF USG ASSISTANCE IN THE SOUTH AMERICAN REGION, WOULD LOSE A SUBSTANTIAL AMOUNT OF ITS FY-1987 AID RESOURCES.

- 11. (C) A FOLLOW-UP CALL ON BEDREGAL AT THE FOREIGN MINISTRY WAS MAINLY PROTOCOLARY. AT A LATER ONE-HOUR SESSION WITH INTERIOR MINISTER BARTHELEMY, BARTHELEMY SAID HE WANTS TO STEP UP INTERDICTION AND HE IS READY TO PUSH FOR IMMEDIATE ERADICATION OF NEW COCA NURSERIES.  (A) EXPLORE THE COCA ERADICATION STRATEGY WITH ABSOLUTELY OPEN MINDS TO SEE IF THE U.S. COMMODITY ASSISTANCE PROPOSAL CAN BE MADE TO WORK; (B) ASSURE U.S. THAT NO MATTER WHAT THE OUTCOME BOLIVIA WILL PUSH INTERDICTION; (C) DEPENDING ON THE RESULTS OF THE JANUARY 13 LUNCH, THE BOLIVIAN GOVERNMENT WILL JUDGE HOW AND HOW FAR IT CAN GO ON ERADICATION.

COMMENT

- 13. (C) THE LUNCHEON CONVERSATION WAS FRANK AND PRODUCTIVE. SANCHEZ DE LOZADA IS COMMITTED TO ACTION AND SEEMS TO BE FLEXIBLE IN THE SEARCH FOR WORKABLE SOLUTIONS. HE IS REALISTIC ABOUT WHAT HE BELIEVES WILL BE POSSIBLE AND WHAT WILL NOT. AN INTERESTING OBSERVATION HE MADE WAS THAT ILLANES WOULD BE A MUCH MORE EFFECTIVE EMISSARY TO THE EUROPEANS THAN SANCHEZ DE LOZADA WHOSE NATIVE AMERICAN ENGLISH UNDERMINES HIS CREDIBILITY AS A BOLIVIAN. BEDREGAL, ON THE OTHER HAND, DEMONSTRATED A MUCH LESS FLEXIBLE ATTITUDE. HE MADE SEVERAL INACCURATE ALLEGATIONS, AND HIS ATTITUDE DID NOT INDICATE A STRONG PREDISPOSITION TO A CONSTRUCTIVE, PROBLEM-SOLVING-ORIENTED WORKING RELATIONSHIP WITH US.

(C) THE BOTTOM LINE ON THE POSSIBILITY OF ARRIVING AT A SATISFACTORY BILATERAL DETERMINATION TO PROCEED ALONG THE LINES DESCRIBED IN REFTEL WILL FOLLOW MORE DETAILED DISCUSSIONS DURING THE WEEK OF JANUARY 11. (LOW) THE AMBASSADOR AND INM ASSISTANT SECRETARY WROBLESKI CALLED ON BOLIVIAN PRESIDENT VICTOR ((PAZ)) ESTENSSORO LATE JANUARY 12. NO OTHER BOLIVIANS WERE PRESENT. INM LATIN AMERICA DIRECTOR SUE PATTERSON AND LA PAZ NAU DIRECTOR DON YELLMAN ALSO WERE THERE. COCA ERADICATION -- FAMILY REHABILITATION FUND

2. CT AMBASSADOR ROWELL OPENED THE CONVERSATION OBSERVING THAT HE AND MRS. WROBLESKI HAD JUST RETURNED FROM THE CHAPARE REGION OF BOLIVIA, WHERE THEY HAD OVERFLOWN MAJOR COCA-PRODUCING AREAS AND VISITED INSTALLATIONS OF BOLIVIAN NARCOTICS STRIKE FORCE POLICE (UMOPAR). THE VISIT HAD BEEN HELPFUL TO THEM IN UNDER-STANDING THE EXTENT OF COCA CULTIVATION AND NARCOTICS PRODUCTION IN BOLIVIA'S MAJOR COCA-PRODUCING REGION. THE AMBASSADOR OBSERVED THAT INSTRUCTIONS HAD JUST BEEN PROVIDED FROM WASHINGTON OUTLINING THE USG POSITION ON BOLIVIA'S STRATEGY FOR NARCOTICS INTERDICTION, COCA REDUCTION AND ASSISTANCE TO FAMILIES THAT VOLUNTARILY ERADICATE THEIR COCA DURING THE FIRST 12 MONTHS OF THE PROGRAM. THE USG WILL DIRECTLY SUPPORT REHABILITATION HELP TO SUCH FAMILIES WITH A MIX OF CASH COMPENSATION FOR LABOR UP TO DOLS 350 PER HECTARE (SUBJECT TO VERIFI-CATION OF LABOR COSTS) AND COMMODITY ASSISTANCE TOTALING ABOUT DOLS 1,650 PER FAMILY.

3. (\$\forall \text{President paz replied that he had been informed by fernando illanes, bolivia's ambassador to washington, that the u.s. resources available to carry out bolivia's coca reduction plan are grossly insufficient and that the usg had determined that the rehabilitation assistance to families could not be cash if usg resources are to be used. He said this news was very discouraging and that he has recalled ambassador illanes to la paz for consultations. He added that foreign minister bedregal was saying the whole coca eradication strategy now is hope-

LESS AND SHOULD BE DUMPED. PLANNING MINISTER SANCHEZ DE LOZADA IS VERY DISCOURAGED. PAZ SAID HE IS MORE OPTIMISTIC THAN EITHER OF HIS MINISTERS THAT A WAY CAN BE FOUND TO PURSUE THE STRATEGY. HE ASKED IF THE USG POSITION AGAINST CASH PAYMENTS AS REPORTED BY AMBASSADOR ILLANES REPRESENTS WASHINGTON'S BOTTOM LINE. 4. (2) MRS. WROBLESKI REPLIED THAT AMBASSADOR ILLANES! REPORT ACCURATELY DESCRIBES USG VIEWS ON THE QUESTION OF CASH VERSUS COMMODITY ASSISTANCE TO FAMILIES. HOWEVER, ILLANES' REPORT FAILS TO CONVEY THE DEPTH AND SERIOUSNESS OF OUR COMMITMENT TO THE BOLIVIAN DEMOCRATIC SYSTEM AND THE SUCCESS OF THE PAZ ADMINISTRATION. THAT COMMITMENT IS CLEARLY EXPRESSED IN PROPOSED LEVELS OF FOREIGN ASSIS-TANCE FOR BOLIVIA IN FY-88 AND IN OUR EXISTING FY-87 COMMITMENTS WHICH ARE GREATER FOR BOLIVIA THAN FOR ANY OTHER WESTERN HEMISPHERE COUNTRY OUTSIDE OF CENTRAL AMERICA. THE U.S. IS COMMITTING OVER 66 MILLION DOLLARS THIS YEAR TO THE ANTI-NARCOTICS EFFORT ALONE IN BOLIVA. THAT IS SIGNIFICANT. PRESIDENT PAZ NODDED AND SMILED, ADDING THAT MAYBE BOLIVIA SHOULD HAVE BEEN CREATED PHYSICALLY CLOSER TO THE U.S.

ESSENTIALITY OF MULTI-FACETED CAMPAIGN

5. (LOW) IN RESPONSE TO PRESIDENT PAZ OBSERVATION THAT INTERDICTION AND EDUCATION MUST BE ACCOMPANIED BY COCA ERADICATION EFFORTS, MRS. WROBLESKI CONCURRED THAT WE HAVE LEARNED THAT A BALANCED STRATEGY INCLUDING ALL THESE ELEMENTS IS NECESSARY FOR SUCCESS. PAZ NOTED THAT IF WE FAIL TO ERADICATE WHEN INTERDICTION MAKES IT POSSIBLE, THE RAW MATERIAL FOR DRUGS WILL REMAIN IN THE FIELD. WITH THAT INCENTIVE, EVENTUALLY THE TRAFFICKERS WILL FIND A WAY AROUND THE INTERDICTION CAMPAIGN AND NOTHING LASTING SECRET SECTION 02 OF 03 LA PAZ 00405 LIMA FOR ASSISTANT SECRETARY WROBLESKI E.O. 12356: DECL: OADR TAGS: SNAR, BL, EAID SUBJECT: INM ASSISTANT SECRETARY WROBLESKI'S CALL ON WILL HAVE BEEN GAINED. ANTI-NARCOTICS LAW

OF PRESIDENT PAZ RAISED THE ISSUE OF NEW BOLIVIAN NARCOTICS LEGISLATION, NOTING THAT SEVERAL PROVISIONS OF THAT LAW WILL BE CONTROVERSIAL IN THE BOLIVIAN CONGRESS. IF CONGRESSIONAL SUPPORT IS TO BE OBTAINED, THE GOVERNMENT MUST BE ABLE TO INFLUENCE CONGRESSIONAL THINKING WITH AS MANY POSITIVE ARGUMENTS AS POSSIBLE. IT IS AN ELECTION YEAR IN BOLIVIA. HE THOUGHT THAT CASH ASSISTANCE TO FARMERS WHO ERADICATE WOULD BE SUCH A POSITIVE FACTOR. MRS. WROBLESKI RESPONDED THAT, WHILE WE UNDERSTAND THE BOLIVIAN INTEREST IN CASH PAYMENTS, OTHER TYPES OF ASSISTANCE COULD BE EQUALLY OR MORE VALUABLE TO THE FARMERS.

7. (2) THE PRESIDENT RESPONDED THAT IT REMAINS TO BE SEEN HOW THE BOLIVIAN CONGRESS AND FARMER REPRESENTATIVES WILL REACT TO THE USG POSITION. HE SAID HE IS NOT AS RIGID IN HIS JUDGMENT ON THIS ISSUE AS HIS MINISTERS HAD BEEN IN EARLIER EXCHANGES ON THE SUBJECT (REF A). HOWEVER, HE STRESSED THE NEED TO HAVE ADEQUATE RESOURCES PLEDGED TO COVER THE REQUIREMENTS FORESEEN IN THE COCA

ERADICATION PROGRAM. HE ADMITTED THAT VOLUNTARY ERADICATION PROGRAMS UNDERTAKEN THUS FAR HAD BEEN A FAILURE. THE AMBASSADOR OBSERVED THAT THE VOLUNTARY ERADICATION PROGRAM PLANNED FOR THE COMMUNITY OF IBUELO IN THE CHAPARE HAD FAILED WHEN THE PRESSURES OF U.S.-SUPPORTED BLAST FURNACE ACTIVITY WERE REMOVED, AND THE PRICE OF COCA LEAF RETURNED TO ITS PREVIOUS LEVELS. THE PRESIDENT AGREED THAT ONLY SUSTAINED ENFORCEMENT EFFORTS CAN KEEP COCA PRICES LOW AND CREATE THE NECESSARY CONDITIONS FOR ERADICATION TO OCCUR.

NEW LAW AND NEED FOR A NEW BILATERAL AGREEMENT

CET RETURNING TO THE SUBJECT OF THE NARCOTICS LAW, AMBASSADOR ROWELL EMPHASIZED THE FUNDAMENTAL IMPORTANCE OF THE NEW GOVERNMENT PROPOSAL TO FUTURE PROGRESS AND COOPERATION ON NARCOTICS. ALSO STRESSED THAT UNLESS A NEW BILATERAL NARCOTICS AGREEMENT WITH BOLIVIA CAN BE AGREED ON AND SIGNED BY FEBRUARY 28, THE EFFECTS ON U.S. AID LEVELS FOR THE BALANCE OF FY-87 WILL BE SEVERE. MRS. WROBLESKI ADDED THAT BOLIVIA IS THE ONLY NARCOTICS-PRODUCING COUNTRY IN THE WORLD WITHOUT ADEQUATE NARCOTICS LEGISLATION. SHE SAID SHE BELIEVED THE PAZ ADMINISTRATION HAS THE OPPORTUNITY TO PASS A TOUGH LAW NOW. THE LAW MUST LIMIT COCA CULTIVATION TO TRADITIONAL NEEDS ONLY AND MAKE CLEAR PROVISION FOR ERADICATION OF THE REMAINDER. WHEN DR. PAZ OBSERVED THAT COCA CULTIVATION IS TRADITIONAL IN BOLIVIA, MRS. WROBLESKI REPLIED THAT OTHER ANDEAN COUNTRIES WHERE COCA CHEWING EXISTS HAVE PASSED SUCH TOUGH LAWS. PRESIDENT PAZ SAID THAT HIS GOVERNMENT IS DOING ITS BEST TO PUSH THE NEW LAW ALONG WITH THE KEY PROVISIONS AGREED DURING THE OCTOBER U.S.-BOLIVIAN BILATERAL DISCUSSIONS, BUT THERE WILL BE DIFFICULTIES IN GETTING THIS LAW PASSED.

U.S. SUPPORT SUBSTANTIAL AND EXCEPTIONAL

MRS. WROBLESKI SAID THAT THE USG SUPPORTS BOLIVIA'S PLAN FOR A 12-MONTH PERIOD OF VOLUNTARY ERADICATION, AND THAT THE ASSISTANCE WE HAVE OFFERED IN THE FORM OF LABOR PAYMENT AND COMMODITY SUPPORT HAS BEEN OFFERED TO NO OTHER NARCOTICS-PRODUCING NATION. PRESIDENT PAZ SAID HE FERVENTLY HOPES THAT WE CAN REACH AN AGREEMENT ON THIS ISSUE. AMBASSADOR ROWELL SAID HE WILL MEET PRIVATELY WITH PLANNING MINISTER GONZALO SANCHEZ DE LOZADA ON THIS SUBJECT JANUARY 13. AMBASSADOR SECRET SECTION 03 OF 03 LA PAZ 00405 LIMA FOR ASSISTANT SECRETARY WROBLESKI E.O. 12356: DECL: OADR TAGS: SNAR, BL, EAID SUBJECT: INM ASSISTANT SECRETARY WROBLESKI'S CALL ON ROWELL CONCURRED THAT QUICK AGREEMENT ON THE FAMILY ASSISTANCE ISSUE IS ESSENTIAL. HE WAS OPTIMISTIC THAT WE WILL SUCCEED.

10. (LOU) MRS. WROBLESKI AND PRESIDENT PAZ EXCHANGED COMMENTS ON THE DANGERS OF NARCOTICS TO CURRENT AND

FUTURE GENERATIONS OF BOLIVIANS. PRESIDENT PAZ AGREED, OBSERVING THAT BOLIVIA MUST ALSO FACE PROBLEMS OF POVERTY AND CORRUPTION. MRS. WROBLESKI REPLIED THAT NARCOTICS TRAFFICKERS MUST BE VIEWED AS COMMON CRIMINALS AND INTERNATIONAL OUTLAWS WHO WORK BY VIOLENCE AND INTIMIDATION. THEY MUST NOT BE ALLOWED TO INFLUENCE THE DECISIONS OF GOVERNMENTS. PRESIDENT PAZ AGREED, NOTING THAT IN BOLIVIA'S CASE CONTINUED INTERNATIONAL SUPPORT WILL BE NECESSARY TO HELP BOLIVIA CARRY ON THE FIGHT.

COMMENT

11. (S) AT A RECEPTION LATE JANUARY 12 FOREIGN MINISTER BEDREGAL TOLD THE AMBASSADOR THAT PRESIDENT PAZ HAD TURNED DOWN BEDREGAL'S REQUEST TO PARTICIPATE IN THE PAZ-WROBLESKI MEETING. WE THINK THAT FOR PERSONAL POLITICAL REASONS BEDREGAL WOULD LIKE TO TORPEDO THE COCA ERADICATION STRATEGY IF HE CAN BLAME THE U.S. FOR THE COLLAPSE. PAZ OBVIOUSLY IS FIGHTING BEDREGAL ON THIS. WE NOTED THE INTENSE BILATERAL DISCUSSIONS THE U.S. HAS CONDUCTED WITH BOLIVIA FOR THE PAST FEW MONTHS AND THE IMPORTANCE OF THE UPCOMING FEBRUARY 7 MEETING IN VIENNA AS A FOLLOW-ON TO THE OCTOBER PARIS WORLD BANK CONSULTATIVE SUB-GROUP DISCUSSIONS OF BOLIVIA'S THREE-YEAR ANTI-NARCOTICS STRATEGY. THE AMBASSADOR MADE CLEAR THAT THE PROJECTED BOLIVIAN DOLS 300 MILLION COSTS FOR THE STRATEGY ARE FAR BEYOND THE ABILITY OF BOLIVIA AND THE U.S. ALONE TO FUND. THIS UNDERSCORES THE IMPORTANCE OF THE VIENNA MEETING AS A POTENTIAL FORUM FOR GAINING ADDITIONAL INTERNATIONAL DONORS. DI GENNARO WAS EXTREMELY PESSIMISTIC ABOUT THE ONE-DAY VIENNA MEETING'S CHANCES OF SECURING SUCH FUNDING. HE INDICATED HE IS MAKING EVERY EFFORT DURING HIS BRIEF STAY IN LA PAZ TO LOWER SUCH BOLIVIAN EXPECTATIONS. DI GENNARO QUESTIONS WISDOM OF FEBRUARY 7 VIENNA

(C-NF) DI GENNARO CANDIDLY SUGGESTED THAT THE UNFDAC DEPUTY DIRECTOR, CAUGHT UP IN THE ENTHUSIASM OF THE OCTOBER PARIS MEETING AND BOLIVIA'S ANTI-NARCOTICS FIGHT, HAD OVER-COMMITTED UNFDAC IN OFFERING TO PROVIDE FACILITATIVE ASSISTANCE FOR A ONE-DAY COUNTRY-SPECIFIC SESSION ON BOLIVIA. HE VOICED CONCERNS THAT EVEN THIS LOGISTICS GESTURE COULD SET A PRECEDENT FOR OTHER COUNTRIES. HE ALSO QUESTIONED WHETHER POTENTIAL DONOR COUNTRIES WOULD HAVE HAD SUFFICIENT TIME TO FOCUS ON BOLIVIA'S NEEDS, AND HE FEARED THAT A CONSEQUENT LACK OF AID PLEDGES -- "FAILURE" -- WOULD HURT UNFDAC'S REPUTATION AS THE "MOST SERIOUS AND EFFECTIVE ORGANIZATION IN THE U.N. SYSTEM." HE ALSO THOUGHT SUCH AN OUTCOME WOULD UNDERMINE HIM IN HIS CURRENT POWER STRUGGLE WITH U.N. SYG PEREZ DE CUELLAR. (2) IN HIS LA PAZ MEETINGS WITH THE GOB, DI GENNARO SAID HE WAS TRYING TO LIMIT DAMAGE BY DEFLATING ### BDFFVARCOTICS. HE CLEARLY INDICATED THAT UNFDAC WOULD STAY AT AN ARM'S-LENGTH DISTANCE FROM THE FEBRUARY VIENNA MEETING ON BOLIVIA.

RUMOR OF U.S. "MISGIVINGS" FIRMLY DENIED ______

(C) WITHOUT OFFERING A SOURCE, DI GENNARO INDICATED THAT THERE IS A RUMOR, PARTICULARLY IN THE U.K., THAT THE U.S. ITSELF HAS BACKED AWAY SOMEWHAT FROM BOTH THE BOLIVIAN STRATEGY AND THE VIENNA MEETING ITSELF. HE INDICATED CONFIDENTIAL SECTION 02 OF 03 LA PAZ 00424 NOFORN

LIMA FOR ASSISTANT SECRETARY WROBLESKI VIENNA FOR UNVIE

TAGS: BL, SNAR, EAID, UNFDAC, UN HE HAD BEEN ACCUSED OF BEING OVERLY INFLUENCED BY THE U.S. LACK OF ENTHUSIASM FOR THE MEETING. (LOW) BOTH ASSISTANT SECRETARY WROBLESKI AND THE AMBASSADOR EMPHATICALLY STATED THAT THE U.S. SUPPORTS THE OBJECTIVES AND FRAMEWORK OF THE BOLIVIAN ANTI-NARCOTICS STRATEGY AS WELL AS THE FEBRUARY VIENNA MEETING. A SUCCESSFUL MEETING IS AN ESSENTIAL PSYCHOLOGICAL BOOST FOR THE BOLIVIAN GOVERNMENT, PARTICULARLY WITH RESPECT TO KEEPING THE PRESSURE ON THE BOLIVIAN GOVERNMENT TO COMPLETE AND SUBMIT A TOUGH NEW ANTI-NARCOTICS LAW TO THE BOLIVIAN CONGRESS PRIOR TO THE VIENNA MEETING. DI GENNARO WAS IN ACCORD WITH THE IMPORTANCE OF THE NEW LAW AND SAID HE WOULD EMPHASIZE THE POINT IN HIS DISCUSSIONS WITH GOB OFFICIALS.

O DI GENNARO SAID HE HAS BEEN TELLING THE BOLIVIANS AND OTHERS THAT HIS VIEWS ABOUT THE FEBRUARY 7 MEETING ARE STRICTLY HIS OWN AND ARE BASED ON HIS CONCERNS FOR UNFDAC INTEGRITY AND POLICY AND HIS PAST EXPERIENCES WITH INTERNATIONAL

- 7. (C) IN CONFIDENCE, DI GENNARO NOTED HIS EXPECTATION THAT THE ITALIAN GOVERNMENT WOULD SUBSTANTIALLY INCREASE ITS CONTRIBUTIONS TO UNFDAC TO SOME 300 MILLION DOLLARS AS OPPOSED TO THE 60 MILLION DOLLARS OVER THE PAST THREE YEARS. HE HOPED TO USE THIS INCREASE AS LEVERAGE FOR ADDITIONAL INTERNATIONAL CONTRIBUTIONS AND, ON THIS SCORE, WAS MOST HOPEFUL ABOUT INCREASES FROM LONDON AND BONN. HIS MOST DISCOURAGING COMMENT WAS ON SPANISH CONTRIBUTIONS THUS FAR WHICH HE TERMED "SHAMEFUL."
- (C) WHILE HE CONTINUES TO EXHIBIT A SOFT SPOT FOR BOLIVIAN NEEDS, DI GENNARO PUT COLOMBIA AT THE TOP OF HIS HEMISPHERIC PRIORITY LIST WHILE CONCEDING THAT HE HOPED TO DOUBLE THE YUNGAS PROJECT FUNDING IN BOLIVIA FROM THE CURRENT 21 MILLION DOLLARS TO APPROXIMATELY 52 MILLION DOLLARS. HE STRONGLY RESISTED THE AMBASSADOR'S SUGGESTION THAT ADDITIONAL UNFDAC FUNDING IN BOLIVIA WOULD MORE PRODUCTIVELY GO TO AREAS SUCH AS THE CHAPARE, BUT DID NOT RULE THE IDEA OUT ENTIRELY. ANY INCREASES IN ALLOCATIONS FOR BOLIVIA OR DIRECTION OF UNFDAC RESOURCES TO AREAS OTHER THAN THE YUNGAS WILL DEPEND ON THE STRENGTH OF SUGGESTIONS ALONG THOSE LINES FROM MAJOR UNFDAC CONTRIBUTORS. DI GENNARO DID APPRECIATE THE NEED TO MULTI-LATERALIZE THE ANTI-NARCOTICS EFFORT IN BOLIVIA BEYOND THE PREDOMINANTLY U.S. FOCUS.

9. (2) IT WAS CRITICAL THAT ANY DOUBTS ABOUT U.S. SUPPORT TO THE BOLIVIAN ANTI-NARCOTICS STRATEGY AND OUR ENTHUSIASTIC PARTICIPATION IN THE UPCOMING VIENNA MEETING WERE RESOLVED. DI GENNARO'S SUGGESTION THAT THE U.S. CONTACT POTENTIAL DONORS BILATERALLY IS PARTICULARLY IMPORTANT IN LIGHT OF HIS DISCOMFORT ABOUT THE UNFDAC ROLE VIS-A-VIS BOLIVIA AT THE VIENNA MEETING AND HIS CLEAR INTENTION TO STAY AT ARM'S-LENGTH. HE HOPED TO USE THIS INCREASE AS LEVERAGE FOR ADDITIONAL INTERNATIONAL CONTRIBUTIONS AND, ON THIS SCORE, WAS MOST HOPEFUL ABOUT INCREASES FROM LONDON AND BONN. HIS MOST DISCOURAGING COMMENT WAS ON SPANISH CONTRIBUTIONS THUS FAR WHICH HE TERMED "SHAMEFUL."

(C) WHILE HE CONTINUES TO EXHIBIT A SOFT SPOT FOR BOLIVIAN NEEDS, DI GENNARO PUT COLOMBIA AT THE TOP OF HIS HEMISPHERIC PRIORITY LIST WHILE CONCEDING THAT HE HOPED TO DOUBLE THE YUNGAS PROJECT FUNDING IN BOLIVIA FROM THE CURRENT 21 MILLION DOLLARS TO APPROXIMATELY 52 MILLION DOLLARS. HE STRONGLY RESISTED THE AMBASSADOR'S SUGGESTION THAT ADDITIONAL UNFDAC FUNDING IN BOLIVIA WOULD MORE PRODUCTIVELY GO TO AREAS SUCH AS THE CHAPARE, BUT DID NOT RULE THE IDEA OUT ENTIRELY. (S) GONY WARNED THAT BEDREGAL'S JANUARY 7 COMMENTS TO THE BOLIVIAN PRESS THAT THE U.S. HAD "BACKED OFF" ON THE "350 MILLION DOLLAR" PROGRAM WERE BASICALLY AN EFFORT BY THE FOREIGN MINISTER TO POSITION HIMSELF TO TAKE ADVANTAGE OF WHATEVER OUTCOME EMERGES FROM OUR CURRENT TALKS. IF WE MANAGE TO PERSUADE OTHER KEY ACTORS, INCLUDING BOLIVIAN CONGRESSMEN, TO GO THROUGH WITH THE STRATEGY ON THE BASIS OF CURRENTLY OFFERED U.S. ASSISTANCE, BEDREGAL IS ON THE HIGH GROUND IN TERMS OF ADVOCATING THE TOTAL STRATEGY. BEDREGAL WOULD SAY THAT BOLIVIA HAD MADE A MAJOR EFFORT TO PRODUCE A WORKABLE STRATEGY THAT PROMISED TO ACCOMPLISH MORE COCA ERADICATION THAN ANY OTHER COUNTRY. BEDREGAL WOULD ADD, HOWEVER, THAT HE WAS NOT PREPARED TO TOLERATE CRITICAL, "UNWORKABLE AND UNACCEPTABLE" U.S. REVISION OF A PROGRAM WHICH IS INTEGRALLY AN ISSUE OF BOLIVIAN NATIONAL SOVEREIGNTY. 5. (C) AMBASSADOR ILLANES, IN PARTICULAR, ENTERED THE MEETING CONVINCED THAT NOTHING SHORT OF THE FULL CASH-PAYMENT BASIS FOR THE FAMILY REHABILITATION FUND WOULD BE POLITICALLY ACCEPTABLE TO THE BOLIVIAN CONGRESS. BASED UPON HIS OWN DISCUSSIONS WITH U.S. CONGRESSIONAL STAFFERS, HE THOUGHT THIS HAD SUPPORT ON THE HILL IN WASHINGTON. HE IS A MAJOR DRIVING FORCE ARGUING FOR A DIRECT COMMUNICATION FROM PRESIDENT PAZ TO PRESIDENT REAGAN ADVOCATING THAT THE USG REVIEW ITS DECISION ON THIS ISSUE. EMBOFFS CHALLENGED THE COMPREHENSIVENESS OF ILLANES' CONGRESSIONAL SAMPLE; REVIEWED CURRENT LEGISLATIVE PROHIBITIONS AS WE UNDERSTAND THEM; NOTED THAT OTHER DRUG-PRODUCING COUNTRIES HAD PREVIOUSLY MADE SIMILAR UNSUCCESSFUL REQUESTS AND RESISTANCE TO CREATING SUCH A PRECEDENT; AND EMPHASIZED THAT THE CURRENT INSTRUCTIONS TO AMBASSADOR ROWELL FROM THE DEPUTY SECRETARY HAD EMERGED AFTER LENGTHY, PAINFULLY THOROUGH DISCUSSION OF THE ISSUES. MOST POINTEDLY, WE URGED THAT ANY PRESIDENTIAL COMMUNICATION SHOULD NOT HAVE A TAKE-IT-OR-LEAVE-IT TONE, BUT SHOULD LEAVE ROOM FOR FLEXIBILITY.

6. (C) CONSIDERABLE TIME WAS SPENT DISCUSSING THE AVAILABLE LATITUDE IN THE CURRENT U.S. POSITION (E.G., POSSIBILITY OF RELOCATION FINANCING, CREDIT, AND LEVEL OF LABOR COSTS FOR ERADICATION). DCM AND

USAID DIRECTOR STRESSED THAT OUR EFFORTS WOULD BE BEST SPENT ON TRYING TO ARRIVE AT A MUTUALLY ACCEPTABLE PACKAGE COMBINING ALL RELEVANT ELEMENTS WHILE RETAINING A HEAVY IN-KIND COMPONENT. PERHAPS THE IN-KIND AID WILL HAVE TO EMPHASIZE FOOD ASSISTANCE. ALL PARTICIPANTS IN THE VOLUNTARY ERADICATION PROGRAM WOULD PROBABLY REQUIRE SUCH AID AS ILLUSTRATED BY THE CURRENT UNEMPLOYED MINERS IN AREAS SUCH AS COCHABAMBA WHO HAD THEMSELVES RECEIVED A CASH PAYMENT AS PART OF THE GOVERNMENT SETTLEMENT.

7. (C) AMBASSADOR ILLANES, REFLECTING MORE OF SANCHEZ DE LOZADA'S OWN PRAGMATISM, BEGAN TO APPEAR WILLING TO CONSIDER SUCH A POSSIBILITY. HE STILL ARGUED, HOWEVER, THAT CASH MUST REMAIN A MAJOR INGREDIENT AS A POLITICAL INDUCEMENT.

8. (C) WE REVIEWED AVAILABLE FY-87 AND PROPOSED FY-88 USG FUNDING FOR BOLIVIA'S COCA ERADICATION STRATEGY. ILLANES SEEMED GREATLY RELIEVED WHEN HE UNDERSTOOD HOW RESOURCES FROM TWO U.S. FISCAL YEARS COULD APPLY TO THE CRITICAL FIRST 12 MONTHS OF THE ERADICATION STRATEGY. THERE ALSO WAS CLEAR RECOGNITION OF THE NECESSITY FOR ADDITIONAL INTERNATIONAL FINANCING. IN THIS CONTEXT ALL PARTIES RECOGNIZED THAT RECENT GOB SPOKESMEN ALLEGING A PURPORTED USG COMMITMENT TO FUND THE FULL 300 MILLION DOLLARS WERE INACCURATE AND DESTRUCTIVE OF OUR MUTUAL EFFORTS.

(C) ON THURSDAY, JANUARY 23, A DELEGATION FROM THE FOREIGN MINISTRY (RENE SORIA GALVARRO, CHIEF OF STAFF; PASTOR SAINZ, U.S. DESK OFFICER; EULELIO MEDINA, DIRECTOR OF MULTILATERAL AFFAIRS) CALLED ON THE AMBASSADOR ON FOREIGN MINISTER BEDREGAL'S INSTRUCTION. ALTHOUGH THERE WAS NO ADVANCE AGENDA, THE 45-MINUTE MEETING DEALT WITH A RANGE OF BOLIVIAN BILATERAL CONCERNS DEALING MAINLY WITH U.S. ANTI-NARCOTICS COOPERATION IN BOLIVIA AND IN U.N. FORA. THE AMBASSADOR TOOK THE OPPORTUNITY TO REVIEW OUR OWN WORRIES ABOUT THE CURRENT COURSE OF CERTAIN BOLIVIAN ANTI-NARCOTICS EFFORTS AND STATEMENTS. THE BOLIVIANS ALSO FEARED POSSIBLE GSA TIN DISPOSALS WOULD SINK A RECENT WEAK TIN PRICE RECOVERY. END SUMMARY.

2. (C) SORIA HANDED THE AMBASSADOR A COPY (TEXT IN SEPTEL) OF A FIRST-PERSON CABLE FROM BEDREGAL TO SECRETARY SHULTZ TO BE DELIVERED BY BOLIVIA'S AMBASSADOR ILLANES IN WASHINGTON. THE MESSAGE REVIEWS, AS A BACKDROP TO THE AMBITIOUS NEW THREE-YEAR ANTI-NARCOTICS PROGRAM, THE ECONOMIC OBSTACLES DARINGLY FACED BY THE BOLIVIAN GOVERNMENT (E.G., DROP IN TIN AND HYDROCARBON PRICES) IN RIGOROUSLY PURSUING ITS NEW ECONOMIC POLICY. - 4. (C) WITHIN THIS CONTEXT, IT WAS BOTH UNFAIR AND DANGEROUSLY INACCURATE FOR THE FOREIGN MINISTER TO REFER TO ANY U.S. MORAL OBLIGATION TO PROVIDE 350 MILLION DOLLARS AS HAD BEEN DONE ON SEVERAL OCCASIONS RECENTLY IN THE BOLIVIAN MEDIA.
- S. (C) THE MOST IMMEDIATE PRIORITY, THE AMBASSADOR STATED, IS ACTION ON THE STILL-STALLED BOLIVIAN ANTI-NARCOTICS LEGISLATION AND ON A NEW BILATERAL AGREEMENT. IF THE LATTER IS NOT COMPLETED BY MARCH 1, BOLIVIA WILL LOSE A SUBSTANTIAL PORTION OF THE REQUIRED U.S. FUNDING, SOME 20 MILLION DOLLARS FOR FY 1987 PLUS MUCH OF THE OVER 100 MILLION DOLLARS PRESIDENT REAGAN HAS ASKED THE CONGRESS TO APPROPRIATE FOR ECONOMIC AND MILITARY ASSISTANCE TO BOLIVIA IN FY 1988. AS A FURTHER COMPLICATION, HE UNDERLINED, U.S. REPRESENTATIVES IN MULTILATERAL FINANCIAL INSTITUTIONS WOULD BE FORCED TO VOTE AGAINST BOLIVIAN LOAN AND GRANT REQUESTS. THE AMBASSADOR REMINDED SORIA THAT

6. (C) COMMENT: OUR EXPERIENCE WITH SORIA IN THE PAST HAS BEEN THAT HE IS AN ACCURATE MESSENGER FOR THE FOREIGN MINISTER. HE TOOK EXTENSIVE NOTES ON THESE POINTS AND EXPRESSED APPRECIATION FOR THE DETAILED REVIEW. IT IS, HOWEVER, IRONIC THAT MUCH OF THIS CONTINUES TO BE RECEIVED AS ANYTHING OF A SURPRISE. WE HAVE BELABORED THE TIME-SENSITIVE NATURE OF BOTH THE LEGISLATION AND BILATERAL AGREEMENT CONTINUOUSLY OVER THE PAST FEW WEEKS, INCLUDING WITH THE FOREIGN MINISTER. END COMMENT.

(C) SORIA AND HIS COLLEAGUES SPENT MOST OF THEIR TIME PRESSING THE SECOND POINT IN BEDREGAL'S MESSAGE: THE LACK OF USG SUPPORT FOR FOREIGN MINISITER BEDGRGAL'S CANDIDACY TO PRESIDE OVER THE JUNE WORLD NARCOTICS CONFERENCE IN VIENNA. SORIA REFERRED TO A LATIN AMERICAN CONSENSUS, INCLUDING THE CARIBBEAN, BEHIND BEDREGAL. HE STRESSED THAT ONLY FULL PUBLIC, U.S. SUPPORT, HOWEVER, COULD BROADEN THIS BACKING ENOUGH TO WIN THE PRESIDENCY FOR BEDREGAL. IN CONTRAST TO OUR LONG-STANDING GOOD RELATIONS AND THE HEMISPHERIC INTERESTS WHICH WOULD ARGUE FOR SUCH SUPPORT, SORIA SAID THAT MALAYSIA HAS BEEN TELLING OTHERS IT HAS U.S. BACKING. ARE MALAYSIA' ASSERTIONS "A GAME," OR IS THE U.S. TURNING ITS BACK ON BEDREGAL?
- B. (S) COMMENT: BEDREGAL HAS A LOT OF PERSONAL POLITICAL AMBITION RIDING ON THIS CANDIDACY. IF FRUSTRATED RECAUSE OF WHAT HE SEES AS U.S. "PERFIDY," HE CAN BECOME A FORMIDABLE OBSTACLE TO A WIDE RANGE OF OUR BILATERAL OBJECTIVES IN BOLIVIA. COULD WE SPONSOR A "CO-PRESIDENCY" IN WHICH BEDREGAL WOULD BE "CO-PRESIDENT" FOR PERENNIAL DRUG CROP (COCA) COUNTRIES? END COMMENT.

REPORTED GSA STRATEGIC MINERALS SALES AUTHORIZATION

9. (C) BOLIVIAN ANXIETY OVER REPORTS OF POSSIBLE GSA STRATEGIC MINERALS SALES WAS RAISED AGAIN. SORIA SPECIFICALLY REFERRED TO RECENT U.S. LEGISLATION AUTHORIZING SUCH SALES. THE AMBASSADOR INDICATED THAT HE HAD NOT SEEN THE REFERENCED REPORT. HOWEVER, SUCH LEGISLATION IS ONLY AN AUTHORIZATION. MOREOVER, GSA SALES MUST ALWAYS BE CONDUCTED IN A FORM THAT MINIMIZES ANY IMPACT ON WORLD PRICES. THEY MUST BE PEGGED AT SECRET SECTION 03 OF 03 LA PAZ 00764 E.O. 12356: DECL: OADR TAGS: SL, PREL, UN, UNFDAC, EMIN SUBJECT: BOLIVIAN DEMARCHE ON RANGE OF FOREIGN THE CURRENT GOING RATE, ARE OFFERED PRIMARILY TO U.S. DOMESTIC PURCHASERS AS PART PAYMENTS FOR REPROCESSING GSA METALS, AND IN RECENT YEARS

HAVE CONSTITUTED NO MORE THAN TWO TO THREE PERCENT OF TOTAL WORLD SALES -- NOT ENOUGH TO AFFECT WORLD PRICES. BRAZILIAN AND CHINESE OUTPUT PLUS THE OLD TIN COUNCIL'S PLEDGED STOCKS ARE THE REAL SOURCE OF DEPRESSED TIN PRICES.

10. (C) SORIA NONETHELESS ASERTED THAT THE GSA SALES HAVE A MAJOR PSYCHOLOGICAL IMPACT, AT LEAST IN THE SHORT RUN, THROUGH THE PUBLICITY THEY GENERATE. THE PRESENT TIMING FOR SUCH SALES IS PARTICULARLY DELICATE FOR BOLIVIA, HE SAID, BECAUSE TIN PRICES HAVE JUST STARTED TO RECOVER.

CONCLUSION

(S) WHILE THERE WAS A FAIR AMOUNT OF FORM IN SORIA'S DEMARCHES, SEVERAL CONCERNS DO STAND OUT WITH LONGER-TERM IMPLICATIONS FOR OUR RELATIONS WITH THE BOLIVIAN GOVERNMENT, PARTICULARLY THE FOREIGN MINISTER. WHILE BEDREGAL'S OUTSPOKEN USE OF THE BOLIVIAN MEDIA TO MISCONSTRUE THE SIZE OF THE U.S. COMMITMENT FOR THE ANTI-NARCOTICS EFFORT INVOLVES HIS OWN POLITICAL POSITIONING TO ENSURE A SCAPEGOAT SHOULD THE EFFORT FAIL, HE DOES HAVE GENUINE RESERVATIONS ABOUT OUR INABILITY TO CONTRIBUTE TO A CASH PAYMENT FOR THE FAMILY REHABILITATION FUND. THESE POLITICAL INSTINCTS ARE SHARED BY PLANNING MINISTER GONZALO SANCHEZ DE LOZADA AND BOLIVIAN AMBASSADOR TO THE U.S. FERNANDO ILLAMES, BOTH OF WHOM ARE FAR MORE SINCERE SUPPORTERS OF THE ANTI-NARCOTICS EFFORT. SECONDLY, BEDREGAL IS SERIOUS BOTH ABOUT HIS CANDIDACY FOR THE PRESIDENCY OF THE JUNE VIENNA MEETING AND THE IMPORTANCE OF STRONG, PUBLIC U.S. BACKING. HIS REACTION, READ RESENTMENT, TO A FAILURE OF SUCH BACKING WILL NOT DISAPPEAR QUICKLY AND, COMBINED WITH AN INSTINCTIVE ANTI-U.S. TEMPERAMENT, CAN COMPLICATE OUR ONGOING BILATERAL EFFORTS IN A MYRIAD OF WAYS. 1. (U) THERE FOLLOWS IN PARAGRAPH 2 AN INFORMAL TRANSLATION OF A PERSONAL MESSAGE WHICH FOREIGN MINISTER BEDREGA CABLED TO AMBASSADOR ILLANES IN WASHINGTON FOR DELIVERY TO SECRETARY SCHULTZ. REFTEL REPORTS THE ORAL EXCHANGE WHEN WE RECEIVED THIS TEXT AND OUR COMMENTS.

2. (LOU) BEGIN TEXT:

"AS YOU ARE FULLY AWARE, THE CONSTITUIONAL GOVERNMENT OF BOLIVIA HAS UNDERTAKEN, BEGINNING IN AUGUST OF 1985, THE FUNDAMENTAL TASK OF HEALING ITS ECONOMY, WHICH WAS GRAVELY THREATENED BY THE WORST HYPERINFLATION IN THE HISTORY OF LATIN AMERICA. ENJOYED THE INITIAL SUPPORT OF THE UNITED STATES GOVERN-MENT IN OPERATION BLAST FURNACE, WHICH, UPON ITS CONCLUSION IN NOVEMBER OF LAST YEAR, SHOULD HAVE BEEN SUBSTITUTED BY A GLOBAL, COHERENT, EFFECTIVE AND SERIOUS PROGRAM. MY GOVERNMENT PROPOSED THE SO-CALLED TRIENNIAL PLAN AGAINST NARCOTICS TRAFFICKING, WHOSE PRINCIPLES WERE ACCEPTED BY RESPONSIBLE AMERICAN OFFICIALS. "THE CONCRETE MANIFESTATION OF THIS SUPPORT CAME ABOUT IN A BILATERAL MEETING OF OUR GOVERNMENTS, IN WHICH WE DISCUSSED ALL THE ASPECTS INHERENT IN THE PROPOSAL, PARTICULARLY THE PROVISION OF JOINT FINANCING FOR THIS UNAVOIDABLE ACTION BY OUR GOVERNMENTS, AN ACTION WHOSE MORAL AND ECONOMIC CONTENT IS OF SUCH IMPORTANCE THAT IT SURPASSES ANY SECONDARY CONSIDERATIONS. (U) ON FRIDAY, FEBRUARY 6, AID ASSISTANT ADMINISTRATOR FOR LATIN AMERICA AND THE CARIBBEAN (AA/LAC) DWIGHT INK MET WITH BOLIVIAN PRESIDENT VICTOR ((PAZ)) ESTENSSORO AND HIS MINISTERS OF FOREIGN RELATIONS (GUILLERMO BEDREGAL), PLANNING (GONZALO SANCHEZ DE LOZADA) AND INTERIOR (FERNANDO BARTHELEMY). ALSO PRESENT WERE THE AMBASSADOR, USAID DIRECTOR AND CRAIG BUCK OF LAC/SAM. 2. (C) INK OUTLINED U.S. ADMIRATION AND SUPPORT FOR THE EFFECTIVE AND COURAGEOUS ACTIONS OF THE PAZ GOVERNMENT IN THE AREAS OF ECONOMIC STABILIZATION AND NARCOTICS CONTROL. HE INDICATED THE HIGH LEVEL OF GOOD WILL TOWARD BOLIVIA THAT HAD DEVELOPED WITHIN THE U.S. HE OFFERED AS TANGIBLE EVIDENCE OF U.S. SUPPORT THE FACT THAT BOLIVIA WAS ONE OF THE FEW COUNTRIES WHERE BILATERAL ASSISTANCE LEVELS HAVE INCREASED IN AN ERA OF DECLINING BUDGETS AS WELL AS U.S. ENCOURAGEMENT OF ADDITIONAL ASSISTANCE FOR BOLIVIA FROM THE IFI'S. HOWEVER, THE ASSISTANT ADMINIS-TRATOR NOTED THAT THIS GOOD WILL COULD RAPIDLY DISSIPATE IF THE GOB DID NOT TAKE IMMEDIATE ACTION TO MAKE ITS NARCOTICS CONTROL EFFORTS MORE EFFECTIVE.

3. (C) INK MADE CLEAR THAT PAYMENT OF CASH TO BOLIVIAN FARMERS WHO ERADICATED THEIR COCA WOULD NOT BE POSSIBLE USING USG FUNDS AND THAT TO DO SO WOULD VIOLATE BOTH U.S. LAW AND DEEPLY-ROOTED, LONG-STANDING U.S. POLICY WHICH IS STRONGLY SUPPORTED IN THE U.S. CONGRESS AS WELL AS IN THE EXECUTIVE BRANCH. HE ALSO REMINDED THE BOLIVIANS THAT THE FOREIGN ASSISTANCE ACT (FAA) SECTION 481(H) DEADLINE FOR PRESIDENTIAL CERTIFICATION ON NARCOTICS PERFORMANCE IS MARCH 1. ABSENT SUCH CERTIFICATION, BOLIVIA WOULD LOSE HALF OF ITS PLANNED FY-1987 U.S. ECONOMIC AND MILITARY ASSISTANCE AND FORCE NEGATIVE U.S. VOTES ON PROPOSED ASSISTANCE FOR BOLIVIA IN THE WORLD BANK (IBRD) AND THE INTERAMERICAN DEVELOPMENT BANK (IDB). CERTIFICATION AS WELL AS THE ACTIONS NECESSARY FOR CERTI-BY LW NARADATE FICATION UNDER FAA SECTION 611(B).

4. (C) THE BOLIVIANS REACTED VERY NEGATIVELY. STRONGLY WORDED STATEMENTS BY THE MINISTERS OF PLANNING AND INTERIOR REITERATED THE GOB BELIEF THAT NOTHING OTHER THAN CASH WOULD BE SUCCESSFUL IN PROVIDING THE MEANS TO ECONOMIC TRANSITION THAT WOULD CONVINCE FARMERS TO ERADICATE THEIR COCA -- AND BOLIVIAN CONGRESSMEN TO MAKE COCA CULTIVATION ILLEGAL. THE INTERIOR MINISTER SAID THAT HE HAS BEEN ACTIVELY CAMPAIGNING WITH CONGRESS-MEN TO PASS A STRONG ANTI-NARCOTICS LAW THAT OUTLAWS COCA CULTIVATION IN ALL OF BOLIVIA EXCEPT NORTH AND SOUTH YUNGAS PROVINCE OF LA PAZ DEPARTMENT. HE SAID THAT THE CONGRESSMEN ARE INSISTING THAT THEY MUST SEE AMPLE, EFFECTIVE FINANCIAL ASSISTANCE FOR THE COCA-GROWING FAMILIES THAT WILL BE FORCED TO ERADICATE AND ABANDON THEIR PRESENT SOURCES OF LIVELIHOOD BEFORE THEY (THE CONGRESSMEN) ARE PREPARED TO TAKE THE POLITICALLY PAINFUL ACTION OF AGREEING TO SUCH A LAW. THE CRUX OF THE ISSUE IS DEMONSTRABLY AVAILABLE FINANCIAL ASSISTANCE FOR THE CAMPESINOS IN EXCHANGE FOR OUTLAWING COCA CULTIVATION. THE MINISTER OF PLANNING SAID THAT THE U.S. POSITION, WHICH WAS CONVEYED TO THE BOLIVIANS IN EARLY JANUARY, MORE THAN TWO MONTHS AFTER THE BILATERAL MEETINGS IN OCTOBER, PUTS BOLIVIA IN A "NO-WIN" DILEMMA GIVEN THE STRONG U.S. SANCTIONS THAT WOULD FOLLOW FROM FAILURE TO REACH AGREEMENT BY THE MARCH 1 CERTIFICATION DEADLINE. FORCING BOLIVIA TO ACT ON SUCH MAJOR ISSUES UNDER SUCH NEGATIVE CONDITIONS AND TIME CONSTRAINTS IS UNFAIR AND LIKELY TO BE EXTREMELY COUNTER-PRODUCTIVE. HE SAID THAT THE U.S. IS, IN FACT, THREATENING THE FUTURE ABILITY OF THE BOLIVIAN GOVERNMENT TO TAKE EFFECTIVE ACTION THAT WE ALL WANT (FOR EXAMPLE, THE PASSAGE OF AN EFFECTIVE NEW ANTI-NARCOTICS LAW). (C) THE PRESIDENT AND THE MINISTERS PRESENT WERE ACUTELY FRUSTRATED BY THE COMBINATION OF U.S. REFUSAL TO AGREE TO CASH PAYMENTS TO EX-COCA GROWERS, THE LACK OF TIME REMAINING UNTIL THE MARCH 1 CERTIFICATION DEAD-LINE, AND THE PROFOUND NEGATIVE IMPACT ON BOLIVIA IF CERTIFICATIONS FOR SECTIONS 481(H) AND 611(B) ARE NOT MADE. GIVEN THE TIME CONSTRAINTS, INK'S VISIT WAS WELL TIMED TO UNDERSCORE THE POTENTIAL DANGERS OF LACK OF MOVEMENT ON THE COMPENSATION ISSUE. 8. (C) THOUGH SILENTLY ANGRY, PRESIDENT PAZ ENDED THE MEETING IN WELL-CONTROLLED FASHION. WHILE THE AMBASSADOR TALKED PRIVATELY WITH THE PRESIDENT FOR A MOMENT ON OTHER SUBJECTS AFTER THE MEETING CLOSED, SANCHEZ DE LOZADA PRIVATELY TOLD INK AND COHEN THAT THE BOLIVIANS WILL LOOK VERY SERIOUSLY AT THE POSSIBLE SOLUTION INK HAD TABLED (PARA 5 ABOVE). 9. (C) AT A MEETING AT THE VICE PRESIDENT'S HOUSE LATER THAT NIGHT, THE AMBASSADOR FOLLOWED UP WITH BEDREGAL ON THE QUESTION OF CREDIT FORGIVENESS, AND BEDREGAL INDICATED THAT IT MERITS SERIOUS CONSIDERATION AS A POSSIBLE EXIT FROM THE IMPASSE. THE COVERAGE EMPHASIZED CLOSE U.S.-BOLIVIAN COOPERATION IN THE WAR AGAINST DRUGS. (USIS MEDIA REACTION REPORT COMING BY SEPTEL.) PARTICULARLY SIGNIFICANT WERE THE STATEMENTS BY FOREIGN MINISTER BEDREGAL AND PLANNING MINISTER SANCHEZ DE LOZADA WHO SPOKE WITH THE PRESS AFTER THE U.S. DELEGATION HAD SPOKEN WITH THE PRESS AND LEFT THE OFFICE OF THE PRESIDENCY. BEDREGAL SAID THE TALKS "WITH USAID ARE ON A GOOD FOOTING, ESPECIALLY FOR ACCELERATING THIS PROGRAM (ANTI-NARCOTICS) WHICH IS MULTILATERAL AND IN WHICH THE UNITED STATES HAS AN IMPORTANT ROLE TO PLAY." 

REMARKS

I would like to take this opportunity to thank you for your letter of January 29 in which you describe your government's outstanding economic accomplishments and ask that I reconsider my government's participation in Bolivia's "Three-Year Plan for Combatting Drug Trafficking".

The economic program your government is carrying out is one of the most impressive reform efforts undertaken in the Western Eemisphere. Your strong and personal commitment to a free market economy has stabilized the Bolivian economy and restored public confidence in democratic government. Your success is particularly impressive because Bolivia has undertaken these reforms during a period of severe domestic recession. Although these courageous measures have a political cost, you have obviously realized that in the long run these measures will insure a more prosperous future for Bolivia's children.





This is an appropriate opportunity to repeat to you my appreciation of the close working relationship established between our governments during operation Blast Furnace. Because of our mutual commitment to rid our countries of the drug scourge, we were able to overcome internal political difficulties and temporarily but successfully stop the illegal drug trade in your country. We can be proud of a job well done. Now, however, the time has come to move forward and resolve those differences that keep our two governments from working together to eliminate — for all time — illegal drugs in Bolivia.

My government supports the framework of the comprehensive narcotics control plan worked out by representatives of our two governments in October. This plan reflects the key elements of your "Three-Year Plan for Combatting Drug Trafficking," which are: effective interdiction, passage of a law outlawing coca production outside of the Yungas, and a 12-month program of voluntary eradication, followed by forced eradication.

We believe that this program is well conceived and will work if both our governments are fully committed to its success. We strongly believe that our assistance is sufficient to allow your government to initiate and carry out the first year of the program. We intend to provide \$75 million (\$30 million in FY87 and \$45 million in FY88) for support to families that voluntary eradicate their coca crops. Although these funds depend upon the approval of a supplemental FY87 request and approval by Congress of our FY88 request, we are sure that they will be available if the voluntary eradication program is working, and Bolivian farmers are eradicating their coca crops. We also intend to use pipeline funds to help provide credit for the families in the impacted regions. In addition, we will continue to supply the bulk of the material and training needed for effective interdiction.

Our faith in your ability to carry out this unprecedented narcotics control program and continue your ambitious economic reform effort is reflected by the increase in our aid to Bolivia. Bolivia now receives more assistance from my government that any country on the continent.

My government has grappled with the question of what form US assistance to coca farmers voluntarily eradicating their crops should take. After several months of intensive discussion, we concluded that in-kind rather than cash payments would be most appropriate. Experience with cash payments indicates that these funds are often quickly dissipated and provide little useful support for needy families. Moreover, my government has refused requests by other nations for cash payments for eradication. If we were to begin a cash payment program now, it could set an unfortunate precedent. Finally, the Foreign Assistance Act prohibits the use of appropriated dollars for eradication of drug corps.

Although in-kind assistance does not provide the "carrot" or incentive for eradication that cash provides, in-kind payment can support a family while its productive members seek alternative employment. We believe that with effective interdiction and the passage of a law outlawing the production of coca, farmers will no longer be able to support themselves through coca production. Consequently, they will agree to eradicate their coca crops in order to receive the in-kind support payment and avoid forced eradication at the end of the voluntary period.

It is my firm hope that our governments will find a mutually satisfactory solution to this payment problem. We can not let this issue stand in the way of winning the drug war, especially since Blast Furance has given us the courage and the momentum needed to successfully carry out this unique narcotics control program.

I hope that you will accept my invitation to officially visit in July. At that time we may review your plans for Bolivia's future, and I suspect that we will find that we have much in common, given your firm determination to direct your country toward a more prosperous future.

THE GOVERNMENTS OF THE REPUBLIC OF BOLIVIA AND THE UNITED STATES OF AMERICA, CONSCIOUS OF THE FACT THAT THE CRIME OF NARCOTICS TRAFFICKING IS A PROBLEM THAT AFFECTS BOTH COUNTRIES AS WELL AS THE INTERNATIONAL COMMUNITY, AND CONSIDERING THAT:

E) OTHER OPERATIONAL SUPPORT COSTS.

ARTICLE 3 THE SIX UH-1 HELICOPTERS MENTIONED ABOVE WILL BE DEDICATED EXCLUSIVELY TO NARCOTICS INTERDICTION AND CROP ERADICATION, AND THE THREE BOLIVIAN AIR FORCE 205 HELICOPTERS WILL BE DEDICATED PREFERENTIALLY AND IN ACCORDANCE WITH ANNEX ONE TO THE SAME TASKS.
