#### NOTES FOR SPERLING BREAKFAST ON WEDNESDAY, FEBRUARY 15th

#### General points

- o On the economy -- RR's program is working:
  - -- Last year, for first time since 1972, had combination of good growth (6% plus), low inflation (2nd straight year under 4%), and falling unemployment (fell 2 ½ points).
  - -- More good news this week as retail sales rose 2.2 percent, putting teeth in surveys that show rising consumer confidence.
  - -- Home and auto sales also up sharply, showing 4 year slump in these industries at an end.
- o On the deficit -- RR wants it cut, but need 3 things:
  - -- Democrats back at the table;
  - -- put aside unrealistic proposals (like \$100 billion defense cut Dems are talking about);
  - -- focus on what's do-able.

#### o On fairness

- -- Nothing fair in Democrats' double-digit inflation.
- -- Unfair to whom? Lower rates not unfair to taxpayers; lower inflation not unfair to fixed income poor and elderly.
- o On campaign '84 -- basically same choice as in 1980.
  - -- Whoever is Democratic nominee, choice for voters is going forward to era of opportunity or back to era of limits.
  - -- Democrats in 1980 said problems were so big we couldn't solve them this soon (but we're doing it). They seemed paralyzed then -- and now -- by America's problems. We thought we'd try to solve them -- and with people's help, we're doing it.

#### POLITICS OF CAMPAIGN '84

## What's RR's biggest problem going into campaign -- deficit, Lebanon, Foreign Policy in general?

- o Have always sought bipartisan foreign policy -- and certainly hope peace-keeping efforts in Lebanon can be removed from partisan politics. (Won't enter into RR's decisions now, or later.)
- o As for deficit, RR's still hopeful both parties can agree on downpayment plan. RR is sure the Democrats will raise deficit as an issue but still hopes they'll work with us now to lower deficit as a percent of GNP.
- o Know what aren't big problems for RR starting campaign:
  - -- inflation (perhaps biggest issue in 1980);
  - -- taxes;
  - -- growth ("era of limits" talk's been silenced);
  - -- declining respect for U.S. abroad;
  - -- malaise (Americans' hopes and confidence about the future -- for country and selves -- are rising).
- o Biggest campaign challenge may be organizational. Need to get Republicans at grass roots working -- now -- to put together structure that can match organizational abilities of Democrats' special interests.

#### Voter Registration -- can GOP counter big Democrat drive?

- o Reagan-Bush and Republican Party to mount major effort.
- o First big effort for us in a dozen years -- and it is critically important. RR understands committees will spend \$4 million or more to register new voters.

#### Why go to Iowa?

- o In 1980, RR learned to his regret that <u>not</u> going to Iowa can be a mistake.
- o Republicans have a process there too. May be less suspense to ours, but there's at least as much enthusiasm.
- Democrats using primary season to tear each other down. Republicans going to use the time to build up the party organizations. RR going to recognize, encourage that in Iowa.

#### Will there be lots of travel -- or "Rose Garden" strategy?

- o Hasn't been a Rose Garden Presidency. Will leave scheduling to campaign managers, but RR always likes getting out with people.
- o No trips planned though, to other early primary states.

#### Is Mondale locked in now? Will you debate him?

- o Nothing's ever locked-in this early in a campaign.
- Over-confidence is the cardinal sin of campaigning.
  RR always runs as if he's behind. Mondale would do
  well to do the same.
- o Whether he's the nominee, or one of the other seven, they all seem to be saying pretty much the same things right now.
- o As for debating: RR has said he favors concept, but too soon to start planning.

#### Matching funds?

NOTE: Rollins says campaign may decide not to take the \$10.5 million in federal matching funds. You are philosophically against. What's the decision?

- o Decision basically up to campaign managers.
- o True that RR doesn't like the idea of federal funds going to political campaigns.
- o But the fact the law is on the books influences campaign decision-making. Have to look at effect passing up matching funds would have on fund-raising for other GOP candidates (Senate, House, Governors, etc.).

NOTE: Laxalt, Rollins not talking about general election campaign. Planning to take federal funds for that. No practical alternative to getting full funding up front at start of campaign instead of mounting major effort after convention to start raising \$40 million or more.

#### Gender gap? How concerned are you? Any special strategy?

- o Pleased to see signs of growing support for RR, GOP among women.
- o Still aware polls show higher support from men than women for RR and his policies.
- o But as we get word out about our policies, as recovery continues to take hold -- as we continue our push for peace, arms reductions -- RR believes reservations among some women will diminish.
- o Pleased at Maureen's efforts in this regard -tonight's (Wednesday night) Susan B. Anthony birthday
  party event dramatizes the concern.

#### Aren't blacks being written off at Campaign headquarters?

- o Not writing any votes off. Going full tilt in all 50 states for every vote we can get.
- o RR thinks his campaign, GOP generally, can begin to build in 1984 on a minority base that's been too small for too many years. (GOP candidate since 1964 get only about 10% of black presidential vote.)
- o We're going to try.

#### UPDATE ON THE ECONOMY

- o 1983 was good year for the economy.
- o 1984 starting off well; should be another good year.
- o Retail sales up yesterday by very solid 2.2 percent. Have been up every month since August.
- o Business investment also rising and Commerce Department survey estimates a rise near 10% for 1984.
- o General retail sales rise accompanied by strength in major purchases. New home sales hit five-year high in 1983 and auto sales were up 33 percent last month over January of 1983.
- O University of Michigan survey out last week found consumer confidence at highest level in 18 years.
- o Hiring intentions among businessmen are also up, offering encouragement that unemployment drop will continue.
- NOTE: Stock Market decline biggest single "downer" right now. (Dow's down about 130 points in last five weeks, now at lowest level since April 1983.) No one can predict or explain the way the market behaves -- RR shouldn't have to try. But, IF ASKED, might offer these observations.
- Market behavior unpredictable.
- o Many observers say the current drop was to be expected after the bull market of 1982-83 (which many critics of RR's program didn't expect.) That got the Dow to a record high -- just shy of 1300 (1287 last November).
- o Some say current drop is a technical correction; others cite concern over deficits.
- Maybe some truth in both, deficits point just underscores importance of getting serious on bipartisan approach to deficit downpayment.

#### SOME REMINDER NOTES ON MAJOR ACCOMPLISHMENTS

- o Back in 1980, they were saying it couldn't be done but we have made a new beginning and brought more improvement, faster, and on many more fronts than most thought possible back then.
  - -- <u>Inflation's down:</u> From two years in double-digits to two years under 4 percent (1982-83).
  - -- <u>Unemployment's falling:</u> Fell more in 1983 than any year since 1950; 4 million found jobs in 1983.
  - -- GNP growth: About 6 percent last year, after virtually no growth for 4 years starting in 1979.
  - -- Tax rates cut: 25 percent for everyone.
  - -- Interest rates down: Prime only about half the post Civil War record of 21.5 percent.
  - -- Growth of government slowed: spending growth rate cut to about 2/3s the 1980 rate of 17.4 percent.
  - -- Regulation: burden reduced to save consumers, business \$150 billion in next 10 years.
  - -- Social Security: Retirement fund saved from bankruptcy while benefits for average retired couple rose more than \$150 a month (under RR).
  - -- Energy crisis eased: gasoline cheaper than on inauguration day; imports cut in half from 1977.
  - -- Education: Debate now focused on how much students learn, not how much government spends.



#### I. PURPOSE

To observe National Crime Prevention Week and to give recognition to elected officials, police chiefs, citizen volunteers, business leaders, and sports celebrities who have been particularly active in crime prevention.

#### II. BACKGROUND

The National Exchange Club began National Crime Prevention Week (February 12-18) 37 years ago and today works with its 1,300-member service clubs across the country to promote crime prevention activities. Their theme this year is "Keep the Watch Because Neighborhood Watch Works."

The National Citizens Crime Prevention Campaign is the major Administration initiative in crime prevention. It is an effective, high visibility public education program that features McGruff and the slogan "take a bite out of crime." The Campaign is funded by the Department of Justice with private sector support. They are focusing this year on protection of children and involving young people as positive partners in crime prevention programs.

The Crime Prevention Coalition is a group of 89 national organizations and Federal and state agencies. Its membership includes the General Foundation of Women's Clubs, the Boy Scouts, the National Urban League, and the American Association of Retired Persons. Lois Herrington chairs the Coalition.

PACT (Police and Citizens Together) is a local group made up of 22 police departments. All funding for the group comes from donations by local companies and service clubs. The Freedom Foundation, of which you are the Honorary Chairman, has selected PACT to receive the George Washington Honor Medal. You will present the medal to Chief Maurice Turner of the Metropolitan Police Department and Officer Kenneth Perry of the U.S. Park Police.

All these activities are mutually reinforcing and this ceremony will give you an opportunity to pay tribute to people from all over the nation who are helping in the battle against crime and restate your commitment to restoring safety to our streets and neighborhoods.
