I. PURPOSE

To demonstrate your concern for issues of interest to the Black Republican community.

II. BACKGROUND

The Council of 100, chaired by Elaine Jenkins, is a group of conservative black Republicans with whom I have been dealing over the past several months. We first got together at my suggestion to talk about enterprise zones from a black perspective and to help stimulate ideas on how to proceed with the President's enterprise zone proposal. Additionally, this group has expressed an interest on their part to talk further about such issues as the family, school prayer, and more recently the Dade County Minority Set Aside Program. This meeting is to fulfill that request.

- -- I know there are a number of other issues in which we are in agreement and your dialogue with us is very valuable.
- I am grateful for all the support that you are giving me and this Administration and we will continue to count on your good advice and help.
- -- I know that you have a full plate of issues, so I'll let you get back to work.

II. BACKGROUND

The NCA will be the first major agricultural organization headed by a woman when the president-elect takes office in January 1985. She was elected in January 1984.

There are approximately 1.3 million full and part-time beef cattle operators across the country. Beef is produced in all 50 states. Agriculture and agribusinesses are the nation's largest employer. Some 23 million persons work in some phase of agriculture and the food and fiber businesses. Farming itself uses 3.5 million workers -- as many as the combined work forces of transportation, steel and the auto industry.

The NCA performs three basic functions: First, the association represents the beef cattle industry to the legislative and administrative branches of the federal government. Second, it interprets beef production and beef economics to the public, and it interprets economic, social and political developments to the industry. Third, it provides economic and other information to the members to aid them in their own planning and management.

I. PURPOSE

To honor Senator Thurmond's request that S. 912 be signed at a White House ceremony.

II. BACKGROUND

The enrolled bill - S. 912 - Richard B. Russell Dam and Lake Project and the City of Abbeville, South Carolina, provides Abbeville with an amount of power from the Richard B. Russell Dam equivalent to the Abbeville plant's loss. The loss was caused by a Corps of Engineers' project upstream that diminishes the downstream power plant's electrical output. This is an Administration bill. Another section of the bill has already been enacted into law as a part of the continuing appropriations for FY 84.

Senator Robert Stafford, as Chairman of the Environmental and Public Works Committee, co-sponsored this legislation with Senator Thurmond. Senator Thurmond worked very hard to get this bill through the Senate and the House.

Senator Thurmond has had a busy First Session of the 98th Congress, with the Crime Package, the School Prayer Constitutional Amendment and Ed Meese's nomination, all before the Senate Judiciary Committee which he chairs. The signing ceremony is an added gesture of appreciation for his continued support of you and your policies.

Senator Thurmond will bring with him the Mayor, City Manager, and City Council of Abbeville, South Carolina. Abbeville is on a lake that borders the state of Georgia.



I. PURPOSE

To emphasize ongoing Presidential concern with respect to the situation in Central America, and to receive a first-hand report from Representatives and Senators who witnessed the election process in El Salvador.

II. BACKGROUND

The Presidential election in El Salvador was held on Sunday, March 25, 1984. A 30-person U.S. Presidential Delegation was in El Salvador to observe the election. Nineteen Members of the Delegation are a bipartisan group of Representatives and Senators who have exerted a leadership role on the Central America issue. This meeting will provide an excellent opportunity to show bipartisan support for our Central America policy and to discuss legislative issues of significance to the overall effort to promote democracy and stability in Central America.

The meeting will also allow the Delegation Members to report first-hand their observations while they were in El Salvador.

SUGGESTED TALKING POINTS FOR MEETING WITH SALVADORAN ELECTION OBSERVER DELEGATION

- -- Welcome back to Washington. I want to thank you all for your participation in a most remarkable demonstration of democracy in action.
- -- The Salvadoran elections prove that the people of El Salvador have chosen democracy and peace over repression and violence. These elections -- and the run-off next month -- are steps in a process of peaceful but fundamental change for El Salvador.
- -- We must ensure that the military in El Salvador -which is committed to this process -- has the resources it needs in order to protect the next round of elections.
- -- Despite the guerilla promises of two weeks ago, they made an effort to disrupt yesterday's peaceful expression of democracy. If the Army is not adequately equipped between now and the end of April, the guerillas could indeed succeed. We must not allow that to happen.

-- We will need your help in the days to come to ensure that our emergency support proposal is approved.
