I. PURPOSE

To sign H. J. Res. 454, honoring the contributions of Blacks to American Independence.

II. BACKGROUND

During the Revolutionary War years of 1776 to 1783, over 5,000 Black men participated in the American Revolution as Members of the Continental Army, and State and local militias. Blacks participated in every major battle, including Monmouth and Yorktown, and many distinguished themselves with acts of heroism.

The resolution which will be signed recognizes the important contributions of Blacks during the American Revolution and extends Congress' appreciation to the descendants of free Blacks and slaves who helped to bring about American Independence. The resolution also calls upon the Federal government and private organizations to commemorate the efforts of Blacks during the Revolution.

NOTES FOR FAMILY WEEKLY INTERVIEW ON MARCH 27th

General points:

- o Having a family in the first place is a statement about the future.
- o RR's policies designed to do two things:
 - ease heavy financial burden of taxes, inflation etc., on families to make the present livable;
 - restore hope for the future, not just in economic terms, but by restoring schools, slowing crime and drug abuse, and creating more job opportunities.
- o Family's are better off now than they were three years ago:
 - Typical family has \$1,100 more purchasing power than if tax and inflation rates were still at 1980 levels (family of four earning \$25,000);
 - Almost 5 million more jobs in last 15 months;
 - Lower interest rates make home-ownership now an affordable dream for millions who couldn't afford it 3 years ago. (Cost of \$50,000 mortgage almost \$160 less a month with lower rates.)
- o Gasoline selling for less than before RR's decontrol order. At start of the year, it was reported to be selling for less than \$1 a gallon in some areas.
- o Food prices trends are also favorable. For example:
 - From December 1980 to December 1983, bacon went up a nickel a pound. If inflation had stayed at 1980 rates, it would have gone up almost \$1.25;
 - Chicken went up a nickel a pound, too, in those three years, instead of almost 50¢;
 - Bread went up 3¢ a loaf, from 52¢ to 55¢, instead of the 16¢ it would have if 1980 price trends continued.

1. What do you see as the major concern of America's families?
 - o Parents' major concern has always been that their children's lives and opportunities will be at least as good -- or even better -- than their own.
 - o In good times or bad, that's what parents hope for -- and confidence that this hope can be realized has been an essential part of the American dream.
 - o In recent years, though, that hope dimmed. Inflation, diminishing job opportunities, the "rising tide of mediocrity" in our schools, the epidemics of crime and drug abuse all combined to make parents fearful and anxious about their children's future -- and uncertain about their own ability to support them in the present.
 - o As President, RR has tried to restore that hope -- to give people reason to believe that the future could be better. (Remember, back in 1980, the late 1970s, lots of talk that maybe America's best days were behind her. For a while, it looked like that might be true.)
 - o Now, though, we're looking forward again.
 - economic recovery has millions going back to work;
 - lower taxes and inflation make our earnings more valuable;
 - crime's down, 4 percent a year, the last two years;
 - nationwide, there's an assault on drug traffickers, and people, especially young people, are moving away from the drug culture (RR's proud of First Lady's role in this);
 - schools improving as parents, teachers, administrators recommit themselves to excellence.
 - o We have further to go, but we've tried to take a few important first steps in restoring hope and parents' confidence that their children's world will be an even better place. RR thinks we've made some progress.

2. What level of aid, if any, should the federal government provide for day care centers?
- o RR believes this need can be met best with policies that allow working parents a range of choices in child care. Single, heavily funded federal program would be a mistake.
 - o Most people with young children, age five or under, seem to prefer home care to institutional settings. Right now, most working parents (almost 80%) who need child care find it in the home -- their own or someone else's (Often, but not always, relatives provide the care.)
 - o This year (FY84), the federal government will provide almost \$4 billion worth of support for child care -- up about 26% from 1981 funding (Carter's last budget).
 - o But these dollars support the mixed approach RR prefers and which broadens choice for parents. The \$4 billion includes:
 - value of the child care tax credit -- which was increased in RR's tax cut of 1981;
 - tax incentives which benefit working parents whose employers provide day care;
 - increased budget for Head Start -- from \$885 million in FY 1981 to \$1,075,000 in FY 1985.

3. Are kids growing up in a more day-care-oriented environment likely to get the same type of upbringing that the traditional structures provide?
- o Lots of different views on how the day care environment affects children -- particularly institutional arrangements versus home care.
 - o But that's the best argument for the mixed approach we are following. When views differ so widely on such an important issue, the best policy is one that maximizes choice.
 - o Parents have the responsibility for raising their children and -- in the cases where child care is needed -- we think government should encourage a wide range of possible choices, so parents can pick the child-care setting they think is best.

4. Do you approve of federal government legal intervention in cases where parents in effect decide not to prolong the life of a seriously deformed child, such as in the case of Baby Doe?
- o RR approves of federal government intervention in cases where possibility exists that medical treatment of a handicapped new-born is being withheld solely because of the handicap.
 - o That's a civil rights issue.
 - o RR knows its controversial, but his Administration has taken important stand -- with "Baby Doe regulations" -- that civil rights laws which prohibit discrimination against the handicapped require federal action in some cases involving new-borns.
 - o Purpose is to make sure that treatment is not being withheld just because some think a baby's handicap is too severe to permit "meaningful" life. Who can make that judgment?
 - o But, as Surgeon General Koop (national respected pediatric surgeon) says, the purpose is never to prolong the act of dying, rather to ensure that the right to life is protected.

5. What is your reaction to the growing involvement of religious leaders in national affairs, particularly the Roman Catholic Church's participation in the ongoing nuclear freeze debate?

- o The involvement of religious figures in national affairs is not a new phenomenon in American politics.
- o In recent years, various issues with strong moral dimensions have -- properly -- prompted religious leaders to voice their opinions.
- o Civil rights, war and peace, arms control, right-to-life -- to mention only a few, are issues with which religious leaders have been involved.
- o By our law, they have a right to be involved; their beliefs very often prompt them to feel an obligation to be involved.
- o Nothing wrong in that nor threatening to our political system.
- o As for arms control statements by Catholic bishops, RR was pleased that Administration officials and bishops could establish a dialogue that allowed a free exchange of views and ideas. Didn't come to full agreement, but did get fuller appreciation of our different perspectives.

6. What level of aid do you think the federal government should provide for abortions?
- o RR doesn't believe federal government should finance abortions at all.
 - o Has supported prohibitions (such as Hyde amendments to appropriations bills) to ban use of taxpayers dollars to pay for abortions.
 - o Do believe we should support efforts to help with alternatives, such as adoption and with counseling and other assistance that can help especially the young to avoid unwanted pregnancies.

7. How much funding do you believe the federal government should provide for birth control?

- o There is a family planning program contained in the Public Health Service Act.
- o Funding this year (FY84) is set at \$140 million, up from \$124 million in FY83.
- o We support incorporating family planning into a block grant to give local communities more flexibility, with a modest funding increase.

8. Should sex education be taught in the public schools?

- o First point is that schools are a local and state responsibility. Should stay that way because that helps to ensure that parents have access to, and influence on, the setting of educational policy for their own communities.
- o So question of whether public schools should teach sex education ought to be decided not by RR, or by federal government, but by local leaders listening to parents.
