I. PURPOSE

Saturday's Radio Address and your speech next Thursday deal with the subject of women in business. We thought it would be useful to talk informally with the members of your advisory committee about the issues affecting women in business.

This should be a working lunch. The group will be ready to engage in discussions as they eat.

II. BACKGROUND

The President's Advisory Committee on Women's Business Ownership was established by Executive Order 12426 on June 22, 1983. You charged the Committee to review the status of businesses owned by women; to foster, through the private sector, financial, educational, and procurement support for women entrepreneurs; and to provide advice to you and the Administrator of the Small Business Administration on their findings and recommendations.

In its first meeting in November of 1983, the Committee established the following goals:

- to determine if there are problems facing women business owners that are unique to women as a result of their sex, and
- 2) to develop recommendations to remedy these problems, if they exist.

A questionnaire has been developed that is being circulated across the country to aid the Committee in determining if women business owners have difficulties that men do not face in similar business dealings. The Committee's preliminary assessment of those data indicates that there are problems inherent to women business owners which place them in a disadvantageous position with their male counterparts.

Those problems appear to fall into two categories:

- 1) women often lack a general knowledge of the business world and, in particular, the skills needed to operate a business successfully. This is primarily due to the reality that, until a decade or so ago, women were not expected to go into business and their academic training, social associations, and daily interests did not reflect this orientation, and
- 2) the business community lacks the awareness of women business owners and, as a result, participation and procurement is usually available only to those in the "old boy network."

An ongoing objective of the Committee is also to determine what programs already exist throughout the nation that can be imitated elsewhere to assist women business owners. The National Initiative Conferences being sponsored by the SBA across the nation are fine examples of the role government and business can play to address the business needs of women.

The Committee has held two organizational meetings and has scheduled five public meetings across the country to interview and collect data on the status of women's business ownership in preparation for their report to you and Administrator Sanders. The first meeting was held in Washington on March 29. The remaining meetings will be held in Chicago (April 12), Tampa (April 30), San Antonio (May 3), and at a yet undecided location in California (late May). The Committee's report will be completed by June 22, 1984.
